SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Standardizes health profession regulatory boards.
Removes certain boards from jurisdiction of Department of Human Services.
Declares emergency, effective on passage.

10 **Be It Enacted by the People of the State of Oregon:**

11 **SECTION 1.** ORS 675.100 is amended to read:

12 675.100. (1) There hereby is created a State Board of Psychologist Examiners consisting of seven
13 members appointed by the Governor **and subject to confirmation by the Senate in the manner**
14 **provided in ORS 171.562 and 171.565. All members of the board must be Oregon residents.**

15 **Of the members of the board:**

16 (a) Five of the members [*shall be residents of Oregon,*] **must** have doctoral degrees with primary
17 emphasis in psychology and [*shall be licensed under ORS 675.010 to 675.150.*] **must be licensed**
18 **psychologists or former licensed psychologists who are retired from the practice of psychol-**
19 **ogy; and**

20 (b) Two **of the** members [*shall be residents of Oregon and shall serve as public members.*] **must**
21 **be members of the public and may not be:**

22 (A) **Otherwise eligible for appointment to the board; or**

23 (B) **A spouse, domestic partner, child, parent or sibling of a licensed psychologist.**

24 (2)(a) **Board members required to be licensed psychologists may be appointed from a list**
25 **of three to five nominees for each vacancy, submitted by any professional organization that**

1 **represents psychologists.**

2 **(b) In selecting the members of the board, the Governor shall strive to balance the rep-**
3 **resentation on the board according to:**

4 **(A) Geographic areas of this state; and**

5 **(B) Ethnic group.**

6 **[(2)] (3)(a) The term of office of a board member [shall be three] is three years, but [the members**
7 **shall serve] a member serves at the pleasure of the Governor. The terms must be staggered so**
8 **that no more than three terms end each year.**

9 **(b) Before the expiration of the term of a member, the Governor shall appoint a successor to**
10 **assume duties on July 1 next following. [A member shall be eligible for one consecutive reappointment**
11 **only.] A member is eligible for reappointment. In case of a vacancy for any cause, the Governor**
12 **shall make an appointment to become immediately effective for the unexpired term.**

13 **(c) A board member shall be removed immediately from the board if, during the mem-**
14 **ber's term, the member:**

15 **(A) Is not a resident of this state;**

16 **(B) Has been absent from three consecutive board meetings, unless at least one absence**
17 **is excused; or**

18 **(C) Is not a licensed psychologist or a retired psychologist who was a licensed psychol-**
19 **ogist in good standing at the time of retirement, if the board member was appointed to serve**
20 **on the board as a psychologist.**

21 *[(3) All appointments of members of the board by the Governor are subject to confirmation by the*
22 *Senate in the manner provided in ORS 171.562 and 171.565.]*

23 **(4) Before entering upon the duties of office, each board member shall subscribe to an oath that**
24 **the member will faithfully and impartially discharge the duties of office and that the member will**
25 **support the Constitution of the United States and the Constitution of this state. The oath shall be**
26 **filed with the Secretary of State.**

27 **(5) Each member of the board is entitled to compensation and expenses as provided in ORS**
28 **292.495. The board may provide by rule for compensation to board members for the per-**
29 **formance of official duties at a rate that is greater than the rate provided in ORS 292.495.**

30 **SECTION 2. ORS 675.310 is amended to read:**

31 **675.310. (1) There is created [in the Department of Human Services] the Occupational Therapy**
32 **Licensing Board. The board is composed of five members appointed by the Governor and subject**
33 **to confirmation by the Senate in the manner provided in ORS 171.562 and 171.565. All mem-**
34 **bers of the board must be residents of this state. Of the members of the board:**

35 **(a) Two [members shall] must be licensed occupational therapists in this state with no less than**
36 **three years of experience in occupational therapy immediately preceding their appointment[.];**

37 **(b) One [member shall] must be a licensed occupational therapy assistant[.]; and**

38 **(c) Two [members shall] must be members of the public[.] who are not:**

39 **(A) Otherwise eligible for appointment to the board; or**

40 **(B) A spouse, domestic partner, child, parent or sibling of an individual who is a licensed**
41 **occupational therapist or licensed occupational therapy assistant.**

42 **(2)(a) Board members required to be occupational therapists or occupational therapy assist-**
43 **ants may be selected by the Governor from a list of three to five nominees for each vacancy,**
44 **submitted by:**

45 **(A) The Occupational Therapy Association of Oregon [and the board.], if the vacancy is in an**

1 occupational therapist position; or

2 (B) Any professional organization representing occupational therapy assistants, if the
3 vacancy is in an occupational therapy assistant position.

4 (b) In selecting the members of the board, the Governor shall strive to balance the rep-
5 resentation on the board according to:

6 (A) Geographic areas of this state; and

7 (B) Ethnic group.

8 *[(2) Members are entitled to compensation and expenses as provided in ORS 292.495.]*

9 (3)(a) Board members *[shall]* serve a term of four years, *[and may not serve more than two con-*
10 *secutive terms.]* but a member serves at the pleasure of the Governor. The terms shall be
11 staggered so that no more than two terms end each year. A member is eligible for reap-
12 pointment. If a vacancy occurs in the membership of the board for any reason, the Governor
13 shall make an appointment to become immediately effective for the expired term.

14 (b) A board member shall be removed immediately from the board if, during the mem-
15 ber's term, the member:

16 (A) Is not a resident of this state;

17 (B) Has been absent from three consecutive board meetings, unless at least one absence
18 is excused;

19 (C) Is not a licensed occupational therapist or a retired occupational therapist who was
20 a licensed occupational therapist in good standing at the time of retirement, if the board
21 member was appointed to serve on the board as an occupational therapist; or

22 (D) Is not a licensed occupational therapy assistant or a retired occupational therapy
23 assistant who was a licensed occupational therapy assistant in good standing at the time of
24 retirement, if the board member was appointed to serve on the board as an occupational
25 therapy assistant.

26 (4) Members of the board are entitled to compensation and expenses as provided in ORS
27 292.495. The board may provide by rule for compensation to board members for the per-
28 formance of official duties at a rate that is greater than the rate provided in ORS 292.495.

29 **SECTION 3.** ORS 675.590 is amended to read:

30 675.590. (1) There is established a State Board of Clinical Social Workers. The board shall
31 consist of seven members appointed by the Governor and subject to confirmation by the
32 Senate in the manner provided in ORS 171.562 and 171.565. All members of the board must
33 be residents of this state. Of the members of the board:

34 (a) Four members must be licensed clinical social workers who are licensed in accordance
35 with the provisions of ORS 675.510 to 675.600; and

36 (b) Three members must be members of the public who have demonstrated an interest
37 in the field of clinical social work and who are not:

38 (A) Licensed clinical social workers; or

39 (B) A spouse, domestic partner, child, parent or sibling of a licensed clinical social
40 worker.

41 *[(2) The Governor shall appoint seven members to the board, consisting of members as specified in*
42 *subsection (4) of this section.]*

43 (2)(a) Board members required to be licensed clinical social workers may be appointed
44 from a list of three to five nominees for each vacancy, submitted by any professional or-
45 ganization that represents clinical social workers.

1 **(b) In selecting the members of the board, the Governor shall strive to balance the rep-**
2 **resentation on the board according to:**

3 **(A) Geographic areas of this state; and**

4 **(B) Ethnic group.**

5 (3)(a) The term of office of each member is four years, but a member serves at the pleasure of
6 the Governor. **The terms must be staggered so that no more than three terms end each year.**

7 **(b)** Before the expiration of the term of a member, the Governor shall appoint a successor whose
8 term begins on July 1 next following. A member is eligible for [*one consecutive*] reappointment. If
9 there is a vacancy for any cause, the Governor shall make an appointment to become immediately
10 effective for the unexpired term.

11 **(c) A board member shall be removed immediately from the board if, during the mem-**
12 **ber's term, the member:**

13 **(A) Is not a resident of this state;**

14 **(B) Has been absent from three consecutive board meetings, unless at least one absence**
15 **is excused; or**

16 **(C) Is not a licensed clinical social worker or a retired clinical social worker who was a**
17 **licensed clinical social worker in good standing at the time of retirement, if the board**
18 **member was appointed to serve on the board as a licensed clinical social worker.**

19 [*(4) The composition of the board shall be as follows:*]

20 [*(a) Four members shall be licensed clinical social workers who are licensed in accordance with*
21 *the provisions of ORS 675.510 to 675.600; and*]

22 [*(b) Three members shall be public citizens who have demonstrated an interest in the field of clin-*
23 *ical social work.*]

24 [*(5)*] **(4) Members of the board** are entitled to compensation and expenses as provided in ORS
25 292.495. **The board may provide by rule for compensation to board members for the per-**
26 **formance of duties at a rate that is greater than the rate provided in ORS 292.495.**

27 **SECTION 4.** ORS 675.775 is amended to read:

28 675.775. (1) The Oregon Board of Licensed Professional Counselors and Therapists is established.

29 [*(2)*] The board [*shall consist*] **consists** of [*seven*] **eight** members [*who shall be*] appointed by the
30 Governor[.] **and subject to confirmation by the Senate in the manner provided in ORS 171.562**
31 **and 171.565. All members of the board must be residents of this state. Of the members of the**
32 **board:**

33 **(a) Three must be licensed as professional counselors under ORS 675.715;**

34 **(b) Two must be licensed as marriage and family therapists under ORS 675.715;**

35 **(c) One must be from the faculty of a school within this state that has programs to train**
36 **persons to become professional counselors or marriage and family therapists; and**

37 **(d) Two must be members of the public who have demonstrated an interest in the fields**
38 **of professional counseling and marriage and family therapy but who are not a:**

39 **(A) Licensed professional counselor or marriage and family therapist; or**

40 **(B) Spouse, domestic partner, child, parent or sibling of a licensee.**

41 **(2)(a) Board members required to be licensees may be selected by the Governor from a**
42 **list of three to five nominees for each vacancy, submitted by any professional organization**
43 **representing licensees.**

44 [*(3)*] **(b) In selecting the members of the board, the Governor shall strive to balance the repre-**
45 **sentation according to:**

1 (A) Geographic areas of this state [, *gender, age*]; and

2 (B) Ethnic group.

3 [(4) *The board shall consist of:*]

4 [(a) *Three members who are persons licensed as professional counselors under ORS 675.715;*]

5 [(b) *Two members who are persons licensed as marriage and family therapists under ORS*
6 *675.715;*]

7 [(c) *One member from the faculty of a school within this state that has programs to train persons*
8 *to become professional counselors or marriage and family therapists; and*]

9 [(d) *One member from the public who has demonstrated an interest in the fields of professional*
10 *counseling and marriage and family therapy.*]

11 [(5) *Statewide counselor and marriage and family therapist organizations may recommend names*
12 *of qualified persons to the Governor at the time for filling vacancies on the board.*]

13 [(6)] **(3)(a)** The term of office of each member is three years, but a member serves at the pleas-
14 ure of the Governor. **The terms must be staggered so that no more than three terms end each**
15 **year.**

16 **(b)** By October 1 of each year, the Governor shall appoint persons to fill positions on the board
17 that are due to become vacant on October 1 of that year. A member is eligible for [*one*
18 *consecutive*] reappointment. If there is a vacancy for any cause, the Governor shall make an ap-
19 pointment to become immediately effective for the unexpired term.

20 **(c) A board member shall be removed immediately from the board if, during the mem-**
21 **ber's term, the member:**

22 **(A) Is not a resident of this state;**

23 **(B) Has been absent from three consecutive board meetings, unless at least one absence**
24 **is excused; or**

25 **(C) Is not a licensee or a retired licensee whose license was in good standing at the time**
26 **of retirement, if the board member was appointed to serve on the board as a licensee.**

27 **(4) Members of the board are entitled to compensation and expenses as provided in ORS**
28 **292.495. The board may provide by rule for compensation to board members for the per-**
29 **formance of official duties at a rate that is greater than the rate provided in ORS 292.495.**

30 **SECTION 5.** ORS 677.235 is amended to read:

31 677.235. (1) The Oregon Medical Board consists of 12 members appointed by the Governor[.] **and**
32 **subject to confirmation by the Senate in the manner provided in ORS 171.562 and 171.565.**
33 **All members of the board must be residents of this state. Of the members of the board:**

34 **(a)** Seven [*of the members shall be appointed from among persons having*] **must have** the degree
35 of Doctor of Medicine[.];

36 **(b)** Two [*from among persons having*] **must have** the degree of Doctor of Osteopathy [*and*];

37 **(c)** One [*from among persons having*] **must have** the degree of Doctor of Podiatric Medicine[.
38 *Of the seven members who hold the degree of Doctor of Medicine, there shall be at least one member*
39 *appointed from each federal congressional district. In addition to the 10 named persons described, there*
40 *shall be appointed*]; **and**

41 **(d)** Two [*public*] **must be** members **of the public** representing health consumers[. *All persons*
42 *appointed must have been residents of this state for at least seven years.*] **who are not otherwise**
43 **eligible for appointment to the board.**

44 **(2)(a)(A) Board members required to possess the degree of Doctor of Medicine may be**
45 **selected by the Governor from a list of three to five physicians for each physician member**

1 of the board whose term expires in that year, submitted by the Oregon Medical Association
2 not later than February 1.

3 (B) Board members required to possess the degree of Doctor of Osteopathy may be se-
4 lected by the Governor from a list of three to five qualified physicians for each vacancy,
5 submitted by the Osteopathic Physicians and Surgeons of Oregon, Inc., not later than Feb-
6 ruary 1 of each odd-numbered year.

7 (C) The board member required to possess the degree of Doctor of Podiatric Medicine
8 may be selected by the Governor from a list of three to five qualified physicians submitted
9 by the Oregon Podiatric Medical Association not later than February 1 of each fourth year.

10 (b) The physician members and the member who is a podiatric physician and surgeon must have
11 been in the active practice of their profession for at least five years immediately preceding their
12 appointment.

13 (c) Neither the public members nor any person [*within the immediate family of the public mem-*
14 *bers shall*] who is a spouse, domestic partner, child, parent or sibling of a public member may
15 be employed as a health professional [*or in any health-related industry*]. The public members [*shall*
16 *be*] are members of the investigative committee of the board.

17 (d)(A) In selecting the members of the board, the Governor shall strive to balance the
18 representation on the board according to geographic areas of this state and ethnic group.

19 (B) Of the seven members who hold the degree of Doctor of Medicine, there shall be at
20 least one member appointed from each federal congressional district.

21 [(2) Not later than February 1 of each year, the Oregon Medical Association shall nominate three
22 qualified physicians for each physician member of the board whose term expires in that year, and shall
23 certify its nominees to the Governor. Not later than February 1 of each odd-numbered year, the
24 Osteopathic Physicians and Surgeons of Oregon, Inc., shall nominate three physicians possessing the
25 degree of Doctor of Osteopathy and shall certify its nominees to the Governor. Not later than February
26 1 of each third year, the Oregon Podiatric Medical Association shall nominate three podiatric physi-
27 cians and surgeons possessing the degree of Doctor of Podiatric Medicine and shall certify its nominees
28 to the Governor. The Governor shall consider these nominees in selecting successors to retiring board
29 members.]

30 (3)(a) [Each member of the board shall serve for a term of three years beginning] The term of
31 office of each board member is three years, but a member serves at the pleasure of the
32 Governor. The terms must be staggered so that no more than four terms end each year. A
33 term begins on March 1 of the year the member is appointed and [*ending*] ends on the last day of
34 February of the third year thereafter. [*No member shall*] A member may not serve more than two
35 consecutive terms.

36 (b) If a vacancy occurs on the board, another qualifying member possessing the same profes-
37 sional degree or fulfilling the same public capacity as the person whose position has been vacated
38 shall be appointed as provided in this section to fill the unexpired term.

39 (c) A board member shall be removed immediately from the board if, during the mem-
40 ber's term, the member:

41 (A) Is not a resident of this state;

42 (B) Has been absent from three consecutive board meetings, unless at least one absence
43 is excused; or

44 (C) Is not a current licensee or a retired licensee whose license was in good standing at
45 the time of retirement, if the board member was appointed to serve on the board as a

1 **licensee.**

2 *[(4) All appointments of members of the board by the Governor are subject to confirmation by the*
3 *Senate in the manner provided in ORS 171.562 and 171.565.]*

4 **(4) Members of the board are entitled to compensation and expenses as provided in ORS**
5 **292.495. The board may provide by rule for compensation to board members for the per-**
6 **formance of official duties at a rate that is greater than the rate provided in ORS 292.495.**

7 **SECTION 6.** ORS 677.280 is amended to read:

8 677.280. *[(1)]* Subject to any applicable provisions of the State Personnel Relations Law, the
9 Oregon Medical Board may employ consultants, investigators and staff for the purpose of enforcing
10 the laws relating to this chapter and securing evidence of violations thereof, and may fix the com-
11 pensation therefor and incur necessary other expenses.

12 *[(2) The board members are entitled to compensation and expenses as provided in ORS 292.495.*
13 *Notwithstanding the provisions of ORS 292.495 (1), a board member shall receive up to \$250 for each*
14 *day or portion thereof during which the member is actually engaged in the performance of official du-*
15 *ties.]*

16 **SECTION 7.** ORS 677.540 is amended to read:

17 677.540. (1) There is created a Physician Assistant Committee, which shall consist of five mem-
18 bers. Members of the committee shall be appointed as follows:

19 (a) The Oregon Medical Board shall appoint one of its members and one physician. One of the
20 two must supervise a physician assistant.

21 (b) The Oregon Medical Board shall appoint three physician assistants after considering persons
22 nominated by the Oregon Society of Physician Assistants.

23 (2) The term of each member of the committee shall be for three years. A member may not serve
24 more than two consecutive terms. A member shall serve until a successor is appointed. If a vacancy
25 occurs, it shall be filled for the unexpired term by a person with the same qualifications as the re-
26 tiring member.

27 (3) If any vacancy under subsection (1) of this section is not filled within 45 days, the Governor
28 shall make the necessary appointment from the category which is vacant.

29 (4) The committee shall elect its own chairperson with such powers and duties as the committee
30 shall fix.

31 (5) A quorum of the committee shall be three members. The committee shall hold a meeting at
32 least once quarterly and at such other times the committee considers advisable to review requests
33 for prescription and dispensing privileges and to review applications for licensure or renewal.

34 (6) The chairperson may call a special meeting of the Physician Assistant Committee upon at
35 least 10 days' notice in writing to each member, to be held at any place designated by the chair-
36 person.

37 (7) The committee members are entitled to compensation and expenses as provided for board
38 members in ORS [677.280 (2)] **677.235.**

39 **SECTION 8.** ORS 677.780 is amended to read:

40 677.780. (1) There is established an Acupuncture Advisory Committee consisting of six members
41 appointed by the Oregon Medical Board. Of the committee members appointed by the board:

42 (a) One shall be a person who is a current member of the board.

43 (b) Two shall be physicians licensed under ORS chapter 677.

44 (c) Three shall be acupuncturists licensed under ORS 677.759. In appointing the three
45 acupuncturists, the board may receive nominations from the [*Oregon Acupuncture Association, the*

1 *Acupuncture and Oriental Medicine Society of Oregon*] **Oregon Association of Acupuncture and**
2 **Oriental Medicine** and other professional acupuncture organizations.

3 (2) The term of office of each committee member is [*four*] **three** years, but a committee member
4 serves at the pleasure of the board. A committee member may not serve more than two consecutive
5 terms. A committee member serves until a successor is appointed and qualified. If there is a vacancy
6 for any cause, the board shall make an appointment to become immediately effective for the unex-
7 pired term.

8 (3) A committee member is entitled to compensation and expenses as provided for board mem-
9 bers in ORS [*677.280 (2)*] **677.235**.

10 (4) A majority of the members of the committee constitutes a quorum for the transaction of
11 business.

12 **SECTION 9.** ORS 678.140 is amended to read:

13 678.140. (1) There is created an Oregon State Board of Nursing composed of nine members[,]
14 **appointed by the Governor and subject to confirmation by the Senate in the manner provided**
15 **in ORS 171.562 and 171.565. All members of the board must be residents of this state. Of the**
16 **members of the board:**

17 (a) Five [*of whom shall*] **must** be registered nurses[.];

18 (b) [*Two of whom shall*] **One must** be a licensed practical [*nurses and*] **nurse;**

19 (c) **One must be a certified nursing assistant; and**

20 (d) Two [*of whom shall*] **must** be members of the public who are otherwise not eligible for ap-
21 pointment to the board.

22 (2)(a) **Board members required to be nurse members may be selected by the Governor**
23 **from a list of three to five nominees for each vacancy, submitted two months before the**
24 **expiration of the term of office of a nurse member by:**

25 (A) **The Oregon Nurses Association or any other professional organization representing**
26 **registered nurses, if the vacancy is in a registered nurse position;**

27 (B) **The Oregon Licensed Practical Nurses Association or any other professional organ-**
28 **ization representing licensed practical nurses, if the vacancy is in a licensed practical nurse**
29 **position; or**

30 (C) **A professional organization representing certified nursing assistants, if the vacancy**
31 **is in a certified nursing assistant position.**

32 (b) **Each nurse or certified nursing assistant member must:**

33 (A) **Be currently licensed and not under disciplinary status with the board in the category**
34 **for which the member is appointed; and**

35 (B) **Have at least five years' experience in the category in which the member is ap-**
36 **pointed, three of which were immediately prior to appointment.**

37 (c) **The public members and any person who is a spouse, domestic partner, child, parent**
38 **or sibling of a public member may not be licensed by the board.**

39 [(2)] (d) In making appointments of registered nurses, the Governor shall [*consider geographic*
40 *balance in making the appointments and shall*] ensure that the following areas of practice are re-
41 presented on the board:

42 [(a)] (A) One nursing educator;

43 [(b)] (B) One nursing administrator;

44 [(c)] (C) Two nonsupervisory nurses involved in direct patient care; and

45 [(d)] (D) One nurse practitioner.

1 (e) In selecting the members of the board, the Governor shall strive to balance the rep-
2 resentation on the board according to:

3 (A) Geographic areas of this state; and

4 (B) Ethnic group.

5 (3)(a) The members of the board shall be appointed by the Governor for terms of three years,
6 beginning on January 1. *[No member shall be eligible to appointment for more than two consecutive*
7 *terms.] A member serves at the pleasure of the Governor. The terms must be staggered so*
8 *that no more than three terms end each year. A member is eligible for reappointment.* An
9 unexpired term of a board member shall be filled in the same manner as an original appointment is
10 made. The appointment shall be for the remainder of the unexpired term. *[All appointments of mem-*
11 *bers of the board by the Governor are subject to confirmation by the Senate pursuant to section 4,*
12 *Article III of the Oregon Constitution.]*

13 (b) A board member shall be removed immediately from the board if, during the mem-
14 ber's term, the member:

15 (A) Is not a resident of this state;

16 (B) Has been absent from three consecutive board meetings, unless at least one absence
17 is excused; or

18 (C) Is not a registered nurse or licensed practical nurse or a retired registered nurse or
19 licensed practical nurse who was a registered nurse in good standing or licensed practical
20 nurse in good standing at the time of retirement, if the board member was appointed to
21 serve on the board as a nurse member.

22 *[(4) Two months before the expiration of the term of office of a nurse member of the board, or when*

3 name of the “Board of Naturopathic Examiners” to the “Oregon Board of Naturopathic Medicine.”

4 (2) For the purpose of harmonizing and clarifying statute sections published in Oregon Revised
5 Statutes, the Legislative Counsel may substitute for words designating the “Board of Naturopathic
6 Examiners,” wherever they occur in Oregon Revised Statutes, other words designating the “Oregon
7 Board of Naturopathic Medicine.”

8 **SECTION 43. The amendments to ORS 675.590 and 685.160 and section 38, chapter 43,**
9 **Oregon Laws 2009 (Enrolled Senate Bill 131), and section 49, chapter __, Oregon Laws 2009**
10 **(Enrolled Senate Bill 177), by sections 39 to 42 of this 2009 Act become operative on January**
11 **1, 2010.**

12 **SECTION 44. This 2009 Act being necessary for the immediate preservation of the public**
13 **peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect**
14 **on its passage.**
