9 “**SECTION 35.** ORS 692.300 is amended to read:

10 “692.300. (1) There is created the State Mortuary and Cemetery Board [*in the Department of*

11 *Human Services*] to carry out the purposes and enforce the provisions of this chapter. [*The board*

12 *shall consist of 11 members. The members of the board shall be as follows:*] **The board consists of**

13 **11 members appointed by the Governor and subject to confirmation by the Senate in the**

14 **manner provided in ORS 171.562 and 171.565. All members of the board must be residents of**

15 **this state. Of the members of the board:**

16 “(a) Two members [*shall*] **must** be licensed funeral service practitioners. One of the members

17 under this paragraph [*shall*] **must** be a funeral service practitioner who does not offer embalming.

18 “(b) One member [*shall*] **must** be a licensed embalmer.

19 “(c) Three members [*shall*] **must** be representatives of cemeteries, one representing for-profit

20 cemeteries, one representing a city or county owned or operated cemetery and one representing a

21 special district owned or operated cemetery.

22 “(d) One member [*shall*] **must** be a representative of a crematorium.

23 “(e) Four members [*shall*] **must** be representatives of the public, one of whom [*shall*] **must** be

24 a member of a recognized senior citizen organization.

25 “(2)(a) **Board members required to be licensed funeral service practitioners or licensed**

26 **embalmers may be selected by the Governor from a list of three to five nominees for each**

27 **vacancy, submitted by:**

28 “(A) **Any professional organization representing funeral service practitioners, if the va-**

29 **cancy on the board is for a funeral service practitioner position; or**

30 “(B) **Any professional organization representing embalmers, if the vacancy on the board**

31 **is for an embalmer position.**

32 “(b) **In selecting the members of the board, the Governor shall strive to balance the**

33 **representation on the board according to:**

34 “(A) **Geographic areas of this state; and**

35 “(B) **Ethnic group.**

36 “[2] (3)(a) The term of office of the members of the board shall be [*four*] **three** years ending

37 on December 31, **but a member serves at the pleasure of the Governor. The terms must be**

38 **staggered so that no more than four terms end each year.** A member is eligible for no more

39 than two consecutive terms. [*They shall be appointed by the Governor and hold office until the ap-*

40 *pointment and qualification of their successors.*] **If there is a vacancy for any cause, the Governor**

41 **shall make an appointment to become immediately effective for the unexpired term.**

42 “(b) **A board member shall be removed immediately from the board if, during the mem-**

43 **ber’s term, the member:**

44 “(A) **Is not a resident of this state;**

45 “(B) **Has been absent from three consecutive board meetings, unless at least one absence**

1 is excused;

2 “(C) Is not a licensed funeral service practitioner or a retired funeral service practitioner
3 whose license was in good standing at the time of retirement, if the board member was ap-
4 pointed to serve on the board as a funeral service practitioner; or

5 “(D) Is not a licensed embalmer or a retired embalmer whose license was in good stand-
6 ing at the time of retirement, if the board member was appointed to serve on the board as
7 a embalmer.”.
