## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires health professional licensee to report prohibited or unprofessional conduct of another licensee to regulatory board responsible for licensee. Punishes failure to report by maximum of \$720 fine.

Requires board to report prohibited conduct to law enforcement agency. Requires licensee arrested for felony or convicted of misdemeanor or felony to report conviction or arrest to licensee's board.

Modifies requirements for initial massage therapist license.

(d) "Unprofessional conduct" means conduct unbecoming a licensee or detrimental to the
 best interests of the public, including conduct contrary to recognized standards of ethics of
 the licensee's profession or conduct that endangers the health, safety or welfare of a patient
 or client.

(2) Unless state or federal laws relating to confidentiality or the protection of health information prohibit disclosure, a licensee who has reasonable cause to believe that another licensee has engaged in prohibited or unprofessional conduct shall report the conduct to the board responsible for the licensee who is believed to have engaged in the conduct. The reporting licensee shall report the conduct without undue delay, but in no event later than 10 working days after the reporting licensee learns of the conduct.

(3) A licensee who is convicted of a misdemeanor or felony or who is arrested for a felony
 crime shall report the conviction or arrest to the licensee's board within 10 days after the
 conviction or arrest.

(4) The board responsible for a licensee who is reported to have engaged in prohibited or
unprofessional conduct shall investigate in accordance with the board's rules. If the board
has reasonable cause to believe that the licensee has engaged in prohibited conduct, the
board shall present the facts to an appropriate law enforcement agency without undue delay,
but in no event later than 10 working days after the board finds reasonable cause to believe
that the licensee engaged in prohibited conduct.

(5) A licensee who fails to report prohibited or unprofessional conduct as required by
subsection (2) of this section or the licensee's conviction or arrest as required by subsection
(3) of this section is subject to discipline by the board responsible for the licensee.

(6) A licensee who fails to report prohibited conduct as required by subsection (2) of this
 section commits a Class A violation.

(7) Notwithstanding any other provision of law, a report under subsection (2) or (3) of
this section is confidential under ORS 676.175. A board may disclose a report as provided in
ORS 676.177.

(8) Except as part of an application for a license or for renewal of a license and except
as provided in subsection (3) of this section, a board may not require a licensee to report the
licensee's criminal conduct.

(4)(a) Unless state or federal laws relating to confidentiality or the protection of health information prohibit disclosure, any health care facility licensed under ORS 441.015 to 441.087 and 441.820, any medical or osteopathic physician licensed under ORS chapter 677, any owner of an ambulance licensed under this chapter or any EMT certified under this chapter shall report to the department any information the person may have that appears to show that an EMT is or may be medically incompetent, guilty of unprofessional or dishonorable conduct or mentally or physically unable to safely function as an EMT.

(b) Unless state or federal laws relating to confidentiality or the protection of health information prohibit disclosure, an EMT certified under this chapter who has reasonable cause
to believe that a licensee of another board has engaged in prohibited conduct as defined in
section 1 of this 2009 Act shall report the prohibited conduct in the manner provided in section 1 of this 2009 Act.

(5) If, in the opinion of the department, it appears that the information provided to it under
provisions of this section is or may be true, the department may request an interview with the EMT.
At the time the department requests an interview, the EMT shall be provided with a general statement of the issue or issues of concern to the department. The request shall include a statement of
the procedural safeguards available to the EMT, including the right to end the interview on request,
