**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Makes technical changes in Oregon tax statutes. Adjusts grammar and syntax. Repeals and deletes obsolete statutes and provisions. Conforms language and structure to existing statutes.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 63.810 is amended to read:

9 63.810. For purposes of ORS [*chapters 305 to 324*] **320.005 to 320.150 and ORS chapters 305,**  
10 **306, 307, 308, 308A, 309, 310, 311, 312, 314, 315, 316, 317, 318, 319, 321, 323 and 324,** a limited li-  
11 ability company formed under this chapter or qualified to do business in this state as a foreign  
12 limited liability company shall be classified in the same manner as it is classified for federal income  
13 tax purposes. For purposes of ORS [*chapters 305 to 324*] **320.005 to 320.150 and ORS chapters 305,**  
14 **306, 307, 308, 308A, 309, 310, 311, 312, 314, 315, 316, 317, 318, 319, 321, 323 and 324,** a member or  
15 an assignee of a member of a limited liability company formed under this chapter or qualified to do  
16 business in this state as a foreign limited liability company shall have the same status as the mem-  
17 ber or assignee of a member has for federal income tax purposes.

19 **SECTION 2.** ORS 118.290 is amended to read:

20 118.290. (1) If any bequest or legacy is charged upon or payable out of any property, the heir  
21 or devisee shall deduct [*such tax therefrom and pay such*] **from the property the tax imposed by**  
22 **ORS 118.005 to 118.840 and pay the tax** to the administrator, executor or trustee, and the tax shall  
23 remain a lien or charge on [*such*] **the** property until paid. The payment thereof shall be enforced  
24 by the executor, administrator or trustee in the same manner that payment of the bequest or legacy  
25 is enforced, or by the Department of Revenue in the same manner as income taxes are collected  
26 under ORS chapter 314.

27 (2) If any bequest or legacy is given in money for a limited period, the administrator, executor  
28 or trustee shall retain the tax upon the whole amount[; *but, if it is not*]. **If any bequest or legacy**

1 **is not given** in money, the administrator, executor or trustee shall make application to the court  
 2 having jurisdiction of an accounting by the administrator, executor or trustee to make an appor-  
 3 tionment, if the case requires, of the sum to be paid by such legatee or beneficiary, and for such  
 4 further order relative thereto as the case may require.

6 **SECTION 3.** ORS 118.830 is amended to read:

7 118.830. (1) The proof required by ORS 118.820 may be in the form of a certificate issued by the  
 8 official or body charged with the administration of the death tax laws of the domiciliary state *[but*  
 9 *if such proof]*.

10 (2) **If the proof** is not filed within the time limit set out in ORS 118.820, the clerk of the court  
 11 *[forthwith]* shall notify by mail the official or body of the domiciliary state charged with the admin-  
 12 istration of the death tax laws *[thereof]* with respect to *[such] the* estate[,] and shall state in *[such]*  
 13 **the** notice, as far as is known to the clerk[:]

14 (a) The name, date of death and last domicile of *[such] the* decedent;

15 (b) The name and address of each executor or administrator;

16 (c) A summary of the values of the real estate, tangible personalty and intangible personalty,  
 17 wherever situated, belonging to *[such] the* decedent at the time of death; and

18 (d) The fact that *[such] the* executor or administrator has not filed *[theretofore]* the proof re-  
 19 quired in ORS 118.820.

20 (3) The clerk shall attach to *[such] the* notice:

21 (a) A plain copy of the will and codicils of *[such] the* decedent, if the decedent died testate[;]  
 22 or

23 (b) If the decedent died intestate, a list of heirs and next of kin of the decedent, so far as is  
 24 known to *[such] the* clerk.

25 (4) Within 60 days after the mailing of *[such] the* notice, the official or body charged with the  
 26 administration of the death tax laws of the domiciliary state may file with the court in this state a  
 27 petition for an accounting in *[such] the* estate. *[Such] The* official or body of the domiciliary state  
 28 shall be deemed a party interested for the purpose of petitioning the court for *[such] the* accounting.

29 (5) If *[such] the* petition is filed within the period of 60 days, the court shall order the  
 30 accounting[, *and upon the accounting being filed and approved]* **and, upon the filing and approval**  
 31 **of the accounting**, shall enter a judgment requiring the remission to the fiduciary appointed by the  
 32 domiciliary probate court of the balance of the intangible personalty after the payment of creditors  
 33 and expenses of administration in this state.

35 **SECTION 4.** ORS 118.870 is amended to read:

36 118.870. (1) When it appears by the written admission of the executor and the tax official of each  
 37 state involved in the dispute that an agreement contemplated in ORS 118.865 (1) cannot be reached  
 38 or, in all events, if one year has elapsed from the date of the election without such an agreement  
 39 having been reached, the domicile of the decedent at the time of death shall be determined solely  
 40 for death tax purposes as *[follows:]* **provided in this section.**

41 *[(1)]* (2) When this state and one other state only are involved in the dispute, the Director of  
 42 the Department of Revenue and the taxing official of the other state shall each appoint a member  
 43 of a board of arbitration and those members shall appoint the third member of the board. If this  
 44 state and more than one other state are involved, the taxing officials *[thereof]* **of the involved**  
 45 **states** shall agree upon the authorities charged with the duty of administering death tax laws in

1 three states not involved in the dispute and each of these authorities shall appoint one member of  
2 the board of arbitration. The board shall select one of its members as chairperson.

3 *[(2) The board shall hold hearings at such places as it deems necessary, upon reasonable notice to  
4 the executor, ancillary administrators, all interested persons and the taxing officials of the states in-  
5 volved, all of whom are entitled to be heard.]*

6 (3) The board may administer oaths, take testimony, subpoena witnesses and require their  
7 attendance[;], require the production of books, papers and documents and issue commissions to take  
8 testimony. Subpoenas may be issued by any member of the board. Failure to obey a subpoena of the  
9 board may be punished by any court of record in the same manner as if the subpoena had been is-  
10 sued by *[such]* **the** court.

11 (4) Whenever practicable the board shall apply the rules of evidence then prevailing in the fed-  
12 eral courts under the federal rules of civil procedure.

13 **(5) The reasonable compensation and expenses of the members of the board and its em-  
14 ployees shall be agreed upon among the members, the taxing officials involved and the ex-  
15 ecutor. If such an agreement cannot be reached, the compensation and expenses shall be  
16 determined by the taxing officials and, if they cannot agree, by the appropriate probate court  
17 of the state determined to be the domicile of the decedent. The amount so determined shall  
18 be borne by the decedent's estate and shall be deemed an administration expense of the es-  
19 tate.**

20 **(6) The board shall hold hearings at places the board deems necessary, upon reasonable  
21 notice to the executor, ancillary administrators, all interested persons and the taxing offi-  
22 cials of the states involved, all of whom are entitled to be heard.**

23 *[(5)]* (7) The board, by the decision of its majority, shall determine the domicile of the decedent  
24 at the time of death. The decision of the board is final and conclusive and binds this state and all  
25 of its judicial and administrative officials on all questions concerning the domicile of the decedent  
26 for death tax purposes. If the board does not render a decision within one year from the time that  
27 it is fully constituted, all authority of the board shall cease and the bar to court proceedings set  
28 forth in ORS 118.860 shall no longer exist.

29 *[(6)]* **(8) The decision of the board and the record of *[its]* **the board's** proceeding shall be filed  
30 with the authority *[having]* **that has** jurisdiction to assess death taxes in the state determined to  
31 be the domicile of the decedent and with the authorities *[which]* **that** would have had jurisdiction  
32 to assess death taxes in each of the other states involved if the decedent had been found to be  
33 domiciled *[therein]* **there**.**

34 *[(7) The reasonable compensation and expenses of the members of the board and its employees shall  
35 be agreed upon among such members, the taxing officials involved, and the executor. If such an  
36 agreement cannot be reached, the compensation and expenses shall be determined by such taxing offi-  
37 cials and, if they cannot agree, by the appropriate probate court of the state determined to be the  
38 domicile of the decedent. Such amount so determined shall be borne by the decedent's estate and shall  
39 be deemed an administration expense thereof.]*

41 **SECTION 5.** ORS 285C.250 is amended to read:

42 285C.250. (1) Within a reasonable period of time prior to the termination of enterprise zones  
43 under ORS 285C.245 (2), the Director of the Economic and Community Development Department  
44 shall competitively designate the same number of enterprise zones effective immediately after ter-  
45 mination of the previous enterprise zones. The determination by the director as to the areas desig-

1 nated as enterprise zones shall be final.

2 (2) When an enterprise zone is terminated under ORS [285B.686 (4) to (6)] **285C.245 (4) to (6)**,  
3 the director may competitively designate a new enterprise zone. The sponsor of the enterprise zone  
4 terminated under ORS 285C.245 (4) or (5) is not eligible to apply for a new enterprise zone, except  
5 for a county government when the terminated zone was also jointly sponsored by one or more cities  
6 or ports.

7 (3) Sponsors of existing enterprise zones that are due to terminate may reapply for designation  
8 under subsection (1) of this section.

9 (4) Any city, county or port may apply to the director for designation of an enterprise zone in  
10 accordance with the criteria set forth in ORS 285C.065 and 285C.090. In addition, the Economic and  
11 Community Development Department by rule shall determine the minimum level of economic hard-  
12 ship in any area to be included within an enterprise zone, any other criteria necessary to evaluate  
13 the need for the enterprise zone and the potential for accomplishing the purposes of ORS 285C.050  
14 to 285C.250.

15 (5) All enterprise zones designated under this section shall terminate in accordance with ORS  
16 285C.245 (2).

17 (6) When the director designates enterprise zones under this section, there is no limit on the  
18 relative number of urban or rural enterprise zones designated.

19 (7) The director may determine when to accept applications for any enterprise zone that termi-  
20 nates under subsection (2) of this section or is not designated under subsection (1) of this section  
21 for lack of qualified applicants.

23 **SECTION 6.** ORS 305.288 is amended to read:

24 305.288. (1) The tax court shall order a change or correction applicable to a separate assessment  
25 of property to the assessment and tax roll for the current tax year or for either of the two tax years  
26 immediately preceding the current tax year, or for any or all of those tax years, if all of the fol-  
27 lowing conditions exist:

28 (a) For the tax year to which the change or correction is applicable, the property was or is used  
29 primarily as a dwelling (or is vacant) and was and is a single-family dwelling, a multifamily dwelling  
30 of not more than four units, a condominium unit, a manufactured structure or a floating home.

31 (b) The change or correction requested is a change in value for the property for the tax year  
32 and it is asserted in the request and determined by the tax court that the difference between the  
33 real market value of the property for the tax year and the real market value on the assessment and  
34 tax roll for the tax year is equal to or greater than 20 percent.

35 (2) If the tax court finds that the conditions needed to order a change or correction under sub-  
36 section (1) of this section exist, the court may order a change or correction in the maximum assessed  
37 value of the property in addition to the change or correction in the real market value of the prop-  
38 erty.

39 (3) The tax court may order a change or correction applicable to a separate assessment of  
40 property to the assessment or tax roll for the current tax year and for either of the two tax years  
41 immediately preceding the current tax year if, for the year to which the change or correction is  
42 applicable, the assessor or taxpayer has no statutory right of appeal remaining and the tax court  
43 determines that good and sufficient cause exists for the failure by the assessor or taxpayer to pursue  
44 the statutory right of appeal.

45 (4) Before ordering a change or correction to the assessment or tax roll under subsection (3)

1 of this section, the tax court may determine whether any of the conditions exist in a particular case.  
2 If the tax court determines that one of the conditions specified does exist, the tax court shall hold  
3 a hearing to determine whether to order a change or correction to the roll.

4 (5) For purposes of this section:

5 (a) "Current tax year" has the meaning given the term under ORS 306.115.

6 (b) "Good and sufficient cause":

7 (A) Means an extraordinary circumstance that is beyond the control of the taxpayer, or the  
8 taxpayer's agent or representative, and that causes the taxpayer, agent or representative to fail to  
9 pursue the statutory right of appeal; and

10 (B) Does not include inadvertence, oversight, lack of knowledge, hardship or reliance on mis-  
11 leading information provided by any person except an authorized tax official providing the relevant  
12 misleading information.

13 (6) The remedy provided under this section is in addition to all other remedies provided by law.

14 (7) As used in subsections (1) to (6) of this section, "manufactured structure" has the meaning  
15 given that term in ORS 446.561.

16 **NOTE:** Provides proper punctuation in (3).

17 **SECTION 7.** ORS 305.620 is amended to read:

18 305.620. (1) Any state agency or department may enter into agreements with any political sub-  
19 division of this state for the collection, enforcement, administration and distribution of local taxes  
20 of the political subdivision imposed upon or measured by gross or net income, wages or net earnings  
21 from self-employment or local general sales and use taxes.

22 (2) The department or agency shall prescribe the rules by which the agreements entered into  
23 under subsection (1) of this section are administered.

24 (3) The department or agency shall prescribe the rules by which the taxes described by sub-  
25 section (1) of this section are administered, collected, enforced and distributed.

26 (4) A political subdivision may appear as an intervenor at any conference held by the Depart-  
27 ment of Revenue or conference, hearing or proceeding held by another department or agency in  
28 connection with a local tax administered by the department or agency. The political subdivision may  
29 be represented by its own counsel. The department or agency shall adopt rules governing the pro-  
30 cedures to be followed by the political subdivision in making an appearance.

31 (5) Costs incurred by the department or agency in the administration, enforcement, collection  
32 and distribution of taxes under the agreements entered into under subsection (1) of this section shall  
33 be first deducted from the taxes collected before distribution is made to the political subdivision  
34 which is a party to the agreement.

35 (6) The Oregon Tax Court shall have exclusive jurisdiction to review determinations of the De-  
36 partment of Revenue or orders of another department or agency relating to the collection, enforce-  
37 ment, administration and distribution of local taxes under agreements entered into under subsection  
38 (1) of this section.

39 (7) A proceeding for refund or to set aside additional taxes or taxes assessed when no return  
40 was filed may be initiated before the state agency or department.

41 (8) An appeal from a determination or an order may be taken by the taxpayer or by the political  
42 subdivision whose taxes are in issue, by filing a complaint with the clerk of the Oregon Tax Court  
43 at its principal office [*at the state capital,*] in Salem, Oregon, within 60 days after the notice of the  
44 determination of the Department of Revenue or the order of the department or agency is sent to the  
45 taxpayer or the political subdivision. The filing of the complaint in the Oregon Tax Court shall

1 constitute perfection of the appeal. Service of the taxpayer's complaint shall be accomplished by the  
 2 clerk of the tax court by filing a copy of the complaint with the administrative head of the depart-  
 3 ment or agency and a copy with the political subdivision. Service of the political subdivision's  
 4 complaint shall be accomplished by the clerk of the tax court by filing a copy of the complaint with  
 5 the administrative head of the department or agency and mailing a copy of the complaint to the  
 6 taxpayer. The complaint of a taxpayer shall be entitled in the name of the person filing as plaintiff  
 7 and the department or agency as defendant. The complaint of a political subdivision shall be entitled  
 8 in the name of the political subdivision as plaintiff and the taxpayer and the department or agency  
 9 as defendants. A copy of the order of the department or agency shall be attached to the complaint.  
 10 All procedures shall be in accordance with ORS 305.405 to 305.494.

12 **SECTION 8.** ORS 305.720 is amended to read:

13 305.720. Subject to ORS 305.710, 305.723 and 305.745, an entity qualifies for listing on the eligi-  
 14 bility roster for form listing to receive contributions by means of checkoff if:

15 (1) The entity supports private charitable causes or engages in public activities that are con-  
 16 sistent with policies and programs of the state and:

17 (a) Checkoff resources are used to augment existing programs or provide new funding to related  
 18 activities of proven value[.];

19 (b) Checkoff funds are not to be used to meet the administrative expenses of the entity;

20 [(b)] (c) Programs funded by checkoff resources [must] result in substantial and direct benefits  
 21 to the human and natural resources of the state that the Oregon Charitable Checkoff Commission  
 22 determines are unlikely to occur under existing public and private programs; and

23 [(c)] (d) After checkoff resources are received by the entity, the entity shows a pattern over  
 24 several years of increasing its total revenues from other than checkoff sources or reaches the level  
 25 where no more than 50 percent of its revenues are from checkoff sources.

26 (2) The entity is qualified to receive contributions that are tax deductible under the following:

27 (a) Section 170 of the Internal Revenue Code (relating to contributions and gifts to charitable  
 28 and governmental entities).

29 (b) Section 501(k) of the Internal Revenue Code (relating to contributions to certain organiza-  
 30 tions providing child care).

31 (c) Section 7871 of the Internal Revenue Code (relating to contributions to Indian tribal gov-  
 32 ernments).

33 (d) Any other federal law allowing a deduction from federal individual income tax for charitable  
 34 contributions to an entity classified by rule of the Department of Revenue as being an entity be-  
 35 longing to the general class described in paragraphs (a) to (c) of this subsection.

36 (3) The entity makes application for listing within the time and in the manner prescribed by ORS  
 37 305.725.

38 (4) The entity files a financial report, and other information, with the commission as described  
 39 under ORS 305.730.

40 (5) The entity received \$25,000 or more in checkoff contributions in at least one of the two tax  
 41 years immediately preceding the tax year for which it is to be listed on the Oregon income tax re-  
 42 turn. This subsection does not apply if the entity has not been included on the Oregon personal in-  
 43 come tax return for each of the two tax years immediately preceding the tax year for which  
 44 determination for purposes of this subsection is being made.

45 **NOTE:** Abolishes abnormal punctuation in (1).

1        **SECTION 9.** ORS 309.100 is amended to read:

2        309.100. (1) The owner or an owner of any taxable property or any person who holds an interest  
3 in the property that obligates the person to pay taxes imposed on the property, may petition the  
4 board of property tax appeals for relief as authorized under ORS 309.026. As used in this subsection,  
5 an interest that obligates the person to pay taxes includes a contract, lease or other intervening  
6 instrumentality.

7        (2) Petitions filed under this section shall be filed with the clerk of the board during the period  
8 following the date the tax statements are mailed for the current tax year and ending December 31.

9        (3) Each petition shall:

10        (a) Be made in writing.

11        (b) State the facts and the grounds upon which the petition is made.

12        (c) Be signed and verified by the oath of a person described in subsection (1) or (4) of this sec-  
13 tion.

14        (d) State the address to which notice of the action of the board shall be sent. The notice may  
15 be sent to a person described in subsection (1) or (4) of this section.

16        (e) State if the petitioner or a representative desires to appear at a hearing before the board.

17        (4)(a) The following persons may sign a petition and appear before the board on behalf of a  
18 person described in subsection (1) of this section:

19        (A) A relative, as defined by rule adopted by the Department of Revenue, of an owner of the  
20 property.

21        (B) A person duly qualified to practice law or public accountancy in this state.

22        (C) A legal guardian or conservator who is acting on behalf of an owner of the property.

23        (D) A real estate broker or principal real estate broker licensed under ORS 696.022.

24        (E) A state certified appraiser or a state licensed appraiser under ORS 674.310 or a registered  
25 appraiser under ORS 308.010.

26        (F) The lessee of the property.

27        (G) An attorney-in-fact under a general power of attorney executed by a principal who is an  
28 owner of the property.

29        (b) A petition signed by a person described in this subsection, other than a legal guardian or  
30 conservator of a property owner, an attorney-in-fact described in paragraph (a)(G) of this subsection  
31 or a person duly qualified to practice law in this state, shall include written [*and signed*] authori-  
32 zation [*from*] **for the person to act on behalf of** the owner or other person described in subsection  
33 (1) of this section [*for the person to act on their behalf*]. **The authorization shall be signed by the**  
34 **owner or other person described in subsection (1) of this section.**

35        (c) In the case of a petition signed by a legal guardian or conservator, the board may request  
36 the guardian or conservator to authenticate the guardianship or conservatorship.

37        (d) In the case of a petition signed by an attorney-in-fact described in paragraph (a)(G) of this  
38 subsection, the petition shall be accompanied by a copy of the general power of attorney.

39        (5) If the petitioner has requested a hearing before the board, the board shall give such  
40 petitioner at least five days' written notice of the time and place to appear. If the board denies any  
41 petition upon the grounds that it does not meet the requirements of subsection (3) of this section,  
42 it shall issue a written order rejecting the petition and set forth in the order the reasons the board  
43 considered the petition to be defective.

44        (6) Notwithstanding ORS 9.160 or 9.320, the owner or other person described in subsection (1)  
45 of this section may appear and represent himself or herself at the hearing before the board, or may

1 be represented at the hearing by any authorized person described in subsection (4) of this section.

3 **SECTION 10.** ORS 312.122 is amended to read:

4 312.122. (1) A county may by ordinance provide the means to require the tax collector of the  
5 county to deed to the county pursuant to ORS 312.200 any real property sold to the county under  
6 ORS 312.100 after the expiration of the 30-day period provided in subsection (2) of this section if:

7 (a) The property is subjected to waste [*which*] **that** results in a forfeiture to the county of the  
8 right to possession of the property under ORS 312.180; or

9 (b) The property is not occupied by the owner or any person or entity that appears in the re-  
10 cords of the county to have a lien or other interest in the property for a period of six consecutive  
11 months, and the property has suffered a substantial depreciation in value or will suffer a substantial  
12 depreciation in value if not occupied.

13 (2)(a) Upon determining that real property sold to the county under ORS 312.100 may be subject  
14 to waste or abandonment as provided in subsection (1) of this section, the county shall set a date,  
15 time and place within the county for a hearing for the purpose of determining whether the property  
16 should be deeded to the county pursuant to subsection (1) of this section.

17 (b) The owner and any person or entity that appears in the records of the county to have a lien  
18 or other interest in the property shall be given an opportunity to be heard at the hearing provided  
19 in paragraph (a) of this subsection.

20 (c) If the county determines after the hearing provided in paragraph (a) of this subsection that  
21 the property is subject to waste or abandonment as provided in subsection (1) of this section, the  
22 county governing body shall provide that any rights of possession the owner may have in the prop-  
23 erty are forfeited and direct the property be deeded to the county by the tax collector of the county  
24 after expiration of a period of 30 days from the date of the action of the county governing body  
25 determining property subject to forfeiture unless it is sooner redeemed by the owner or any person  
26 or entity that then appears in the records of the county to have a lien or other interest in the  
27 property. All rights of redemption with respect to the real property described in that deed shall  
28 terminate on the execution of the deed to the county.

29 (d) The county shall, in its ordinance, provide for procedures for the hearing required under this  
30 subsection that are compatible with the requirements of due process of law.

31 (3) Not less than 30 days prior to the hearing provided in subsection (2) of this section, the  
32 county shall notify the owner and any person or entity that then appears in the records of the  
33 county to have a lien or other interest in the property of the hearing. The notice shall contain:

34 (a) The date, time and place of the hearing provided for in subsection (2) of this section;

35 (b) The date of the judgment;

36 (c) The normal date of expiration of the period of redemption under ORS 312.120;

37 (d) **A** warning to the effect that if the county determines that the property is subject to waste
