# SUMMARY

SECTION 1. ORS 63.810 is amended to read: 8

9 63.810. For purposes of ORS [chapters 305 to 324] 320.005 to 320.150 and ORS chapters 305, 10 306, 307, 308, 308A, 309, 310, 311, 312, 314, 315, 316, 317, 318, 319, 321, 323 and 324, a limited liability company formed under this chapter or qualified to do business in this state as a foreign 11 12 limited liability company shall be classified in the same manner as it is classified for federal income 13 tax purposes. For purposes of ORS [chapters 305 to 324] 320.005 to 320.150 and ORS chapters 305, 306, 307, 308, 308A, 309, 310, 311, 312, 314, 315, 316, 317, 318, 319, 321, 323 and 324, a member or 14 an assignee of a member of a limited liability company formed under this chapter or qualified to do 15 business in this state as a foreign limited liability company shall have the same status as the mem-16 17ber or assignee of a member has for federal income tax purposes.

(1) If any bequest or legacy is charged upon or payable out of any property, the heir 2021or devise shall deduct [such tax therefrom and pay such] from the property the tax imposed by ORS 118.005 to 118.840 and pay the tax to the administrator, executor or trustee, and the tax shall 22remain a lien or charge on [such] the property until paid. The payment thereof shall be enforced 2324 by the executor, administrator or trustee in the same manner that payment of the bequest or legacy is enforced, or by the Department of Revenue in the same manner as income taxes are collected 25under ORS chapter 314. 26

(4) Within 60 days after the mailing of [*such*] **the** notice, the official or body charged with the administration of the death tax laws of the domiciliary state may file with the court in this state a petition for an accounting in [*such*] **the** estate. [*Such*] **The** official or body of the domiciliary state shall be deemed a party interested for the purpose of petitioning the court for [*such*] **the** accounting.

(5) If [such] the petition is filed within the period of 60 days, the court shall order the accounting[, and upon the accounting being filed and approved] and, upon the filing and approval of the accounting, shall enter a judgment requiring the remission to the fiduciary appointed by the domiciliary probate court of the balance of the intangible personalty after the payment of creditors and expenses of administration in this state.

SECTION 4. ORS 118.870 is amended to read:

118.870. (1) When it appears by the written admission of the executor and the tax official of each state involved in the dispute that an agreement contemplated in ORS 118.865 (1) cannot be reached or, in all events, if one year has elapsed from the date of the election without such an agreement having been reached, the domicile of the decedent at the time of death shall be determined solely for death tax purposes as [follows:] provided in this section.

[(1)] (2) When this state and one other state only are involved in the dispute, the Director of the Department of Revenue and the taxing official of the other state shall each appoint a member of a board of arbitration and those members shall appoint the third member of the board. If this state and more than one other state are involved, the taxing officials [thereof] of the involved states shall agree upon the authorities charged with the duty of administering death tax laws in

three states not involved in the dispute and each of these authorities shall appoint one member of 1 the board of arbitration. The board shall select one of its members as chairperson. 2

[(2) The board shall hold hearings at such places as it deems necessary, upon reasonable notice to 3 the executor, ancillary administrators, all interested persons and the taxing officials of the states in-4 volved, all of whom are entitled to be heard.] 5

(3) The board may administer oaths, take testimony, subpoena witnesses and require their 6 attendance[;], require the production of books, papers and documents and issue commissions to take 7 testimony. Subpoenas may be issued by any member of the board. Failure to obey a subpoena of the 8 9 board may be punished by any court of record in the same manner as if the subpoena had been is-10 sued by [such] the court.

(4) Whenever practicable the board shall apply the rules of evidence then prevailing in the federal courts under the federal rules of civil procedure.

13 (5) The reasonable compensation and expenses of the members of the board and its employees shall be agreed upon among the members, the taxing officials involved and the ex-14 15 ecutor. 285C.250. (1) Within a reasonable period of time prior to the termination of enterprise zones 42

under ORS 285C.245 (2), the Director of the Economic and Community Development Department 43 shall competitively designate the same number of enterprise zones effective immediately after ter-44 mination of the previous enterprise zones. The determination by the director as to the areas desig-45

nated as enterprise zones shall be final. 1

2 (2) When an enterprise zone is terminated under ORS [285B.686 (4) to (6)] 285C.245 (4) to (6), the director may competitively designate a new enterprise zone. The sponsor of the enterprise zone 3 terminated under ORS 285C.245 (4) or (5) is not eligible to apply for a new enterprise zone, except 4 for a county government when the terminated zone was also jointly sponsored by one or more cities 5 6 or ports.

7 (3) Sponsors of existing enterprise zones that are due to terminate may reapply for designation under subsection (1) of this section. 8

9 (4) Any city, county or port may apply to the director for designation of an enterprise zone in accordance with the criteria set forth in ORS 285C.065 and 285C.090. 305.288. (1) The tax court shall order a change or correction applicable to a separate assessment 24 of property to the assessment and tax roll for the current tax year or for either of the two tax years 25immediately preceding the current tax year, or for any or all of those tax years, if all of the fol-2627lowing conditions exist:

(a) For the tax year to which the change or correction is applicable, the property was or is used 28primarily as a dwelling (or is vacant) and was and is a single-family dwelling, a multifamily dwelling 2930 of not more than four units, a condominium unit, a manufactured structure or a floating home.

31 (b) The change or correction requested is a change in value for the property for the tax year and it is asserted in the request and determined by the tax court that the difference between the 32real market value of the property for the tax year and the real market value on the assessment and 33 34 tax roll for the tax year is equal to or greater than 20 percent.

35 (2) If the tax court finds that the conditions needed to order a change or correction under subsection (1) of this section exist, the court may order a change or correction in the maximum assessed 36 37 value of the property in addition to the change or correction in the real market value of the prop-38 erty.

(3) The tax court may order a change or correction applicable to a separate assessment of 39 property to the assessment or tax roll for the current tax year and for either of the two tax years 40 immediately preceding the current tax year if, for the year to which the change or correction is 41 applicable, the assessor or taxpayer has no statutory right of appeal remaining and the tax court 42 determines that good and sufficient cause exists for the failure by the assessor or taxpayer to pursue 43 the statutory right of appeal. 44

(4) Before ordering a change or correction to the assessment or tax roll under subsection (3)

1 of this section, the tax court may determine whether any of the conditions exist in a particular case.

2 If the tax court determines that one of the conditions specified does exist, the tax court shall hold

3 a hearing to determine whether to order a change or correction to the roll.

4 (5) For purposes of this section:

6 (b) "Good and sufficient cause":

7 (A) Means an extraordinary circumstance that is beyond the control of the taxpayer, or the 8 taxpayer's agent or representative, and that causes the taxpayer, agent or representative to fail to 9 pursue the statutory right of appeal; and

(B) Does not include inadvertence, oversight, lack of knowledge, hardship or reliance on mis leading information provided by any person except an authorized tax official providing the relevant

SECTION 7. ORS 305.620 is amended to read:

305.620. (1) Any state agency or department may enter into agreements with any political subdivision of this state for the collection, enforcement, administration and distribution of local taxes of the political subdivision imposed upon or measured by gross or net income, wages or net earnings from self-employment or local general sales and use taxes.

(2) The department or agency shall prescribe the rules by which the agreements entered intounder subsection (1) of this section are administered.

(3) The department or agency shall prescribe the rules by which the taxes described by sub section (1) of this section are administered, collected, enforced and distributed.

(4) A political subdivision may appear as an intervenor at any conference held by the Department of Revenue or conference, hearing or proceeding held by another department or agency in
connection with a local tax administered by the department or agency. The political subdivision may
be represented by its own counsel. The department or agency shall adopt rules governing the procedures to be followed by the political subdivision in making an appearance.

(5) Costs incurred by the department or agency in the administration, enforcement, collection and distribution of taxes under the agreements entered into under subsection (1) of this section shall be first deducted from the taxes collected before distribution is made to the political subdivision which is a party to the agreement.

(6) The Oregon Tax Court shall have exclusive jurisdiction to review determinations of the De partment of Revenue or orders of another department or agency relating to the collection, enforce ment, administration and distribution of local taxes under agreements entered into under subsection
 (1) of this section.

(7) A proceeding for refund or to set aside additional taxes or taxes assessed when no return
 was filed may be initiated before the state agency or department.

(8) An appeal from a determination or an order may be taken by the taxpayer or by the political subdivision whose taxes are in issue, by filing a complaint with the clerk of the Oregon Tax Court at its principal office [at the state capital,] in Salem, Oregon, within 60 days after the notice of the determination of the Department of Revenue or the order of the department or agency is sent to the taxpayer or the political subdivision. The filing of the complaint in the Oregon Tax Court shall

constitute perfection of the appeal. Service of the taxpayer's complaint shall be accomplished by the 1 clerk of the tax court by filing a copy of the complaint with the administrative head of the depart-2 ment or agency and a copy with the political subdivision. Service of the political subdivision's 3 complaint shall be accomplished by the clerk of the tax court by filing a copy of the complaint with 4 the administrative head of the department or agency and mailing a copy of the complaint to the 5 taxpayer. The complaint of a taxpayer shall be entitled in the name of the person filing as plaintiff 6 and the department or agency as defendant. The complaint of a political subdivision shall be entitled 7 in the name of the political subdivision as plaintiff and the taxpayer and the department or agency 8 9 as defendants. A copy of the order of the department or agency shall be attached to the complaint. All procedures shall be in accordance with ORS 305.405 to 305.494. 10

305.720. Subject to ORS 305.710, 305.723 and 305.745, an entity qualifies for listing on the eligi bility roster for form listing to receive contributions by means of checkoff if:

(1) The entity supports private charitable causes or engages in public activities that are con-sistent with policies and programs of the state and:

(a) Checkoff resources are used to augment existing programs or provide new funding to related
 activities of proven value[.];

(b) Checkoff funds are not to be used to meet the administrative expenses of the entity;

[(b)] (c) Programs funded by checkoff resources [must] result in substantial and direct benefits to the human and natural resources of the state that the Oregon Charitable Checkoff Commission determines are unlikely to occur under existing public and private programs; and

[(c)] (d) After checkoff resources are received by the entity, the entity shows a pattern over
several years of increasing its total revenues from other than checkoff sources or reaches the level
where no more than 50 percent of its revenues are from checkoff sources.

(2) The entity is qualified to receive contributions that are tax deductible under the following:

(a) Section 170 of the Internal Revenue Code (relating to contributions and gifts to charitableand governmental entities).

(b) Section 501(k) of the Internal Revenue Code (relating to contributions to certain organiza tions providing child care).

(c) Section 7871 of the Internal Revenue Code (relating to contributions to Indian tribal gov-ernments).

(d) Any other federal law allowing a deduction from federal individual income tax for charitable
 contributions to an entity classified by rule of the Department of Revenue as being an entity be longing to the general class described in paragraphs (a) to (c) of this subsection.

(3) The entity makes application for listing within the time and in the manner prescribed by ORS
 305.725.

(4) The entity files a financial report, and other information, with the commission as describedunder ORS 305.730.

(5) The entity received \$25,000 or more in checkoff contributions in at least one of the two tax years immediately preceding the tax year for which it is to be listed on the Oregon income tax return. This subsection does not apply if the entity has not been included on the Oregon personal income tax return for each of the two tax years immediately preceding the tax year for which determination for purposes of this subsection is being made.
