SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Makes technical changes in Oregon tax statutes. Adjusts grammar and syntax. Repeals and deletes obsolete statutes and provisions. Conforms language and structure to existing statutes.

63.810. For purposes of ORS [chapters 305 to 324] 320.005 to 320.150 and ORS chapters 305, 9 306, 307, 308, 308A, 309, 310, 311, 312, 314, 315, 316, 317, 318, 319, 321, 323 and 324, a limited li-10 11 ability company formed under this chapter or qualified to do business in this state as a foreign limited liability company shall be classified in the same manner as it is classified for federal income 12 tax purposes. For purposes of ORS [chapters 305 to 324] 320.005 to 320.150 and ORS chapters 305, 13 306, 307, 308, 308A, 309, 310, 311, 312, 314, 315, 316, 317, 318, 319, 321, 323 and 324, a member or 14 an assignee of a member of a limited liability company formed under this chapter or qualified to do 1516 business in this state as a foreign limited liability company shall have the same status as the member or assignee of a member has for federal income tax purposes. 17

118.290. (1) If any bequest or legacy is charged upon or payable out of any property, the heir or devisee shall deduct [such tax therefrom and pay such] from the property the tax imposed by ORS 118.005 to 118.840 and pay the tax to the administrator, executor or trustee, and the tax shall remain a lien or charge on [such] the property until paid. The payment thereof shall be enforced by the executor, administrator or trustee in the same manner that payment of the bequest or legacy is enforced, or by the Department of Revenue in the same manner as income taxes are collected under ORS chapter 314.

27 (2) If any bequest or legacy is given in money for a limited period, the administrator, executor

SECTION 4. ORS 118.870 is amended to read:

118.870. (1) When it appears by the written admission of the executor and the tax official of each state involved in the dispute that an agreement contemplated in ORS 118.865 (1) cannot be reached or, in all events, if one year has elapsed from the date of the election without such an agreement having been reached, the domicile of the decedent at the time of death shall be determined solely for death tax purposes as [follows:] provided in this section.

42 [(1)] (2) When this state and one other state only are involved in the dispute, the Director of 43 the Department of Revenue and the taxing official of the other state shall each appoint a member 44 of a board of arbitration and those members shall appoint the third member of the board. If this 45 state and more than one other state are involved, the taxing officials [thereof] of the involved

states shall agree upon the authorities charged with the duty of administering death tax laws in three states not involved in the dispute and each of these authorities shall appoint one member of the board of arbitration. The board shall select one of its members as chairperson.
