For the purposes of this chapter: 12"(1) 'Active member' means a member of the pension program or the individual account program 13 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position. 14 "(2) 'Actuarial equivalent' means a payment or series of payments having the same value as the 15payment or series of payments replaced, computed on the basis of interest rate and mortality as-16 sumptions adopted by the board. 17 "(3) 'Board' means the Public Employees Retirement Board. 18 "(4) 'Eligible employee' means a person who performs services for a participating public em-19 ployer, including elected officials other than judges. 'Eligible employee' does not include: 20 "(a) Persons engaged as independent contractors; 21"(b) Aliens working under a training or educational visa; 22(c) Persons, other than workers in the Industries for the Blind Program under ORS 346.190, provided sheltered employment or make-work by a public employer; 2324 "(d) Persons categorized by a participating public employer as student employees; 25"(e) Any person who is an inmate of a state institution; "(f) Employees of foreign trade offices of the Economic and Community Development Department 26 27who live and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g); 28(g) An employee actively participating in an alternative retirement program established under 29 ORS 353.250 or an optional retirement plan established under ORS 341.551; "(h) Employees of the Oregon University System who are actively participating in an optional 30 31 retirement plan offered under ORS 243.800; 32(i) Any employee who belongs to a class of employees that was not eligible on August 28, 2003, for membership in the system under the provisions of ORS chapter 238 or other law; 33 34 (j) Any person who belongs to a class of employees who are not eligible to become members 35of the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

1 "(k) Any person who is retired under ORS 238A.100 to 238A.245 or ORS chapter 238 and who 2 continues to receive retirement benefits while employed; and

3 "(L) Judges.

"(5) 'Firefighter' means:

5 "(a) A person employed by a local government, as defined in ORS 174.116, whose primary job 6 duties include the fighting of fires;

7 "(b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;8 and

9 "(c) An employee of the State Forestry Department who is certified by the State Forester as a 10 professional wildland firefighter and whose primary duties include the abatement of uncontrolled 11 fires as described in ORS 477.064.

12 "(6) 'Fund' means the Public Employees Retirement Fund.

13 "(7)(a) 'Hour of service' means:

"(A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment by a participating public employer for performance of duties in a qualifying position; and

"(B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave during which an employee does not perform duties but for which the employee is directly or indirectly paid or entitled to payment by a participating public employer for services in a qualifying position, as long as the hour is within the number of hours regularly scheduled for the performance of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave.

"(b) 'Hour of service' does not include any hour for which payment is made or due under a plan maintained solely for the purpose of complying with applicable workers' compensation laws or unemployment compensation laws.

25 "(8) 'Inactive member' means a member of the pension program or the individual account pro-26 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who 27 is not a retired member and who is not employed in a qualifying position.

"(9) 'Individual account program' means the defined contribution individual account program of
the Oregon Public Service Retirement Plan established under ORS 238A.025.

"(10) 'Member' means an eligible employee who has established membership in the pension program or the individual account program of the Oregon Public Service Retirement Plan and whose
membership has not been terminated under ORS 238A.110 or 238A.310.

"(11) 'Participating public employer' means a public employer as defined in ORS 238.005 that provides retirement benefits for employees of the public employer under the system.

"(12) 'Pension program' means the defined benefit pension program of the Oregon Public Service
 Retirement Plan established under ORS 238A.025.

"(13) 'Police officer' means a police officer as described in ORS 238.005.

38 "(14) 'Qualifying position' means one or more jobs with one or more participating public em-39 ployers in which an eligible employee performs 600 or more hours of service in a calendar year, 40 excluding any service in a job for which benefits are not provided under the Oregon Public Service 41 Retirement Plan pursuant to ORS 238A.070 (2).

42 "(15) 'Retired member' means a pension program member who is receiving a pension as provided
43 in ORS 238A.180 to 238A.195.

44 "(16)(a) 'Salary' means the remuneration paid to an active member in return for services to the 45 participating public employer, including remuneration in the form of living quarters, board or other 1 items of value, to the extent the remuneration is includable in the employee's taxable income under

2 Oregon law. Salary includes the additional amounts specified in paragraph (b) of this subsection,

3 but does not include the amounts specified in paragraph (c) of this subsection, regardless of whether

4 those amounts are includable in taxable income.

5 "(b) 'Salary' includes the following amounts:

6 "(A) Payments of employee and employer money into a deferred compensation plan that are 7 made at the election of the employee.

8 "(B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the 9 employee.

"(C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit plan by the employer at the election of the employee and that is not includable in the taxable income of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on [December 31, 2008] May 1, 2009.

"(D) Any amount that is contributed to a cash or deferred arrangement by the employer at the election of the employee and that is not included in the taxable income of the employee by reason of 26 U.S.C. 402(e)(3), as in effect on [December 31, 2008] May 1, 2009.

"(E) Retroactive payments made to an employee to correct a clerical error, pursuant to an award by a court or by order of or pursuant to a conciliation agreement with an administration agency charged with enforcing federal or state law protecting the employee's rights to employment or wages, which shall be allocated to and deemed paid in the periods in which the work was done or in which the work would have been done.

"(F) The amount of an employee contribution to the individual account program that is paid by
the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
(1) and (2)(a).

25 "(G) The amount of an employee contribution to the individual account program that is not paid 26 by the employer under ORS 238A.335.

"(H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS652.190.

29 "(c) 'Salary' does not include the following amounts:

30 "(A) Travel or any other expenses incidental to employer's business which is reimbursed by the 31 employer.

32 "(B) Payments made on account of an employee's death.

"(C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
 leave.

"(D) Any severance payment, accelerated payment of an employment contract for a future period
 or advance against future wages.

"(E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

38 "(F) Payment for a leave of absence after the date the employer and employee have agreed that 39 no future services in a qualifying position will be performed.

40 "(G) Payments for instructional services rendered to institutions of the Department of Higher 41 Education or the Oregon Health and Science University when those services are in excess of full-42 time employment subject to this chapter. A person employed under a contract for less than 12 43 months is subject to this subparagraph only for the months covered by the contract.

44 "(H) The amount of an employee contribution to the individual account program that is paid by 45 the employer and is not deducted from the compensation of the employee, as provided under ORS 1 238A.335 (1) and (2)(b).

"(I) Any amount in excess of \$200,000 for a calendar year. If any period over which salary is determined is less than 12 months, the \$200,000 limitation for that period shall be multiplied by a fraction, the numerator of which is the number of months in the determination period and the denominator of which is 12. The board shall adopt rules adjusting this dollar limit to incorporate cost-of-living adjustments authorized by the Internal Revenue Service.

"(17) 'System' means the Public Employees Retirement System.

8 "SECTION 2. ORS 238A.125, as amended by section 2, chapter 5, Oregon Laws 2009 (Enrolled
9 House Bill 2157), is amended to read:

"238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall
be paid an annual pension for the life of the member as follows:

"(a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied
by the number of years of retirement credit attributable to service as a police officer or firefighter.
"(b) For service as other than a police officer or firefighter, 1.5 percent of final average salary
multiplied by the number of years of retirement credit attributable to service as other than a police
officer or firefighter.

"(2) Notwithstanding any provision of ORS 238A.100 to 238A.245, the annual benefit payable to a member under the pension program and under any other tax-qualified defined benefit plan maintained by the participating public employer may not exceed the applicable limitations set forth in 26 U.S.C. 415(b), as in effect on [December 31, 2008] May 1, 2009. The Public Employees Retirement Board shall adopt rules for the administration of this limitation, including adjustments in the annual dollar limitation to reflect cost-of-living adjustments authorized by the Internal Revenue Service.

"(3) The board shall make no actuarial adjustment in a member's pension calculated under this section by reason of the member's retirement after normal retirement age.

"<u>SECTION 3.</u> ORS 238A.150, as amended by section 3, chapter 5, Oregon Laws 2009 (Enrolled
 House Bill 2157), is amended to read:

27 "238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to 238A.245, an eligible 28 employee who leaves a qualifying position for the purpose of performing service in the uniformed 29 services, and who subsequently returns to employment with a participating public employer with 30 reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the 31 probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS 32 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2) 33 of this section.

"(2) The board shall adopt rules establishing benefits and service credit for any period of service in the uniformed services by an employee described in subsection (1) of this section. For the purpose of adopting rules under this subsection, the board shall consider and take into account all federal law relating to benefits and service credit for any period of service in the uniformed services, including 26 U.S.C. 414(u), as in effect on [*December 31, 2008*] **May 1, 2009**. (1) An active member of the pension program who is 70-1/2 years of age or older must 44 retire not later than April 1 of the calendar year following the calendar year in which the member 45 terminates employment with all participating public employers. An inactive member of the pension program must retire not later than April 1 of the calendar year following the calendar year in which
 the member attains 70-1/2 years of age.

"(2) Notwithstanding any other provision of ORS 238A.100 to 238A.245, the entire interest of a member of the pension program must be distributed over a time period commencing no later than the required beginning date set forth in subsection (1) of this section, and must be distributed in a manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations implementing that section, as in effect on [*December 31, 2008*] **May 1, 2009**. The Public Employees Retirement Board shall adopt rules implementing those minimum distribution requirements.

"(2)(a) The death benefit to be paid under this section shall be for the life of the spouse or other person who is constitutionally required to be treated in the same manner as a spouse, and shall be the actuarial equivalent of 50 percent of the pension that would otherwise have been paid to the deceased member.

(1) Upon retirement on or after the earliest retirement date, as described in ORS 5 238A.165, a member of the individual account program shall receive in a lump sum the amounts in 6 the member's employee account, rollover account and employer account to the extent the member 7 is vested in those accounts under ORS 238A.320.

8 "(2) In lieu of a lump sum payment under subsection (1) of this section, a member of the individual account program may elect to receive the amounts in the member's employee account and 9 10 employer account, to the extent the member is vested in those accounts under ORS 238A.320, in 11 substantially equal installments paid over a period of 5, 10, 15 or 20 years, or over a period that is 12equal to the anticipated life span of the member as actuarially determined by the Public Employees 13Retirement Board. "(3) A member of the individual account program electing to receive installments under subsection (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies before all amounts in the employee and vested employer accounts are paid, all remaining installment payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary may elect to receive a lump sum distribution of the remaining amounts.

"(4) A member who is entitled to receive retirement benefits under ORS chapter 238 may receive vested amounts in the member's employee account, rollover account and employer account in the manner provided by this section when the member retires for service under the provisions of ORS chapter 238.

"(5) Notwithstanding any other provision of ORS 238A.300 to 238A.415, the entire interest of a member of the individual account program must be distributed over a time period commencing no later than the latest retirement date set forth in ORS 238A.170, and must be distributed in a manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations implementing that section, as in effect on [*December 31, 2008*] **May 1, 2009**. The board shall adopt rules implementing those minimum distribution requirements.

37 "<u>SECTION 8.</u> ORS 238A.410, as amended by section 8, chapter 5, Oregon Laws 2009 (Enrolled

39 "238A.410. (1) If a member of the individual account program dies before retirement, the 40 amounts in the member's employee account, rollover account and employer account, to the extent 41 the member is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the 42 beneficiary or beneficiaries designated by the member for the purposes of this section.

43 "(2) If a member of the individual account program is married at the time of death, or there
44 exists at the time of death any other person who is constitutionally required to be treated in the
45 same manner as a spouse for the purpose of retirement benefits, the spouse or other person shall

Any credit remaining unused in that next succeeding tax year may be carried forward and used in the second succeeding tax year, and likewise, any credit not used in that second 3 4 succeeding tax year may be carried forward and used in the third succeeding tax year, and likewise, any credit not used in that third succeeding tax year may be carried forward and used in the fourth 5 succeeding tax year, and likewise, any credit not used in that fourth succeeding tax year may be 6 7 carried forward and used in the fifth succeeding tax year, and likewise, any credit not used in that 8 fifth succeeding tax year may be carried forward and used in the sixth succeeding tax year, and likewise, any credit not used in that sixth succeeding tax year may be carried forward and used in 9 10 the seventh succeeding tax year, and likewise, any credit not used in that seventh succeeding tax 11 year may be carried forward and used in the eighth succeeding tax year, but may not be carried 12forward for any tax year thereafter. Credits may be carried forward to and used in a tax year be-13yond the years specified in subsection (1) of this section only as provided in this subsection.

"(7) The credit provided by this section is not in lieu of any depreciation or amortization deduction for the facility to which the taxpayer otherwise may be entitled for purposes of ORS chapter 316, 317 or 318 for such year.

"(8) The taxpayer's adjusted basis for determining gain or loss may not be decreased by any tax credits allowed under this section.

"(9) If a homebuilder claims a credit under this section with respect to a homebuilder-installed renewable energy system or a high-performance home:
