SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Revises election law.
Declares emergency, effective on passage.

2 Relating to elections; creating new provisions; amending ORS 247.012, 247.125, 247.302, 247.307,
3 248.008, 249.056, 249.190, 254.085, 254.175, 254.426, 254.470, 254.476, 254.480, 254.529, 258.006,
4 258.016, 258.026, 258.036, 258.046, 258.055 and 260.993; and declaring an emergency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 247.012, as amended by section 1, chapter 53, Oregon Laws 2008, is amended
7 to read:

8 247.012. (1) A qualified person may register to vote or update a registration to vote by:

9 (a) Delivering by mail or otherwise a completed registration card to any county clerk, the Sec-
10 retary of State, any office of the Department of Transportation or any designated voter registration
11 agency as described in ORS 247.208;

12 (b) Personally delivering the card to an official designated by a county clerk under subsection
13 (7) of this section; or

14 (c) Completing the voter registration portion of the application for issuance or renewal of a
15 driver license, issuance of a state identification card under ORS 807.400 or a change of address at
16 an office of the Department of Transportation under ORS 247.017.

17 (2) If a registration card is mailed or delivered to:

18 (a) Any person other than a county clerk or the Secretary of State, the person shall forward the
19 card to a county clerk or the Secretary of State not later than the fifth day after receiving the card;
20 or

21 (b) The Secretary of State or a county clerk for a county other than the county in which the
22 person applying for registration resides, the Secretary of State or county clerk shall forward the
23 card to the county clerk for the county in which the person resides not later than the fifth day after
24 receiving the card.

25 (3) Registration of a qualified person occurs:

26 (a) When a legible, accurate and complete registration card is received in the office of any
27 county clerk, the Office of the Secretary of State, an office of the Department of Transportation, a

1 designated voter registration agency under ORS 247.208 or at a location designated by a county
2 clerk under subsection (7) of this section;

3 (b) On the date a registration card is postmarked if the card is received after the 21st day im-
4 mediately preceding an election but is postmarked not later than the 21st day immediately preceding
5 the election and is addressed to an office of any county clerk, the Office of the Secretary of State,
6 an office of the Department of Transportation or any designated voter registration agency as de-
7 scribed in ORS 247.208; or

8 (c) In the case of a registration card missing a date of birth, containing an incomplete date of
9 birth or containing an unintentional scrivener's error that is supplied or corrected as described in
10 subsection (4) or (6) of this section, on the date that registration would have occurred if the regis-
11 tration card had not been missing the date of birth, contained an incomplete date of birth or con-
12 tained the scrivener's error.

13 (4) **Except as provided in ORS 247.125**, if a registration card is legible, accurate and contains,
14 at a minimum, the registrant's name, residence address, date of birth and signature, the county clerk
15 shall register the person. If this information is missing from the registration card or the date of birth
16 is incomplete, the county clerk shall attempt to contact the person to obtain the missing or incom-
17 plete information. The county clerk may supply the registrant's date of birth from any previous
18 registration of the registrant.

19 (5) If a registration card meets the requirements of subsection (4) of this section but is missing
20 an indication of political party affiliation, the registrant shall be considered not affiliated with any
21 political party. This subsection does not apply if an elector is updating a registration within the
22 same county.

23 (6) If a registration card contains an unintentional scrivener's error, the county clerk may at-
24 tempt to contact the person to correct the error.

25 (7) A county clerk may appoint officials to accept registration of persons at designated locations.
26 The appointments and locations shall be in writing and filed in the office of the county clerk. The
27 county clerk shall be responsible for the performance of duties by those appointed.

28 (8) A registration card received and accepted under this section shall be considered an active
29 registration.

30 (9) A registration may be updated at any time.

31 **SECTION 2.** ORS 247.125 is amended to read:

32 247.125. (1) [No] **A person [shall] may not** alter any information supplied on a registration card
33 except:

34 [(1)] (a) An elections officer in the performance of official duties.

35 [(2)] (b) The person who [fills out] **supplies the information on** the registration card for the
36 purpose of registering to vote.

37 **(2) A county clerk may not register a person who alters any information printed on a**
38 **registration card regarding:**

39 (a) **The indication that the person is a citizen of the United States; or**

40 (b) **The signature statement in which the person attests to the person's qualifications**
41 **as an elector and the information supplied on the voter registration card.**

42 **SECTION 3.** ORS 247.302 is amended to read:

43 247.302. (1) The effective date of a voter registration updated under ORS 247.292 [or] **is the date**
44 **on which the county clerk receives written evidence of the change of residence or mailing**
45 **address.**

1 **(2) The effective date of a voter registration updated under ORS 247.296** is the date *[that]*
2 **on which** the county clerk changes the address information on the voter registration file.

3 **SECTION 4.** ORS 248.008 is amended to read:

4 248.008. (1) An affiliation of electors becomes a minor political party in the state, a county or
5 other electoral district, qualified to make nominations for public office in that electoral district and
6 in any other electoral district wholly contained within the electoral district, when either of the
7 following events occurs:

8 (a) When the affiliation of electors has filed with the Secretary of State a petition with the
9 signatures of at least a number of electors equal to one and one-half percent of the total votes cast
10 in the electoral district for all candidates for Governor at the most recent election at which a candi-
11 didate for Governor was elected to a full term. The petition also *[shall]* **must** state the intention to
12 form a new political party and give the designation of it. The *[filed]* petition *[shall]* **must** contain
13 only original signatures. *The petition shall* **and must** be filed not later than two years following
14 the date the prospective petition is filed. The circulator shall certify on each signature sheet that
15 the circulator witnessed the signing of the signature sheet by each individual whose signature ap-
16 pears on the signature sheet and that the circulator believes each individual is an elector registered
17 in the electoral district. The Secretary of State shall verify whether the petition contains the re-
18 quired number of signatures of electors. *[The petition shall not be accepted]* **The Secretary of State**
19 **may not accept a petition** for filing if it contains less than 100 percent of the required number of
20 signatures. The Secretary of State by rule shall designate a statistical sampling technique to verify
21 whether a petition contains the required number of signatures of electors. A petition *[shall]* **may**
22 not be rejected for the reason that it contains less than the required number of signatures unless
23 two separate sampling processes both establish that the petition lacks the required number of sig-
24 natures. The second sampling must contain a larger number of signatures than the first sampling.
25 The Secretary of State may employ professional assistance to determine the sampling technique. The
26 statistical sampling technique may be the same as that adopted under ORS 250.105. Before circu-
27 lating the petition, the chief sponsor of the petition *[shall]* **must** file with the Secretary of State a
28 signed copy of the prospective petition. The chief sponsor *[shall]* **must** include with the prospective
29 petition a statement declaring whether one or more persons will be paid money or other valuable
30 consideration for obtaining signatures of electors on the petition. After the prospective petition is
31 filed, the chief sponsor *[shall]* **must** notify the filing officer not later than the 10th day after the
32 chief sponsor first has knowledge or should have had knowledge that:

33 (A) Any person is being paid for obtaining signatures, when the statement included with the
34 prospective petition declared that no such person would be paid.

35 (B) No person is being paid for obtaining signatures, when the statement included with the
36 prospective petition declared that one or more such persons would be paid.

37 (b) When the affiliation of electors has polled for any one of its candidates for any public office
38 in the electoral district at least one percent of the total votes cast in the electoral district for all
39 candidates for:

40 (A) Presidential elector at the last general election at which candidates for President and Vice
41 President of the United States were listed on the ballot; or

42 (B) Any single state office to be voted upon in the state at large for which nominations by pol-
43 itical parties are permitted by law at the most recent election at which a candidate for the office
44 was elected to a full term.

45 (2) After satisfying either requirement of subsection (1) of this section, the minor political party

1 may nominate candidates **for election** at the next general election [*if at any time during the period*
2 *beginning on the date of the next primary election and ending on the 90th day before the next general*
3 *election, a number of electors equal to at least one-tenth of one percent of the total votes cast in the state*
4 *or electoral district for all candidates for Governor at the most recent election at which a candidate for*
5 *Governor was elected to a full term are registered as members of the party*].

6 (3) A filing officer [*shall*] **may** not accept a certificate of nomination of a candidate nominated
7 by a minor political party **for a subsequent general election** unless the minor political party has
8 satisfied the [*registration requirement*] **requirements** of subsection [(2)] **(4)(a) or (b)** of this section.

9 (4) After a minor political party qualifies to nominate candidates **for a general election under**
10 **subsection (1) of this section**, in order to maintain status as a minor political party **for a subse-**
11 **quent general election:**

12 (a)(A) **Following each general election, at any time during the period beginning on the**
13 **date of the next primary election and ending on the 90th day before the next general election,**
14 **a number of electors equal to at least one-tenth of one percent of the total votes cast in the**
15 **state or electoral district for all candidates for Governor at the most recent election at**
16 **which a candidate for Governor was elected to a full term must be registered as members**
17 **of the party; and**

18 (B) A candidate or candidates of the party must poll a number of votes described in subsection
19 (1)(b) of this section at each subsequent general election [*and following each general election, the*
20 *registration requirement of subsection (2) of this section must be satisfied*]; or

21 (b) Following each general election, at any time during the period beginning on the date of the
22 next primary election and ending on the 90th day before the next general election, a number of
23 electors equal to at least one-half of one percent of the total number of registered electors in this
24 state must be registered as members of the party.

25 [(5) *An affiliation of electors ceases to be a minor political party in the state or electoral district*
26 *if:*]

27 [(a) *The registration requirement of subsection (2) or (4)(b) of this section is not satisfied. The af-*
28 *filiation of electors ceases to be a minor political party on the date of the deadline for satisfying the*
29 *registration requirement; or]*

30 [(b) *Except as provided in subsection (4)(b) of this section, in the case of a minor political party*
31 *qualified to nominate candidates, a candidate or candidates of the minor political party do not satisfy*
32 *the one percent requirement specified in subsection (1)(b) of this section at the next general election.*
33 *The affiliation of electors ceases to be a minor political party on the date of the election.]*

34 (5) **An affiliation of electors that fails to maintain its status as a minor political party,**
35 **as described in subsection (4) of this section, ceases to be a minor political party on the 90th**
36 **day before the date of the next general election.**

37 (6) During the period beginning on the date of the primary election and ending on the 90th day
38 before the date of the general election, the Secretary of State shall determine not less than once
39 each month whether the registration [*requirement*] **requirements** of subsection [(2) or (4)(b)] **(4)**
40 of this section [*has*] **have** been satisfied. If the **minor political** party changes its name, only those
41 electors who register on or after the effective date of the name change as members of the party
42 under the new party name shall be counted as members of the party under this subsection.

43 (7) An affiliation of electors or a minor political party may not satisfy the one percent require-
44 ment referred to in subsection (1)(b) of this section by nominating a candidate who is the nominee
45 of another political party at the same election.

1 **(8) For purposes of this section, “subsequent general election” means any general**
2 **election that is held after the first general election following qualification as a minor political**
3 **party under subsection (1) of this section.**

4 **SECTION 5.** ORS 249.056 is amended to read:

5 249.056. (1) At the time of filing a declaration of candidacy a candidate for the following offices
6 shall pay to the officer with whom the declaration is filed the following fee:

7 (a) United States Senator, \$150.

8 (b) Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the Bu-
9 reau of Labor and Industries, Superintendent of Public Instruction, Representative in Congress,
10 judge of the Supreme Court, Court of Appeals or Oregon Tax Court, or executive officer or auditor
11 of a metropolitan service district, \$100.

12 (c) County [*office*] **officer**, district attorney, **county judge who exercises judicial functions** or
13 circuit court judge, \$50.

14 (d) State Senator or Representative or councilor of a metropolitan service district under ORS
15 chapter 268, \$25.

16 (2) No filing fee shall be required of persons filing a declaration of candidacy for precinct com-
17 mitteeperson or justice of the peace.

18 **SECTION 6.** ORS 249.190 is amended to read:

19 249.190. (1) Except as provided in ORS 254.650, a vacancy in the nomination of a major political
20 party candidate may be filled before the date of the general election by that political party in a
21 manner prescribed by party rule.

22 (2) Immediately after selecting a new nominee, the party, by the most expeditious means prac-
23 ticable, shall notify the filing officer with whom a declaration of candidacy for the office is filed of
24 the name of the nominee.

25 **(3) If the filing officer with whom a declaration of candidacy for the office is filed deter-**
26 **mines that the candidate who has been nominated by a major political party is ineligible to**
27 **be elected to the office, the officer shall declare the nomination vacant and the political party**
28 **shall select another candidate to fill the vacancy in the nomination as provided under this**
29 **section.**

30 [(3)] (4) The Secretary of State by rule may adopt a schedule specifying the period following a
31 vacancy within which a major political party must notify the filing officer of the name of the new
32 nominee.

33 **SECTION 7.** ORS 254.085 is amended to read:

34 254.085. (1) The Secretary of State, not later than the 61st day before the date of a primary or
35 general election, shall file with each county clerk a statement of the **federal and** state [*and con-*
36 *gressional district*] offices to be filled or for which candidates are to be nominated in the county at
37 the election, information concerning all candidates for the offices, and the state measures to be
38 voted on.

39 (2) The information concerning candidates for the Supreme Court, Court of Appeals, Oregon Tax
40 Court and circuit court shall include a designation of incumbent for each candidate who is the
41 regularly elected or appointed judge of the court to which the candidate seeks election. If a candi-
42 date was regularly elected or appointed to a specific position or department on the court, the candi-
43 date shall be designated as the incumbent only if the person is a candidate for that position or
44 department.

45 (3) Included with each state measure shall be the measure number, the latest ballot title certi-

1 fied by the Attorney General under ORS 250.067 (2) or, if the Supreme Court has reviewed the title
2 under ORS 250.085, the title certified by the court and the financial estimates under ORS 250.125.
3 The Secretary of State shall keep a copy of the statement.

4 **SECTION 8.** ORS 254.175 is amended to read:

5 254.175. (1) In lieu of printing the complete ballot title of any measure, other than a state
6 measure, the county clerk may print the caption and the question of the ballot title and the measure
7 number on the ballot.

8 (2) In lieu of printing the complete ballot title and financial estimates of any state measure to
9 be initiated or referred, the county clerk may print the caption of the ballot title, the statements
10 described in ORS 250.035 (2)(b) and (c) and the measure number on the ballot.

11 (3) In the case of a recall election, **the following shall be printed on the ballot:**

12 (a) The statements described in section 18, Article II of the Oregon Constitution, and ORS
13 249.877 [*shall be printed on the ballot.*]; and

14 (b) **The question “Do you vote to recall _____ from the office of**
15 **_____?”**, with the name of the person against whom a recall petition has been filed
16 **printed in the first blank space and the public office held by the person printed in the second**
17 **blank space.**

18 (4) The complete text of each ballot title and any financial estimates shall be included with each
19 official ballot.

20 **SECTION 9.** ORS 254.426 is amended to read:

21 254.426. (1) Whenever any person votes a challenged ballot, the county clerk shall ensure that
22 the ballot offered by the person includes the number of the written statement of challenge so that
23 the ballot may be identified in any future contest of the election.

24 (2) The county clerk shall examine the challenge and determine if the person is validly regis-
25 tered to vote and if the vote was properly cast. The ballot shall be counted only if the county clerk
26 determines the person is validly registered.

27 (3) The county clerk shall ensure that the information on the numbered written statement is
28 treated as confidential so that in the event of a recount of votes it cannot be determined how any
29 challenged person voted.

30 (4) **The county clerk shall mail to each person voting under this section and ORS 254.415**
31 **a written statement that describes the nature of the challenge. If the person does not pro-**
32 **vide evidence sufficient to verify the person’s registration by the deadline described in sub-**
33 **section (5) of this section, the registration of the person shall be considered inactive until**
34 **the person updates or verifies the registration, the registration is canceled or the county**
35 **clerk determines that the person is validly registered.**

36 [(4)] (5) The registration of [*any*] **each** person voting under this section and ORS 254.415 shall
37 be verified not later than the [*last business day prior to the last day for the official certification of*
38 *election results required by ORS 254.545 (3) and 255.295 (1)*] **10th calendar day after the date of**
39 **the election** in order for the vote of the person to be counted.

40 **SECTION 10.** ORS 254.476 is amended to read:

41 254.476. The county clerk may employ personnel as necessary to open envelopes, prepare ballots
42 for counting and count ballots. [*Such*] **The** personnel [*shall*] **may** not all be members of the same
43 political party. **A candidate on the ballot at an election, other than an incumbent candidate**
44 **for county clerk, or** a person who is the spouse, child, son-in-law, daughter-in-law, parent, mother-
45 in-law, father-in-law, sibling, brother-in-law, sister-in-law, aunt, uncle, niece, nephew, stepparent or

1 stepchild of [a] **any** candidate on the ballot [*at an election shall*] **may** not be employed and may not
2 serve as a volunteer in the capacity described in this section.

3 **SECTION 11.** ORS 254.529 is amended to read:

4 254.529. (1) At each general election, the county clerk shall conduct a hand count of ballots as
5 described in this section and compare the tally of votes for those ballots produced by a vote tally
6 system with the tally of votes for those ballots produced by the hand count.

7 (2)(a) In the event that the unofficial tally of ballots produced by a vote tally system reveals that
8 the margin of victory between the two candidates receiving the largest number of votes in the
9 county is less than one percent of the total votes cast in that election in the county, the county
10 clerk shall conduct a hand count of ballots in at least 10 percent of all precincts or of ballots in
11 at least 10 percent of all batches of ballots collected by the county clerk.

12 (b) In the event that the unofficial tally of ballots reveals that the margin of victory between
13 the two candidates receiving the largest number of votes in the county is greater than or equal to
14 one percent but less than two percent of the total votes cast in the county, the county clerk shall
15 conduct a hand count of ballots in at least five percent of all precincts or of ballots in at least five
16 percent of all batches of ballots collected by the county clerk.

17 (c) In the event that the unofficial tally of ballots reveals that the margin of victory between
18 the two candidates receiving the largest number of votes in the county is greater than or equal to
19 two percent of the total votes cast in the county, the county clerk shall conduct a hand count of
20 ballots in at least three percent of all precincts or of ballots in at least three percent of all batches
21 of ballots collected by the county clerk.

22 (3) The Secretary of State shall select the precincts at random. At the general election, no fewer
23 than 150 ballots must have been cast in at least one of the precincts selected. The county clerk shall
24 conduct a hand count of ballots cast in the election contest between the two candidates receiving
25 the largest number of votes in the county, an election contest for [*a state office*] **an office to be**
26 **voted on in the state at large** and, if possible, an election contest for a state measure.

27 (4) Not later than **5 p.m. of the third business** day after the date of the general election, the
28 Secretary of State shall advise county clerks in writing of:

29 (a) The election contests for which ballots are to be hand counted; and

30 (b) The precincts in which ballots are to be hand counted.

31 (5) A county clerk shall begin the hand counts prescribed by this section not later than the
32 [*20th*] **21st** day after the election and complete the hand counts not later than the 30th day after the
33 election. The results of the hand counts shall be provided to the Secretary of State, who shall make
34 the results publicly available on the Secretary of State's website.

35 [(6) *The county clerk shall conduct the hand counts required by this section in the manner provided*
36 *in ORS 258.200 and 258.211.*]

37 [(7)] **(6)** A comparison of the tally of votes produced by a vote tally system with the tally of
38 votes produced by the hand count required by this section must show that the tally of votes
39 produced by the vote tally system differs by no more than one-half of one percent from the tally of
40 votes produced by the hand count.

41 [(8)(a)] **(7)(a)** If a hand count conducted under this section results in a tally of votes for a can-
42 didate or measure that is different from the tally of votes produced by the vote tally system for that
43 candidate or measure, and the difference for each race is equal to or less than one-half of one per-
44 cent, the tally of votes produced by the vote tally system is the official tally of votes for that vote
45 tally system.

1 (b) If a hand count conducted under this section results in a tally of votes for a candidate or
2 measure that is different from the tally of votes produced by the vote tally system for that candidate
3 or measure, and the difference in any race is greater than one-half of one percent, the county clerk
4 shall conduct a second hand count of the same ballots.

5 (c) If the second hand count conducted under this subsection results in a tally of votes for a
6 candidate or measure that is different from the tally of votes produced by the vote tally system for
7 that candidate or measure, and the difference for each race is equal to or less than one-half of one
8 percent, the tally of votes produced by the vote tally system is the official tally of votes for that
9 vote tally system.

10 (d) If the second hand count conducted under this subsection results in a tally of votes for a
11 candidate or measure that is different from the tally of votes produced by the vote tally system for
12 that candidate or measure, and the difference in any race is greater than one-half of one percent,
13 the county clerk shall conduct a hand count of all ballots counted by that vote tally system. The
14 hand count is the official tally of votes for that vote tally system. If the hand count is the official
15 tally of votes, not later than the 30th day after the election, the county clerk shall certify amended
16 abstracts of votes to appropriate elections officials.

17 [(9)] (8) For purposes of conducting the hand counts required under this section, the county
18 clerk shall:

19 (a) Retain custody of the ballots; and

20 (b) Provide for security for the ballots and the information required to be collected under this
21 subsection.

22 [(10)] (9) [Subsections (1) to (9) of] This section [do] **does** not apply:

23 (a) **To precincts that are subject to a recount under ORS 258.161, 258.280 or 258.290.**

24 (b) If federal law requires a post-election hand count of ballots at the general election to verify
25 election results and the Secretary of State determines that the requirements of federal law are at
26 least as stringent as the requirements of subsections (1) to [(9)] (8) of this section.

27 **SECTION 12.** ORS 258.006 is amended to read:

28 258.006. As used in this chapter:

29 (1) "Candidate" means a candidate for nomination or election to any elective office.

30 (2) "Contestant" means any person who files a petition of contest under ORS 258.036.

31 (3) "Contestee" means:

32 (a) In a contest of the nomination of a person for an office or the election of a person to an
33 office, all candidates for the nomination or office, other than a candidate who is a contestant.

34 (b) In a contest of the approval or rejection of a measure proposed by initiative petition, the
35 chief petitioner of the petition, unless the chief petitioner is a contestant, and any other person in-
36 volved in the cause of the contest.

37 (c) **In a contest of the result of a recall election, the public officer subject to the recall.**

38 [(c)] (d) If the cause of the contest is ORS 258.016 (6) or (7), the county clerk.

39 (4) "County clerk" means the county clerk or the county official in charge of elections.

40 (5) "Elector" means an individual qualified to vote under section 2, Article II, Oregon Consti-
41 tution.

42 (6) "Full recount" means a recount of all the precincts in which votes were cast for the nomi-
43 nation or office for which a candidate received a vote or on any measure that appeared on the
44 ballot.

45 (7) "Measure" includes any of the following submitted to the people for their approval or re-

1 jection at an election:

2 (a) A proposed law.

3 (b) An Act or part of an Act of the Legislative Assembly.

4 (c) A revision of or amendment to the Oregon Constitution.

5 (d) Local, special or municipal legislation.

6 (e) A proposition or question.

7 (8) "Partial recount" means a recount conducted in a number of precincts equal to the greater
8 of:

9 (a) Five percent of the precincts in which votes were cast for the nomination or office for which
10 a candidate received a vote or on any measure that appeared on the ballot; or

11 (b) Three specified precincts in which votes were cast for the nomination or office for which a
12 candidate received a vote or on any measure that appeared on the ballot.

13 **SECTION 13.** ORS 258.016 is amended to read:

14 258.016. The nomination or election of [*any person or the decision on any*] **a person, the result**
15 **of a recall election or the approval or rejection of a** measure may be contested by any elector
16 entitled to vote for the person, **recall** or measure, by any person who was a candidate at the
17 election for the same nomination or office, **by the public officer subject to the recall**, by the
18 Secretary of State if the contest involves a state measure, **the recall of a state officer** or a candi-
19 didate for whom the Secretary of State is the filing officer, or by the county clerk who conducted
20 the election, only for the following causes:

21 (1) Deliberate and material violation of any provision of the election laws in connection with the
22 nomination, election, **recall election or** approval or rejection **of a measure**.

29 (7) A challenge to the determination of the number of electors who were eligible to participate
30 in an election on a measure conducted under section 11 (8), Article XI of the Oregon Constitution.

32 258.026. (1) The nomination or election of a person [*shall*] **may** not be set aside for any cause
33 listed in ORS 258.016 (3) to (5) unless:

34 (a) The person nominated or elected had knowledge of or connived in the cause of the contest;

36 (b) The number of votes taken from the person nominated or elected by reason of the cause of
37 the contest would reduce the legal votes of the person below the number of legal votes given to

11 258.036. (1) Not later than the 40th day after the election or the seventh day after completion
12 of a recount of votes cast in connection with the [*nomination, office or measure*] **election**, any person

15 (a) The Circuit Court for Marion County if the petition involves a state measure, a candidate
