SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes name of Oregon Economic and Community Development Commission to Oregon Business Development Commission. Changes name of Economic and Community Development Department to Oregon Business Development Department.

Creates Oregon Infrastructure Finance Authority and Oregon Infrastructure Finance Authority Board within Oregon Business Development Department.

Establishes Oregon Infrastructure Finance Fund. Continuously appropriates moneys in fund to Oregon Business Development Department to promote infrastructure development.

Transfers responsibilities of Oregon Economic and Community Development Commission and Economic and Community Development Department to and among Oregon Business Development Commission, Oregon Business Development Department and Oregon Infrastructure Finance Authority.

Declares emergency, effective on passage.

Be It Enacted by the People of the State of Oregon:

1 **OREGON INFRASTRUCTURE FINANCE AUTHORITY**
2 **CREATION AND ADMINISTRATIVE PROVISIONS**
3

4 **SECTION 1.** Sections 1a to 7 of this 2009 Act are added to and made a part of ORS
5 chapter 285A.

6 **SECTION 1a.** (1) The Oregon Infrastructure Finance Authority Board is created as a
7 policy-making and advisory body within the Oregon Business Development Department. The
8 board consists of nine members as follows:

9 (a) One nonvoting member appointed from members of the Senate by the President of
10 the Senate;

11 (b) One nonvoting member appointed from members of the House of Representatives by
12 the Speaker of the House of Representatives;

13 (c) One member appointed by the State Treasurer; and

14 (d) Six members appointed by the Governor.

15 (2) Persons appointed members of the board must be Oregon residents, well qualified by
16 experience to make policy and recommendations in areas of concern to the Oregon
17 Infrastructure Finance Authority and to perform the duties of office. Members shall be ap-
18 pointed with consideration given to knowledge and experience:

19 (a) In the field of state and municipal finance;

20 (b) Of the infrastructure and public works needs in Oregon cities;

21 (c) Of the infrastructure and public works needs in Oregon counties;

22 (d) Of issues related to ports that affect the state;

23 (e) Of issues related to special service district services furnished across the state; and

24 (f) Of infrastructure and public works necessary to further Oregon's long term economic
25 growth.

26 (3) The office of the State Treasurer may recommend persons with expertise in the field
27 of state and municipal finance for membership on the board.

28 (4) The term of a member of the board appointed by the Governor, the State Treasurer
29 or the President of the Senate is four years. The term of a member appointed by the Speaker
30 of the House of Representatives is two years.

31 (5) In case of a vacancy on the board for any cause, the appointing authority shall ap-
32 point a successor to serve for the unexpired term.

33 (6) A member of the board may be appointed to serve two consecutive terms. A member
34 who serves two consecutive terms is not eligible for reappointment within one year following
35 the expiration of the second term.

36 (7) The board shall select one of its members to chair the board for such term and with
37 duties and powers necessary to perform the functions of the office as the board determines.

38 (8) A majority of the voting members of the board constitutes a quorum for the trans-
39 action of business.

40 **SECTION 2.** The Oregon Infrastructure Finance Authority Board shall:

41 (1) Serve as a body to advise municipalities, state agencies and private persons on the
42 development and implementation of state policies and programs relating to the
43 infrastructure needs of this state and its communities.

44 (2) Advise the Governor, the Director of the Oregon Business Development Department
45 and the Oregon Business Development Department on all matters relating to infrastructure

1 and public works programs and activities administered by the Oregon Infrastructure Finance
2 Authority.

3 (3) Develop a recommended biennial budget for the operation of the authority and submit
4 the budget to the director and the Governor.

5 (4) Seek and receive the views of all levels of government and the private sector with
6 respect to state policies and programs to address the infrastructure needs of this state.

7 (5) Prepare and submit to the Director of the Oregon Business Development Department
8 suggested administrative rules that the board determines are necessary for the operation of
9 the programs under the direction of the authority.

10 (6) Establish policies and procedures for loan and grant programs administered by the
11 authority.

12 **SECTION 3.** (1) The Oregon Infrastructure Finance Authority is established as an ad-
13 ministrative section within the Oregon Business Development Department, subject to the
14 supervision of the administrator of the authority. The authority consists of the administra-
15 tor and all personnel employed by the authority.

16 (2) The authority shall develop and administer programs and funds of the department
17 that address the infrastructure needs of this state pursuant to the policies of, and as may
18 be recommended by, the Oregon Infrastructure Finance Authority Board.

19 (3) The authority shall provide the Oregon Infrastructure Finance Authority Board with
20 staff and other assistance as necessary for the board to perform its duties.

21 (4) The authority shall employ, in accordance with the State Personnel Relations Law,
22 the staff necessary to allow the authority to carry out its responsibilities.

23 **SECTION 3a.** (1) The Oregon Infrastructure Finance Authority may:

24 (a) Conduct hearings and conferences to develop facts, explain programs and activities,
25 and obtain advice;

26 (b) Enter into agreements with other public bodies, as defined in ORS 174.109, or associ-
27 ations or private persons for services to assist the authority and the Oregon Infrastructure
28 Finance Authority Board;

29 (c) Enter into agreements with other public bodies, as defined in ORS 174.109, the federal
30 government, associations or private persons for cooperative endeavors that further pro-
31 grams administered by the authority;

32 (d) Subject to applicable policies and procedures, enter into agreements for loans, grants
33 or other assistance, including, but not limited to, direct purchase of goods or services, with
34 local governments, as defined in ORS 174.116, special government bodies, as defined in ORS
35 174.117, or other eligible applicants for infrastructure development;

36 (e) Appoint committees, consultants or other persons with expertise in infrastructure-
37 related matters to advise the Oregon Infrastructure Finance Authority Board or the au-
38 thority;

39 (f) Obtain assistance or data from any state agency; or

40 (g) Perform any other act necessary to carry out the duties of the authority.

41 (2) The authority shall administer the state's participation in the federal Community
42 Development Block Grant funding program authorized by 42 U.S.C. 5301 et seq.

43 **SECTION 4.** (1) The Director of the Oregon Business Development Department, upon
44 consultation with and the approval of the Oregon Infrastructure Finance Authority Board,
45 shall appoint an administrator of the Oregon Infrastructure Finance Authority who shall

1 serve at the pleasure of the director.

2 (2) The administrator shall receive such salary as may be provided by law or as fixed by
3 the director.

4 (3) The administrator shall be the administrative head of the authority.

5 (4) The administrator may suggest rules to the director for the government of the au-
6 thority, the conduct of its employees, the assignment and performance of its business and
7 the custody, use and preservation of its records, papers and property.

8 (5) The administrator shall hire the staff necessary to allow the authority to carry out
9 its duties. In accordance with the State Personnel Relations Law, the administrator and any
10 manager hired by the administrator shall be in the unclassified service.

11 **SECTION 5.** (1) The Oregon Infrastructure Finance Fund is established in the State
12 Treasury, separate and distinct from the General Fund. Interest earned by the Oregon
13 Infrastructure Finance Fund shall be credited to the fund. The Oregon Infrastructure Fi-
14 nance Fund consists of all moneys credited to the fund, including moneys from the Admin-
15 istrative Services Economic Development Fund, federal funds collected or received and fees,
16 moneys or other revenues, including miscellaneous receipts, collected or received by the
17 Oregon Infrastructure Finance Authority. The moneys in the Oregon Infrastructure Finance
18 Fund are continuously appropriated to the Oregon Business Development Department for the
19 authority for the purposes of sections 1a to 7 of this 2009 Act.

20 (2) The authority may finance programs and projects determined to further
21 infrastructure development within this state by making grants or loans using moneys in the
22 fund.

23 (3) The Oregon Infrastructure Finance Authority Board may suggest to the Director of
24 the Oregon Business Development Department administrative rules for establishing stan-
25 dards, objectives and criteria for use of moneys in the fund. The department shall adopt rules
26 to establish standards, objectives and criteria for use of moneys in the fund.

27 **SECTION 6.** The Oregon Infrastructure Finance Authority may not direct, supervise or
28 control the policy, programs, personnel or administration of any program or entity unless
29 specifically authorized by statute.

30 **SECTION 7.** The Director of the Oregon Business Development Department, in accord-
31 ance with ORS chapter 183, may adopt rules for the operation of the Oregon Infrastructure
32 Finance Authority as the director determines necessary or convenient for the authority to
33 perform its duties and functions and as are consistent with and necessary to carry out the
34 policies established by the Oregon Infrastructure Finance Authority Board.

36 **OREGON BUSINESS DEVELOPMENT COMMISSION**
37 **ADMINISTRATIVE PROVISIONS**
38

39 **SECTION 8.** ORS 285A.010 is amended to read:

40 285A.010. As used in ORS 284.101 to 284.146 and ORS chapters 285A, 285B and 285C, unless the
41 context requires otherwise:

42 (1) “Administrator” means the administrator of the Oregon Infrastructure Finance Au-
43 thority.

44 (2) “Association” means a nonprofit, private, incorporated or unincorporated institution,
45 foundation, organization, entity or group, whether local, state, regional or national, that is

1 **operating or doing business in Oregon.**

2 (3) **“Authority” means the Oregon Infrastructure Finance Authority.**

3 (4) **“Board” means the Oregon Infrastructure Finance Authority Board.**

4 [(1)] (5) **“Commission” means the [Oregon Economic and Community Development Commission]**
5 **Oregon Business Development Commission.**

6 [(2)] (6) **“Community” means an area or locality in which the body of inhabitants has common**
7 **economic or employment interests. The term is not limited to a city, county or other political sub-**
8 **division and need not, but may be, limited by political boundaries.**

9 [(3)] (7) **“Department” means the [Economic and Community Development Department] Oregon**
10 **Business Development Department.**

11 [(4)] (8) **“Director” means the Director of the [Economic and Community Development**
12 **Department] Oregon Business Development Department.**

13 [(5)] (9) **“Distressed area” means a county, city, community or other geographic area that is**
14 **designated as a distressed area by the department, based on indicators of economic distress or dis-**
15 **location, including but not limited to unemployment, poverty and job loss.**

16 [(6)] (10) **“International trade” means the export and import of products and services and the**
17 **movement of capital for the purpose of investment.**

18 (11) **“Local government” has the meaning given that term in ORS 174.116.**

19 (12) **“Municipality” means an Oregon city or county, the Port of Portland created by ORS**
20 **778.010, a county service district organized under ORS chapter 451, a district as defined in**
21 **ORS 198.010, a tribal council of a federally recognized Indian tribe in this state or an airport**
22 **district organized under ORS chapter 838.**

23 (13) **“Public body” has the meaning given that term in ORS 174.109.**

24 [(7)] (14) **“Rural area” means an area located entirely outside of the acknowledged Portland**
25 **Metropolitan Area Regional Urban Growth Boundary and the acknowledged urban growth bounda-**
26 **ries of cities with populations of 30,000 or more.**

27 [(8)] *“Traded sector” means industries in which member firms sell their goods or services into*
28 *markets for which national or international competition exists.]*

29 [(9)] (15) **“Small business” means a business having 100 or fewer employees.**

30 (16) **“State agency” includes state officers, departments, boards and commissions.**

31 (17) **“Traded sector” means industries in which member firms sell their goods or services**
32 **into markets for which national or international competition exists.**

33 **SECTION 9.** ORS 285A.020 is amended to read:

34 285A.020. (1) The Legislative Assembly finds that:

35 (a) Oregon possesses *[many]* unique and sustaining virtues that will guide and assist in main-
36 taining the state’s economic health, including but not limited to Oregon’s:

37 (A) Special heritage;

38 (B) Respect for and cultivation of the environment; and

39 (C) Attention to quality of life issues that are important to the state’s economic development,
40 including but not limited to access to quality, affordable child care for all children in Oregon.

41 (b) Oregon is strategically placed to compete and succeed in the global *[community.] market-*
42 **place.**

43 (c) All regions of the state should share in Oregon’s economic recovery.

44 (d) Creating and retaining quality jobs *[is]* **are** vital to the state’s *[continued economic develop-*
45 **ment.] economic health.**

1 (e) Oregon's agriculture and natural resource industries provide opportunities for beneficial
2 economic enterprise, including sustainable *[economic]* **business** development activities.

3 (f) A well educated and trained workforce is necessary to *[advance in today's global economy.]*
4 **support business and industry needs throughout the state.**

5 (g) The ability of existing businesses to grow *[and prosper]* is critical to Oregon's *[economy.]*
6 **prosperity.**

7 (h) *[Utilizing the state's]* **The state must utilize its** competitive advantages *[is essential]* to re-
8 tain existing businesses and attract new companies and investment into the state.

9 (i) Continued *[economic]* development **in Oregon** depends on strengthening traded sector indus-
10 tries.

11 (j) International trade **and** development *[and promotion is invaluable]* **of international trade**
12 **are essential** for future *[economic]* **business** development opportunities.

13 (k) Small businesses remain a critical element of the state's *[economic development, comprising*
14 *more than 90 percent of Oregon's businesses.]* **economy.**

15 (L) Capacity building **to support business development** in rural and distressed areas is a key
16 component of economic development and revitalization efforts.

17 (m) Oregon's ports are important partners in the state's economic development efforts and are
18 key components of local and state economic development strategies.

19 (n) Improving and enhancing infrastructure is necessary to the state's future economic develop-
20 ment.

21 (o) Federal, state and local agencies working together will continue to enhance industrial site
22 development and other economic development activities.

23 *[p) The Economic and Community Development Department should be encouraged to convene*
24 *community development partners to explore the prospect of making loans to private industrial land-*
25 *owners from the Brownfields Redevelopment Fund for future development opportunities.]*

26 (2) It is the purpose of ORS 284.101 to 284.146 and ORS chapters 285A, 285B and 285C *[to ad-*
27 *van*ce Oregon's economy.] **to enable the creation, retention, expansion and attraction of busi-**
28 **nesses that provide sustainable, living wage jobs for Oregonians through public-private**
29 **partnerships and leveraged funding and to support economic opportunities for Oregon com-**
30 **panies and entrepreneurs.**

31 (3) The Legislative Assembly declares that it is the immediate economic strategy of the state to:

32 (a) Promote a favorable investment climate to strengthen businesses, create jobs and raise real
33 wages;

34 (b) Improve the national and global competitiveness of Oregon companies; and

35 (c) Assist *[Oregon communities in building capacity]* **and further efforts** to retain, expand and
36 attract businesses.

37 (4) To promote the advancement of the Oregon economy and implement the immediate economic
38 strategy of the state, the *[Economic and Community]* **Oregon Business** Development Department
39 shall invest resources in accordance with the following principles:

40 (a) Processes for making public investments and working with local and regional issues must
41 be designed for flexibility so that actions can adapt to the constantly changing conditions and de-
42 mands under which communities and businesses operate.

43 (b) Partnerships among local, state and federal governments and public and private organiza-
44 tions and entities should be strengthened to further the economic strategy of the state.

45 (c) The expected impact of public investment and assistance shall be identified, in terms of

1 measurable outcomes, whenever possible.

2 (d) State, federal and community goals, constraints and obligations should be identified at the
3 beginning of the planning process, and the state should work actively with community partners, re-
4 gions and state and local agencies to address and accomplish their mutual objectives.

5 (5) When the department provides funds or assistance for projects, programs, technical support
6 or other authorized activities pursuant to ORS 284.101 to 284.146 and ORS chapters 285A, 285B and
7 285C, the department shall give priority to projects, programs and activities that:

8 (a) Retain and create jobs and raise real wages;

9 [(b) Promote capacity building, emphasizing rural and distressed areas;]

10 **(b) Promote capacity building, emphasizing rural and distressed areas to further eco-
11 nomic development initiatives;**

12 (c) Assist small business creation and expansion;

13 (d) Invest and engage in training a skilled workforce;

14 (e) Retain and expand existing companies and recruit new investment to Oregon;

15 (f) Capitalize on Oregon's competitive advantages and strategically invest resources to offset
16 competitive disadvantages;

17 (g) Support innovation and research;

18 (h) Assist industry clusters to succeed;

19 (i) Market Oregon's advantages;

20 (j) Promote international trade and attract foreign direct investment;

21 (k) Support the development of industrial and commercial lands;

22 (L) Advance the efforts of ports to promote economic development activities; and

23 (m) Build capacity in Oregon's arts and cultural organizations, creative businesses and individ-
24 ual artists.

25 **SECTION 10.** ORS 285A.040 is amended to read:

26 285A.040. (1) There is established the Oregon [*Economic and Community*] **Business** Development
27 Commission consisting of nine members appointed as follows:

28 (a) One nonvoting[, *ex officio*] member appointed from among the members of the Senate by the
29 President of the Senate;

30 (b) One nonvoting[, *ex officio*] member appointed from among the members of the House of Rep-
31 resentatives by the Speaker of the House of Representatives; and

32 (c) Seven members appointed by the Governor, subject to confirmation by the Senate in the
33 manner prescribed in ORS 171.562 and 171.565. The Governor shall appoint members of the com-
34 mission in compliance with all of the following:

35 (A) Members shall be appointed with consideration given to representation of the different ge-
36 ographic regions of the state, and at least one member shall be a resident of the area east of the
37 Cascade Range.

38 (B) Not more than five members may belong to one political party. Party affiliation shall be
39 determined by the appropriate entry on official election registration cards.

40 (C) Members shall be appointed with consideration given to representation of the following
41 areas of expertise or training:

42 (i) International trade;

43 **(ii) Traded sector business development;**

44 [(ii)] **(iii) Small business [*needs and issues*]; development;**

45 [(iii)] **(iv) Local [*government needs and issues*]; economic development;**

1 [(iv) *Marketing and branding*];

2 [(v) *Arts and culture*];

3 [(vi)] (v) Finance **and business investment**;

4 [(vii)] (vi) Innovation; **or**

5 [(viii) *Telecommunications*; or]

6 [(ix)] (vii) Other areas of training or expertise identified by the [*commission*.] **Governor**.

7 (2)(a) The term of office of each member appointed by the Governor is four years, but a member
8 serves at the pleasure of the Governor. Before the expiration of the term of a member appointed by
9 the Governor, the Governor shall appoint a successor whose term begins on July 1 of the following
10 year. A member appointed by the Governor is eligible for reappointment. In case of a vacancy among
11 the members appointed by the Governor for any cause, the Governor shall appoint a person to fill
12 the office for the unexpired term.

13 (b) The term of office of the member appointed by the President of the Senate is four years. In
14 case of a vacancy for any cause, the President of the Senate shall appoint a Senator to fill the office
15 for the unexpired term.

16 (c) The term of office of the member appointed by the Speaker of the House of Representatives
17 is two years. In case of a vacancy for any cause, the Speaker of the House of Representatives shall
18 appoint a Representative to fill the office for the unexpired term.

19 (3) A member of the commission who is appointed by the Governor is entitled to compensation
20 and expenses as provided by ORS 292.495. [*Ex officio*] **Legislative** members of the commission are
21 prohibited from receiving compensation and reimbursement for expenses.

22 (4) Subject to confirmation by the Senate, the Governor shall appoint one of the voting com-
23 missioners as presiding officer of the commission. The presiding officer shall have duties and powers
24 as the commission determines are necessary for the office.

25 (5) Five voting members of the commission constitute a quorum for the transaction of business.

26 (6) The commission shall meet at least quarterly at a time and place determined by the com-
27 mission. The commission shall also meet at other times and places as are specified by the call of the
28 presiding officer or by the call of a majority of the voting members of the commission.

29 (7) A vacancy among the voting members of the commission does not impair the right of the
30 remaining voting commissioners to exercise all the powers of the commission. If the remaining vot-
31 ing commissioners are unable to agree, the Governor shall have the right to vote as a member of
32 the commission.

33 **(8) A member of the commission appointed due to expertise or training in local economic**
34 **development described in subsection (1)(c)(C)(iv) of this section shall also be an elected local**
35 **government official with experience in economic development matters.**

36 **SECTION 11.** ORS 285A.045 is amended to read:

37 285A.045. (1) As its primary duty, the Oregon [*Economic and Community*] **Business** Development
38 Commission shall develop and maintain [*an*] **the** economic [*and community*] development policy **and**
39 **strategy** for this state [*that implements the strategy declared*] **outlined** in ORS 285A.020 [(3)].

40 (2) The commission shall provide oversight and direction to the [*Economic and Community*]
41 **Oregon Business** Development Department in carrying out the [*duties and creating*] **economic de-**
42 **velopment** policies [*to further the economic*] **and** strategy [*set forth in ORS 285A.020.*] **established**
43 **by the commission.** In addition, the commission may perform any other duty vested in the com-
44 mission by law.

45 (3) The commission shall keep complete and accurate records of all the meetings, transactions

1 and business of the commission at the office of the [*Economic and Community Development*] depart-
2 ment.

3 (4) When a power, duty or function is vested in the commission, the commission may designate
4 department officers, agents, employees or committee members to exercise the power, duty or func-
5 tion of the commission. When the commission designates a person in writing to exercise a power,
6 duty or function of the commission, the person may exercise the power, duty or function.

7 (5) In carrying out its duties under subsection (1) of this section, the commission shall coordi-
8 nate its activities with federal, state and local agencies, community partners and regions, when ap-
9 propriate.

10 (6) **The commission may prepare and submit suggested administrative rules to the Di-**
11 **rector of the Oregon Business Development Department that the commission determines are**
12 **necessary for the objectives and programs of the department.**

13 **SECTION 12.** ORS 285A.050 is amended to read:

14 285A.050. (1) The Oregon [*Economic and Community*] **Business** Development Commission shall
15 report biennially to the Governor and the Legislative Assembly on the success of economic devel-
16 opment efforts. The report shall include the progress toward achievement of performance measures
17 for the [*Economic and Community*] **Oregon Business** Development Department as adopted by the

7 (2) The [*Economic and Community*] **Oregon Business** Development Department shall assist pri-
8 vate persons and local governments to redevelop brownfields.

9 (3) The [*Economic and Community Development*] department shall:

10 (a) Act as the primary point of contact for information regarding public and private funding
11 options available to a person interested in redeveloping a brownfield;

12 (b) Facilitate the funding process involving landowners or prospective purchasers, lending in-
13 stitutions, other state agencies, local jurisdictions, consultants and interested citizens;

14 (c) Serve as a key advocate for the redevelopment of brownfields in Oregon;

15 (d) Provide information to private persons and local governments on brownfield redevelopment
16 funding;

12 other provision of an eligible project from an authorized agency of the federal government, and enter
13 into agreements with the agency respecting the loans or grants.

14 (h) Acquire, own, sell, assign or otherwise hold legal or equitable title to or an interest in eli-
15 gible projects or hold federal tax ownership of eligible projects.

16 (2) A lease or sublease entered into under subsection (1)(b) of this section must provide that:

17 (a) Rents charged for the use of the project are established and revised as necessary to produce
18 sufficient revenue to allow for payment of the principal of and interest on bonds issued under this
19 chapter when due; and

20 (b) The lessee or sublessee is required to pay:

21 (A) The expenses of the operation and maintenance of the project including, but not limited to,
22 adequate insurance on the project and insurance against liability for injury to persons or property
23 arising from the operation of the project; and

24 (B) The taxes and special assessments levied upon the leased or subleased premises and payable
25 during the term of the lease or sublease.

26 (3) During the term of a lease or sublease entered into under subsection (1)(b) of this section,

29 project.

6 [(14) "Sewage system" means a facility necessary for collecting, pumping, treating or disposing of

SECTION 135. ORS 200.025 is amended to read:

200.025. (1) There is created, in the Office of the Governor, the Advocate for Minority, Women and Emerging Small Business who shall be appointed by the Governor.

(2) There is created in the [*Department of Consumer and Business Services*] **Oregon Business Development Department** the Office for Minority, Women and Emerging Small Business, the employees of which shall be appointed by the Director of the **Oregon Business Development Department** [*of Consumer and Business Services*].

(3)(a) The director may prescribe the duties and assignments of all officers and employees of the Office for Minority, Women and Emerging Small Business. The director shall establish the compensation of all officers and employees of the office.

(b) The officers and employees of the office shall be allowed reimbursement for reasonable and necessary travel and other expenses incurred in the performance of their duties.

[(3)] (4) The Advocate for Minority, Women and Emerging Small Business shall:

(a) Advise the Governor and the director on activities and initiatives that may promote the economic integration of minorities, women and emerging small businesses into the business sector;

(b) Prepare an annual report to the Governor, director and Legislative Assembly on the status of minorities and women in the marketplace, accomplishments and resolutions of issues of concern to minority and women's enterprises and recommendations for executive and legislative actions; and

(c) Carry out other duties that may be assigned by the Governor.

[(4)] (5) The Office for Minority, Women and Emerging Small Business shall:

(a) Provide information to minority, women and emerging small businesses;

(b) Assist in the development and implementation of an aggressive strategy for this state, based on research and monitoring, that encourages participation of minorities, women and emerging small businesses in the state's economy;

(c) Make recommendations to the director on the research, development and implementation of the plan for the involvement of disadvantaged and minority groups and emerging small businesses

1 in all state programs;

2 (d) Maintain an Oregon Opportunity Register and Clearinghouse for information on public
3 agency and other contract solicitations for professional services, supplies and services and other bid
4 opportunities, in consultation with the State Board of Higher Education, the Department of Trans-
5 portation and other entities;

6 (e) Monitor the certification and compliance program for disadvantaged, minority, women and
7 emerging small businesses under ORS 200.055;

8 (f) Investigate complaints and possible abuses of the certification program; and

9 (g) Assist in the promotion and coordination of plans, programs and operations of state govern-
10 ment that strengthen minority and women participation in the economic life of this state.

11 **SECTION 136.** ORS 200.045 is amended to read:

12 200.045. (1) To determine whether a bidder that has failed to meet emerging small business en-
13 terprise contract requirements may be awarded the contract, the public contracting agency must
14 decide whether the bidder's efforts to obtain participation by emerging small business enterprises
15 were good faith efforts to meet the requirements.

16 (2) Performing all of the following actions by a bidder constitutes a rebuttable presumption that
17 the bidder has made a good faith effort to satisfy the subcontracting requirement for emerging small
18 businesses. It shall be a rebuttable presumption that the bidder has not made a good faith effort if
19 the bidder has not acted consistently with such actions. Efforts that are merely superficial are not
20 good faith efforts:

21 (a) The bidder attended any presolicitation or prebid meetings that were scheduled by the con-
22 tracting agency to inform emerging small business enterprises of contracting and subcontracting or
23 material supply opportunities available on the project;

24 (b) The bidder identified and selected specific economically feasible units of the project to be
25 performed by emerging small business enterprises in order to increase the likelihood of participation
26 by such enterprises;

27 (c) The bidder advertised in general circulation, trade association, minority and trade oriented,
28 women-focus publications, if any, concerning the subcontracting or material supply opportunities;

29 (d) The bidder provided written notice to a reasonable number of specific emerging small busi-
30 ness enterprises, identified from a list of certified emerging small business enterprises provided or
31 maintained by the **Oregon Business Development** Department [*of Consumer and Business*
32 *Services*] for the selected subcontracting or material supply work, in sufficient time to allow the
33 enterprises to participate effectively;

34 (e) The bidder followed up initial solicitations of interest by contacting the enterprises to de-
35 termine with certainty whether the enterprises were interested;

36 (f) The bidder provided interested emerging small business enterprises with adequate information
37 about the plans, specifications and requirements for the selected subcontracting or material supply
38 work;

39 (g) The bidder negotiated in good faith with the enterprises, and did not without justifiable
40 reason reject as unsatisfactory bids prepared by any emerging small business enterprises;

41 (h) Where applicable, the bidder advised and made efforts to assist interested emerging small
42 business enterprises in obtaining bonding, lines of credit or insurance required by the contracting
43 agency or contractor;

44 (i) The bidder's efforts to obtain emerging small business enterprise participation were reason-
45 ably expected to produce a level of participation sufficient to meet the goals or requirement of the

1 public contracting agency; and

2 (j) The bidder used the services of minority community organizations, minority contractor
3 groups, local, state and federal minority business assistance offices and other organizations identi-
4 fied by the Advocate for Minority, Women and Emerging Small Business that provide assistance in
5 the recruitment and placement of emerging small business enterprises.

6 (3) To determine whether a bidder is a responsible bidder, the performance of all the following
7 actions constitutes a rebuttable presumption that the bidder is responsible. It shall be a rebuttable
8 presumption that the bidder is not responsible if the bidder has not acted consistently with the
9 actions described in this subsection. Efforts that are merely superficial are not good faith efforts.

10 (a) The bidder attended any presolicitation or prebid meetings that were scheduled by the con-
11 tracting agency to inform minority or women business enterprises of contracting and subcontracting
12 or material supply opportunities available on the project;

13 (b) The bidder identified and selected specific economically feasible units of the project to be
14 performed by minority or women business enterprises in order to increase the likelihood of partic-
15 ipation by such enterprises;

16 (c) The bidder advertised in general circulation, trade association, minority and trade oriented,
17 women-focus publications, if any, concerning the subcontracting or material supply opportunities;

18 (d) The bidder provided written notice to a reasonable number of specific minority or women
19 business enterprises, identified from a list of certified minority or women business enterprises pro-
20 vided or maintained by the **Oregon Business Development** Department [*of Consumer and Business*
21 *Services*] for the selected subcontracting or material supply work, in sufficient time to allow the
22 enterprises to participate effectively;

23 (e) The bidder followed up initial solicitations of interest by contacting the enterprises to de-
24 termine with certainty whether the enterprises were interested;

25 (f) The bidder provided interested minority or women business enterprises with adequate infor-
26 mation about the plans, specifications and requirements for the selected subcontracting or material
27 supply work;

28 (g) The bidder negotiated in good faith with interested, capable and competitive minority or
29 women business enterprises submitting bids;

30 (h) Where applicable, the bidder advised and made efforts to assist interested minority or women
31 business enterprises in obtaining bonding, lines of credit or insurance required by the contracting
32 agency or contractor;

33 (i) The bidder's efforts to obtain minority or women business enterprise participation were rea-
34 sonably expected to produce a level of participation sufficient to meet the goals of the public con-
35 tracting agency; and

36 (j) The bidder used the services of minority community organizations, minority contractor
37 groups, local, state and federal minority business assistance offices and other organizations identi-
38 fied by the Advocate for Minority, Women and Emerging Small Business that provide assistance in
39 the recruitment and placement of disadvantaged, minority or women business enterprises.

40 **SECTION 137.** ORS 200.055 is amended to read:

41 200.055. (1) Any disadvantaged, minority, women or emerging small business enterprise is enti-
42 tled to be certified as such upon application to the **Oregon Business Development** Department
43 [*of Consumer and Business Services*]. If the application is approved by the department, the depart-
44 ment shall certify the applicant as a disadvantaged, minority, women or emerging small business
45 enterprise. The enterprise shall be considered so certified by any public contracting agency.

1 (2) In consultation with the State Board of Higher Education and the Department of Transpor-
2 tation, and with the approval of the Advocate for Minority, Women and Emerging Small Business,
3 the **Oregon Business Development** Department [*of Consumer and Business Services*] by rule shall
4 adopt a uniform standard form and procedure designed to provide complete documentation that a
5 business enterprise is certified as a disadvantaged, minority, women or emerging small business en-
6 terprise. The department [*of Consumer and Business Services*] shall compile and make available upon
7 request a list of certified disadvantaged, minority, women or emerging small business enterprises.

8 (3) Any business enterprise that is refused certification as a disadvantaged business enterprise
9 or denied recertification as such or whose certification is revoked may appeal directly to the United
10 States Department of Transportation.

11 (4) Any business enterprise that is refused certification as a minority, women or emerging small
12 business enterprise or has its certification revoked may request a contested case hearing as pro-
13 vided in ORS chapter 183.

14 (5) The **Oregon Business Development** Department [*of Consumer and Business Services*] shall
15 be the sole agency authorized to certify enterprises as disadvantaged, minority, women or emerging
16 small business enterprises eligible to perform on public contracts in this state.

17 (6) The **Oregon Business Development** Department [*of Consumer and Business Services*] by
18 rule may establish a fee not to exceed \$100 for a copy of the list of certified disadvantaged, minority,
19 women and emerging small business enterprises and may assess state agencies for services under
20 ORS 200.005 to 200.075.

21 (7) The Department of Transportation may collect a fee, not to exceed \$200, from a bidder upon
22 bidder prequalifications to cover the costs of the **Oregon Business Development** Department [*of*
23 *Consumer and Business Services*] in administering ORS 200.005 to 200.075. The Department of
24 Transportation shall transfer such fees to the credit of the account established under subsection (8)
25 of this section.

26 (8) The **Oregon Business Development** Department [*of Consumer and Business Services*] shall
27 establish a special account in which to deposit fees and assessments. The special account is con-
28 tinuously appropriated to the department [*of Consumer and Business Services*] to meet its expenses
29 in administering ORS 200.005 to 200.075.

30 **SECTION 138.** ORS 200.057 is amended to read:

31 200.057. (1) A business may be certified as an emerging small business by the **Oregon Business**
32 **Development** Department [*of Consumer and Business Services*] for up to 12 years and may be:

33 (a) Designated a tier one firm for up to six years unless the business no longer qualifies as a
34 tier one firm.

35 (b) Designated a tier two firm for up to six years unless the business no longer qualifies as a
36 tier two firm.

37 (2) The department shall adjust annually the amount of the average annual gross receipts re-
38 quired to qualify as a tier one firm or a tier two firm using the most recent three-year average of
39 the Portland-Salem Consumer Price Index for All Urban Consumers for All Items, as reported by the
40 United States Bureau of Labor Statistics.

41 (3) Notwithstanding the time limits established by subsection (1) of this section, if a tier one firm
42 provides compelling information showing, in the judgment of the department [*of Consumer and*
43 *Business Services*], that the firm has not been afforded an opportunity to bid on emerging small
44 business projects during a year of eligibility, the department shall extend the tier one designation
45 of the firm for one year. A tier one firm may receive the extension described in this subsection only

1 once.

2 **SECTION 139.** ORS 200.065 is amended to read:

3 200.065. (1) It shall be unlawful for any person fraudulently to obtain or retain or attempt to
4 obtain or retain or to aid another person fraudulently to obtain or retain or attempt to obtain or
5 retain certification as a disadvantaged, minority, women or emerging small business enterprise.

6 (2) It shall be unlawful knowingly to make a false claim that any person is qualified for certif-
7 ication or is certified under ORS 200.055 for the purpose of gaining a contract or subcontract or
8 other benefit.

9 (3) The public contracting agency may withhold payment, suspend or terminate the contract and
10 may impose on any person a civil penalty not to exceed 10 percent of the contract or subcontract
11 price or \$5,000, whichever is less, for each violation of subsection (1) or (2) of this section. The
12 penalty shall be paid to the Office for Minority, Women and Emerging Small Business.

13 (4) The **Oregon Business Development** Department [*of Consumer and Business Services*] or an
14 affected public contracting agency shall investigate any complaint that a person has violated sub-
15 section (1) or (2) of this section. In investigating such a complaint, the department or an affected
16 public contracting agency may require any additional information, administer oaths, take depositions
17 and issue subpoenas to compel the attendance of witnesses and the production of books, papers, re-
18 cords, memoranda or other information necessary to carry out its duties. If any person fails to
19 comply with any subpoena issued under this subsection or refuses to testify on any matter on which
20 a person may lawfully be interrogated, the procedure provided in ORS 183.440 shall be followed to
21 compel compliance.

22 (5) An affected public contracting agency or the department [*of Consumer and Business Services*
23 *may*] disqualify any person found to have violated subsection (1) or (2) of this section or who admits
24 to such violation under oath during the course of an investigation from bidding or participating in
25 any public contract for a period of time specified by the agency or department, not to exceed three
26 years. Any contracting agency that has notice of the finding of the fraudulent certification may also
27 disqualify the person from bidding on or participating in any public contract.

28 **SECTION 140.** ORS 200.110 is amended to read:

29 200.110. (1) The [*Economic and Community*] **Oregon Business** Development Department may
30 recognize the mentor relationship between contractors and minority business enterprises or women
31 business enterprises certified under this chapter. The mentor relationship shall offer the opportunity
32 to foster and encourage minority and women business enterprises, to expand the capacity of pres-
33 ently existing minority and women businesses and to offer the opportunity for less experienced mi-
34 nority and women businesses to gain training and assistance.

35 (2) Guidelines for eligibility for the mentor relationship include, but are not limited to:

36 (a) Minority and women business enterprises that meet the certification requirements of the U.S.
37 Department of Transportation are eligible for participation in a mentor program. Other minority
38 and women business enterprises are also eligible if they meet the certification requirements of this
39 chapter. An agency may grant approval of an enterprise application for certification concurrent with
40 approval of a mentor arrangement.

41 (b) The minority or women business enterprise must be an independent organization, and the
42 ownership by the individuals must be real. Other employment and business interests by the individ-
43 uals are not precluded, if such employment or business interests do not conflict with the power of
44 the minority or women owners to direct the management and policies of the minority or women
45 enterprise to make day-to-day as well as major decisions on matters of management, policy and op-

1 erations.

2 (c) The mentor program is intended to provide minority and women business enterprises with
3 advice, assistance and training. The enterprise shall be responsible for management and operations
4 of the business. The mentor shall not be responsible for the management of the firm. The mentor
5 and the enterprise shall remain separate and independent business entities with the exception that
6 facilities may be provided to the enterprise by the mentor if a separate lease agreement is main-
7 tained by the parties.

8 (d) Part ownership in a minority or women business enterprise by a nondisadvantaged party,
9 including a mentor, is permitted if in compliance with 49 C.F.R. 23. Any property, equipment, sup-
10 plies or other services which are sold, rented or donated to the enterprise and any investment made
11 by nondisadvantaged individuals must be reported to the agency involved in the mentor program.
12 Documentation shall be provided by bills of sale, lease agreements or similar documents.

13 (e) The mentor relationship may include an arrangement with an independent third party, such
14 as a bank or accountant, to act as an agent. Third parties may receive progress payments for work
15 accomplished by the minority or women business enterprise, made out jointly to the agent and the
16 enterprise, and make payments, on behalf of the enterprise, to material suppliers or for federal and
17 state payroll taxes.

18 (3) Types of assistance a mentor may provide to the minority or women business enterprise in-
19 clude:

- 20 (a) Financial assistance;
- 21 (b) Technical and management assistance;
- 22 (c) Equipment rental and use of personnel; and
- 23 (d) Bonding assistance.

24 **SECTION 141.** ORS 200.120 is amended to read:

25 200.120. (1) Mentor relationships may be documented by a written development plan, approved
26 by the [*Economic and Community*] **Oregon Business** Development Department in consultation with
27 the Oregon Association of Minority Entrepreneurs. The development plan shall:

- 28 (a) Clearly set forth the objectives of the parties and their respective roles;
- 29 (b) Be for a specified length of time;
- 30 (c) Determine measurable goals to be reached by the minority or women business enterprise; and
- 31 (d) Provide that if resources of the mentor are utilized by the minority or women business en-
32 terprise in the performance of contracts or subcontracts for the mentor or for another contractor,
33 the resources shall be separately identified, accounted for and compensated directly by the minority
34 or women business enterprise to the mentor. If the plan provides for extensive use of the mentor's
35 resources by the minority or women business enterprise, the arrangement may be closely monitored.

36 (2) The development plan may also include training to be provided by the mentor to the minority
37 or women business enterprise. Training may include:

- 38 (a) Business planning;
- 39 (b) Record keeping;
- 40 (c) Technical training;
- 41 (d) Capital formation;
- 42 (e) Loan packaging;
- 43 (f) Financial counseling;
- 44 (g) Bonding; and
- 45 (h) Equipment utilization.

1 (3) The development plan may be reviewed annually by the [*Economic and Community*] **Oregon**
2 **Business** Development Department and the Oregon Association of Minority Entrepreneurs to re-
3 view the progress of the mentor program.

4 (4) The development plan shall contain a provision that the mentor relationship may be termi-
5 nated by mutual consent or upon determination that:

6 (a) The mentor firm no longer meets the eligibility standards for certification as a minority or
7 women business enterprise;

8 (b) Either party has failed or is unable to meet its obligations under the development plan;

9 (c) The minority or women business enterprise is not progressing or is not likely to progress in
10 accordance with the development plan;

11 (d) The minority or women business enterprise has reached a satisfactory level of self-sufficiency
12 to compete without resorting to special treatment provided in the development plan; or

13 (e) The plan or provisions thereof are contrary to the requirements of federal, state, or local law
14 or regulation, or otherwise contrary to public policy.

15 (5) Copies of the development plan shall be retained by all parties to it, and by the [*Economic*
16 *and Community*] **Oregon Business** Development Department and the Oregon Association of Minor-
17 ity Entrepreneurs.

18 (6) The development plan may include a provision that the arrangement shall be dissolved by
19 either party for reason by notifying the [*Economic and Community*] **Oregon Business** Development
20 Department and the Oregon Association of Minority Entrepreneurs.

21 **SECTION 142.** ORS 200.170 is amended to read:

22 200.170. (1) Subject to subsection (2) of this section, to participate in the emerging small business
23 program under ORS 200.160 to 200.200, an applicant must:

24 (a) Be certified by the **Oregon Business Development** Department [*of Consumer and Business*
25 *Services*] under ORS 200.005 to 200.075 as an emerging small business;

26 (b) Show that the applicant's place of business and the work in which the applicant seeks to
27 participate are located in this state; and

28 (c) Show that the applicant is in compliance with applicable licensing and registration require-
29 ments.

30 (2) The Department of Transportation may limit eligibility for participation on a specific project
31 or contract to emerging small businesses that are located in or draw a part of their workforce from
32 economically distressed areas or enterprise zones in this state, as designated by the [*Economic and*
33 *Community*] **Oregon Business** Development Department in consultation with the Employment De-
34 partment.

35 (3) An applicant who participates under ORS 200.160 to 200.200 must perform at least 51 percent
36 of the labor provided by the applicant on a public improvement or maintenance project using the
37 applicant's own workforce.

39 **MARINE NAVIGATION IMPROVEMENT**

40
41 **SECTION 143.** ORS 777.267 is amended to read:

42 777.267. (1) There is established in the State Treasury the Marine Navigation Improvement
43 Fund. **Interest earned by the Marine Navigation Improvement Fund shall credited to the**
44 **fund.** The moneys in the fund and interest earnings on the moneys in the fund are continuously
45 appropriated to the [*Economic and Community Development Department*] **Oregon Business Devel-**

1 **opment Department for the Oregon Infrastructure Finance Authority** for the purposes of:

2 (a) Paying a portion of the costs of dredging activities that are carried out in the harbors and
3 channels on the Oregon coast and along the Columbia River when federal law or regulation requires
4 a portion of the costs of such dredging to be paid by nonfederal interests; and

5 (b) Paying the study and construction costs of other new navigation improvement projects that
6 directly support a federally authorized navigation improvement project.

7 (2) The Marine Navigation Improvement Fund established by this section consists of moneys
8 appropriated to the fund by the Legislative Assembly, repayment of loans made with moneys in the
9 fund and bond proceeds deposited in the fund.

10 (3) Moneys in the fund shall be used primarily to make loans to ports for eligible projects. The
11 *[department]* **authority** may award a grant or provide other assistance from moneys in the fund to
12 a port for an eligible project only if a loan is not feasible due to the financial hardship of the port
13 or other special circumstances, as set forth in rules adopted by the department.

14 (4) Eligibility for assistance from the Marine Navigation Improvement Fund shall be limited to
15 and funded, subject to the availability of funds, in the following order of priority:

16 (a) Federally authorized studies and construction of new navigation improvement projects.

17 (b) Other new navigation improvement projects if the projects directly support or provide access
18 to a federally authorized navigation improvement project or a federally authorized navigation
19 channel.

20 (5) Financial assistance for construction costs under subsection (4)(a) of this section shall be
21 limited to those projects that have completed all federally required studies and have confirmed
22 positive cost-benefit ratios as required by the National Economic Development Plan.

23 (6) Financial assistance for construction costs under subsection (4)(b) of this section is limited
24 to projects sponsored by a port, as defined in ORS 777.005 or 778.005, that meet criteria developed
25 by the *[department]* **authority**.

26 (7) Financial assistance for studies of other new construction projects under subsection (1)(b)
27 of this section is limited to projects that meet criteria developed by the *[department]* **authority**.

28 **SECTION 144.** ORS 777.277 is amended to read:

29 777.277. As used in ORS 777.277 to 777.287:

30 (1) "Channel Deepening Account" means the account in the Marine Navigation Improvement
31 Fund created by ORS 777.282.

32 (2) "Channel Deepening Debt Service Account" means the account in the Marine Navigation
33 Improvement Fund created by ORS 777.282.

34 (3) "Channel deepening project" means a project to deepen the deep draft Columbia River nav-
35 igation channel from an authorized depth of 40 feet.

36 [(4) "Department" means the Economic and Community Development Department.]

37 [(5) "Director" means the Director of the Economic and Community Development Department.]

38 [(6)] (4) "Grant agreement" means the grant agreement described in ORS 777.284.

39 [(7)] (5) "Oregon nonfederal share" means that portion of the cost of the channel deepening
40 project that is allocable to the Oregon sponsors and that is not paid by the federal government, the
41 State of Washington or the Washington sponsors.

42 [(8)] (6) "Oregon sponsors" means the Port of St. Helens, the Port of Portland or any agency
43 acting on behalf of the government of the State of Oregon as a financial contributor to the channel
44 deepening project.

45 [(9)] (7) "Primary sponsor" means the Port of Portland as representative of the Oregon sponsors.

1 [(10)] (8) "Project cooperation agreement" means a written agreement between the United States
2 Government and a nonfederal sponsor that requires the United States Government to construct, and
3 the nonfederal sponsor to share in the cost of, a project authorized under the Water Resources De-
4 velopment Act or a similar Act of the United States Congress.

5 [(11)] (9) "Washington sponsors" means the Port of Vancouver, the Port of Kalama, the Port of
6 Woodland, the Port of Longview or any agency acting on behalf of the government of the State of
7 Washington as a financial contributor to the channel deepening project.

8 **SECTION 145.** ORS 777.282 is amended to read:

9 777.282. (1) The Channel Deepening Account is hereby created in the Marine Navigation Im-
10 provement Fund.

11 (2) Any earnings **and interest earned** on amounts in the Channel Deepening Account shall be
12 credited to the Channel Deepening Account. [*All moneys on deposit from time to time in the Channel*
13 *Deepening Account, including investment earnings thereon, shall be allocated and are hereby appro-*
14 *propriated continuously]* **The moneys in the Channel Deepening Account are continuously appro-**
15 **propriated** to the [*Economic and Community Development Department,*] **Oregon Business Development**
16 **Department for the Oregon Infrastructure Finance Authority** and shall be transferred by the
17 [*department*] **authority** to the primary sponsor pursuant to and upon the terms and conditions set
18 forth in the grant agreement entered into under ORS 777.284 to pay the Oregon nonfederal share.

19 [(3) *Notwithstanding directions for transfer of moneys to the primary sponsor in subsection (2) of*
20 *this section and the grant agreement entered into under ORS 777.284 prior to August 29, 2003, the*
21 *Economic and Community Development Department shall transfer moneys in the Channel Deepening*
22 *Account on August 29, 2003, to the Channel Deepening Debt Service Account for payment of bond-*
23 *related costs for lottery bonds issued under ORS 285B.551 (5) and section 12, chapter 741, Oregon*
24 *Laws 2003, and for lottery bonds issued for channel deepening under ORS 285B.551 (3) and section*
25 *6, chapter 942, Oregon Laws 2001.*]

26 [(4)] (3) The Channel Deepening Debt Service Account is hereby created in the Marine Navi-
27 gation Improvement Fund.

28 [(5)] (4) Any earnings **and interest earned** on amounts in the Channel Deepening Debt Service
29 Account must be credited to the Channel Deepening Debt Service Account. [*All moneys on deposit*
30 *from time to time in the Channel Deepening Debt Service Account, including investment earnings*

2 ferred to the Oregon Business Development Department by this 2009 Act are transferred to
3 and are available for expenditure by the Oregon Business Development Department for the

6 (2) The expenditure classifications, if any, established by Acts authorizing or limiting

30 (2) For the purpose of harmonizing and clarifying statute sections published in Oregon
31 Revised Statutes, the Legislative Counsel may substitute for words designating the “Regional
32 Investment Fund,” wherever they occur in Oregon Revised Statutes, other words designating
33 the “Local Economic Opportunity Fund.”

34 **SECTION 170.** (1) The amendments to ORS 285B.290 by section 83 of this 2009 Act are
35 intended to change the name of the Industry Outreach Fund to the Industry Competitiveness
36 Fund.

37 (2) For the purpose of harmonizing and clarifying statute sections published in Oregon
38 Revised Statutes, the Legislative Counsel may substitute for words designating the “Industry
39 Outreach Fund,” wherever they occur in Oregon Revised Statutes, other words designating
40 the “Industry Competitiveness Fund.”

41 **SECTION 171.** ORS 285A.483, 285A.486, 285A.489, 285A.495, 285B.239, 285B.242, 285B.245,
42 285B.248, 285B.263, 285B.264 and 285B.269 are repealed.

43 **SECTION 172.** Notwithstanding the terms of office specified by section 1 of this 2009 Act,
44 of the members first appointed by the Governor to the Oregon Infrastructure Finance Au-
45 thority Board:

1 (1) Two shall serve for a term ending June 30, 2010.

2 (2) Two shall serve for a term ending June 30, 2011.

3 (3) Two shall serve for a term ending June 30, 2012.

9 legislative intent in the enactment of this 2009 Act.

10 **SECTION 174.** This 2009 Act being necessary for the immediate preservation of the public
11 peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect
12 on its passage.
