### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes name of Oregon Economic and Community Development Commission to Oregon Business Development Commission. Changes name of Economic and Community Development Department to Oregon Business Development Department.

Creates Oregon Infrastructure Finance Authority and Oregon Infrastructure Finance Authority Board within Oregon Business Development Department.

Establishes Oregon Infrastructure Finance Fund. Continuously appropriates moneys in fund to Oregon Business Development Department to promote infrastructure development.

Transfers responsibilities of Oregon Economic and Community Development Commission and Economic and Community Development Department to and among Oregon Business Development Commission, Oregon Business Development Department and Oregon Infrastructure Finance Authority.

Declares emergency, effective on passage.

2 **Be It Enacted by the People of the State of Oregon:**

4 **OREGON INFRASTRUCTURE FINANCE AUTHORITY**  
5 **CREATION AND ADMINISTRATIVE PROVISIONS**  
6

7 **SECTION 1.** Sections 1a to 7 of this 2009 Act are added to and made a part of ORS  
8 chapter 285A.

9 **SECTION 1a.** (1) The Oregon Infrastructure Finance Authority Board is created as a  
10 policy-making and advisory body within the Oregon Business Development Department. The  
11 board consists of nine members as follows:

12 (a) One nonvoting member appointed from members of the Senate by the President of  
13 the Senate;

14 (b) One nonvoting member appointed from members of the House of Representatives by  
15 the Speaker of the House of Representatives;

16 (c) One member appointed by the State Treasurer; and

17 (d) Six members appointed by the Governor.

18 (2) Persons appointed members of the board must be Oregon residents, well qualified by  
19 experience to make policy and recommendations in areas of concern to the Oregon  
20 Infrastructure Finance Authority and to perform the duties of office. Members shall be ap-  
21 pointed with consideration given to knowledge and experience:

22 (a) In the field of state and municipal finance;

23 (b) Of the infrastructure and public works needs in Oregon cities;

24 (c) Of the infrastructure and public works needs in Oregon counties;

25 (d) Of issues related to ports that affect the state;

26 (e) Of issues related to special service district services furnished across the state; and

27 (f) Of infrastructure and public works necessary to further Oregon's long term economic  
28 growth.

29 (3) The office of the State Treasurer may recommend persons with expertise in the field  
30 of state and municipal finance for membership on the board.

31 (4) The term of a member of the board appointed by the Governor, the State Treasurer  
32 or the President of the Senate is four years. The term of a member appointed by the Speaker  
33 of the House of Representatives is two years.

34 (5) In case of a vacancy on the board for any cause, the appointing authority shall ap-  
35 point a successor to serve for the unexpired term.

36 (6) A member of the board may be appointed to serve two consecutive terms. A member  
37 who serves two consecutive terms is not eligible for reappointment within one year following  
38 the expiration of the second term.

39 (7) The board shall select one of its members to chair the board for such term and with  
40 duties and powers necessary to perform the functions of the office as the board determines.

41 (8) A majority of the voting members of the board constitutes a quorum for the trans-  
42 action of business.

43 **SECTION 2.** The Oregon Infrastructure Finance Authority Board shall:

44 (1) Serve as a body to advise municipalities, state agencies and private persons on the  
45 development and implementation of state policies and programs relating to the

1 infrastructure needs of this state and its communities.

2 (2) Advise the Governor, the Director of the Oregon Business Development Department  
3 and the Oregon Business Development Department on all matters relating to infrastructure  
4 and public works programs and activities administered by the Oregon Infrastructure Finance  
5 Authority.

6 (3) Develop a recommended biennial budget for the operation of the authority and submit  
7 the budget to the director and the Governor.

8 (4) Seek and receive the views of all levels of government and the private sector with  
9 respect to state policies and programs to address the infrastructure needs of this state.

10 (5) Prepare and submit to the Director of the Oregon Business Development Department  
11 suggested administrative rules that the board determines are necessary for the operation of  
12 the programs under the direction of the authority.

13 (6) Establish policies and procedures for loan and grant programs administered by the  
14 authority.

15 **SECTION 3.** (1) The Oregon Infrastructure Finance Authority is established as an ad-  
16 ministrative section within the Oregon Business Development Department, subject to the  
17 supervision of the administrator of the authority. The authority consists of the administra-  
18 tor and all personnel employed by the authority.

19 (2) The authority shall develop and administer programs and funds of the department  
20 that address the infrastructure needs of this state pursuant to the policies of, and as may  
21 be recommended by, the Oregon Infrastructure Finance Authority Board.

22 (3) The authority shall provide the Oregon Infrastructure Finance Authority Board with  
23 staff and other assistance as necessary for the board to perform its duties.

24 (4) The authority shall employ, in accordance with the State Personnel Relations Law,  
25 the staff necessary to allow the authority to carry out its responsibilities.

26 **SECTION 3a.** (1) The Oregon Infrastructure Finance Authority may:

27 (a) Conduct hearings and conferences to develop facts, explain programs and activities,  
28 and obtain advice;

29 (b) Enter into agreements with other public bodies, as defined in ORS 174.109, or associ-  
30 ations or private persons for services to assist the authority and the Oregon Infrastructure  
31 Finance Authority Board;

32 (c) Enter into agreements with other public bodies, as defined in ORS 174.109, the federal  
33 government, associations or private persons for cooperative endeavors that further pro-  
34 grams administered by the authority;

35 (d) Subject to applicable policies and procedures, enter into agreements for loans, grants  
36 or other assistance, including, but not limited to, direct purchase of goods or services, with  
37 local governments, as defined in ORS 174.116, special government bodies, as defined in ORS  
38 174.117, or other eligible applicants for infrastructure development;

39 (e) Appoint committees, consultants or other persons with expertise in infrastructure-  
40 related matters to advise the Oregon Infrastructure Finance Authority Board or the au-  
41 thority;

42 (f) Obtain assistance or data from any state agency; or

43 (g) Perform any other act necessary to carry out the duties of the authority.

44 (2) The authority shall administer the state's participation in the federal Community  
45 Development Block Grant funding program authorized by 42 U.S.C. 5301 et seq.

2 (2) **“Association” means a nonprofit, private, incorporated or unincorporated institution,**  
3 **foundation, organization, entity or group, whether local, state, regional or national, that is**  
4 **operating or doing business in Oregon.**

5 (3) **“Authority” means the Oregon Infrastructure Finance Authority.**

6 (4) **“Board” means the Oregon Infrastructure Finance Authority Board.**

7 [(1)] (5) **“Commission” means the [Oregon Economic and Community Development Commission]**  
8 **Oregon Business Development Commission.**

9 [(2)] (6) **“Community” means an area or locality in which the body of inhabitants has common**  
10 **economic or employment interests. The term is not limited to a city, county or other political sub-**  
11 **division and need not, but may be, limited by political boundaries.**

12 [(3)] (7) **“Department” means the [Economic and Community Development Department] Oregon**  
13 **Business Development Department.**

14 [(4)] (8) **“Director” means the Director of the [Economic and Community Development**  
15 **Department] Oregon Business Development Department.**

16 [(5)] (9) **“Distressed area” means a county, city, community or other geographic area that is**  
17 **designated as a distressed area by the department, based on indicators of economic distress or dis-**  
18 **location, including but not limited to unemployment, poverty and job loss.**

19 [(6)] (10) **“International trade” means the export and import of products and services and the**  
20 **movement of capital for the purpose of investment.**

21 (11) **“Local government” has the meaning given that term in ORS 174.116.**

22 (12) **“Municipality” means an Oregon city or county, the Port of Portland created by ORS**  
23 **778.010, a county service district organized under ORS chapter 451, a district as defined in**  
24 **ORS 198.010, a tribal council of a federally recognized Indian tribe in this state or an airport**  
25 **district organized under ORS chapter 838.**

26 (13) **“Public body” has the meaning given that term in ORS 174.109.**

27 [(7)] (14) **“Rural area” means an area located entirely outside of the acknowledged Portland**  
28 **Metropolitan Area Regional Urban Growth Boundary and the acknowledged urban growth bounda-**  
29 **ries of cities with populations of 30,000 or more.**

30 [(8) *“Traded sector” means industries in which member firms sell their goods or services into*  
31 *markets for which national or international competition exists.*]

32 [(9)] (15) **“Small business” means a business having 100 or fewer employees.**

33 (16) **“State agency” includes state officers, departments, boards and commissions.**

34 (17) **“Traded sector” means industries in which member firms sell their goods or services**  
35 **into markets for which national or international competition exists.**

36 **SECTION 9.** ORS 285A.020 is amended to read:

37 285A.020. (1) The Legislative Assembly finds that:

38 (a) Oregon possesses [*many*] unique and sustaining virtues that will guide and assist in main-  
39 taining the state’s economic health, including but not limited to Oregon’s:

40 (A) Special heritage;

41 (B) Respect for and cultivation of the environment; and

42 (C) Attention to quality of life issues that are important to the state’s economic development,  
43 including but not limited to access to quality, affordable child care for all children in Oregon.

44 (b) Oregon is strategically placed to compete and succeed in the global [*community.*] **market-**  
45 **place.**

1 (c) All regions of the state should share in Oregon's economic recovery.

2 (d) Creating and retaining quality jobs *[is]* **are** vital to the state's *[continued economic develop-*  
3 *ment.]* **economic health.**

4 (e) Oregon's agriculture and natural resource industries provide opportunities for beneficial  
5 economic enterprise, including sustainable *[economic]* **business** development activities.

6 (f) A well educated and trained workforce is necessary to *[advance in today's global economy.]*  
7 **support business and industry needs throughout the state.**

8 (g) The ability of existing businesses to grow *[and prosper]* is critical to Oregon's *[economy.]*  
9 **prosperity.**

10 (h) *[Utilizing the state's]* **The state must utilize its** competitive advantages *[is essential]* to re-  
11 tain existing businesses and attract new companies and investment into the state.

12 (i) Continued *[economic]* development **in Oregon** depends on strengthening traded sector indus-  
13 tries.

14 (j) International trade **and** development *[and promotion is invaluable]* **of international trade**  
15 **are essential** for future *[economic]* **business** development opportunities.

16 (k) Small businesses remain a critical element of the state's *[economic development, comprising*  
17 *more than 90 percent of Oregon's businesses.]* **economy.**

18 (L) Capacity building **to support business development** in rural and distressed areas is a key  
19 component of economic development and revitalization efforts.

20 (m) Oregon's ports are important partners in the state's economic development efforts and are  
21 key components of local and state economic development strategies.

22 (n) Improving and enhancing infrastructure is necessary to the state's future economic develop-  
23 ment.

24 (o) Federal, state and local agencies working together will continue to enhance industrial site  
25 development and other economic development activities.

26 *[(p) The Economic and Community Development Department should be encouraged to convene*  
27 *community development partners to explore the prospect of making loans to private industrial land-*  
28 *owners from the Brownfields Redevelopment Fund for future development opportunities.]*

29 (2) It is the purpose of ORS 284.101 to 284.146 and ORS chapters 285A, 285B and 285C *[to ad-*  
30 *van*ce Oregon's economy.] **to enable the creation, retention, expansion and attraction of busi-**  
31 **nesses that provide sustainable, living wage jobs for Oregonians through public-private**  
32 **partnerships and leveraged funding and to support economic opportunities for Oregon com-**  
33 **panies and entrepreneurs.**

34 (3) The Legislative Assembly declares that it is the immediate economic strategy of the state to:

35 (a) Promote a favorable investment climate to strengthen businesses, create jobs and raise real  
36 wages;

37 (b) Improve the national and global competitiveness of Oregon companies; and

38 (c) Assist *[Oregon communities in building capacity]* **and further efforts** to retain, expand and  
39 attract businesses.

40 (4) To promote the advancement of the Oregon economy and implement the immediate economic  
41 strategy of the state, the *[Economic and Community]* **Oregon Business** Development Department  
42 shall invest resources in accordance with the following principles:

43 (a) Processes for making public investments and working with local and regional issues must  
44 be designed for flexibility so that actions can adapt to the constantly changing conditions and de-  
45 mands under which communities and businesses operate.

1 (b) Partnerships among local, state and federal governments and public and private organiza-  
2 tions and entities should be strengthened to further the economic strategy of the state.

3 (c) The expected impact of public investment and assistance shall be identified, in terms of  
4 measurable outcomes, whenever possible.

5 (d) State, federal and community goals, constraints and obligations should be identified at the  
6 beginning of the planning process, and the state should work actively with community partners, re-  
7 gions and state and local agencies to address and accomplish their mutual objectives.

8 (5) When the department provides funds or assistance for projects, programs, technical support  
9 or other authorized activities pursuant to ORS 284.101 to 284.146 and ORS chapters 285A, 285B and  
10 285C, the department shall give priority to projects, programs and activities that:

11 (a) Retain and create jobs and raise real wages;

12 [(b) Promote capacity building, emphasizing rural and distressed areas;]

13 **(b) Promote capacity building, emphasizing rural and distressed areas to further eco-**  
14 **nomical development initiatives;**

15 (c) Assist small business creation and expansion;

16 (d) Invest and engage in training a skilled workforce;

17 (e) Retain and expand existing companies and recruit new investment to Oregon;

18 (f) Capitalize on Oregon's competitive advantages and strategically invest resources to offset  
19 competitive disadvantages;

20 (g) Support innovation and research;

21 (h) Assist industry clusters to succeed;

22 (i) Market Oregon's advantages;

23 (j) Promote international trade and attract foreign direct investment;

24 (k) Support the development of industrial and commercial lands;

25 (L) Advance the efforts of ports to promote economic development activities; and

26 (m) Build capacity in Oregon's arts and cultural organizations, creative businesses and individ-  
27 ual artists.

28 **SECTION 10.** ORS 285A.040 is amended to read:

29 285A.040. (1) There is established the Oregon [*Economic and Community*] **Business** Development  
30 Commission consisting of nine members appointed as follows:

31 (a) One nonvoting[, *ex officio*] member appointed from among the members of the Senate by the  
32 President of the Senate;

33 (b) One nonvoting[, *ex officio*] member appointed from among the members of the House of Rep-  
34 resentatives by the Speaker of the House of Representatives; and

35 (c) Seven members appointed by the Governor, subject to confirmation by the Senate in the  
36 manner prescribed in ORS 171.562 and 171.565. The Governor shall appoint members of the com-  
37 mission in compliance with all of the following:

38 (A) Members shall be appointed with consideration given to representation of the different ge-  
39 ographic regions of the state, and at least one member shall be a resident of the area east of the  
40 Cascade Range.

41 (B) Not more than five members may belong to one political party. Party affiliation shall be  
42 determined by the appropriate entry on official election registration cards.

43 (C) Members shall be appointed with consideration given to representation of the following  
44 areas of expertise or training:

45 (i) International trade;

1 **(ii) Traded sector business development;**

2 [(ii)] **(iii) Small business [needs and issues;] development;**

3 [(iii)] **(iv) Local [government needs and issues;] economic development;**

4 [(iv) *Marketing and branding;*]

5 [(v) *Arts and culture;*]

6 [(vi)] **(v) Finance and business investment;**

7 [(vii)] **(vi) Innovation; or**

8 [(viii) *Telecommunications; or*]

9 [(ix)] **(vii) Other areas of training or expertise identified by the [commission.] Governor.**

10 (2)(a) The term of office of each member appointed by the Governor is four years, but a member  
11 serves at the pleasure of the Governor. Before the expiration of the term of a member appointed by  
12 the Governor, the Governor shall appoint a successor whose term begins on July 1 of the following  
13 year. A member appointed by the Governor is eligible for reappointment. In case of a vacancy among  
14 the members appointed by the Governor for any cause, the Governor shall appoint a person to fill  
15 the office for the unexpired term.

16 (b) The term of office of the member appointed by the President of the Senate is four years. In  
17 case of a vacancy for any cause, the President of the Senate shall appoint a Senator to fill the office  
18 for the unexpired term.

19 (c) The term of office of the member appointed by the Speaker of the House of Representatives  
20 is two years. In case of a vacancy for any cause, the Speaker of the House of Representatives shall  
21 appoint a Representative to fill the office for the unexpired term.

22 (3) A member of the commission who is appointed by the Governor is entitled to compensation  
23 and expenses as provided by ORS 292.495. [*Ex officio*] **Legislative** members of the commission are  
24 prohibited from receiving compensation and reimbursement for expenses.

25 (4) Subject to confirmation by the Senate, the Governor shall appoint one of the voting com-  
26 missioners as presiding officer of the commission. The presiding officer shall have duties and powers  
27 as the commission determines are necessary for the office.

28 (5) Five voting members of the commission constitute a quorum for the transaction of business.

29 (6) The commission shall meet at least quarterly at a time and place determined by the com-  
30 mission. The commission shall also meet at other times and places as are specified by the call of the  
31 presiding officer or by the call of a majority of the voting members of the commission.

32 (7) A vacancy among the voting members of the commission does not impair the right of the  
33 remaining voting commissioners to exercise all the powers of the commission. If the remaining vot-  
34 ing commissioners are unable to agree, the Governor shall have the right to vote as a member of  
35 the commission.

36 **(8) A member of the commission appointed due to expertise or training in local economic**  
37 **development described in subsection (1)(c)(C)(iv) of this section shall also be an elected local**  
38 **government official with experience in economic development matters.**

39 **SECTION 11.** ORS 285A.045 is amended to read:

40 285A.045. (1) As its primary duty, the Oregon [*Economic and Community*] **Business** Development  
41 Commission shall develop and maintain [*an*] **the** economic [*and community*] development policy **and**  
42 **strategy** for this state [*that implements the strategy declared*] **outlined** in ORS 285A.020 [(3)].

43 (2) The commission shall provide oversight and direction to the [*Economic and Community*]  
44 **Oregon Business** Development Department in carrying out the [*duties and creating*] **economic de-**  
45 **velopment** policies [*to further the economic*] **and** strategy [*set forth in ORS 285A.020.*] **established**



1 **by the commission.** In addition, the commission may perform any other duty vested in the com-  
2 mission by law.

3 (3) The commission shall keep complete and accurate records of all the meetings, transactions  
4 and business of the commission at the office of the [*Economic and Community Development*] depart-  
5 ment.

6 (4) When a power, duty or function is vested in the commission, the commission may designate  
7 department officers, agents, employees or committee members to exercise the power, duty or func-  
8 tion of the commission. When the commission designates a person in writing to exercise a power,  
9 duty or function of the commission, the person may exercise the power, duty or function.

10 (5) In carrying out its duties under subsection (1) of this section, the commission shall coordi-  
11 nate its activities with federal, state and local agencies, community partners and regions, when ap-  
12 propriate.

13 **(6) The commission may prepare and submit suggested administrative rules to the Di-**  
14 **rector of the Oregon Business Development Department that the commission determines are**  
15 **necessary for the objectives and programs of the department.**

16 **SECTION 12.** ORS 285A.050 is amended to read:

17 285A.050. (1) The Oregon [*Economic and Community*] **Business** Development Commission shall  
18 report biennially to the Governor and the Legislative Assembly on the success of economic devel-  
19 opment efforts. The report shall include the progress toward achievement of performance measures  
20 for the [*Economic and Community*] **Oregon Business** Development Department as adopted by the  
21 Legislative Assembly. At a minimum, the report shall include the following:

22 (a) For the overall [*Economic and Community Development*] department and for [*each*] identifiable  
23 [*program*] **programs** and funding [*source*] **sources**:

- 24 (A) The number of jobs created and retained;
- 25 (B) The average wage levels of jobs created and retained; and
- 26 (C) Other measures identified by the commission.

27 (b) The status of the Oregon economy as it relates to the economic strategy outlined in ORS  
28 285A.020.

29 (c) Other issues identified by the commission.

30 (2) Reports to the Legislative Assembly required under this section shall be made in accordance  
31 with ORS 192.245.

32 **SECTION 13.** ORS 285A.055 is amended to read:

33 285A.055. Prior to the approval of bond financing of economic development projects under ORS  
34 285B.320 to 285B.371[,] **or** the making of [*a loan*] **loans** [*under ORS 285A.666 to 285A.732 or the*  
35 *making of any loan*] or the granting of any moneys from any source, the Oregon [*Economic and*  
36 *Community*] **Business** Development Commission[, *or the Economic and Community Development De-*  
37 *partment as the designee of the commission*], **or the Oregon Business Development Department**  
38 **as the designee of the commission**, shall:

39 (1) Determine that the action is cost effective, considering both major public expenses and major  
40 public benefits;

41 (2) Find that the project will produce goods or services which are sold in markets for which  
42 national or international competition exists or, if the project is to be constructed and operated by  
43 a nonprofit organization, that the project will not compete with local for-profit businesses;

44 (3) Determine that the action is the best use of the moneys involved, considering other pending  
45 applications for those moneys;

1 (4) Find that the project involved is consistent with the *[Economic and Community]* **Oregon**  
2 **Business** Development Department's comprehensive policy and programs; and

3 (5) Find that the project involved is consistent with applicable adopted local economic develop-  
4 ment plans.

5 **SECTION 14.** ORS 285A.060 is amended to read:

6 285A.060. (1) To aid and advise the Oregon *[Economic and Community]* **Business** Development  
7 Commission in the performance of its duties, the commission may establish such advisory and tech-  
8 nical committees as it considers necessary. Such committees may be continuing or temporary. The  
9 presiding officer of the commission shall determine the representation, membership, terms and or-  
10 ganization of the committees and shall appoint their members. Members shall be appointed with due  
11 consideration given to the geographic representation described in ORS 285A.040 (1). The Director

1 (c) Pledge or assign all or part of the revenues of one or more eligible projects owned or to be  
2 acquired by the state to the holders of bonds issued under this section or to a trustee for the hold-  
3 ers, and segregate the revenues or provide for payment of the revenues to the trustee.

4 (d) Mortgage or otherwise encumber eligible projects in favor of the holders of bonds issued  
5 under this section, a trustee for the holders of the bonds, or an escrow agent, vendor, lender, other  
6 financing party or trustee for the bonds without obligating the state except with respect to the

31 tirement System for the purpose of determining the eligibility of members of the retirement system  
32 for disability retirement allowances under ORS chapter 238. The information disclosed is confiden-  
33 tial and may not be used for any other purpose. The costs of disclosing information under this par-  
34 agraph shall be paid by the Public Employees Retirement System.

35 (h) Disclose to the Oregon [*Economic and Community*] **Business** Development Commission in-  
36 formation required by the commission in performing its duty under ORS 285A.050 to verify changes  
37 in employment levels following direct employer participation in [*Economic and Community*] **Oregon**  
38 **Business** Development Department programs or indirect participation through municipalities under  
39 ORS 285B.410 to 285B.482. [*and regional boards and partnerships under ORS 285B.230 to 285B.269.*]  
40 The information disclosed to the commission may include an employer's employment level, total  
41 subject wages payroll and whole hours worked. The information disclosed is confidential and may  
42 not be used for any other purpose. The commission may not disclose the information in any manner  
43 that would identify an employing unit or employee except to the extent necessary to carry out the  
44 commission's duty under ORS 285A.050. If the information disclosed under this paragraph is not  
45 prepared for the use of the Employment Department, the costs of disclosing the information shall

1 be paid by the commission.

2 (i) Disclose information to the Department of Revenue for the purpose of performing its duties  
3 under ORS 293.250 or under the revenue and tax laws of this state. The information disclosed may  
4 include the names and addresses of employers and employees and payroll data of employers and  
5 employees. The information disclosed is confidential and may not be disclosed by the Department  
6 of Revenue in any manner that would identify an employing unit or employee except to the extent  
7 necessary to carry out the department's duties under ORS 293.250 or in auditing or reviewing any  
8 report or return required or permitted to be filed under the revenue and tax laws administered by  
9 the department. The Department of Revenue may not disclose any information received to any pri-  
10 vate collection agency or for any other purpose. If the information disclosed under this paragraph  
11 is not prepared for the use of the Employment Department, the costs of disclosing the information  
12 shall be paid by the Department of Revenue.

13 (j) Disclose information to the Department of Consumer and Business Services for the purpose  
14 of performing its duties under ORS chapters 654 and 656. The information disclosed may include the  
15 name, address, number of employees and industrial classification code of an employer and payroll  
16 data of employers and employees. The information disclosed is confidential and may not be disclosed  
17 by the Department of Consumer and Business Services in any manner that would identify an em-  
18 ploying unit or employee except to the extent necessary to carry out the department's duties under  
19 ORS chapters 654 and 656, including administrative hearings and court proceedings in which the  
20 Department of Consumer and Business Services is a party. If the information disclosed under this  
21 paragraph is not prepared for the use of the Employment Department, the costs of disclosing the  
22 information shall be paid by the Department of Consumer and Business Services.

23 (k) Disclose information to the Construction Contractors Board for the purpose of performing  
24 its duties under ORS chapter 701. The information disclosed to the board may include the names and  
25 addresses of employers and status of their compliance with this chapter. If the information disclosed  
26 under this paragraph is not prepared for the use of the Employment Department, the costs of dis-  
27 closing the information shall be paid by the board.

28 (L) Disclose information to the State Fire Marshal to assist the State Fire Marshal in carrying  
29 out duties under ORS 453.307 to 453.414. The information disclosed may include the name, address,  
30 telephone number and industrial classification code of an employer. The information disclosed is  
31 confidential and may not be disclosed by the State Fire Marshal in any manner that would identify  
32 an employing unit except to the extent necessary to carry out duties under ORS 453.307 to 453.414.  
33 If the information disclosed under this paragraph is not prepared for the use of the Employment  
34 Department, the costs of disclosing the information shall be paid by the office of the State Fire  
35 Marshal.

36 (m) Disclose information to the Oregon Student Assistance Commission for the purpose of per-  
37 forming the commission's duties under ORS chapter 348 and Title IV of the Higher Education Act  
38 of 1965. The information disclosed may include the names and addresses of employers and employees  
39 and payroll data of employers and employees. The information disclosed is confidential and may not  
40 be disclosed by the commission in any manner that would identify an employing unit or employee  
41 except to the extent necessary to carry out the commission's duties under ORS chapter 348 or Title  
42 IV of the Higher Education Act of 1965. If the information disclosed under this paragraph is not  
43 prepared for the use of the Employment Department, the costs of disclosing the information shall  
44 be paid by the commission.

45 (n) Disclose information to the Department of Transportation to assist the Department of

1 Transportation in carrying out the duties of the Department of Transportation relating to collection  
2 of delinquent and liquidated debts, including taxes, under ORS 184.610 to 184.666, 184.670 to 184.733  
3 and 805.263, ORS chapter 319 and the Oregon Vehicle Code. The information disclosed may include  
4 the names and addresses of employers and employees and payroll data of employers and employees.  
5 The information disclosed is confidential and may not be disclosed by the Department of Transpor-  
6 tation in any manner that would identify an employing unit or employee except to the extent nec-  
7 essary to carry out the Department of Transportation's duties relating to collection of delinquent  
8 and liquidated debts or in auditing or reviewing any report or return required or permitted to be  
9 filed under the revenue and tax laws administered by the Department of Transportation. The De-  
10 partment of Transportation may not disclose any information received to any private collection  
11 agency or for any other purpose. If the information disclosed under this paragraph is not prepared  
12 for the use of the Employment Department, the costs of disclosing the information shall be paid by  
13 the Department of Transportation.

14 (o) Disclose to any person establishment level information secured pursuant to this chapter from  
15 federal, state and local government employing units. If the information disclosed under this para-  
16 graph is not prepared for the use of the Employment Department, the costs of disclosing the infor-  
17 mation shall be paid by the party requesting the information.

18 (p) Disclose to any person the industrial classification code assigned to an employing unit. If the  
19 information disclosed under this paragraph is not prepared for the use of the Employment Depart-  
20 ment, the costs of disclosing the information shall be paid by the party requesting the information.

21 (5) Any officer appointed by or any employee of the Director of the Employment Department  
22 who discloses confidential information, except with the authority of the director, pursuant to rules  
23 or as otherwise required by law, may be disqualified from holding any appointment or employment  
24 with the Employment Department.

25 (6) Any person or any officer or employee of an entity to whom information is disclosed by the  
26 Employment Department under this section who divulges or uses the information for any purpose  
27 other than that specified in the provision of law or agreement authorizing the use or disclosure may  
28 be disqualified from performing any service under contract or disqualified from holding any ap-  
29 pointment or employment with the state agency that engaged or employed that person, officer or  
30 employee. The Employment Department may immediately cancel or modify any information sharing  
31 agreement with an entity when a person or an officer or employee of that entity discloses confi-  
32 dential information, other than as specified in law or agreement.
