SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law.

Takes effect on 91st day following adjournment sine die.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 238A.005 is amended to read:

9 238A.005. For the purposes of this chapter:

10 (1) "Active member" means a member of the pension program or the individual account program
11 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

12 (2) "Actuarial equivalent" means a payment or series of payments having the same value as the
13 payment or series of payments replaced, computed on the basis of interest rate and mortality as-
14 sumptions adopted by the board.

15 (3) "Board" means the Public Employees Retirement Board.

16 (4) "Eligible employee" means a person who performs services for a participating public em-
17 ployer, including elected officials other than judges. "Eligible employee" does not include:

18 (a) Persons engaged as independent contractors;

19 (b) Aliens working under a training or educational visa;

20 (c) Persons, other than workers in the Industries for the Blind Program under ORS 346.190,
21 provided sheltered employment or make-work by a public employer;

22 (d) Persons categorized by a participating public employer as student employees;

23 (e) Any person who is an inmate of a state institution;

24 (f) Employees of foreign trade offices of the Economic and Community Development Department
25 who live and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g);

26 (g) An employee actively participating in an alternative retirement program established under
27 ORS 353.250 or an optional retirement plan established under ORS 341.551;

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (h) Employees of the Oregon University System who are actively participating in an optional
2 retirement plan offered under ORS 243.800;

3 (i) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,
4 for membership in the system under the provisions of ORS chapter 238 or other law;

5 (j) Any person who belongs to a class of employees who are not eligible to become members of
6 the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

7 (k) Any person who is retired under ORS 238A.100 to 238A.245 or ORS chapter 238 and who
8 continues to receive retirement benefits while employed; and

9 (L) Judges.

10 (5) "Firefighter" means:

11 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
12 duties include the fighting of fires;

13 (b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;
14 and

15 (c) An employee of the State Forestry Department who is certified by the State Forester as a
16 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
17 fires as described in ORS 477.064.

18 (6) "Fund" means the Public Employees Retirement Fund.

19 (7)(a) "Hour of service" means:

20 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
21 by a participating public employer for performance of duties in a qualifying position; and

22 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
23 during which an employee does not perform duties but for which the employee is directly or indi-
24 rectly paid or entitled to payment by a participating public employer for services in a qualifying
25 position, as long as the hour is within the number of hours regularly scheduled for the performance
26 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-
27 thorized leave.

28 (b) "Hour of service" does not include any hour for which payment is made or due under a plan
29 maintained solely for the purpose of complying with applicable workers' compensation laws or un-
30 employment compensation laws.

31 (8) "Inactive member" means a member of the pension program or the individual account pro-
32 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who
33 is not a retired member and who is not employed in a qualifying position.

34 (9) "Individual account program" means the defined contribution individual account program of
35 the Oregon Public Service Retirement Plan established under ORS 238A.025.

36 (10) "Member" means an eligible employee who has established membership in the pension pro-
37 gram or the individual account program of the Oregon Public Service Retirement Plan and whose
38 membership has not been terminated under ORS 238A.110 or 238A.310.

39 (11) "Participating public employer" means a public employer as defined in ORS 238.005 that
40 provides retirement benefits for employees of the public employer under the system.

41 (12) "Pension program" means the defined benefit pension program of the Oregon Public Service
42 Retirement Plan established under ORS 238A.025.

43 (13) "Police officer" means a police officer as described in ORS 238.005.

44 (14) "Qualifying position" means one or more jobs with one or more participating public em-
45 ployers in which an eligible employee performs 600 or more hours of service in a calendar year,

1 excluding any service in a job for which benefits are not provided under the Oregon Public Service
2 Retirement Plan pursuant to ORS 238A.070 (2).

3 (15) "Retired member" means a pension program member who is receiving a pension as provided
4 in ORS 238A.180 to 238A.195.

5 (16)(a) "Salary" means the remuneration paid to an active member in return for services to the
6 participating public employer, including remuneration in the form of living quarters, board or other
7 items of value, to the extent the remuneration is includable in the employee's taxable income under
8 Oregon law. Salary includes the additional amounts specified in paragraph (b) of this subsection,
9 but does not include the amounts specified in paragraph (c) of this subsection, regardless of whether
10 those amounts are includable in taxable income.

11 (b) "Salary" includes the following amounts:

12 (A) Payments of employee and employer money into a deferred compensation plan that are made
13 at the election of the employee.

14 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the
15 employee.

16 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit
17 plan by the employer at the election of the employee and that is not includable in the taxable in-
18 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on [August 29, 2003] **De-**
19 **cember 31, 2008.**

20 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the
21 election of the employee and that is not included in the taxable income of the employee by reason
22 of 26 U.S.C. 402(e)(3), as in effect on [August 29, 2003] **December 31, 2008.**

23 (E) Retroactive payments made to an employee to correct a clerical error, pursuant to an award
24 by a court or by order of or pursuant to a conciliation agreement with an administration agency
25 charged with enforcing federal or state law protecting the employee's rights to employment or
26 wages, which shall be allocated to and deemed paid in the periods in which the work was done or
27 in which the work would have been done.

28 (F) The amount of an employee contribution to the individual account program that is paid by
29 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
30 (1) and (2)(a).

31 (G) The amount of an employee contribution to the individual account program that is not paid
32 by the employer under ORS 238A.335.

33 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
34 652.190.

35 (c) "Salary" does not include the following amounts:

36 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
37 employer.

38 (B) Payments made on account of an employee's death.

39 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
40 leave.

41 (D) Any severance payment, accelerated payment of an employment contract for a future period
42 or advance against future wages.

43 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

44 (F) Payment for a leave of absence after the date the employer and employee have agreed that
45 no future services in a qualifying position will be performed.

1 (G) Payments for instructional services rendered to institutions of the Department of Higher
2 Education or the Oregon Health and Science University when those services are in excess of full-
3 time employment subject to this chapter. A person employed under a contract for less than 12
4 months is subject to this subparagraph only for the months covered by the contract.

5 (H) The amount of an employee contribution to the individual account program that is paid by
6 the employer and is not deducted from the compensation of the employee, as provided under ORS
7 238A.335 (1) and (2)(b).

8 (I) Any amount in excess of \$200,000 for a calendar year. If any period over which salary is
9 determined is less than 12 months, the \$200,000 limitation for that period shall be multiplied by a
10 fraction, the numerator of which is the number of months in the determination period and the de-
11 nominator of which is 12. The board shall adopt rules adjusting this dollar limit to incorporate
12 cost-of-living adjustments authorized by the Internal Revenue Service.

13 (17) "System" means the Public Employees Retirement System.

14 **SECTION 2.** ORS 238A.125 is amended to read:

15 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall
16 be paid an annual pension for the life of the member as follows:

17 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied
18 by the number of years of retirement credit attributable to service as a police officer or firefighter.

19 (b) For service as other than a police officer or firefighter, 1.5 percent of final average salary
20 multiplied by the number of years of retirement credit attributable to service as other than a police
21 officer or firefighter.

22 (2) Notwithstanding any provision of ORS 238A.100 to 238A.245, the annual benefit payable to
23 a member under the pension program and under any other tax-qualified defined benefit plan main-
24 tained by the participating public employer may not exceed the applicable limitations set forth in
25 26 U.S.C. 415(b), as in effect on [August 29, 2003] **December 31, 2008**. The Public Employees Re-
26 tirement Board shall adopt rules for the administration of this limitation, including adjustments in
27 the annual dollar limitation to reflect cost-of-living adjustments authorized by the Internal Revenue
28 Service.

29 (3) The board shall make no actuarial adjustment in a member's pension calculated under this
30 section by reason of the member's retirement after normal retirement age.

31 **SECTION 3.** ORS 238A.150 is amended to read:

32 238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to 238A.245, an eligible em-
33 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
34 vices, and who subsequently returns to employment with a participating public employer with
35 reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the
36 probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS
37 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2)
38 of this section.

39 (2) The board shall adopt rules establishing benefits and service credit for any period of service
40 in the uniformed services by an employee described in subsection (1) of this section. For the purpose
41 of adopting rules under this subsection, the board shall consider and take into account all federal
42 law relating to benefits and service credit for any period of service in the uniformed services, in-
43 cluding 26 U.S.C. 414(u), as in effect on [August 29, 2003] **December 31, 2008**. Benefits and service
44 credit under rules adopted by the board pursuant to this subsection may not exceed benefits and
45 service credit required under federal law for periods of service in the uniformed services.

1 **SECTION 4.** ORS 238A.170 is amended to read:

2 238A.170. (1) An active member of the pension program who is 70-1/2 years of age or older must
3 retire not later than April 1 of the calendar year following the calendar year in which the member
4 terminates employment with all participating public employers. An inactive member of the pension
5 program must retire not later than April 1 of the calendar year following the calendar year in which
6 the member attains 70-1/2 years of age.

7 (2) Notwithstanding any other provision of ORS 238A.100 to 238A.245, the entire interest of a
8 member of the pension program must be distributed over a time period commencing no later than
9 the required beginning date set forth in subsection (1) of this section, and must be distributed in a
10 manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regu-
11 lations implementing that section, as in effect on [August 29, 2003] **December 31, 2008**. The Public
12 Employees Retirement Board shall adopt rules implementing those minimum distribution require-
13 ments.

14 **SECTION 5.** ORS 238A.230 is amended to read:

15 238A.230. (1) If a member of the pension program who is vested dies before the member's effec-
16 tive date of retirement, the Public Employees Retirement Board shall pay the death benefit provided
17 for in this section to the spouse of the member or to any other person who is constitutionally re-
18 quired to be treated in the same manner as a spouse for the purpose of retirement benefits.

19 (2)(a) The death benefit to be paid under this section shall be for the life of the spouse or other
20 person who is constitutionally required to be treated in the same manner as a spouse, and shall be
21 the actuarial equivalent of 50 percent of the pension that would otherwise have been paid to the
22 deceased member.

23 (b) For the purpose of paragraph (a) of this subsection, the amount of the pension that would
24 otherwise have been paid to the deceased member shall be calculated:

25 (A) As of the date of death if the member dies after the earliest retirement date for the member
26 under ORS 238A.165; or

27 (B) As if the member became an inactive member on the date of death and thereafter retired
28 at the earliest retirement date if the member dies before the earliest retirement date for the member
29 under ORS 238A.165.

30 (3) The death benefit provided under this section is first effective on the first day of the month
31 following the date of death of the member. The surviving spouse or other person entitled to the
32 death benefit may elect to delay payment of the death benefit, but payment must commence no later
33 than December 31 of the calendar year in which the member would have reached 70-1/2 years of age.

34 (4) Notwithstanding any other provision of ORS 238A.100 to 238A.245, distributions of death
35 benefits under the pension program must comply with the minimum distribution requirements of 26
36 U.S.C. 401(a)(9) and the regulations implementing that section, as in effect on [August 29, 2003]
37 **December 31, 2008**. The board shall adopt rules implementing those minimum distribution require-
38 ments.

39 **SECTION 6.** ORS 238A.370 is amended to read:

40 238A.370. Notwithstanding any other provision of ORS 238A.300 to 238A.415, the annual addition
41 to the employee and employer accounts of a member of the individual account program for a cal-
42 endar year, together with the annual additions to the accounts of the member under any other de-
43 fined contribution plan maintained by the participating public employer for a calendar year, may
44 not exceed the lesser of \$40,000, or 100 percent of the member's compensation for that calendar year.
45 For purposes of this section, "annual addition" has the meaning given that term in 26 U.S.C.

1 415(c)(2), as in effect on [August 29, 2003] **December 31, 2008**, and “compensation” has the meaning
 2 given the term “participant’s compensation” in 26 U.S.C. 415(c)(3), as in effect on [August 29, 2003]
 3 **December 31, 2008**. The Public Employees Retirement Board shall adopt rules for the adminis-
 4 tration of this limitation, including adjustments in the annual dollar limitation to reflect cost-of-
 5 living adjustments authorized by the Internal Revenue Service.

6 **SECTION 7.** ORS 238A.400 is amended to read:

7 238A.400. (1) Upon retirement on or after the earliest retirement date, as described in ORS
 8 238A.165, a member of the individual account program shall receive in a lump sum the amounts in
 9 the member’s employee account, rollover account and employer account to the extent the member
 10 is vested in those accounts under ORS 238A.320.

11 (2) In lieu of a lump sum payment under subsection (1) of this section, a member of the individ-
 12 ual account program may elect to receive the amounts in the member’s employee account and em-
 13 ployer account, to the extent the member is vested in those accounts under ORS 238A.320, in
 14 substantially equal installments paid over a period of 5, 10, 15 or 20 years, or over a period that is
 15 equal to the anticipated life span of the member as actuarially determined by the Public Employees
 16 Retirement Board. Installments may be made on a monthly, quarterly or annual basis. In no event
 17 may the period selected by the member exceed the time allowed by the minimum distribution re-
 18 quirements described in subsection (5) of this section. The board shall by rule establish the manner
 19 in which installments will be adjusted to reflect investment gains and losses on the unpaid balance
 20 during the payout period elected by the member under this subsection. The board by rule may es-
 21 tablish minimum monthly amounts payable under this subsection. The board may require that a
 22 lump sum payment, or an installment schedule different than the schedules provided for in this
 23 subsection, be used to pay the vested amounts in the member’s accounts if those amounts are not
 24 adequate to generate the minimum monthly amounts specified by the rule.

25 (3) A member of the individual account program electing to receive installments under sub-
 26 section (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies
 27 before all amounts in the employee and vested employer accounts are paid, all remaining installment
 28 payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary
 29 may elect to receive a lump sum distribution of the remaining amounts.

30 (4) A member who is entitled to receive retirement benefits under ORS chapter 238 may receive
 31 vested amounts in the member’s employee account, rollover account and employer account in the
 32 manner provided by this section when the member retires for service under the provisions of ORS
 33 chapter 238.

34 (5) Notwithstanding any other provision of ORS 238A.300 to 238A.415, the entire interest of a
 35 member of the individual account program must be distributed over a time period commencing no
 36 later than the latest retirement date set forth in ORS 238A.170, and must be distributed in a manner
 37 that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations im-
 38 plementing that section, as in effect on [January 1, 2008] **December 31, 2008**. The board shall adopt
 39 rules implementing those minimum distribution requirements.

40 **SECTION 8.** ORS 238A.410 is amended to read:

41 238A.410. (1) If a member of the individual account program dies before retirement, the amounts
 42 in the member’s employee account, rollover account and employer account, to the extent the member
 43 is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the beneficiary or
 44 beneficiaries designated by the member for the purposes of this section.

45 (2) If a member of the individual account program is married at the time of death, or there exists

1 at the time of death any other person who is constitutionally required to be treated in the same
 2 manner as a spouse for the purpose of retirement benefits, the spouse or other person shall be the
 3 beneficiary for purposes of the death benefit payable under this section unless the spouse or other
 4 person consents to the designation of a different beneficiary or beneficiaries before the designation
 5 has been made and the consent has not been revoked by the spouse or other person as of the time
 6 of the member's death. Consent and revocation of consent must be in writing, acknowledged by a
 7 notary public, and submitted to the Public Employees Retirement Board in accordance with rules
 8 adopted by the board. If the member's spouse is designated as the member's beneficiary and the
 9 marriage of the member and spouse is subsequently dissolved, the former spouse shall be treated as
 10 predeceasing the member for purposes of this section, unless the member expressly designates the
 11 former spouse as beneficiary after the effective date of the dissolution or the former spouse is re-
 12 quired to be designated as a beneficiary under the provisions of ORS 238.465.

13 (3) For purposes of this section and ORS 238A.400 (3), if a member fails to designate a benefi-
 14 ciary, or if the person or persons designated do not survive the member, the death benefit provided
 15 for in this section shall be paid to the following person or persons, in the following order of priority:

16 (a) The member's surviving spouse or other person who is constitutionally required to be treated
 17 in the same manner as a spouse;

18 (b) The member's surviving children, in equal shares; or

19 (c) The member's estate.

20 (4) The entire amount of a deceased member's vested accounts must be distributed by December
 21 31 of the fifth calendar year after the year in which the member died. Notwithstanding any other
 22 provision of this chapter, distributions of death benefits under the individual account program must
 23 comply with the minimum distribution requirements of 26 U.S.C. 401(a)(9) and the regulations im-
 24 plementing that section, as in effect on [August 29, 2003] **December 31, 2008**. The Public Employees
 25 Retirement Board shall adopt rules implementing those minimum distribution requirements.

26 **SECTION 9.** ORS 238A.415 is amended to read:

27 238A.415. (1) Notwithstanding any other provision of ORS 238A.300 to 238A.415, an eligible em-
 28 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
 29 vices, and who subsequently returns to employment with a participating public employer with
 30 reemployment rights under federal law, is entitled to credit toward the probationary period required
 31 by ORS 238A.300, credit toward the vesting requirements of ORS 238A.320 and contributions under
 32 rules adopted by the Public Employees Retirement Board pursuant to subsection (2) of this section.

33 (2) The board shall adopt rules establishing contributions and service credit for any period of
 34 service in the uniformed services by an employee described in subsection (1) of this section. For the
 35 purpose of adopting rules under this subsection, the board shall consider and take into account all
 36 federal law relating to benefits and service credit for any period of service in the uniformed ser-
 37 vices, including 26 U.S.C. 414(u), as in effect on [August 29, 2003] **December 31, 2008**. Contributions
 38 and service credit under rules adopted by the board pursuant to this subsection may not exceed
 39 contributions and service credit required under federal law for periods of service in the uniformed
 40 services.

41 **SECTION 10.** ORS 238A.430 is amended to read:

42 238A.430. (1) To the extent required by law, and except as otherwise provided by rules adopted
 43 by the Public Employees Retirement Board under subsection (4) of this section, any portion of a
 44 distribution of benefits described in subsection (2) of this section shall, at the election of and in lieu
 45 of distribution to the distributee, be paid directly to an eligible retirement plan specified by the

1 distributee.

2 (2) The provisions of subsection (1) of this section apply to a distribution of any benefit under
3 the pension program or the individual account program except:

4 (a) A distribution that is one of a series of substantially equal periodic payments made at least
5 annually for the life or life expectancy of the distributee, or for the joint lives or life expectancies
6 of the distributee and a designated beneficiary;

7 (b) A distribution that is one of a series of substantially equal periodic payments made at least
8 annually for a specified period of 10 years or more; and

9 (c) A distribution to the extent that the distribution is required under 26 U.S.C. 401(a)(9).

10 (3) The provisions of subsection (1) of this section apply to any portion of a distribution of
11 benefits under the pension program or the individual account program even though the portion
12 consists of after-tax employee contributions that are not includable in gross income. Any portion of
13 a distribution that consists of after-tax employee contributions that are not includable in gross in-
14 come may be transferred only to an individual retirement account or annuity described in 26 U.S.C.
15 408(a) or (b), or to a qualified defined contribution **or defined benefit** plan described in 26 U.S.C.
16 401(a) or [403(a)] **403(b)** that agrees to account separately for amounts transferred, including ac-
17 counting separately for the portion of the distribution that is includable in gross income and the
18 portion of the distribution that is not includable in gross income. The amount transferred shall be
19 treated as consisting first of the portion of the distribution that is includable in gross income, de-
20 termined without regard to 26 U.S.C. 402(c)(1).

21 (4) The board shall adopt rules implementing the direct rollover requirements of 26 U.S.C.
22 401(a)(31) and the regulations implementing that section, and may adopt administrative exceptions
23 to the direct rollover requirements to the extent permitted by 26 U.S.C. 401(a)(31) and the regu-
24 lations implementing that section.

25 (5) All references in this section to federal laws and regulations are to the laws and regulations
26 in effect on [August 29, 2003] **December 31, 2008**.

27 (6) For purposes of this section:

28 (a) "Distributee" means a member, a member's surviving spouse or a member's alternate payee
29 under ORS 238.465.

30 (b) "Eligible retirement plan" means:

31 (A) An individual retirement account described in 26 U.S.C. 408(a);

32 (B) An individual retirement annuity described in 26 U.S.C. 408(b), other than an endowment
33 contract;

34 (C) A qualified trust under 26 U.S.C. 401(a), that is a defined contribution **or defined benefit**
35 plan and permits the acceptance of rollover contributions;

36 (D) An annuity plan described in 26 U.S.C. 403(a);

37 (E) An eligible deferred compensation plan described in 26 U.S.C. 457(b) that is maintained by
38 an eligible governmental employer described in 26 U.S.C. 457(e)(1)(A) and that agrees to account
39 separately for amounts transferred into such plan from the distributing plan; or

40 (F) An annuity contract described in 26 U.S.C. 403(b).

41 **SECTION 11.** ORS 305.230, as amended by section 1, chapter 45, Oregon Laws 2008, is amended
42 to read:

43 305.230. (1) Notwithstanding ORS 9.320:

44 (a) Any person who is qualified to practice law or public accountancy in this state, any person
45 who has been granted active enrollment to practice before the Internal Revenue Service and who

1 is qualified to prepare tax returns in this state or any person who is the authorized employee of a
2 taxpayer and is regularly employed by the taxpayer in tax matters may represent the taxpayer be-
3 fore a tax court magistrate or the Department of Revenue in any conference or proceeding with
4 respect to the administration of any tax.

6 such licensing requirement as provided for and limited by ORS 673.610 may represent a taxpayer
7 before a tax court magistrate or the department in any conference or proceeding with respect to the
8 administration of any tax on or measured by net income.

9 (c) Any shareholder of an S corporation, as defined in section 1361 of the Internal Revenue
10 Code, as amended and in effect on December 31, [2007] **2008**, may represent the corporation in any
11 proceeding before a tax court magistrate or the department in the same manner as if the share-
12 holder were a partner and the S corporation were a partnership. The S corporation must designate
13 in writing a tax matters shareholder authorized to represent the S corporation.

14 (d) An individual who is licensed as a real estate broker or principal real estate broker under
15 ORS 696.022 or is a state certified appraiser or state licensed appraiser under ORS 674.310 or is a
16 registered appraiser under ORS 308.010 may represent a taxpayer before a tax court magistrate or
17 the department in any conference or proceeding with respect to the administration of any ad
18 valorem property tax.

19 (e) A general partner who has been designated by members of a partnership as their tax matters
20 partner under ORS 305.242 may represent those partners in any conference or proceeding with re-
21 spect to the administration of any tax on or measured by net income.

22 (f) Any person authorized under rules adopted by the department may represent a taxpayer be-
23 fore the department in any conference or proceeding with respect to any tax. Rules adopted under
24 this paragraph, to the extent feasible, shall be consistent with federal law that governs represen-
25 tation before the Internal Revenue Service, as federal law is amended and in effect on December 31,
26 [2007] **2008**.

27 (g) Any person authorized under rules adopted by the tax court may represent a taxpayer in a
28 proceeding before a tax court magistrate.

29 (2) A person may not be recognized as representing a taxpayer pursuant to this section unless
30 there is first filed with the magistrate or department a written authorization, or unless it appears
31 to the satisfaction of the magistrate or department that the representative does in fact have au-
32 thority to represent the taxpayer. A person recognized as an authorized representative under rules
33 or procedures adopted by the tax court shall be considered an authorized representative by the de-

18 intended to interpret the terms of section 11b, Article XI of the Oregon Constitution, as originally
19 adopted and as amended by section 11 (11), Article XI of the Oregon Constitution, consistent with
20 the intent of the people in adopting these provisions, so that the provisions of section 11b, Article
21 XI of the Oregon Constitution, may be given effect uniformly throughout the State of Oregon, with

23 revenue and tax laws of this state, and for purposes of section 11b, Article XI of the Oregon Con-

25 (1) "Actual cost" means all direct or indirect costs incurred by a government unit in order to
26 deliver goods or services or to undertake a capital construction project. The "actual cost" of pro-
27 viding goods or services to a property or property owner includes the average cost or an allocated
28 portion of the total amount of the actual cost of making a good or service available to the property
29 or property owner, whether stated as a minimum, fixed or variable amount. "Actual cost" includes,
30 but is not limited to, the costs of labor, materials, supplies, equipment rental, property acquisition,
31 permits, engineering, financing, reasonable program delinquencies, return on investment, required
32 fees, insurance, administration, accounting, depreciation, amortization, operation, maintenance, re-
33 pair or replacement and debt service, including debt service payments or payments into reserve ac-
34 counts for debt service and payment of amounts necessary to meet debt service coverage
35 requirements.

36 (2) "Assessment for local improvement" means any tax, fee, charge or assessment that does not
37 exceed the actual cost incurred by a unit of government for design, construction and financing of
38 a local improvement.

39 (3) "Bonded indebtedness" means any formally executed written agreement representing a
40 promise by a unit of government to pay to another a specified sum of money, at a specified date or
41 dates at least one year in the future.

42 (4) "Capital construction":

43 (a) For bonded indebtedness issued prior to December 5, 1996, and for the proceeds of any
44 bonded indebtedness approved by electors prior to December 5, 1996, that were spent or
45 contractually obligated to be spent prior to June 20, 1997, means the construction, modification,

1 replacement, repair, remodeling or renovation of a structure, or addition to a structure, that is ex-
2 pected to have a useful life of more than one year, and includes, but is not limited to:

3 (A) Acquisition of land, or a legal interest in land, in conjunction with the capital construction
4 of a structure.

5 (B) Acquisition, installation of machinery or equipment, furnishings or materials that will be-
6 come an integral part of a structure.

7 (C) Activities related to the capital construction, including planning, design, authorizing, issuing,
8 carrying or repaying interim or permanent financing, research, land use and environmental impact
9 studies, acquisition of permits or licenses or other services connected with the construction.

10 (D) Acquisition of existing structures, or legal interests in structures, in conjunction with the
11 capital construction.

12 (b) For bonded indebtedness issued on or after December 5, 1996, except for the proceeds of any
13 bonded indebtedness approved by electors prior to December 5, 1996, that were spent or
14 contractually obligated to be spent before June 20, 1997, has the meaning given that term in para-
15 graph (a) of this subsection, except that “capital construction”:

16 (A) Includes public safety and law enforcement vehicles with a projected useful life of five years
17 or more; and

18 (B) Does not include:

19 (i) Maintenance and repairs, the need for which could be reasonably anticipated;

20 (ii) Supplies and equipment that are not intrinsic to the structure; or

21 (iii) Furnishings, unless the furnishings are acquired in connection with the acquisition, con-
22 struction, remodeling or renovation of a structure, or the repair of a structure that is required be-
23 cause of damage or destruction of the structure.

24 (5) “Capital improvements”:

25 (a) For bonded indebtedness issued prior to December 5, 1996, and for the proceeds of any
26 bonded indebtedness approved by electors before December 5, 1996, that were spent or contractually
27 obligated to be spent before June 20, 1997, means land, structures, facilities, personal property that
28 is functionally related and subordinate to real property, machinery, equipment or furnishings having
29 a useful life longer than one year.

30 (b) For bonded indebtedness issued on or after December 5, 1996, except for the proceeds of any
31 bonded indebtedness approved by electors prior to December 5, 1996, that were spent or
32 contractually obligated to be spent before June 20, 1997, has the meaning given that term in para-
33 graph (a) of this subsection, except that “capital improvements”:

34 (A) Includes public safety and law enforcement vehicles with a projected useful life of five years
35 or more; and

36 (B) Does not include:

37 (i) Maintenance and repairs, the need for which could be reasonably anticipated;

38 (ii) Supplies and equipment that are not intrinsic to the structure; or

39 (iii) Furnishings, unless the furnishings are acquired in connection with the acquisition, con-
40 struction, remodeling or renovation of a structure, or the repair of a structure that is required be-

42 (6) “Direct consequence of ownership” means that the obligation of the owner of property to pay

45 tervening transaction, condition or event.

1 (7)(a) "Exempt bonded indebtedness" means:

2 (A) Bonded indebtedness authorized by a specific provision of the Oregon Constitution;

3 (B) Bonded indebtedness incurred or to be incurred for capital construction or capital improve-
4 ments that was issued as a general obligation of the issuing governmental unit on or before No-
5 vember 6, 1990;

6 (C) Bonded indebtedness incurred or to be incurred for capital construction or capital improve-
7 ments that was issued as a general obligation of the issuing governmental unit after November 6,

13 (b) "Exempt bonded indebtedness" includes bonded indebtedness issued to refund or refinance

15 (8)(a) "Incurred charge" means a charge imposed by a unit of government on property or upon
16 a property owner that does not exceed the actual cost of providing goods or services and that can
17 be controlled or avoided by the property owner because:

18 (A) The charge is based on the quantity of the goods or services used, and the owner has direct
19 control over the quantity;

20 (B) The goods or services are provided only on the specific request of the property owner; or

21 (C) The goods or services are provided by the government unit only after the individual property
22 owner has failed to meet routine obligations of ownership of the affected property, and such action
23 is deemed necessary by an appropriate government unit to enforce regulations pertaining to health

25 (b) For purposes of this subsection, an owner of property may control or avoid an incurred

29 over the quantity of goods or services if the owner of property has the ability, whether or not that
30 ability is exercised, to determine the quantity of goods or services provided or to be provided.

31 (9)(a) "Local improvement" means a capital construction project, or part thereof, undertaken by
32 a local government, pursuant to ORS 223.387 to 223.399, or pursuant to a local ordinance or resol-
33 ution prescribing the procedure to be followed in making local assessments for benefits from a local
34 improvement upon the lots that have been benefited by all or a part of the improvement:

35 (A) That provides a special benefit only to specific properties or rectifies a problem caused by
36 specific properties;

37 (B) The costs of which are assessed against those properties in a single assessment upon the
38 completion of the project; and

39 (C) For which the property owner may elect to make payment of the assessment plus appropriate
40 interest over a period of at least 10 years.

41 (b) For purposes of paragraph (a) of this subsection, the status of a capital construction project
42 as a local improvement is not affected by the accrual of a general benefit to property other than the
43 property receiving the special benefit.

44 (10) "Maintenance and repairs, the need for which could be reasonably anticipated":

45 (a) Means activities, the type of which may be deducted as an expense under the provisions of

1 the federal Internal Revenue Code, as amended and in effect on December 31, [2007] **2008**, that keep
2 the property in ordinarily efficient operating condition and that do not add materially to the value
3 of the property nor appreciably prolong the life of the property;

4 (b) Does not include maintenance and repair of property that is required by damage, destruction
5 or defect in design, or that was otherwise not reasonably expected at the time the property was
6 constructed or acquired, or the addition of material that is in the nature of the replacement of
7 property and that arrests the deterioration or appreciably prolongs the useful life of the property;
8 and

9 (c) Does not include street and highway construction, overlay and reconstruction.

10 (11) "Projected useful life" means the useful life, as reasonably estimated by the unit of gov-
11 ernment undertaking the capital construction or capital improvement project, beginning with the
12 date the property was acquired, constructed or reconstructed and based on the property's condition
13 at the time the property was acquired, constructed or reconstructed.

14 (12) "Routine obligations of ownership" means a standard of operation, maintenance, use or care
15 of property established by law, or if established by custom or common law, a standard that is rea-
16 sonable for the type of property affected.

17 (13) "Single assessment" means the complete assessment process, including preassessment, as-
18 sessment or reassessment, for any local improvement authorized by ORS 223.387 to 223.399, or a
19 local ordinance or resolution that provides the procedure to be followed in making local assessments
20 for benefits from a local improvement upon lots that have been benefited by all or part of the im-
21 provement.

22 (14) "Special benefit only to specific properties" shall have the same meaning as "special and
23 peculiar benefit" as that term is used in ORS 223.389.

24 (15) "Specific request" means:

25 (a) An affirmative act by a property owner to seek or obtain delivery of goods or services;

26 (b) An affirmative act by a property owner, the legal consequence of which is to cause the de-
27 livery of goods or services to the property owner; or

28 (c) Failure of an owner of property to change a request for goods or services made by a prior
29 owner of the property.

30 (16) "Structure" means any temporary or permanent building or improvement to real property
31 of any kind that is constructed on or attached to real property, whether above, on or beneath the
32 surface.

33 (17) "Supplies and equipment intrinsic to a structure" means the supplies and equipment that
34 are necessary to permit a structure to perform the functions for which the structure was con-
35 structed, or that will, upon installation, constitute fixtures considered to be part of the real property
36 that is comprised, in whole or part, of the structure and land supporting the structure.

37 (18) "Tax on property" means any tax, fee, charge or assessment imposed by any government
38 unit upon property or upon a property owner as a direct consequence of ownership of that property,
39 but does not include incurred charges or assessments for local improvements. As used in this sub-
40 section, "property" means real or tangible personal property, and intangible property that is part
41 of a unit of real or tangible personal property to the extent that such intangible property is subject
42 to a tax on property.

43 **SECTION 18.** ORS 310.630, as amended by section 8, chapter 45, Oregon Laws 2008, is amended
44 to read:

45 310.630. As used in ORS 310.630 to 310.706:

1 (1) "Contract rent" means rental paid to the landlord for the right to occupy a homestead, in-
2 cluding the right to use the personal property located therein. "Contract rent" does not include
3 rental paid for the right to occupy a homestead that is exempt from taxation, unless payments in lieu
4 of taxes of 10 percent or more of the rental exclusive of fuel and utilities are made on behalf of the
5 homestead. "Contract rent" does not include advanced rental payments for another period and rental
6 deposits, whether or not expressly set out in the rental agreement, or payments made to a nonprofit
7 home for the elderly described in ORS 307.375. If a landlord and tenant have not dealt with each
8 other at arm's length, and the Department of Revenue is satisfied that the contract rent charged
9 was excessive, it may adjust the contract rent to a reasonable amount for purposes of ORS 310.630
10 to 310.706.

11 (2) "Department" means the Department of Revenue.

12 (3) "Fuel and utility payments" includes payments for heat, lights, water, sewer and garbage
13 made solely to secure those commodities or services for the homestead of the taxpayer. "Fuel and
14 utility payments" does not include telephone service.

15 (4) "Gross rent" means contract rent paid plus the fuel and utility payments made for the
16 homestead in addition to the contract rent, during the calendar year for which the claim is filed.

17 (5) "Homestead" means the taxable principal dwelling located in Oregon, either real or personal
18 property, rented by the taxpayer, and the taxable land area of the tax lot upon which it is built.

19 (6) "Household" means the taxpayer, the spouse of the taxpayer and all other persons residing
20 in the homestead during any part of the calendar year for which a claim is filed.

21 (7) "Household income" means the aggregate income of the taxpayer and the spouse of the tax-
22 payer who reside in the household, that was received during the calendar year for which the claim
23 is filed. "Household income" includes payments received by the taxpayer or the spouse of the tax-
24 payer under the federal Social Security Act for the benefit of a minor child or minor children who
25 are members of the household.

26 (8) "Income" means "adjusted gross income" as defined in the federal Internal Revenue Code,
27 as amended and in effect on December 31, [2007] **2008**, even when the amendments take effect or
28 become operative after that date, relating to the measurement of taxable income of individuals, es-
29 tates and trusts, with the following modifications:

30 (a) There shall be added to adjusted gross income the following items of otherwise exempt in-
31 come:

32 (A) The gross amount of any otherwise exempt pension less return of investment, if any.

33 (B) Child support received by the taxpayer.

34 (C) Inheritances.

35 (D) Gifts and grants, the sum of which are in excess of \$500 per year.

36 (E) Amounts received by a taxpayer or spouse of a taxpayer for support from a parent who is
37 not a member of the taxpayer's household.

38 (F) Life insurance proceeds.

39 (G) Accident and health insurance proceeds, except reimbursement of incurred medical expenses.

40 (H) Personal injury damages.

41 (I) Sick pay which is not included in federal adjusted gross income.

42 (J) Strike benefits excluded from federal gross income.

43 (K) Worker's compensation, except for reimbursement of medical expense.

44 (L) Military pay and benefits.

45 (M) Veteran's benefits.

1 (N) Payments received under the federal Social Security Act which are excluded from federal
2 gross income.

3 (O) Welfare payments, except as follows:

4 (i) Payments for medical care, drugs and medical supplies, if the payments are not made directly
5 to the welfare recipient;

6 (ii) In-home services authorized and approved by the Department of Human Services; and

7 (iii) Direct or indirect reimbursement of expenses paid or incurred for participation in work or
8 training programs.

9 (P) Nontaxable dividends.

10 (Q) Nontaxable interest not included in federal adjusted gross income.

11 (R) Rental allowance paid to a minister that is excluded from federal gross income.

12 (S) Income from sources without the United States that is excluded from federal gross income.

13 (b) Adjusted gross income shall be increased due to the disallowance of the following deductions:

14 (A) The amount of the net loss, in excess of \$1,000, from all dispositions of tangible or intangible
15 properties.

16 (B) The amount of the net loss, in excess of \$1,000, from the operation of a farm or farms.

17 (C) The amount of the net loss, in excess of \$1,000, from all operations of a trade or business,
18 profession or other activity entered into for the production or collection of income.

19 (D) The amount of the net loss, in excess of \$1,000, from tangible or intangible property held for
20 the production of rents, royalties or other income.

21 (E) The amount of any net operating loss carryovers or carrybacks included in federal adjusted
22 gross income.

25 (G) The amount added or subtracted, as required within the context of this section, for adjust-

27 (c) "Income" does not include any of the following:

28 (A) Any governmental grant which must be used by the taxpayer for rehabilitation of the
29 homestead of the taxpayer.

9 (a) "Annual rate" means the yearly interest rate specified on the note, and not the annual per-
10 centage rate, if any, disclosed to the applicant to comply with the federal Truth in Lending Act.

11 (b) "Finance charge" means the total of all interest, loan fees, interest on any loan fees financed
12 by the lending institution, and other charges related to the cost of obtaining credit.

13 (c) "Lending institution" means any insured institution, as that term is defined in ORS 706.008,
14 any mortgage banking company that maintains an office in this state or any community development
15 corporation that is organized under the Oregon Nonprofit Corporation Law.

16 (d) "Manufactured dwelling park" has the meaning given that term in ORS 446.003.

17 (e) "Nonprofit corporation" means a corporation that is exempt from income taxes under section
18 501(c)(3) or (4) of the Internal Revenue Code as amended and in effect on December 31, [2007]
19 **2008**.

20 (f) "Preservation project" means housing that was previously developed as affordable housing
21 with a contract for rent assistance from the United States Department of Housing and Urban De-
22 velopment or the United States Department of Agriculture and that is being acquired by a spon-
23 soring entity.

24 (g) "Qualified assignee" means any investor participating in the secondary market for real estate
25 loans.

26 (h) "Qualified borrower" means any borrower that is a sponsoring entity that has a controlling
27 interest in the real property that is financed by the loan described in subsection (4) of this section.
28 Such a controlling interest includes, but is not limited to, a controlling interest in the general
29 partner of a limited partnership that owns the real property.

30 (i) "Sponsoring entity" means a nonprofit corporation, nonprofit cooperative, state governmental
31 entity, local unit of government as defined in ORS 466.706, housing authority or any other person,
32 provided that the person has agreed to restrictive covenants imposed by a nonprofit corporation,
33 nonprofit cooperative, state governmental entity, local unit of government or housing authority.

34 (11) Notwithstanding any other provision of law, a lending institution that is a community de-
35 velopment corporation organized under the Oregon Nonprofit Corporation Law may transfer any
36 part or all of any tax credit arising under subsection (1) of this section to one or more other lending
37 institutions that are stockholders or members of the community development corporation or that
38 otherwise participate through the community development corporation in the making of one or more
39 loans that generate the tax credit under subsection (1) of this section.

40 (12) The lending institution shall file an annual statement with the Housing and Community
41 Services Department, specifying that it has conformed with all requirements imposed by law to
42 qualify for this tax credit.

43 (13) The Housing and Community Services Department and the Department of Revenue may
44 adopt rules to carry out the provisions of this section.

4 (1) "Account holder" means a resident of this state who:

5 (a) Is 12 years of age or older;

6 (b) Is a member of a lower income household; and

7 (c) Has established an individual development account with a fiduciary organization.

8 (2) "Fiduciary organization" means an organization selected under ORS 458.695 to administer
9 state moneys directed to individual development accounts and that is:

10 (a) A nonprofit, fund raising organization that is exempt from taxation under section 501(c)(3)
11 of the Internal Revenue Code as amended and in effect on December 31, [2007] **2008**; or

12 (b) A federally recognized Oregon Indian tribe that is located, to a significant degree, within the
13 boundaries of this state.

14 (3) "Financial institution" means:

15 (a) An organization regulated under ORS chapters 706 to 716, 722 or 723; or

16 (b) In the case of individual development accounts established for the purpose described in ORS
17 458.685 (1)(c), a financial institution as defined in ORS 348.841.

18 (4) "Individual development account" means a contract between an account holder and a
19 fiduciary organization, for the deposit of funds into a financial institution by the account holder, and
20 the deposit of matching funds into the financial institution by the fiduciary organization, to allow
21 the account holder to accumulate assets for use toward achieving a specific purpose approved by
22 the fiduciary organization.

23 (5) "Lower income household" means a household having an income equal to or less than 80
24 percent of the median household income for the area as determined by the Housing and Community
25 Services Department. In making the determination, the department shall give consideration to any
26 data on area household income published by the United States Department of Housing and Urban
27 Development.

28 (6) "Resident of this state" has the meaning given that term in ORS 316.027.

29 **SECTION 27.** ORS 657.010, as amended by section 17, chapter 45, Oregon Laws 2008, is
30 amended to read:

31 657.010. As used in this chapter, unless the context requires otherwise:

32 (1) "Base year" means the first four of the last five completed calendar quarters preceding the
33 benefit year.

34 (2) "Benefits" means the money allowances payable to unemployed persons under this chapter.

35 (3) "Benefit year" means a period of 52 consecutive weeks commencing with the first week with
36 respect to which an individual files an initial valid claim for benefits, and thereafter the 52 consec-
37 utive weeks period beginning with the first week with respect to which the individual next files an
38 initial valid claim after the termination of the individual's last preceding benefit year except that
39 the benefit year shall be 53 weeks if the filing of an initial valid claim would result in overlapping
40 any quarter of the base year of a previously filed initial valid claim.

41 (4) "Calendar quarter" means the period of three consecutive calendar months ending on March
42 31, June 30, September 30 or December 31, or the approximate equivalent thereof, as the Director
43 of the Employment Department may, by regulation, prescribe.

44 (5) "Contribution" or "contributions" means the taxes, as defined in subsection (13) of this sec-

33 Columbia and Puerto Rico. However, for all purposes of this chapter the Virgin Islands shall be
34 considered a state on and after the day on which the United States Secretary of Labor first approves
35 the Virgin Islands' law under section 3304(a) of the Federal Unemployment Tax Act as amended by

37 (13) "Taxes" means the money payments to the Unemployment Compensation Trust Fund re-
38 quired, or voluntary payments permitted, by this chapter.

39 (14) "Valid claim" means any claim for benefits made in accordance with ORS 657.260 if the
40 individual meets the wages-paid-for-employment requirements of ORS 657.150.

41 (15) "Week" means any period of seven consecutive calendar days ending at midnight, as the
42 director may, by regulation, prescribe. The director may by regulation prescribe that a "week" shall
43 be "in," "within," or "during" the calendar quarter that includes the greater part of such week.

10 law amending the Internal Revenue Code apply for Oregon personal income and corporate
11 excise and income tax purposes, to the extent they can be made applicable, in the same
12 manner as they are applied under the Internal Revenue Code and related federal law.

13 (3)(a) If a deficiency is assessed against any taxpayer for a tax year beginning before
14 January 1, 2009, and the deficiency or any portion thereof is attributable to any retroactive

29 fore January 1, 2010, shall be made by filing an amended return within the time prescribed
30 by law.

31 (d) If a taxpayer fails to file an amended return under paragraph (c) of this subsection,
32 the Department of Revenue shall make any changes under paragraph (c) of this subsection
33 on the return to which the changes relate within the period specified for issuing a notice of
34 deficiency or claiming a refund as otherwise provided by law with respect to that return, or
35 within one year after a return for a tax year beginning on or after January 1, 2009, and be-
36 fore January 1, 2010, is filed, whichever period expires later.

1 317.018. It is the intent of the Legislative Assembly:

2 (1) To make the Oregon corporate excise tax law, insofar as it relates to the measurement of
3 taxable income, identical to the provisions of the federal Internal Revenue Code, as in effect and
4 applicable [*for the tax year of the taxpayer*] **on December 31, 2008**, to the end that taxable income
5 of a corporation for Oregon purposes is the same as it is for federal income tax purposes, subject
6 to Oregon's jurisdiction to tax, and subject to the additions, subtractions, adjustments and modifi-
7 cations contained in this chapter.

8 (2) To achieve the results desired under subsection (1) of this section by application of the var-
9 ious provisions of the federal Internal Revenue Code relating to the definitions for corporations, of
