### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies class of non-Oregon convictions or juvenile delinquency adjudications that require sex offender reporting.

*[Requires interstate compact administrators to determine whether person transferring supervision to Oregon is required to report as sex offender under Oregon law. Requires administrators to notify person before responding to request to transfer supervision to this state.]*

**Requires Juvenile Compact Administrator, when delinquent juvenile from another state seeks to transfer parole or probation to Oregon, to determine if delinquent juvenile is required to report as sex offender. Requires administrator to make diligent effort to ensure that state in which delinquent juvenile resides notify delinquent juvenile of obligation to report.**

7 **SECTION 1.** ORS 181.594 is amended to read:

8 181.594. As used in **this section and** ORS 181.595, 181.596, 181.597, *[and]* 181.603, **181.826,**  
9 **181.830 and 181.833:**

10 (1) **"Another United States court"** means a federal court, a military court, the tribal  
11 court of a federally recognized Indian tribe or a court of:

12 (a) **A state other than Oregon;**

13 (b) **The District of Columbia;**

14 (c) **The Commonwealth of Puerto Rico;**

15 (d) **Guam;**

16 (e) **American Samoa;**

17 (f) **The Commonwealth of the Northern Mariana Islands; or**

18 (g) **The United States Virgin Islands.**

19 *[(1)]* (2) "Attends" means is enrolled on a full-time or part-time basis.

20 *[(2)(a)]* (3)(a) "Correctional facility" means any place used for the confinement of persons:

21 (A) Charged with or convicted of a crime or otherwise confined under a court order.

5 after being found guilty except for insanity under ORS 161.290 to 161.370.

6 [(3)] (4) "Institution of higher education" means a public or private educational institution that  
7 provides a program of post-secondary education.

10 (b) Sodomy in any degree;

17 (a) Make the initial report to the appropriate agency [*or official*];

18 (b) Report when the person works at, carries on a vocation at or attends an institution of higher  
19 education;

20 (c) Report following a change of residence, school enrollment or employment status, including  
21 enrollment, employment or vocation status at an institution of higher education;

22 (d) Make an annual report; or

23 (e) Provide complete and accurate information.

24 (2) Except as otherwise provided in subsection (3) of this section, failure to report as a sex  
25 offender is a Class A misdemeanor.

36 person was under 18 years of age that would constitute a sex crime if committed in this state by  
37 an adult, the person may file a petition in the circuit court of the county in which the person resides  
38 for an order relieving the person of the duty to report if:

39 (a) The person has been registered as a sex offender in this state for at least two years;

40 (b) At least two years, but not more than five years, have elapsed since the termination of  
41 supervision on probation or parole; and

42 (c) The person submits with the petition all releases and waivers necessary to allow the district

10 (2) A person filing a petition under this section has the burden of proving by clear and con-

11 vincing evidence that the person is rehabilitated and does not pose a threat to the safety of the

12 public.

13 (3) Unless the court finds good cause for a continuance, the court shall hold a hearing on the

14 petition no sooner than 90 days and no later than 150 days after the date the petition is filed.

15 (4) Notwithstanding subsection (1)(b) of this section, if a person has not been registered as a sex

16 offender in this state for two years until more than five years have elapsed since the termination

17 of supervision on probation or parole, the person may file a petition seeking relief under this section

18 if the person files the petition no later than 90 days after the date on which the person has been

19 registered as a sex offender in this state for two years.

36 181.833. (1) A person who meets the criteria described in ORS 181.830 and seeks relief from the

37 requirement to report under ORS 181.595, 181.596 or 181.597 shall:

38 (a) If the person was convicted in this state of the offense or adjudicated in this state for the

39 act giving rise to the obligation to report, file a motion for relief from the requirement to report and

40 an affidavit of eligibility with the circuit court of the county in which the person was convicted or

41 adjudicated and serve a copy of the motion and affidavit on the district attorney for that county.

42 (b) If the person was convicted in another [*jurisdiction*] **United States court** of [*an*] **the** offense

8 of age, the court, if requested by the victim, shall include as a special condition of the person's

36 (d) Report to the parole officer as directed by the board or parole officer.

37 (e) Not own, possess or be in control of any weapon.

38 (f) Respect and obey all municipal, county, state and federal laws.

39 (g) Understand that the board may, in its discretion, suspend or revoke parole if it determines  
40 that the parole is not in the best interest of the parolee, or in the best interest of society.

41 (3)(a) The board may establish such special conditions as it determines are necessary because

43 (b) If the person is on parole following conviction of a sex crime, as defined in ORS 181.594, the

39 (i) "Dwelling" has the meaning given that term in ORS 469.160.

40 (ii) "Dwelling" does not include a residential treatment facility or a halfway house.

41 (iii) "Halfway house" means a publicly or privately operated profit or nonprofit residential fa-  
42 cility that provides rehabilitative care and treatment for sex offenders.

43 (c)(A) If the person is on parole following conviction of a sex crime, as defined in ORS 181.594,  
44 or an assault, as defined in ORS 163.175 or 163.185, and the victim was under 18 years of age, the  
45 board, if requested by the victim, shall include as a special condition of the person's parole that the

1 person not reside within three miles of the victim unless:

2 (i) The victim resides in a county having a population of less than 130,000 and the person is  
3 required to reside in that county under subsection (5) of this section;

4 (ii) The person demonstrates to the board by a preponderance of the evidence that no mental  
5 intimidation or pressure was brought to bear during the commission of the crime;

6 (iii) The person demonstrates to the board by a preponderance of the evidence that imposition

4 **(i) Discharge, release on parole or release on any form of supervised or conditional re-**  
5 **lease, from a jail, prison or other correctional facility or detention facility; or**

6 **(ii) Discharge, release or placement on probation, by another United States court;**

7 **(B) Within 10 days of a change of residence;**

8 **(C) Once each year within 10 days of the person's birth date, regardless of whether the**  
9 **person has changed residence;**

10 **(D) Within 10 days of the first day the person works at, carries on a vocation at or at-**  
11 **tends an institution of higher education; and**

12 **(E) Within 10 days of a change in work, vocation or attendance status at an institution**  
13 **of higher education.**

14 *[(c)]* **(d)** As used in paragraph (b) of this subsection, "attends school" means enrollment in any  
15 type of school on a full-time or part-time basis.

16 *[(d)]* **(e)** When a person reports under *[paragraph (a) of]* this subsection, the agency *[or official*  
17 *to whom]* **to which** the person reports shall complete a sex offender registration form concerning  
18 the person.

19 *[(e)]* **(f)** The obligation to report under this section terminates if the conviction or adjudication  
20 that gave rise to the obligation is reversed or vacated or if the registrant is pardoned.

21 (2) Subsection (1) of this section applies to:

22 (a) A person convicted in another *[jurisdiction]* **United States court** of a crime if the elements  
23 of the crime would constitute a sex crime;

24 (b) A person found by *[a court in another jurisdiction]* **another United States court** to have  
25 committed an act while the person was under 18 years of age that would constitute a sex crime if  
26 committed in this state by an adult; and

27 (c) A person required to register in another state for having committed a sex offense in that  
28 state regardless of whether the crime would constitute a sex crime in this state.

29 (3) As part of the registration required under this section, the Department of State Police, *[a]*  
30 **the** city police department or *[a]* **the** sheriff's office:

31 (a) Shall photograph the person and obtain the signature of the person; and

32 (b) May fingerprint the person.

33 **SECTION 23. If House Bill 2173 becomes law, section 9 of this 2009 Act (amending ORS**  
34 **181.830) is repealed and ORS 181.830, as amended by section 1, chapter \_\_, Oregon Laws 2009**  
35 **(Enrolled House Bill 2173), is amended to read:**

36 181.830. A person otherwise required to report under ORS 181.595, 181.596 or 181.597 is not re-  
37 quired to report, and if currently reporting is no longer required to report, if:

38 (1)(a) The person has been convicted of:

39 (A) Rape in the third degree as defined in ORS 163.355;

40 (B) Sodomy in the third degree as defined in ORS 163.385;

41 (C) Sexual abuse in the third degree as defined in ORS 163.415;

42 (D) Contributing to the sexual delinquency of a minor as defined in ORS 163.435;

43 (E) Sexual misconduct as defined in ORS 163.445; or

44 (F) An attempt to commit an offense listed in subparagraphs (A) to (E) of this paragraph;

45 (b) The person has been found guilty except for insanity of an offense listed in paragraph (a) of

1 this subsection;

2 (c) The person has been found to be within the jurisdiction of the juvenile court for having  
3 committed an act that if committed by an adult would constitute an offense listed in paragraph (a)  
4 of this subsection; or

5 (d) The person is paroled to this state under ORS 144.610 after being convicted in another [*ju-*  
6 *risdiction*] **United States court** of a crime that would constitute an offense listed in paragraph (a)  
7 of this subsection;

8 (2)(a) The person is less than five years older than the victim;

9 (b) The victim's lack of consent was due solely to incapacity to consent by reason of being less  
10 than a specified age;

11 (c) The victim was at least 14 years of age at the time of the offense or act;

12 (d) Except for the convictions or findings described in subsection (1) of this section, the person  
13 has not been convicted of, found guilty except for insanity of, or found to be within the jurisdiction  
14 of the juvenile court based on, [*an offense listed in ORS 181.594 (4)*] **a sex crime or an offense, in**  
15 **another United States court, for** conduct [*in another jurisdiction*] that if committed in this state  
16 would constitute [*an offense listed in ORS 181.594 (4)*] **a sex crime**; and

17 (e) Each conviction or finding described in subsection (1) of this section involved the same vic-  
18 tim; and

19 (3) The court enters an order relieving the person of the requirement to report under ORS  
20 181.832 or 181.833.

21 **SECTION 24. (1) The amendments to ORS 181.595 by sections 2 and 20 of this 2009 Act**  
22 **apply to persons paroled to or otherwise placed in this state on or after the effective date**  
23 **of this 2009 Act.**

24 **(2) The amendments to ORS 181.596 by sections 3 and 21 of this 2009 Act apply to persons**  
25 **discharged, released or placed on probation to this state on or after the effective date of this**  
26 **2009 Act.**

27 **(3)(a) Except as provided in paragraph (b) of this subsection, the amendments to ORS**  
28 **181.597 by sections 4 and 22 of this 2009 Act apply to persons who move into this state, or**  
29 **whose first day of school attendance or work in this state occurs, on or after the effective**  
30 **date of this 2009 Act.**

31 **(b) ORS 181.597 (1)(c) applies to persons convicted of a crime or adjudicated for an act**  
32 **on or after the effective date of this 2009 Act.**

33 **(4) The amendments to ORS 181.599 by section 5 of this 2009 Act apply to conduct oc-**  
34 **curring on or after the effective date of this 2009 Act.**

35 **(5) The amendments to ORS 181.826, 181.830 and 181.833 by sections 6, 7, 9 and 23 of this**  
36 **2009 Act apply to petitions or motions filed on or after the effective date of this 2009 Act.**

37
