SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Prohibits individual from engaging in business as mortgage loan originator without obtaining license from Director of Department of Consumer and Business Services and obtaining unique identifier from Nationwide Mortgage Licensing System and Registry. **Creates exception, including exception for certain employees of dealers of manufactured structures.**

Requires applicant for license to submit certain information to director and to Nationwide Mortgage Licensing System and Registry. Specifies standards director must use to evaluate application. Permits director to issue interim license under certain conditions.

Specifies requirements for applicant to obtain or renew license, including educational requirements.

Authorizes director to deny, suspend, place conditions upon, revoke or decline to renew license under specified conditions. Permits director to contract with Nationwide Mortgage Licensing System and Registry to collect and process records, application fees and perform other duties.

Requires person that employs mortgage loan originator to file corporate surety bond with director in amount director prescribes by rule.

Authorizes director to investigate violations of provisions of Act and require production of specified records.

Provides that mortgage loan originator may not take certain actions. Requires mortgage loan originator to display license and unique identifier on specified documents and in certain locations.

Provides that person that violates provisions of Act is subject to civil penalty in amount of \$5,000 per violation *[and]*. **Provides that person that knowingly violates provisions of Act is subject to maximum criminal penalty of five years' imprisonment, or \$125,000 fine, or both.**

Declares emergency, effective on passage.

7 Whereas the activities of mortgage loan originators and the origination or offer of financing for
8 real property have a direct, valuable and immediate impact on consumers, on the economy, neigh-
9 borhoods and communities of this state and on the housing and real estate industry; and

10 Whereas access to mortgage credit is vital to the citizens of this state; and

11 Whereas reasonable standards to license and regulate the business practices of mortgage loan
12 originators are essential to protect the citizens of this state and the stability of this state's economy;
13 and

14 Whereas the Legislative Assembly therefore declares that the purpose of sections 1 to 13 of this

1 2009 Act is to protect consumers that seek mortgage loans and to ensure that the mortgage lending
2 industry operates without unfair, deceptive or fraudulent practices among mortgage loan originators;
3 now, therefore,

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. As used in sections 1 to 13 of this 2009 Act:**

6 (1) **“Depository institution” means a depository institution, as defined in 12 U.S.C. 1813(c),
7 and a credit union, as defined in ORS 723.008.**

8 (2) **“Federal banking agency” means:**

9 (a) **The Board of Governors of the Federal Reserve System;**

10 (b) **The Comptroller of the Currency;**

11 (c) **The Director of the Office of Thrift Supervision in the United States Department of
12 the Treasury;**

13 (d) **The National Credit Union Administration Board; and**

14 (e) **The Board of Directors of the Federal Deposit Insurance Corporation.**

15 (3)(a) **“Loan processor or underwriter” means an individual who, after receiving an ap-
16 plication, performs clerical or support duties that include:**

17 (A) **Receiving, collecting, distributing and analyzing information commonly used in pro-
18 cessing or underwriting a residential mortgage loan; or**

19 (B) **Communicating with a consumer to obtain information necessary to process or
20 underwrite a residential mortgage loan.**

21 (b) **“Loan processor or underwriter” does not include an individual who communicates
22 with a consumer for the purpose of offering or negotiating residential mortgage loan terms
23 with the consumer or offering counsel or consultation to the consumer concerning residen-
24 tial mortgage loan terms or rates.**

25 (4)(a) **“Mortgage loan originator” means an individual who, for compensation or gain:**

26 (A) **Takes an application for a residential mortgage loan; or**

27 (B) **Offers or negotiates terms for a residential mortgage loan.**

28 (b) **“Mortgage loan originator” does not include:**

29 (A) **An individual who, as an employee or independent contractor, works solely as a loan
30 processor or underwriter;**

31 (B) **A person that performs professional real estate activities, as defined in ORS 696.010,
32 unless the person is compensated by a mortgage banker, mortgage broker, mortgage loan
33 originator or lender or an agent of a mortgage banker, mortgage broker, mortgage loan
34 originator or lender;**

35 (C) **An individual that extends credit solely in connection with a timeshare plan, as de-
36 fined in 11 U.S.C. 101(53D); or**

37 (D) **An individual who:**

38 (i) **Is employed by a person that is licensed by the Director of the Department of Con-
39 sumer and Business Services; and**

40 (ii) **Collects or receives payments on behalf of a person that holds a residential mortgage,
41 including payments of principal, interest, escrow amounts and other amounts due on obli-
42 gations that under the terms of the note are due and owed to the person that holds the
43 residential mortgage.**

44 (5) **“Nationwide Mortgage Licensing System and Registry” means a system that the
45 Conference of State Bank Supervisors and the American Association of Residential Mortgage**

1 **Regulators maintain to register and license mortgage loan originators.**

2 (6) **“Nontraditional mortgage” means a mortgage other than a 30-year fixed-rate mort-**
3 **gage or a mortgage that the director by rule defines as a nontraditional mortgage.**

4 (7) **“Registered mortgage loan originator” means an individual who:**

5 (a) **Is employed by:**

6 (A) **A depository institution;**

7 (B) **A subsidiary of a depository institution that is regulated by a federal banking agency;**

8 **or**

9 (C) **An institution that is regulated by the Farm Credit Administration;**

10 (b) **Performs the duties of a mortgage loan originator; and**

11 (c) **Complies with the registration requirements set forth in 12 U.S.C. 5106.**

12 (8) **“Residential mortgage loan” means a loan that is secured by a mortgage, deed of trust**
13 **or equivalent consensual security interest on four or fewer residential dwelling units, in-**
14 **cluding but not limited to individual dwelling units, mobile homes, condominiums or cooper-**
15 **atives that are planned for or situated on real property in this state.**

16 (9) **“Unique identifier” means a number or other means of identification that is assigned**
17 **by or under protocols established by the Nationwide Mortgage Licensing System and Regis-**
18 **try.**

19 **SECTION 2. (1) Except as provided in subsection (2) of this section, an individual may**
20 **not engage in business as a mortgage loan originator in this state without first:**

21 (a) **Obtaining and maintaining a mortgage loan originator’s license under section 4 of this**
22 **2009 Act or renewing a mortgage loan originator’s license under section 6 of this 2009 Act;**
23 **and**

24 (b) **Obtaining a unique identifier from the Nationwide Mortgage Licensing System and**
25 **Registry.**

26 (2) **Subsection (1) of this section does not apply to:**

27 (a) **A registered mortgage loan originator who acts within the scope of the registered**
28 **mortgage loan originator’s employment;**

29 (b) **An individual who offers or negotiates terms of a residential mortgage loan with or**
30 **on behalf of the individual’s spouse, child, sibling, parent, grandparent, grandchild or a rela-**
31 **tive in a similar relationship with the individual that is created by law, marriage or adoption;**

32 (c) **An individual who offers or negotiates terms of a residential mortgage loan that is**
33 **secured by a dwelling that served as the individual’s residence; or**

34 (d) **An attorney licensed or otherwise authorized to practice law in this state if the at-**
35 **torney:**

36 (A) **Negotiates the terms of a residential mortgage loan as an ancillary matter in the**
37 **attorney’s representation of a client; and**

38 (B) **Does not receive compensation from a mortgage banker, mortgage broker, mortgage**
39 **loan originator or lender or an agent of the mortgage banker, mortgage broker, mortgage**
40 **loan originator or lender.**

41 (3) **The director by rule may exempt a person from the requirement to obtain a mortgage**
42 **loan originator’s license under sections 1 to 13 of this 2009 Act if the United States Depart-**
43 **ment of Housing and Urban Development requires or permits the exemption under 12 U.S.C.**
44 **5101 et seq.**

45 (4)(a) **Except as provided in paragraph (b) of this subsection, an employee of a dealer, as**

1 defined in ORS 446.003, is not subject to the provisions of sections 1 to 13 of this 2009 Act if
2 the employee:

3 (A) Performs only administrative or clerical tasks; and

4 (B) Receives in connection with a sale or other transaction related to a manufactured
5 structure, as defined in ORS 446.003, only a salary or commission that is customary among
6 dealers and employees of dealers.

7 (b) An employee of a dealer is subject to the provisions of sections 1 to 13 of this 2009
8 Act if the United States Department of Housing and Urban Development in a guideline, rule,
9 regulation or interpretive letter determines that the exemption granted in paragraph (a) of
10 this subsection is inconsistent with requirements set forth in 12 U.S.C. 5101 et seq.

11 **SECTION 3.** (1) The Director of the Department of Consumer and Business Services by
12 rule shall determine the manner in which an applicant must apply and the form and contents
13 of an application for a license to conduct business as a mortgage loan originator.

14 (2) In connection with an application under this section, an applicant shall apply for and
15 receive a unique identifier from the Nationwide Mortgage Licensing System and Registry.
16 As part of the application, the director by rule shall require the applicant to submit to the
17 director or directly to the Nationwide Mortgage Licensing System and Registry:

18 (a) Fingerprints that the Federal Bureau of Investigation, or another government agency
19 that is authorized to receive fingerprints, can use to perform a state, national and interna-
20 tional criminal background check;

21 (b) A summary of the applicant's personal history and experience on a form prescribed
22 by the Nationwide Mortgage Licensing System and Registry;

23 (c) A document that authorizes the Nationwide Mortgage Licensing System and Registry
24 to obtain, with reference to the applicant:

25 (A) A credit report from a consumer reporting agency, as defined in 15 U.S.C. 1681a(f),
26 or a consumer reporting agency that compiles and maintains files on consumers on a na-
27 tionwide basis, as defined in 15 U.S.C. 1681a(p); and

28 (B) Information about administrative, civil or criminal proceedings and findings con-
29 cerning the applicant in any governmental jurisdiction; and

30 (d) Other information the director or the Nationwide Mortgage Licensing System and
31 Registry may require.

32 **SECTION 3a.** The Director of the Department of Consumer and Business Services may
33 issue an interim mortgage loan originator's license to a person that is not licensed under
34 section 4 of this 2009 Act if the director finds that issuing the interim license will facilitate
35 the business of licensed mortgage loan originators or prevent an undue delay in issuing a
36 mortgage loan originator's license. The director may specify the term of the interim mort-
37 gage loan originator's license and may issue the interim license to an applicant for a mort-
38 gage loan originator's license only if the director finds that the applicant:

39 (1) Is employed by a person that has a valid license or registration from the Department
40 of Consumer and Business Services;

41 (2) Substantially meets the requirements of sections 3, 4 and 5 of this 2009 Act as of the
42 operative date of this section; and

43 (3) Has not committed an act prohibited under section 12 of this 2009 Act.

44 **SECTION 4.** (1) The Director of the Department of Consumer and Business Services may
45 not issue a mortgage loan originator's license to an applicant unless the director finds, at a

1 **minimum, that the applicant:**

2 (a) **Has obtained a unique identifier from the Nationwide Mortgage Licensing System and**
3 **Registry.**

4 (b) **Has not had a mortgage loan originator's license revoked in another jurisdiction. For**
5 **purposes of this paragraph, an applicant's mortgage loan originator's license was not revoked**
6 **if an order or decision to revoke the license was later rescinded or vacated.**

7 (c) **Has not been convicted of or pleaded guilty or no contest in a state, federal, foreign**
8 **or military court to a felony or to a misdemeanor if an essential element of the misdemeanor**
9 **involved false statements or dishonesty:**

10 (A) **During a period of seven years before the date the applicant submits an application**
11 **under section 3 of this 2009 Act; or**

12 (B) **At any time before the date the applicant submits an application under section 3 of**
13 **this 2009 Act, if the conviction or plea involved a felony and an element of the felony was**
14 **an act of fraud, dishonesty, a breach of trust or laundering a monetary instrument. For**
15 **purposes of this paragraph, a conviction that was later pardoned is not a conviction.**

16 (d) **Has demonstrated financial responsibility sufficient to command the confidence of the**
17 **community and warrant the determination that the applicant will operate honestly, fairly**
18 **and efficiently within the purposes of sections 1 to 13 of this 2009 Act.**

19 (e) **Has completed the education requirement set forth in section 5 of this 2009 Act and**
20 **passed a test that meets the standards set forth in section 5 of this 2009 Act.**

21 (f) **Is covered by a surety bond in accordance with the provisions of section 9 of this 2009**
22 **Act.**

23 **(2) The director may not:**

24 (a) **Deny a mortgage loan originator's license to an applicant because of the applicant's**
25 **credit score; or**

26 (b) **Use information in a credit report as the sole basis for denying the mortgage loan**
27 **originator's license.**

28 **(3) The director shall issue a mortgage loan originator's license to an applicant if:**

29 (a) **The director is satisfied that the information contained in the application for a**
30 **mortgage loan originator's license is accurate and complete; and**

31 (b) **No reason exists under subsection (1) of this section to deny the applicant a mortgage**
32 **loan originator's license.**

33 (4) **The director by rule may specify criteria for determining financial responsibility un-**
34 **der subsection (1)(d) of this section.**

35 **SECTION 5. (1) An applicant for a mortgage loan originator's license shall:**

36 (a) **Complete, at a minimum, 20 hours of an approved course of prelicensing education**
37 **that, at a minimum, must include:**

38 (A) **Three hours devoted to federal laws and regulations;**

39 (B) **Three hours devoted to ethics, with instruction concerning fraud, consumer pro-**
40 **tection and fair lending; and**

41 (C) **Two hours devoted to lending standards applicable to nontraditional mortgages; and**

42 (b) **Pass a qualified written test with a score of 75 percent correct or better. The test**
43 **must measure the applicant's knowledge of:**

44 (A) **Ethics; and**

45 (B) **Federal and state laws, regulations and rules that apply to residential mortgage loan**

1 origination, including laws, regulations and rules that concern fraud, consumer protection,
2 fair lending and nontraditional mortgages.

3 (2) For purposes of this section:

4 (a) An approved course of prelicensing education is a course that the Nationwide Mort-
5 gage Licensing System and Registry has reviewed and for which the Nationwide Mortgage
6 Licensing System and Registry has approved the contents, provider, instructional standards
7 and means and methods of delivery, using reasonable standards.

8 (b) A qualified written test is a test that the Nationwide Mortgage Licensing System and
9 Registry develops and for which the Nationwide Mortgage Licensing System and Registry
10 approves the test provider and method of test administration, using reasonable standards.

11 (3) The director shall accept for the purposes of the requirements set forth in subsection
12 (1) of this section an approved course of prelicensing education that an applicant completed
13 in another state.

14 (4) This section does not preclude:

15 (a) An applicant's employer or a subsidiary, agent or affiliate of the employer from pro-
16 viding an approved course of prelicensing education; or

17 (b) An approved test provider from administering a qualified test at the business location
18 of the applicant's employer or an affiliate, subsidiary or agent of the employer or at the
19 business location of a person with which the employer has an exclusive contractual ar-
20 rangement related to mortgage loan origination.

21 (5) An applicant may take a qualified test four consecutive times, provided that each test
22 administration occurs 30 days after a previous test administration. If the applicant fails the
23 approved test four consecutive times, the applicant must wait at least six months before
24 retaking the test.

25 **SECTION 6.** (1) The Director of the Department of Consumer and Business Services shall
26 renew a mortgage loan originator's license if the director finds that:

27 (a) The licensed mortgage loan originator continues to meet the requirements set forth
28 under section 4 of this 2009 Act;

29 (b) The licensed mortgage loan originator paid the fee required to renew the mortgage
30 loan originator's license; and

31 (c) The licensed mortgage loan originator satisfied the continuing education requirements
32 set forth in section 7 of this 2009 Act. If the licensed mortgage loan originator did not satisfy
33 the requirements under section 7 of this 2009 Act, instead of declining to renew the mortgage
34 loan originator's license, the director by rule or order may permit or require the licensed
35 mortgage loan originator to make up the deficiency in continuing education.

36 (2)(a) A mortgage loan originator's license expires if:

37 (A) The licensed mortgage loan originator does not apply to renew the mortgage loan
38 originator's license;

39 (B) The director declines to renew the mortgage loan originator's license; or

40 (C) The licensed mortgage loan originator does not otherwise maintain eligibility under
41 the requirements set forth in sections 1 to 13 of this 2009 Act.

42 (b) The director by rule may establish a procedure and requirements for reinstating a
43 license that has expired. The procedure and requirements the director establishes must be
44 consistent with standards established by the Nationwide Mortgage Licensing System and
45 Registry and must at a minimum provide that an applicant for reinstatement who has al-

1 lowed the applicant's mortgage loan originator's license to lapse for a period of five or more
2 years, whether or not the applicant was employed or continued to engage in business as a
3 mortgage loan originator during the period of the lapse, shall:

4 (A) Demonstrate to the director that the applicant completed the continuing education
5 requirements set forth in section 7 of this 2009 Act that were required in the year in which
6 the applicant last held a mortgage loan originator's license; and

7 (B) Pass the qualified written test as provided in section 5 of this 2009 Act.

8 **SECTION 7.** (1) A licensed mortgage loan originator each year shall complete at least
9 eight hours of an approved course of continuing education that, at a minimum, must include:

10 (a) Three hours devoted to federal laws and regulations;

11 (b) Two hours devoted to ethics, with instruction concerning fraud, consumer protection
12 and fair lending; and

13 (c) Two hours devoted to lending standards applicable to nontraditional mortgages.

14 (2) For purposes of this section, an approved course of continuing education is a course
15 that the Nationwide Mortgage Licensing System and Registry has reviewed and for which the
16 Nationwide Mortgage Licensing System and Registry has approved the contents, provider,
17 instructional standards and means and methods of delivery, using reasonable standards.

18 (3) This section does not preclude a licensed mortgage loan originator's employer or a
19 subsidiary, agent or affiliate of the employer from providing an approved course of continu-
20 ing education.

21 (4) The Director of the Department of Consumer and Business Services shall accept for
22 the purposes of the requirement set forth in subsection (1) of this section an approved course
23 of continuing education that a licensed mortgage loan originator completed in another state.

24 (5) A licensed mortgage loan originator:

25 (a) May receive credit for a continuing education course only in the year in which the
26 licensed mortgage loan originator takes the course, unless the director under section 6 of
27 this 2009 Act permits or requires the mortgage loan originator to make up a deficiency in
28 continuing education; and

29 (b) May not for the purposes of meeting the requirement set forth in subsection (1) of
30 this section take the same approved course of continuing education in the same year or in
31 any two successive years.

32 (6) A licensed mortgage loan originator who is also approved as an instructor for an ap-
33 proved course of continuing education may receive two hours of credit toward the licensed
34 mortgage loan originator's own continuing education requirement for each hour of the ap-
35 proved course of continuing education that the licensed mortgage loan originator teaches.

36 **SECTION 8.** (1) In addition to authority the Director of the Department of Consumer and
37 Business Services has under ORS 59.840 to 59.980, the director under this section has the
38 authority, subject to ORS chapter 183, to deny, suspend, place conditions upon, revoke or
39 decline to renew a mortgage loan originator's license or permanently prohibit a person from
40 conducting business as a mortgage loan originator if:

41 (a) A licensed mortgage loan originator violates a provision of sections 1 to 13 of this 2009
42 Act or a rule or order the director issues under sections 1 to 13 of this 2009 Act;

43 (b) The director makes a finding under section 4 or 6 of this 2009 Act that the director
44 believes justifies a decision to deny or decline to renew a mortgage loan originator's license;

45 (c) An applicant makes a false statement or a material misstatement of fact on an ap-

1 plication for a mortgage loan originator's license or a licensed mortgage loan originator
2 makes a false statement or a material misstatement of fact on an application to renew a
3 mortgage loan originator's license; or

4 (d) A person who is not exempted from the requirement to obtain a mortgage loan orig-
5 inator's license under section 2 (2) of this 2009 Act conducts business as a mortgage loan
6 originator without applying for and receiving a mortgage loan originator's license under
7 sections 3 and 4 of this 2009 Act.

8 (2) The director, subject to ORS chapter 183, may order a person that is subject to reg-
9 ulation under sections 1 to 13 of this 2009 Act to:

10 (a) Cease and desist immediately or permanently from violating a provision of sections 1
11 to 13 of this 2009 Act or from an act or practice related to mortgage loan origination that
12 the director deems harmful to a consumer or to the public;

13 (b) Stop or suspend business related to mortgage loan origination;

14 (c) Pay restitution to a consumer or another person that the director finds suffered harm
15 from the person's acts, omissions, practices or operations or as a result of the person's vi-
16 olation of a provision of sections 1 to 13 of this 2009 Act; or

17 (d) Take or refrain from taking an action the director deems necessary to comply with
18 sections 1 to 13 of this 2009 Act.

19 (3)(a) The director, in accordance with ORS 183.745, may impose a civil penalty in an
20 amount not to exceed \$5,000 for each separate instance of a violation of or failure to comply
21 with the provisions of sections 1 to 13 of this 2009 Act or a rule or order the director adopted
22 or issued under sections 1 to 13 of this 2009 Act.

23 (b) Every violation described in paragraph (a) of this subsection is a separate offense that
24 is subject to a separate penalty. Each day in which the same violation occurs is a separate
25 violation. A violation that continues for more than one day is a continuing violation that is
26 subject to a maximum penalty of \$20,000.

27 (4)(a) A person may not knowingly:

28 (A) Violate a provision of section 2 of this 2009 Act;

29 (B) Fail to comply with an order the director issues under this section;

30 (C) Fail to produce records at the director's request under section 11 of this 2009 Act;

31 (D) Employ a device, scheme or artifice to defraud or engage in an act, practice or course
32 of business that operates or would operate as a fraud or deceit;

33 (E) Make an untrue statement of a material fact or omit from a statement a material
34 fact that would make the statement not misleading in light of the circumstances under
35 which the person makes the statement; or

36 (F) Make or file or cause to be made or filed with the director a statement, report or
37 document that the person knows is false in a material respect or matter.

38 (b) A person who takes an action described in paragraph (a) of this subsection commits
39 a Class C felony.

40 **SECTION 9.** (1) A person that employs a mortgage loan originator shall file with the Di-
41 rector of the Department of Consumer and Business Services a corporate surety bond that
42 runs to the State of Oregon and that covers each mortgage loan originator the person em-
43 ploys. The corporate surety bond must be issued by a corporate surety or an insured insti-
44 tution, as defined in ORS 706.008, that is authorized to transact business in this state.

45 (2) The director by rule shall:

1 (a) Prescribe the form of the corporate surety bond;

2 (b) Require the person to maintain the corporate surety bond in an amount that reflects
3 the dollar amount of the loans the person originated or in a minimum amount the director
4 specifies; and

5 (c) Prescribe other requirements for the corporate surety bond as are necessary to ac-
6 complish the purposes of sections 1 to 13 of this 2009 Act.

7 (3) A right of action against the corporate surety bond required under this section exists
8 to the same extent that a right of action exists under ORS 59.925.

9 (4) The director may require the person to file a new corporate surety bond if an action
10 is commenced against the corporate surety bond on file with the director. The person shall
11 file a new corporate surety bond immediately if a recovery is obtained against the bond.

12 **SECTION 10.** (1) The Director of the Department of Consumer and Business Services
13 may contract with or otherwise agree with the Nationwide Mortgage Licensing System and
14 Registry, or a person the Nationwide Mortgage Licensing System and Registry designates,
15 to:

16 (a) Collect and maintain records in connection with an application under section 4 or 6
17 of this 2009 Act;

18 (b) Collect and process application fees or other fees that are authorized under sections
19 1 to 13 of this 2009 Act and imposed by a government agency or association of government
20 agencies;

21 (c) Serve as a point of contact the director may use to request information from and
22 provide information to the United States Department of Justice, the Federal Bureau of In-
23 vestigation or other government agencies;

24 (d) Apply, abide by and implement standards the Nationwide Mortgage Licensing System
25 and Registry establishes for:

26 (A) Setting or resetting dates for reporting information or renewing a mortgage loan
27 originator's license; and

28 (B) Amending or surrendering a mortgage loan originator's license; and

29 (e) Otherwise participate in the Nationwide Mortgage Licensing System and Registry.

30 (2) The director may agree with the Conference of State Bank Supervisors, the American
31 Association of Residential Mortgage Regulators or other government agencies or associ-
32 ations of government agencies to share and to maintain under subsection (4) of this section
33 the confidentiality or privilege applicable to information or material that:

34 (a) An applicant provides under section 3 of this 2009 Act;

35 (b) A mortgage loan originator provides under section 6 of this 2009 Act; or

36 (c) The director obtains from investigations, inquiries, proceedings, submissions or other
37 sources under the authority of sections 1 to 13 of this 2009 Act.

38 (3) The director shall provide copies of information and material that the director sup-
39 plies to or receives from the Nationwide Mortgage Licensing System and Registry to an ap-
40 plicant for a mortgage loan originator's license under section 4 of this 2009 Act or to a
41 licensed mortgage loan originator who applies to renew a license under section 6 of this 2009
42 Act. The director by rule shall establish a procedure for challenging the accuracy or com-
43 pleteness of the information and materials.

44 (4)(a) Except as provided in subsections (5) and (6) of this section and 12 U.S.C. 5111, in-
45 formation or material that an applicant, a mortgage loan originator or the director provides

1 or discloses to the Nationwide Mortgage Licensing System and Registry retains the
2 confidentiality or privilege from public disclosure that applies to the information under ORS
3 192.410 to 192.505 or under other applicable state or federal law, including court rules. The
4 confidentiality or privilege applies to the information or material despite disclosure to state
5 or federal agencies with regulatory authority over persons, businesses or activities related
6 to mortgage lending.

7 (b) Information that is subject to a privilege described in paragraph (a) of this subsection
8 is not subject to:

9 (A) Disclosure under state or federal law that governs disclosure of information in the
10 possession of a public official; or

11 (B) Subpoena, discovery or admission into evidence in an administrative proceeding or
12 private civil action, unless the person whose information is protected by the confidentiality
13 or privilege waives the confidentiality or privilege in whole or in part.

14 (c) To the extent that the provisions of ORS 192.410 to 192.505 conflict with the provisions
15 of this section, the provisions of this section control.

16 (5) Subsection (4) of this section does not apply to information or material concerning
17 an applicant's or a mortgage loan originator's employment history or records of discipline
18 and enforcement actions that appear in and are open to public access in the Nationwide
19 Mortgage Licensing System and Registry. The director may publish on the Internet infor-
20 mation that the director receives from the Nationwide Mortgage Licensing System and Reg-
21 istry that is not subject to a privilege described in subsection (4) of this section.

22 (6) The director shall regularly report to the Nationwide Mortgage Lending System and
23 Registry violations of the provisions of sections 1 to 13 of this 2009 Act, enforcement actions
24 against a person subject to sections 1 to 13 of this 2009 Act and other information the di-
25 rector deems necessary to meet the director's obligations under agreements with the Na-
26 tionwide Mortgage Licensing System and Registry.

27 (7) To the extent reasonably necessary to participate in the Nationwide Mortgage Li-
28 censing System and Registry, the director by rule or order may waive or modify, in whole
29 or in part, the requirements set forth in sections 1 to 13 of this 2009 Act or establish new
30 requirements consistent with the provisions of sections 1 to 13 of this 2009 Act.

31 **SECTION 11.** (1) The Director of the Department of Consumer and Business Services, as
32 often as the director deems necessary to carry out the purposes of sections 1 to 13 of this
33 2009 Act, may:

34 (a) Request or require a person that employs a mortgage loan originator or that under
35 the provisions of sections 1 to 13 of this 2009 Act should employ a mortgage loan originator
36 to produce, for the director's examination and use, books, accounts, records, files, docu-
37 ments or other information or evidence;

38 (b) Investigate or examine an applicant or a licensed mortgage loan originator and review
39 the applicant's or licensed mortgage loan originator's:

40 (A) History of criminal, civil and administrative proceedings, enforcement actions, ar-
41 rests or other information related to the applicant's or licensed mortgage loan originator's
42 compliance with state and federal law, rules or regulations; and

43 (B) Personal history and experience, including information obtained from credit reports
44 from a consumer reporting agency, as defined in 15 U.S.C. 1681a(f) or from a consumer re-
45 porting agency that compiles and maintains files on consumers on a nationwide basis, as

1 defined in 15 U.S.C. 1681a(p);

2 (c) Direct, subpoena, examine, compel the attendance of, administer oaths and affirma-
3 tions to, and request production of books, accounts, records, files, documents or other in-
4 formation or evidence from witnesses and persons that are subject to regulation under
5 sections 1 to 13 of this 2009 Act; and

6 (d) Interview and take and preserve testimony concerning business practices and oper-
7 ations from the applicant's or licensed mortgage loan originator's officers, principals, mort-
8 gage loan originators, employees, agents and customers or independent contractors
9 associated with the applicant or licensed mortgage loan originator.

10 (2)(a) The director may, with reference to documents, materials or records described in
11 subsection (1) of this section:

12 (A) Take possession of, sequester, control or restrict access to the documents, materials
13 or records; or

14 (B) Designate a person to take exclusive charge of the documents, materials or records
15 in the location in which the documents, materials or records are usually kept.

16 (b) At a time in which the director has taken an action described in paragraph (a) of this
17 subsection, a person may not, without the director's permission or a court order, remove
18 or attempt to remove the documents, materials or records from the director's possession
19 or control or from the location in which the documents, materials or records are kept under
20 the exclusive charge of the person the director designates.

21 (c) A person who owns or has a right to possess or control the documents, materials or
22 records may have access necessary to conduct the person's ordinary business, unless the
23 director reasonably believes that the documents, materials or records have been or are at
24 risk of alteration or destruction for the purposes of concealing a violation of sections 1 to
25 13 of this 2009 Act.

26 (3) In carrying out the purposes of this section, the director may:

27 (a) Retain attorneys, accountants or other professionals or specialists to conduct inves-
28 tigations, audits or examinations or assist in conducting investigations, audits or examina-
29 tions;

30 (b) Agree with other government agencies or officials to share resources, information,
31 methods, procedures, documents, records, materials and information obtained in the course
32 of investigations, audits, examinations and related activities;

33 (c) Purchase, share, use or employ analytical systems, methods or software available
34 from public or private sources;

35 (d) Accept and rely upon the results of or reports concerning investigations, audits, ex-
36 aminations or proceedings conducted by other government agencies or officials in this state
37 or in other states; and

38 (e) Accept, use and incorporate in the director's findings, reports, orders or other actions
39 audit reports from an independent certified public accountant.

40 (4) The director's authority under this section applies to a person who is subject to reg-
41 ulation under sections 1 to 13 of this 2009 Act, whether or not the person is licensed as a
42 mortgage loan originator.

43 (5) An applicant or licensed mortgage loan originator shall:

44 (a) Make available to the director at the director's request books, accounts, records, files
45 and other documents relating to the applicant's or licensed mortgage loan originator's busi-

1 **ness operations and practices; and**

2 **(b) Prepare, compile and deliver to the director reports, accounting compilations, lists**
3 **and data concerning loan transactions and other information the director requires to carry**
4 **out the purposes of sections 1 to 13 of this 2009 Act.**

5 **(6) A person subject to investigation, audit or examination under this section may not**
6 **knowingly withhold, abstract, remove, mutilate, destroy or conceal books, accounts, records,**
7 **computer records, files, documents or other information or evidence that is subject to the**
8 **director's authority under this section.**

9 **SECTION 12. A person who is subject to regulation under sections 1 to 13 of this 2009**
10 **Act in connection with the person's activities as a mortgage loan originator may not:**

11 **(1) Perform an act as a mortgage loan originator in a negligent or incompetent manner;**

12 **(2) Employ a device, scheme or artifice to defraud or engage in an act, practice or course**
13 **of business that operates or would operate as a fraud or deceit;**

14 **(3) Knowingly make an untrue statement of a material fact or omit from a statement a**
15 **material fact that would make the statement not misleading in light of the circumstances**
16 **under which the person makes the statement;**

17 **(4) Make or file or cause to be made or filed with the Director of the Department of**
18 **Consumer and Business Services a statement, report or document that the person knows is**
19 **false in a material respect or matter;**

20 **(5) Engage in an unfair or deceptive practice toward another person;**

21 **(6) Obtain property by fraud or misrepresentation;**

22 **(7) Solicit or enter into a contract with a borrower, the terms of which provide that the**
23 **person may earn a fee or commission for using the person's best efforts to obtain a resi-**
24 **dential mortgage loan even if the person does not obtain a residential mortgage loan for the**
25 **borrower, except that the terms of the contract may provide that the person may earn an**
26 **advance fee or recover actual expenses that the person incurs;**

27 **(8) Solicit, advertise or enter into a contract, the terms of which specify an interest rate,**
28 **points or other financing terms unless the interest rate, points or other financing terms are**
29 **available to a prospective borrower at the time the person makes the solicitation or adver-**
30 **tisement or enters into the contract;**

31 **(9) Conduct or operate a business that requires a mortgage loan originator's license**
32 **without holding a license issued under section 4 or 6 of this 2009 Act or assist or enable an-**
33 **other person who does not have a mortgage loan originator's license to conduct or operate**
34 **a business that requires a mortgage loan originator's license;**

35 **(10) Fail to disclose or provide information required under sections 1 to 13 of this 2009**
36 **Act or by state or federal laws, rules or regulations;**

37 **(11) Fail to comply with a provision of sections 1 to 13 of this 2009 Act, a rule adopted**
38 **by the Director of the Department of Consumer and Business Services or state or federal**
39 **laws, rules or regulations that apply to a business that is subject to regulation under**
40 **sections 1 to 13 of this 2009 Act;**

41 **(12) Fail to conduct business as a mortgage loan originator in compliance with the pro-**
42 **visions of:**

43 **(a) The Truth in Lending Act, 15 U.S.C. 1601 et seq. and Regulation Z, 12 C.F.R. part 226,**
44 **as in effect on October 1, 2009;**

45 **(b) The Real Estate Settlement Procedures Act, 12 U.S.C. 2601 et seq. and Regulation X,**

1 24 C.F.R. part 3500, as in effect on January 1, 2010;

2 (c) The Equal Credit Opportunity Act, 15 U.S.C. 1691 et seq. and Regulation B, 12 C.F.R.
3 202.9, 202.11, 202.12 and 202.14, as in effect on the effective date of this 2009 Act; or

4 (d) 12 U.S.C. 5101 et seq. and regulations adopted under 12 U.S.C. 5101 et seq.;

5 (13) Make, negligently or intentionally, a false or deceptive statement or representation
6 in any manner concerning the rates, points or other financing terms or conditions for a
7 residential mortgage loan;

8 (14) Make a false statement negligently in, or omit knowingly or willfully a material fact
9 from, a report or information the person submits to a government agency or the Nationwide
10 Mortgage Licensing System and Registry or in connection with an investigation or exam-
11 ination conducted by the director or a government agency;

12 (15) Make a payment, threat or promise, directly or indirectly, to another person for the
13 purpose of influencing the other person's independent judgment concerning a residential
14 mortgage loan or to an appraiser for the purpose of influencing the appraiser's independent
15 judgment concerning the value of property;

16 (16) Charge or collect, attempt to charge or collect or propose or enter into an agreement
17 in which the person charges or collects a fee that is prohibited under sections 1 to 13 of this
18 2009 Act;

19 (17) Cause or require a borrower to obtain property insurance in an amount that exceeds
20 the replacement cost of the property subject to the residential mortgage loan; or

21 (18) Fail to account truthfully for moneys that belong to a party to a residential mort-
22 gage loan transaction.

23 **SECTION 13.** (1)(a) A licensed mortgage loan originator shall clearly display the licensed
24 mortgage loan originator's unique identifier on a residential mortgage loan application form,
25 solicitation, advertisement, promotional material or website the licensed mortgage loan
26 originator uses in connection with the licensed mortgage loan originator's business.

27 (b) The Director of the Department of Consumer and Business Services by rule may
28 specify the location, size or other characteristics of the unique identifier that must appear
29 on the materials described in paragraph (a) of this subsection and the materials on which the
30 unique identifier must appear.

31 (2) A person that employs a licensed mortgage loan originator shall submit a report of
32 condition to the Nationwide Mortgage Licensing System and Registry. The form and contents
33 of the report and the times at which the licensed mortgage loan originator submits the re-
34 port shall comply with the specifications of the Nationwide Mortgage Licensing System and
35 Registry.

36 (3) A loan processor or underwriter may not represent to the public by means of adver-
37 tising, business cards, stationery, brochures, signs, rate lists or other communications, pro-
38 motional items or methods that the loan processor or underwriter can, will or is authorized
39 to perform the duties of a mortgage loan originator unless the loan processor or underwriter
40 obtains a mortgage loan originator's license under section 4 of this 2009 Act.

41 **SECTION 13a.** The Director of the Department of Consumer and Business Services may
42 adopt, amend and repeal rules that are necessary to carry out the provisions of sections 1
43 to 13 of this 2009 Act.

44 **SECTION 14.** ORS 59.840 is amended to read:

45 59.840. As used in ORS 59.840 to 59.980:

1 [(1) "Director" means the Director of the Department of Consumer and Business Services.]

2 [(2)] (1) "Fraud," "deceit" and "defraud" are not limited to common-law deceit.

3 [(3)] (2) "License" means a license issued to a mortgage banker or mortgage broker under ORS
4 59.840 to 59.980.

5 [(4)(a) "Loan originator" means an individual employed by or purporting to act as an agent or
6 independent contractor for a mortgage banker or mortgage broker that is required to be licensed under
7 ORS 59.840 to 59.980, with the expectation by the individual of compensation or gain that is determined
8 by the amount borrowed or the terms and conditions agreed to by the mortgage loan borrower, and
9 having primary job responsibilities that include negotiating with a borrower or potential borrower for
10 the purpose of establishing the terms and conditions of a mortgage loan.]

11 [(b) "Loan originator" includes a person employed at a location outside this state whose primary
12 job responsibilities include contacting or attempting to contact a borrower or potential borrower within
13 this state through any medium or mode of communication for purposes of providing a mortgage loan
14 within this state.]

15 [(c) "Loan originator" does not include an individual whose responsibilities are clerical or admin-
16 istrative functions, including but not limited to gathering information, requesting information, word
17 processing, soliciting general interest in mortgage loans, sending correspondence and assembling
18 files.]

19 [(d) "Loan originator" does not include an employee of a mortgage banker that is rated as good
20 or better under the federal rating system in effect on May 1, 2001, for seller-servicers of Federal
21 Housing Administration, Federal Home Loan Mortgage Corporation or Federal National Mortgage
22 Association loans and that has an office within this state at which the mortgage banker maintains
23 complete and current copies of all employment records and other records as required by the Director
24 of the Department of Consumer and Business Services by order or rule, in a format acceptable to the
25 director.]

26 [(e) "Loan originator" does not include an insurance producer licensed under ORS 744.052 to
27 744.089 or insurance consultant licensed under ORS 744.002.]

28 [(f) "Loan originator" does not include a person or group of persons exempted by rule or order of
29 the director.]

30 [(5)] (3)(a) "Mortgage banker"[:]

31 [(a)] means [any] a person [who] **that** for compensation or in the expectation of compensation:

32 (A) Either directly or indirectly makes, negotiates or offers to make or negotiate a mortgage
33 banking loan or a mortgage loan; and

34 (B) Services or sells a mortgage banking loan.

35 (b) "**Mortgage banker**" does not include:

36 (A) A financial institution, as defined in ORS 706.008.

37 (B) A financial holding company or a bank holding company, as defined in ORS 706.008, holding
38 an institution described in subparagraph (A) of this paragraph; a savings and loan holding company
39 as defined in [section 408 of the National Housing Act, 12 U.S.C. 1730a (1982)] **12 U.S.C.**
40 **1467a(a)(1)(D)**, holding an association described in subparagraph (A) of this paragraph; the subsid-
41 iaries and affiliates of the financial holding company, bank holding company or savings and loan
42 holding company; or subsidiaries and affiliates of institutions described in subparagraph (A) of this
43 paragraph, provided that the appropriate statutory regulatory authority is exercising control over
44 or is regulating or supervising the persons listed in this subparagraph in their mortgage banking
45 activities in accordance with the purposes of ORS 59.840 to 59.980.

1 (C) A person *[who]* **that** makes a loan secured by an interest in real estate with the person's
2 own moneys[,] for the person's own investment and *[who]* **that** is not engaged in the business of
3 making loans secured by an interest in real estate.

4 (D) *[An attorney licensed in this state who negotiates mortgage banking loans or mortgage loans*
5 *in the ordinary course of business, unless the business of negotiating mortgage banking loans or*
6 *mortgage loans constitutes substantially all of the attorney's professional activity.]* **An attorney li-**
7 **censed or otherwise authorized to practice law in this state if the attorney:**

8 (i) **Negotiates the terms of a residential mortgage loan as an ancillary matter in the at-**
9 **torney's representation of a client; and**

10 (ii) **Does not receive compensation from a mortgage banker, mortgage broker, mortgage**
11 **loan originator or lender or an agent of the mortgage banker, mortgage broker, mortgage**
12 **loan originator or lender.**

13 (E) A person *[who]* **that**, as seller of real property, receives one or more mortgages or deeds of
14 trust as security for a separate money obligation.

15 (F) An agency of *[any]* a state or of the United States.

16 (G) A person *[who]* **that** receives a mortgage or deed of trust on real property as security for
17 an obligation payable on an installment or deferred payment basis and arising out of materials fur-
18 nished or services rendered in the improvement of *[that]* **the** real property or *[any]* a lien created
19 without the consent of the owner of the real property.

20 (H) A person *[who]* **that** funds a mortgage banking loan or mortgage loan *[which has been*
21 *originated and processed by a licensee or by an exempt person and who]* **that a licensee or exempt**
22 **person originated and processed and that** does not maintain a place of business in this state in
23 connection with funding mortgage banking loans or mortgage loans, does not directly or indirectly
24 solicit borrowers in this state for the purpose of making mortgage banking loans or mortgage loans
25 and does not participate in *[the negotiation of]* **negotiating** mortgage banking loans or mortgage
26 loans. For the purpose of this subparagraph, "*[negotiation of]* **negotiating** mortgage banking loans
27 or mortgage loans" does not include setting the terms under which a person may buy or fund a
28 mortgage banking loan or a mortgage loan *[originated by]* **that** a licensee or exempt person **origi-**
29 **nated.**

30 (I) A nonprofit federally tax exempt corporation certified by the United States Small Business
31 Administration and organized to promote economic development within this state whose primary
32 activity consists of providing financing for business expansion.

33 (J) A licensee licensed under ORS chapter 725 or a mortgage broker.

34 (K) A retirement or pension fund.

35 (L) An insurer as defined in ORS 731.106.

36 (M) A court appointed fiduciary.

37 (N) *[Any other]* **A** person designated by rule or order of the Director **of the Department of**
38 **Consumer and Business Services.**

39 [(6)] (4) "Mortgage banking loan" means a loan, extension of credit or a retail sales contract
40 that is funded exclusively from the mortgage banker's own resources, *[which]* **that** is directly or
41 indirectly secured by a mortgage or deed of trust or any lien interest on real estate and *[which]* **that**
42 is created with the consent of the owner of the real property. For purposes of this subsection, "own
43 resources" means any of the following:

44 (a) Cash, corporate capital, warehouse credit lines at financial institutions defined in ORS
45 706.008 or other sources that are liability items of the mortgage banker's financial statements for

1 which *[its]* **the mortgage banker's** assets are pledged;

2 (b) Correspondent contracts between the mortgage banker and a bank, savings bank, trust
3 company, savings and loan association, credit union, profit sharing or pension trust, a licensee under
4 ORS chapter 725 or an insurance company; or

5 (c) The mortgage banker's affiliates' cash, corporate capital, warehouse credit lines at financial
6 institutions defined in ORS 706.008 or other sources that are liability items on the affiliates' finan-
7 cial statements for which the affiliates' assets are pledged. As used in this paragraph, "affiliates"
8 means entities that, directly or indirectly, through one or more intermediaries *[controls]* **control**, are
9 controlled by or are under common control with the entity specified.

10 *[(7)] (5)(a) "Mortgage broker"[:]*

11 *[(a)]* means a person *[who]* **that**:

12 (A) Engages all or part of the time, for the account of others or for the person's own account,
13 in the business of selling real estate paper whether as issuer, agent or principal to persons other
14 than persons enumerated in ORS 59.035 (4);

15 (B) Engages all or part of the time, for the account of others or for the person's own account,
16 in the business of accepting funds from one or more persons other than persons enumerated in ORS
17 59.035 (4) for investment in real estate paper; or

18 (C) For compensation, or in the expectation of compensation, either directly or indirectly makes,
19 negotiates or offers to make or negotiate a mortgage loan.

20 (b) **"Mortgage broker"** does not include:

21 (A) A financial institution, as defined in ORS 706.008.

22 (B)(i) A financial holding company or a bank holding company, as defined in ORS 706.008,
23 holding an institution described in subparagraph (A) of this paragraph;

24 (ii) A savings and loan holding company as defined in *[section 408 of the National Housing Act,*
25 *12 U.S.C. 1730a (1982)]* **12 U.S.C. 1467a(a)(1)(D)**, holding an association described in subparagraph
26 (A) of this paragraph;

27 (iii) The subsidiaries and affiliates of the financial holding company, bank holding company or
28 savings and loan holding company; or

29 (iv) Subsidiaries and affiliates of institutions described in subparagraph (A) of this paragraph,
30 provided that the appropriate statutory regulatory authority is exercising control over or is regu-
31 lating or supervising the persons listed in this subparagraph in *[their]* **the persons'** mortgage bro-
32 kering activities in accordance with the purposes of ORS 59.840 to 59.980.

33 (C) A person *[who]* **that** purchases real property and issues an obligation to finance the trans-
34 action to the seller incidentally to the sale.

35 (D) A real estate licensee as defined in ORS 696.010 who performs services solely incidental to
36 the practice of professional real estate activity as defined in ORS 696.010, unless the real estate
37 licensee performs the functions of a mortgage banker or a mortgage broker as defined in this sec-
38 tion.

39 (E) A person licensed under the provisions of ORS chapter 725 or a mortgage banker.

40 (F) A person *[who]* **that** makes a loan secured by an interest in real estate with the person's
41 own moneys, for the person's own investment and *[who]* **that** is not engaged in the business of
42 making loans secured by an interest in real estate.

43 (G) *[An attorney licensed in this state who negotiates mortgage loans in the ordinary course of*
44 *business, unless the business of negotiating mortgage loans constitutes substantially all of the attorney's*
45 *professional activity.]* **An attorney licensed or otherwise authorized to practice law in this state**

1 **if the attorney:**

2 (i) **Negotiates the terms of a residential mortgage loan as an ancillary matter in the at-**
3 **torney's representation of a client; and**

4 (ii) **Does not receive compensation from a mortgage banker, mortgage broker, mortgage**
5 **loan originator or lender or an agent of the mortgage banker, mortgage broker, mortgage**
6 **loan originator or lender.**

7 (H) A person *[who]* **that**, as a seller of real property, receives one or more mortgages or deeds
8 of trust as security for a separate money obligation.

9 (I) An agency of *[any]* a state or of the United States.

10 (J) A person *[who]* **that** receives a mortgage or deed of trust on real property as security for
11 an obligation payable on an installment or deferred payment basis and arising out of materials fur-
12 nished or services rendered in the improvement of *[that]* **the** real property or *[any]* a lien created
13 without the consent of the owner of the real property.

14 (K) A person *[who]* **that** funds a mortgage loan *[which has been originated and processed by a*
15 *licensee or by an exempt person and who]* **that a licensee or exempt person originated and pro-**
16 **cessed and that** does not maintain a place of business in this state in connection with funding
17 mortgage loans, does not directly or indirectly solicit borrowers in this state for the purpose of
18 making mortgage loans and does not participate in *[the negotiation of]* **negotiating** mortgage loans.
19 For the purpose of this subparagraph, "*[negotiation of]* **negotiating** mortgage loans" does not include
20 setting the terms under which a person may buy or fund a mortgage loan *[originated by]* **that** a
21 licensee or exempt person **originated**.

22 (L) A nonprofit federally tax exempt corporation certified by the United States Small Business
23 Administration and organized to promote economic development within this state whose primary
24 activity consists of providing financing for business expansion.

25 (M) A person licensed under ORS 446.691 or 446.696 or a temporary manufactured structure
26 dealer licensee under ORS 446.701 *[who]* **that** provides services customarily associated with the re-

36 **SECTION 38. If House Bill 2188 becomes law, section 2, chapter ___, Oregon Laws 2009 (En-**
37 **rolled House Bill 2188), is amended to read:**

38 **Sec. 2. (1)(a) As used in this section, "negative amortization loan" means a mortgage loan or**
39 **mortgage banking loan that is structured in such a way that a borrower in any period may make**
40 **a scheduled loan payment that is insufficient to pay accruing interest.**

41 (b) **"Negative amortization loan" does not include:**

42 (A) **A loan commonly known as a bridge loan, the terms of which specify that:**

43 (i) **The maturity period for the loan is less than 18 months; and**

44 (ii) **The borrower may pay only interest until a time when the entire unpaid loan balance is due**
45 **and payable.**

1 (B) A mortgage loan in which:

2 (i) The principal amount is not more than \$50,000; and

3 (ii) The combined loan to value ratio between all mortgage loans that are secured by the same
4 property and the value of the securing property is not more than 50 percent.

5 (C) A loan commonly known as a reverse mortgage, the terms of which specify that the loan:

6 (i) Is a non-recourse loan secured by real property;

7 (ii) Provides cash advances to the borrower based on the equity or value in the borrower's
8 owner-occupied principal residence;

9 (iii) Requires no payment of principal or interest until the entire loan becomes due and payable;
10 and

11 (iv) Is made by a mortgage lender licensed in this state or licensed under the laws of the United
12 States.

13 (D) A loan commonly known as a home equity line of credit, in which:

14 (i) The amounts borrowed and the interest and other charges are debited to an account that is
15 secured by an interest in real estate;

16 (ii) Interest on the account is computed periodically;

17 (iii) The borrower has the right to pay in full at any time without penalty or to pay in install-
18 ments that are specified in the loan agreement; and

19 (iv) The lender agrees to permit a borrower from time to time to borrow money, with the max-
20 imum limit on the amount of each borrowing established by the loan agreement.

21 (2) A mortgage banker, mortgage broker or **mortgage** loan originator may not negotiate or
22 make, or offer to negotiate or make, a negative amortization loan without regard to the borrower's
23 repayment ability at the time the loan is made, including the borrower's current and reasonably
24 expected income, employment, assets other than the collateral, current obligations and mortgage
25 related obligations. The mortgage banker, mortgage broker or **mortgage** loan originator shall verify
26 the income and assets of the borrower that will be relied on to evaluate the borrower's repayment
27 ability. The borrower's repayment ability must be evaluated and the borrower's income and assets
28 must be verified in a manner that is consistent with the requirements of 12 C.F.R. 226.34, as
29 promulgated on the effective date of **chapter __, Oregon Laws 2009 (Enrolled House Bill 2188)**
30 [*this 2009 Act*].

31 (3) A negative amortization loan may not contain a prepayment penalty beyond the first 24
32 months after the date on which the loan is made.

33 (4) A creditor may not collect a prepayment penalty on an existing negative amortization loan
34 in return for or as a consequence of refinancing or providing funds to refinance the negative
35 amortization loan.

36 **SECTION 39.** If House Bill 2188 becomes law, section 3, chapter __, Oregon Laws 2009 (En-
37 rolled House Bill 2188), is amended to read:

38 **Sec. 3.** (1) A mortgage banker, a mortgage broker or a **mortgage** loan originator shall provide
39 in writing the materials identified in subsection (2) of this section to a borrower if the mortgage
40 banker, mortgage broker or **mortgage** loan originator:

41 (a) Communicates or causes to be communicated an advertisement in a language other than
42 English or otherwise solicits business in a language other than English; and

43 (b) Offers to negotiate or make, or negotiates or makes, a residential mortgage transaction in
44 the course of which a substantial portion of the communication with the borrower that is related
45 to the transaction takes place in the language other than English that was used to communicate the

1 advertisement or make the solicitation.

2 (2) A mortgage banker, mortgage broker or **mortgage** loan originator that takes an action de-
3 scribed in subsection (1) of this section shall provide the following materials to the borrower in
4 English and in the language other than English in which a substantial portion of the communication
5 that is related to the transaction takes place:

6 (a) A good faith estimate required under the Real Estate Settlement Procedures Act, 12 U.S.C.
7 2601 et seq., and under Regulation X, 24 C.F.R. part 3500, as enacted or promulgated on January
8 1, 2010;

9 (b) The disclosures related to the transaction that are required under the Truth in Lending Act,
10 15 U.S.C. 1601 et seq., and under Regulation Z, 12 C.F.R. part 226, as enacted or promulgated on the
11 effective date of **chapter __, Oregon Laws 2009 (Enrolled House Bill 2188)** [*this 2009 Act*]; and

12 (c) A statement notifying the borrower that loan documents associated with the transaction will
13 be in English and advising the borrower to obtain appropriate assistance with any necessary trans-
14 lations.

15 (3) The Director of the Department of Consumer and Business Services shall develop and dis-
16 tribute translated versions of the materials identified in subsection (2) of this section in the three
17 languages other than English that are most commonly spoken in this state.

18 **SECTION 40. The amendments to sections 2 and 3, chapter __, Oregon Laws 2009 (En-**
19 **rolled House Bill 2188), by sections 38 and 39 of this 2009 Act become operative on January**
20 **1, 2010.**

21 **SECTION 41.** If House Bill 2191 becomes law, ORS 697.612, as amended by section 2, chapter
22 __, Oregon Laws 2009 (Enrolled House Bill 2191), is amended to read:

23 697.612. (1) A person that has not registered with the Director of the Department of Consumer
24 and Business Services under ORS 697.632 may not engage in business in this state in the course of
25 which the person:

26 (a) Performs a debt management service; or

27 (b) Receives money or other valuable consideration or expects to receive money or other valu-
28 able consideration for:

29 (A) Soliciting or receiving an application from a consumer for a debt management service;

30 (B) Forwarding or providing a completed application for a debt management service to a debt
31 management service provider;

32 (C) Referring a consumer to another debt management service provider, if the person is a debt
33 management service provider;

34 (D) Providing a consumer's name, address or other information that identifies the consumer to
35 a debt management service provider for the purpose of arranging the provision of a debt manage-
36 ment service; or

37 (E) Providing advice, assistance, instruction or instructional material concerning a debt man-
38 agement service to a consumer.

39 (2) A debt management service provider registered under ORS 697.632 may negotiate on a con-
40 sumer's behalf for a reasonable alternative repayment schedule or to reduce a claim described in
41 11 U.S.C. 502 if the debt management service provider is a nonprofit budget and credit counseling
42 agency approved in accordance with 11 U.S.C. 111.

43 (3) Subsection (1) of this section does not apply to:

44 (a) An employee of a debt management service provider, if the debt management service pro-
45 vider is registered under ORS 697.632.

1 (b) An attorney licensed or authorized to practice law in this state, if the attorney provides a
2 debt management service only incidentally in the practice of law.

3 (c) A financial institution or a trust company, both as defined in ORS 706.008.

4 (d) A consumer finance company licensed under ORS chapter 725.

5 (e) An escrow agent licensed under ORS 696.505 to 696.590.

6 (f) A mortgage banker or mortgage broker licensed under ORS 59.840 to 59.980 or a **mortgage**
7 loan originator, as defined in ORS 59.840.

8 (g) A broker-dealer registered with the United States Securities and Exchange Commission or
9 the United States Commodity Futures Trading Commission, if the broker-dealer is subject to and
10 acts in accordance with regulations promulgated by either commission.

11 (h) A consumer reporting agency, as defined in 15 U.S.C. 1681a(f).

12 (i) A public body, as defined in ORS 174.109.

13 (j) A person that is obeying or acting in accordance with a court order.

14 (k) An accredited educational institution or program that offers or performs a debt management
15 service without receiving money or other valuable consideration, if the institution or program per-
16 forms the debt management service as an incidental part of a class or a duty the institution or
17 program provides regularly.

18 (L) A nonprofit budget and credit counseling agency approved in accordance with 11 U.S.C. 111
19 that:

20 (i) Provides only an individual or group briefing, as described in 11 U.S.C. 109(h), or an in-
21 structural course concerning personal financial management, as described in 11 U.S.C. 111; and

22 (ii) Does not receive or offer to receive funds from a consumer for the purpose of distributing
23 the funds among the consumer's creditors in full or partial payment of the consumer's debts.

24 (m) A nonprofit entity that provides advice, assistance, instruction or instructional materials to
25 a consumer in return for a fee that is reasonably calculated to pay the cost of making the advice,
26 assistance, instruction or instructional materials available.

27 (n) An organization or a counselor approved by the United States Department of Housing and
28 Urban Development under 12 U.S.C. 1701x.

29 **SECTION 42. The amendments to ORS 697.612 by section 41 of this 2009 Act become op-**
30 **erative on January 1, 2010.**

31 **SECTION 43. This 2009 Act being necessary for the immediate preservation of the public**
32 **peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect**
33 **on its passage.**
