

HOUSE AMENDMENTS TO HOUSE BILL 2189

1 On page 1 of the printed bill, delete lines 3 through 5 and insert “59.850, 59.855, 59.860, 59.865,
2 59.875, 59.880, 59.900, 59.905, 59.925, 59.962, 59.967, 59.971, 59.972, 59.992, 446.691, 446.696, 446.706,
3 446.741, 725.010, 725.140 and 725.230; repealing ORS 59.969, 59.970, 59.973, 59.975 and 59.977; and
4 declaring an emergency.

5 “Whereas the activities of mortgage loan originators and the origination or offer of financing
6 for real property have a direct, valuable and immediate impact on consumers, on the economy,
7 neighborhoods and communities of this state and on the housing and real estate industry; and

8 “Whereas access to mortgage credit is vital to the citizens of this state; and

9 “Whereas reasonable standards to license and regulate the business practices of mortgage loan
10 originators are essential to protect the citizens of this state and the stability of this state’s economy;
11 and

12 “Whereas the Legislative Assembly therefore declares that the purpose of sections 1 to 13 of
13 this 2009 Act is to protect consumers that seek mortgage loans and to ensure that the mortgage
14 lending industry operates without unfair, deceptive or fraudulent practices among mortgage loan
15 originators; now, therefore,”.

16 Delete lines 7 through 23 and delete pages 2 through 18 and insert:

17 **“SECTION 1. As used in sections 1 to 13 of this 2009 Act:**

18 **“(1) ‘Depository institution’ means a depository institution, as defined in 12 U.S.C.**
19 **1813(c), and a credit union, as defined in ORS 723.008.**

20 **“(2) ‘Federal banking agency’ means:**

21 **“(a) The Board of Governors of the Federal Reserve System;**

22 **“(b) The Comptroller of the Currency;**

23 **“(c) The Director of the Office of Thrift Supervision in the United States Department of**
24 **the Treasury;**

25 **“(d) The National Credit Union Administration Board; and**

26 **“(e) The Board of Directors of the Federal Deposit Insurance Corporation.**

27 **“(3)(a) ‘Loan processor or underwriter’ means an individual who, after receiving an ap-**
28 **plication, performs clerical or support duties that include:**

29 **“(A) Receiving, collecting, distributing and analyzing information commonly used in pro-**
30 **cessing or underwriting a residential mortgage loan; or**

31 **“(B) Communicating with a consumer to obtain information necessary to process or**
32 **underwrite a residential mortgage loan.**

33 **“(b) ‘Loan processor or underwriter’ does not include an individual who communicates**
34 **with a consumer for the purpose of offering or negotiating residential mortgage loan terms**
35 **with the consumer or offering counsel or consultation to the consumer concerning residen-**

1 tial mortgage loan terms or rates.

2 “(4)(a) ‘Mortgage loan originator’ means an individual who, for compensation or gain:

3 “(A) Takes an application for a residential mortgage loan; or

4 “(B) Offers or negotiates terms for a residential mortgage loan.

5 “(b) ‘Mortgage loan originator’ does not include:

6 “(A) An individual who, as an employee or independent contractor, works solely as a loan
7 processor or underwriter;

8 “(B) A person that performs professional real estate activities, as defined in ORS 696.010,
9 unless the person is compensated by a mortgage banker, mortgage broker, mortgage loan
10 originator or lender or an agent of a mortgage banker, mortgage broker, mortgage loan
11 originator or lender;

12 “(C) An individual that extends credit solely in connection with a timeshare plan, as de-
13 fined in 11 U.S.C. 101(53D); or

14 “(D) An individual who:

15 “(i) Is employed by a person that is licensed by the Director of the Department of Con-
16 sumer and Business Services; and

17 “(ii) Collects or receives payments on behalf of a person that holds a residential mort-
18 gage, including payments of principal, interest, escrow amounts and other amounts due on
19 obligations that under the terms of the note are due and owed to the person that holds the
20 residential mortgage.

21 “(5) ‘Nationwide Mortgage Licensing System and Registry’ means a system that the
22 Conference of State Bank Supervisors and the American Association of Residential Mortgage
23 Regulators maintain to register and license mortgage loan originators.

24 “(6) ‘Nontraditional mortgage’ means a mortgage other than a 30-year fixed-rate mort-
25 gage or a mortgage that the director by rule defines as a nontraditional mortgage.

26 “(7) ‘Registered mortgage loan originator’ means an individual who:

27 “(a) Is employed by:

28 “(A) A depository institution;

29 “(B) A subsidiary of a depository institution that is regulated by a federal banking
30 agency; or

31 “(C) An institution that is regulated by the Farm Credit Administration;

32 “(b) Performs the duties of a mortgage loan originator; and

33 “(c) Complies with the registration requirements set forth in 12 U.S.C. 5106.

34 “(8) ‘Residential mortgage loan’ means a loan that is secured by a mortgage, deed of
35 trust or equivalent consensual security interest on four or fewer residential dwelling units,
36 including but not limited to individual dwelling units, mobile homes, condominiums or coop-
37 eratives that are planned for or situated on real property in this state.

38 “(9) ‘Unique identifier’ means a number or other means of identification that is assigned
39 by or under protocols established by the Nationwide Mortgage Licensing System and Regis-
40 try.

41 “SECTION 2. (1) Except as provided in subsection (2) of this section, an individual may
42 not engage in business as a mortgage loan originator in this state without first:

43 “(a) Obtaining and maintaining a mortgage loan originator’s license under section 4 of
44 this 2009 Act or renewing a mortgage loan originator’s license under section 6 of this 2009
45 Act; and

1 “(b) Obtaining a unique identifier from the Nationwide Mortgage Licensing System and
2 Registry.

3 “(2) Subsection (1) of this section does not apply to:

4 “(a) A registered mortgage loan originator who acts within the scope of the registered
5 mortgage loan originator’s employment;

6 “(b) An individual who offers or negotiates terms of a residential mortgage loan with or
7 on behalf of the individual’s spouse, child, sibling, parent, grandparent, grandchild or a rela-
8 tive in a similar relationship with the individual that is created by law, marriage or adoption;

9 “(c) An individual who offers or negotiates terms of a residential mortgage loan that is
10 secured by a dwelling that served as the individual’s residence; or

11 “(d) An attorney licensed or otherwise authorized to practice law in this state if the at-
12 torney:

13 “(A) Negotiates the terms of a residential mortgage loan as an ancillary matter in the
14 attorney’s representation of a client; and

15 “(B) Does not receive compensation from a mortgage banker, mortgage broker, mortgage
16 loan originator or lender or an agent of the mortgage banker, mortgage broker, mortgage
17 loan originator or lender.

18 “(3) The director by rule may exempt a person from the requirement to obtain a mort-
19 gage loan originator’s license under sections 1 to 13 of this 2009 Act if the United States
20 Department of Housing and Urban Development requires or permits the exemption under 12
21 U.S.C. 5101 et seq.

22 “SECTION 3. (1) The Director of the Department of Consumer and Business Services by
23 rule shall determine the manner in which an applicant must apply and the form and contents
24 of an application for a license to conduct business as a mortgage loan originator.

25 “(2) In connection with an application under this section, an applicant shall apply for and
26 receive a unique identifier from the Nationwide Mortgage Licensing System and Registry.
27 As part of the application, the director by rule shall require the applicant to submit to the
28 director or directly to the Nationwide Mortgage Licensing System and Registry:

29 “(a) Fingerprints that the Federal Bureau of Investigation, or another government
30 agency that is authorized to receive fingerprints, can use to perform a state, national and
31 international criminal background check;

32 “(b) A summary of the applicant’s personal history and experience on a form prescribed
33 by the Nationwide Mortgage Licensing System and Registry;

34 “(c) A document that authorizes the Nationwide Mortgage Licensing System and Registry
35 to obtain, with reference to the applicant:

36 “(A) A credit report from a consumer reporting agency, as defined in 15 U.S.C. 1681a(f),
37 or a consumer reporting agency that compiles and maintains files on consumers on a na-
38 tionwide basis, as defined in 15 U.S.C. 1681a(p); and

39 “(B) Information about administrative, civil or criminal proceedings and findings con-
40 cerning the applicant in any governmental jurisdiction; and

41 “(d) Other information the director or the Nationwide Mortgage Licensing System and
42 Registry may require.

43 “SECTION 3a. The Director of the Department of Consumer and Business Services may
44 issue an interim mortgage loan originator’s license to a person that is not licensed under
45 section 4 of this 2009 Act if the director finds that issuing the interim license will facilitate

1 the business of licensed mortgage loan originators or prevent an undue delay in issuing a
2 mortgage loan originator's license. The director may specify the term of the interim mort-
3 gage loan originator's license and may issue the interim license to an applicant for a mort-
4 gage loan originator's license only if the director finds that the applicant:

5 “(1) Is employed by a person that has a valid license or registration from the Department
6 of Consumer and Business Services;

7 “(2) Substantially meets the requirements of sections 3, 4 and 5 of this 2009 Act as of the
8 operative date of this section; and

9 “(3) Has not committed an act prohibited under section 12 of this 2009 Act.

10 **SECTION 4.** (1) The Director of the Department of Consumer and Business Services
11 may not issue a mortgage loan originator's license to an applicant unless the director finds,
12 at a minimum, that the applicant:

13 “(a) Has obtained a unique identifier from the Nationwide Mortgage Licensing System
14 and Registry.

15 “(b) Has not had a mortgage loan originator's license revoked in another jurisdiction. For
16 purposes of this paragraph, an applicant's mortgage loan originator's license was not revoked
17 if an order or decision to revoke the license was later rescinded or vacated.

18 “(c) Has not been convicted of or pleaded guilty or no contest in a state, federal, foreign
19 or military court to a felony or to a misdemeanor if an essential element of the misdemeanor
20 involved false statements or dishonesty:

21 “(A) During a period of seven years before the date the applicant submits an application
22 under section 3 of this 2009 Act; or

23 “(B) At any time before the date the applicant submits an application under section 3 of
24 this 2009 Act, if the conviction or plea involved a felony and an element of the felony was
25 an act of fraud, dishonesty, a breach of trust or laundering a monetary instrument. For
26 purposes of this paragraph, a conviction that was later pardoned is not a conviction.

27 “(d) Has demonstrated financial responsibility sufficient to command the confidence of
28 the community and warrant the determination that the applicant will operate honestly, fairly
29 and efficiently within the purposes of sections 1 to 13 of this 2009 Act.

30 “(e) Has completed the education requirement set forth in section 5 of this 2009 Act and
31 passed a test that meets the standards set forth in section 5 of this 2009 Act.

32 “(f) Is covered by a surety bond in accordance with the provisions of section 9 of this 2009
33 Act.

34 “(2) The director may not:

35 “(a) Deny a mortgage loan originator's license to an applicant because of the applicant's
36 credit score; or

37 “(b) Use information in a credit report as the sole basis for denying the mortgage loan
38 originator's license.

39 “(3) The director shall issue a mortgage loan originator's license to an applicant if:

40 “(a) The director is satisfied that the information contained in the application for a
41 mortgage loan originator's license is accurate and complete; and

42 “(b) No reason exists under subsection (1) of this section to deny the applicant a mort-
43 gage loan originator's license.

44 “(4) The director by rule may specify criteria for determining financial responsibility
45 under subsection (1)(d) of this section.

1 **“SECTION 5. (1) An applicant for a mortgage loan originator’s license shall:**

2 **“(a) Complete, at a minimum, 20 hours of an approved course of prelicensing education**
3 **that, at a minimum, must include:**

4 **“(A) Three hours devoted to federal laws and regulations;**

5 **“(B) Three hours devoted to ethics, with instruction concerning fraud, consumer pro-**
6 **tection and fair lending; and**

7 **“(C) Two hours devoted to lending standards applicable to nontraditional mortgages; and**

8 **“(b) Pass a qualified written test with a score of 75 percent correct or better. The test**
9 **must measure the applicant’s knowledge of:**

10 **“(A) Ethics; and**

11 **“(B) Federal and state laws, regulations and rules that apply to residential mortgage loan**
12 **origination, including laws, regulations and rules that concern fraud, consumer protection,**
13 **fair lending and nontraditional mortgages.**

14 **“(2) For purposes of this section:**

15 **“(a) An approved course of prelicensing education is a course that the Nationwide Mort-**
16 **gage Licensing System and Registry has reviewed and for which the Nationwide Mortgage**
17 **Licensing System and Registry has approved the contents, provider, instructional standards**
18 **and means and methods of delivery, using reasonable standards.**

19 **“(b) A qualified written test is a test that the Nationwide Mortgage Licensing System and**
20 **Registry develops and for which the Nationwide Mortgage Licensing System and Registry**
21 **approves the test provider and method of test administration, using reasonable standards.**

22 **“(3) The director shall accept for the purposes of the requirements set forth in sub-**
23 **section (1) of this section an approved course of prelicensing education that an applicant**
24 **completed in another state.**

25 **“(4) This section does not preclude:**

26 **“(a) An applicant’s employer or a subsidiary, agent or affiliate of the employer from**
27 **providing an approved course of prelicensing education; or**

28 **“(b) An approved test provider from administering a qualified test at the business lo-**
29 **cation of the applicant’s employer or an affiliate, subsidiary or agent of the employer or at**
30 **the business location of a person with which the employer has an exclusive contractual ar-**
31 **rangement related to mortgage loan origination.**

32 **“(5) An applicant may take a qualified test four consecutive times, provided that each**
33 **test administration occurs 30 days after a previous test administration. If the applicant fails**
34 **the approved test four consecutive times, the applicant must wait at least six months before**
35 **retaking the test.**

36 **“SECTION 6. (1) The Director of the Department of Consumer and Business Services**
37 **shall renew a mortgage loan originator’s license if the director finds that:**

38 **“(a) The licensed mortgage loan originator continues to meet the requirements set forth**
39 **under section 4 of this 2009 Act;**

40 **“(b) The licensed mortgage loan originator paid the fee required to renew the mortgage**
41 **loan originator’s license; and**

42 **“(c) The licensed mortgage loan originator satisfied the continuing education require-**
43 **ments set forth in section 7 of this 2009 Act. If the licensed mortgage loan originator did not**
44 **satisfy the requirements under section 7 of this 2009 Act, instead of declining to renew the**
45 **mortgage loan originator’s license, the director by rule or order may permit or require the**

1 licensed mortgage loan originator to make up the deficiency in continuing education.

2 “(2)(a) A mortgage loan originator’s license expires if:

3 “(A) The licensed mortgage loan originator does not apply to renew the mortgage loan
4 originator’s license;

5 “(B) The director declines to renew the mortgage loan originator’s license; or

6 “(C) The licensed mortgage loan originator does not otherwise maintain eligibility under
7 the requirements set forth in sections 1 to 13 of this 2009 Act.

8 “(b) The director by rule may establish a procedure and requirements for reinstating a
9 license that has expired. The procedure and requirements the director establishes must be
10 consistent with standards established by the Nationwide Mortgage Licensing System and
11 Registry and must at a minimum provide that an applicant for reinstatement who has al-
12 lowed the applicant’s mortgage loan originator’s license to lapse for a period of five or more
13 years, whether or not the applicant was employed or continued to engage in business as a
14 mortgage loan originator during the period of the lapse, shall:

15 “(A) Demonstrate to the director that the applicant completed the continuing education
16 requirements set forth in section 7 of this 2009 Act that were required in the year in which
17 the applicant last held a mortgage loan originator’s license; and

18 “(B) Pass the qualified written test as provided in section 5 of this 2009 Act.

19 “SECTION 7. (1) A licensed mortgage loan originator each year shall complete at least
20 eight hours of an approved course of continuing education that, at a minimum, must include:

21 “(a) Three hours devoted to federal laws and regulations;

22 “(b) Two hours devoted to ethics, with instruction concerning fraud, consumer protection
23 and fair lending; and

24 “(c) Two hours devoted to lending standards applicable to nontraditional mortgages.

25 “(2) For purposes of this section, an approved course of continuing education is a course
26 that the Nationwide Mortgage Licensing System and Registry has reviewed and for which the
27 Nationwide Mortgage Licensing System and Registry has approved the contents, provider,
28 instructional standards and means and methods of delivery, using reasonable standards.

29 “(3) This section does not preclude a licensed mortgage loan originator’s employer or a
30 subsidiary, agent or affiliate of the employer from providing an approved course of continu-
31 ing education.

32 “(4) The Director of the Department of Consumer and Business Services shall accept for
33 the purposes of the requirement set forth in subsection (1) of this section an approved course
34 of continuing education that a licensed mortgage loan originator completed in another state.

35 “(5) A licensed mortgage loan originator:

36 “(a) May receive credit for a continuing education course only in the year in which the
37 licensed mortgage loan originator takes the course, unless the director under section 6 of
38 this 2009 Act permits or requires the mortgage loan originator to make up a deficiency in
39 continuing education; and

40 “(b) May not for the purposes of meeting the requirement set forth in subsection (1) of
41 this section take the same approved course of continuing education in the same year or in
42 any two successive years.

43 “(6) A licensed mortgage loan originator who is also approved as an instructor for an
44 approved course of continuing education may receive two hours of credit toward the licensed
45 mortgage loan originator’s own continuing education requirement for each hour of the ap-

1 proved course of continuing education that the licensed mortgage loan originator teaches.

2 **“SECTION 8. (1) In addition to authority the Director of the Department of Consumer**
3 **and Business Services has under ORS 59.840 to 59.980, the director under this section has the**
4 **authority, subject to ORS chapter 183, to deny, suspend, place conditions upon, revoke or**
5 **decline to renew a mortgage loan originator’s license or permanently prohibit a person from**
6 **conducting business as a mortgage loan originator if:**

7 **“(a) A licensed mortgage loan originator violates a provision of sections 1 to 13 of this**
8 **2009 Act or a rule or order the director issues under sections 1 to 13 of this 2009 Act;**

9 **“(b) The director makes a finding under section 4 or 6 of this 2009 Act that the director**
10 **believes justifies a decision to deny or decline to renew a mortgage loan originator’s license;**

11 **“(c) An applicant makes a false statement or a material misstatement of fact on an ap-**
12 **plication for a mortgage loan originator’s license or a licensed mortgage loan originator**
13 **makes a false statement or a material misstatement of fact on an application to renew a**
14 **mortgage loan originator’s license; or**

15 **“(d) A person who is not exempted from the requirement to obtain a mortgage loan**
16 **originator’s license under section 2 (2) of this 2009 Act conducts business as a mortgage loan**
17 **originator without applying for and receiving a mortgage loan originator’s license under**
18 **sections 3 and 4 of this 2009 Act.**

19 **“(2) The director, subject to ORS chapter 183, may order a person that is subject to**
20 **regulation under sections 1 to 13 of this 2009 Act to:**

21 **“(a) Cease and desist immediately or permanently from violating a provision of sections**
22 **1 to 13 of this 2009 Act or from an act or practice related to mortgage loan origination that**
23 **the director deems harmful to a consumer or to the public;**

24 **“(b) Stop or suspend business related to mortgage loan origination;**

25 **“(c) Pay restitution to a consumer or another person that the director finds suffered**
26 **harm from the person’s acts, omissions, practices or operations or as a result of the person’s**
27 **violation of a provision of sections 1 to 13 of this 2009 Act; or**

28 **“(d) Take or refrain from taking an action the director deems necessary to comply with**
29 **sections 1 to 13 of this 2009 Act.**

30 **“(3)(a) The director, in accordance with ORS 183.745, may impose a civil penalty in an**
31 **amount not to exceed \$5,000 for each separate instance of a violation of or failure to comply**
32 **with the provisions of sections 1 to 13 of this 2009 Act or a rule or order the director adopted**
33 **or issued under sections 1 to 13 of this 2009 Act.**

34 **“(b) Every violation described in paragraph (a) of this subsection is a separate offense**
35 **that is subject to a separate penalty. Each day in which the same violation occurs is a sep-**
36 **arate violation. A violation that continues for more than one day is a continuing violation**
37 **that is subject to a maximum penalty of \$20,000.**

38 **“(4)(a) A person may not knowingly:**

39 **“(A) Violate a provision of section 2 of this 2009 Act;**

40 **“(B) Fail to comply with an order the director issues under this section;**

41 **“(C) Fail to produce records at the director’s request under section 11 of this 2009 Act;**

42 **“(D) Employ a device, scheme or artifice to defraud or engage in an act, practice or**
43 **course of business that operates or would operate as a fraud or deceit;**

44 **“(E) Make an untrue statement of a material fact or omit from a statement a material**
45 **fact that would make the statement not misleading in light of the circumstances under**

1 which the person makes the statement; or

2 “(F) Make or file or cause to be made or filed with the director a statement, report or
3 document that the person knows is false in a material respect or matter.

4 “(b) A person who takes an action described in paragraph (a) of this subsection commits
5 a Class C felony.

6 “**SECTION 9.** (1) A person that employs a mortgage loan originator shall file with the
7 Director of the Department of Consumer and Business Services a corporate surety bond that
8 runs to the State of Oregon and that covers each mortgage loan originator the person em-
9 ploys. The corporate surety bond must be issued by a corporate surety or an insured insti-
10 tution, as defined in ORS 706.008, that is authorized to transact business in this state.

11 “(2) The director by rule shall:

12 “(a) Prescribe the form of the corporate surety bond;

13 “(b) Require the person to maintain the corporate surety bond in an amount that reflects
14 the dollar amount of the loans the person originated or in a minimum amount the director
15 specifies; and

16 “(c) Prescribe other requirements for the corporate surety bond as are necessary to ac-
17 complish the purposes of sections 1 to 13 of this 2009 Act.

18 “(3) A right of action against the corporate surety bond required under this section exists
19 to the same extent that a right of action exists under ORS 59.925.

20 “(4) The director may require the person to file a new corporate surety bond if an action
21 is commenced against the corporate surety bond on file with the director. The person shall
22 file a new corporate surety bond immediately if a recovery is obtained against the bond.

23 “**SECTION 10.** (1) The Director of the Department of Consumer and Business Services
24 may contract with or otherwise agree with the Nationwide Mortgage Licensing System and
25 Registry, or a person the Nationwide Mortgage Licensing System and Registry designates,
26 to:

27 “(a) Collect and maintain records in connection with an application under section 4 or 6
28 of this 2009 Act;

29 “(b) Collect and process application fees or other fees that are authorized under sections
30 1 to 13 of this 2009 Act and imposed by a government agency or association of government
31 agencies;

32 “(c) Serve as a point of contact the director may use to request information from and
33 provide information to the United States Department of Justice, the Federal Bureau of In-
34 vestigation or other government agencies;

35 “(d) Apply, abide by and implement standards the Nationwide Mortgage Licensing System
36 and Registry establishes for:

37 “(A) Setting or resetting dates for reporting information or renewing a mortgage loan
38 originator’s license; and

39 “(B) Amending or surrendering a mortgage loan originator’s license; and

40 “(e) Otherwise participate in the Nationwide Mortgage Licensing System and Registry.

41 “(2) The director may agree with the Conference of State Bank Supervisors, the Ameri-
42 can Association of Residential Mortgage Regulators or other government agencies or asso-
43 ciations of government agencies to share and to maintain under subsection (4) of this section
44 the confidentiality or privilege applicable to information or material that:

45 “(a) An applicant provides under section 3 of this 2009 Act;

1 “(b) A mortgage loan originator provides under section 6 of this 2009 Act; or

2 “(c) The director obtains from investigations, inquiries, proceedings, submissions or
3 other sources under the authority of sections 1 to 13 of this 2009 Act.

4 “(3) The director shall provide copies of information and material that the director sup-
5 plies to or receives from the Nationwide Mortgage Licensing System and Registry to an ap-
6 plicant for a mortgage loan originator’s license under section 4 of this 2009 Act or to a
7 licensed mortgage loan originator who applies to renew a license under section 6 of this 2009
8 Act. The director by rule shall establish a procedure for challenging the accuracy or com-
9 pleteness of the information and materials.

10 “(4)(a) Except as provided in subsections (5) and (6) of this section and 12 U.S.C. 5111,
11 information or material that an applicant, a mortgage loan originator or the director pro-
12 vides or discloses to the Nationwide Mortgage Licensing System and Registry retains the
13 confidentiality or privilege from public disclosure that applies to the information under ORS
14 192.410 to 192.505 or under other applicable state or federal law, including court rules. The
15 confidentiality or privilege applies to the information or material despite disclosure to state
16 or federal agencies with regulatory authority over persons, businesses or activities related
17 to mortgage lending.

18 “(b) Information that is subject to a privilege described in paragraph (a) of this sub-
19 section is not subject to:

20 “(A) Disclosure under state or federal law that governs disclosure of information in the
21 possession of a public official; or

22 “(B) Subpoena, discovery or admission into evidence in an administrative proceeding or
23 private civil action, unless the person whose information is protected by the confidentiality
24 or privilege waives the confidentiality or privilege in whole or in part.

25 “(c) To the extent that the provisions of ORS 192.410 to 192.505 conflict with the pro-
26 visions of this section, the provisions of this section control.

27 “(5) Subsection (4) of this section does not apply to information or material concerning
28 an applicant’s or a mortgage loan originator’s employment history or records of discipline
29 and enforcement actions that appear in and are open to public access in the Nationwide
30 Mortgage Licensing System and Registry. The director may publish on the Internet infor-
31 mation that the director receives from the Nationwide Mortgage Licensing System and Reg-
32 istry that is not subject to a privilege described in subsection (4) of this section.

33 “(6) The director shall regularly report to the Nationwide Mortgage Lending System and
34 Registry violations of the provisions of sections 1 to 13 of this 2009 Act, enforcement actions
35 against a person subject to sections 1 to 13 of this 2009 Act and other information the di-
36 rector deems necessary to meet the director’s obligations under agreements with the Na-
37 tionwide Mortgage Licensing System and Registry.

38 “(7) To the extent reasonably necessary to participate in the Nationwide Mortgage Li-
39 censing System and Registry, the director by rule or order may waive or modify, in whole
40 or in part, the requirements set forth in sections 1 to 13 of this 2009 Act or establish new
41 requirements consistent with the provisions of sections 1 to 13 of this 2009 Act.

42 “SECTION 11. (1) The Director of the Department of Consumer and Business Services,
43 as often as the director deems necessary to carry out the purposes of sections 1 to 13 of this
44 2009 Act, may:

45 “(a) Request or require a person that employs a mortgage loan originator or that under

1 the provisions of sections 1 to 13 of this 2009 Act should employ a mortgage loan originator
2 to produce, for the director's examination and use, books, accounts, records, files, docu-
3 ments or other information or evidence;

4 "(b) Investigate or examine an applicant or a licensed mortgage loan originator and re-
5 view the applicant's or licensed mortgage loan originator's:

6 "(A) History of criminal, civil and administrative proceedings, enforcement actions, ar-
7 rests or other information related to the applicant's or licensed mortgage loan originator's
8 compliance with state and federal law, rules or regulations; and

9 "(B) Personal history and experience, including information obtained from credit reports
10 from a consumer reporting agency, as defined in 15 U.S.C. 1681a(f) or from a consumer re-
11 porting agency that compiles and maintains files on consumers on a nationwide basis, as
12 defined in 15 U.S.C. 1681a(p);

13 "(c) Direct, subpoena, examine, compel the attendance of, administer oaths and affirma-
14 tions to, and request production of books, accounts, records, files, documents or other in-
15 formation or evidence from witnesses and persons that are subject to regulation under
16 sections 1 to 13 of this 2009 Act; and

17 "(d) Interview and take and preserve testimony concerning business practices and oper-
18 ations from the applicant's or licensed mortgage loan originator's officers, principals, mort-
19 gage loan originators, employees, agents and customers or independent contractors
20 associated with the applicant or licensed mortgage loan originator.

21 "(2)(a) The director may, with reference to documents, materials or records described in
22 subsection (1) of this section:

23 "(A) Take possession of, sequester, control or restrict access to the documents, materi-
24 als or records; or

25 "(B) Designate a person to take exclusive charge of the documents, materials or records
26 in the location in which the documents, materials or records are usually kept.

27 "(b) At a time in which the director has taken an action described in paragraph (a) of this
28 subsection, a person may not, without the director's permission or a court order, remove
29 or attempt to remove the documents, materials or records from the director's possession
30 or control or from the location in which the documents, materials or records are kept under
31 the exclusive charge of the person the director designates.

32 "(c) A person who owns or has a right to possess or control the documents, materials
33 or records may have access necessary to conduct the person's ordinary business, unless the
34 director reasonably believes that the documents, materials or records have been or are at
35 risk of alteration or destruction for the purposes of concealing a violation of sections 1 to
36 13 of this 2009 Act.

37 "(3) In carrying out the purposes of this section, the director may:

38 "(a) Retain attorneys, accountants or other professionals or specialists to conduct in-
39 vestigations, audits or examinations or assist in conducting investigations, audits or exam-
40 inations;

41 "(b) Agree with other government agencies or officials to share resources, information,
42 methods, procedures, documents, records, materials and information obtained in the course
43 of investigations, audits, examinations and related activities;

44 "(c) Purchase, share, use or employ analytical systems, methods or software available
45 from public or private sources;

1 “(d) Accept and rely upon the results of or reports concerning investigations, audits,
2 examinations or proceedings conducted by other government agencies or officials in this
3 state or in other states; and

4 “(e) Accept, use and incorporate in the director’s findings, reports, orders or other
5 actions audit reports from an independent certified public accountant.

6 “(4) The director’s authority under this section applies to a person who is subject to
7 regulation under sections 1 to 13 of this 2009 Act, whether or not the person is licensed as
8 a mortgage loan originator.

9 “(5) An applicant or licensed mortgage loan originator shall:

10 “(a) Make available to the director at the director’s request books, accounts, records,
11 files and other documents relating to the applicant’s or licensed mortgage loan originator’s
12 business operations and practices; and

13 “(b) Prepare, compile and deliver to the director reports, accounting compilations, lists
14 and data concerning loan transactions and other information the director requires to carry
15 out the purposes of sections 1 to 13 of this 2009 Act.

16 “(6) A person subject to investigation, audit or examination under this section may not
17 knowingly withhold, abstract, remove, mutilate, destroy or conceal books, accounts, records,
18 computer records, files, documents or other information or evidence that is subject to the
19 director’s authority under this section.

20 “SECTION 12. A person who is subject to regulation under sections 1 to 13 of this 2009
21 Act in connection with the person’s activities as a mortgage loan originator may not:

22 “(1) Perform an act as a mortgage loan originator in a negligent or incompetent manner;

23 “(2) Employ a device, scheme or artifice to defraud or engage in an act, practice or
24 course of business that operates or would operate as a fraud or deceit;

25 “(3) Knowingly make an untrue statement of a material fact or omit from a statement
26 a material fact that would make the statement not misleading in light of the circumstances
27 under which the person makes the statement;

28 “(4) Make or file or cause to be made or filed with the Director of the Department of
29 Consumer and Business Services a statement, report or document that the person knows is
30 false in a material respect or matter;

31 “(5) Engage in an unfair or deceptive practice toward another person;

32 “(6) Obtain property by fraud or misrepresentation;

33 “(7) Solicit or enter into a contract with a borrower, the terms of which provide that the
34 person may earn a fee or commission for using the person’s best efforts to obtain a resi-
35 dential mortgage loan even if the person does not obtain a residential mortgage loan for the
36 borrower, except that the terms of the contract may provide that the person may earn an
37 advance fee or recover actual expenses that the person incurs;

38 “(8) Solicit, advertise or enter into a contract, the terms of which specify an interest
39 rate, points or other financing terms unless the interest rate, points or other financing
40 terms are available to a prospective borrower at the time the person makes the solicitation
41 or advertisement or enters into the contract;

42 “(9) Conduct or operate a business that requires a mortgage loan originator’s license
43 without holding a license issued under section 4 or 6 of this 2009 Act or assist or enable an-
44 other person who does not have a mortgage loan originator’s license to conduct or operate
45 a business that requires a mortgage loan originator’s license;

1 “(10) Fail to disclose or provide information required under sections 1 to 13 of this 2009
2 Act or by state or federal laws, rules or regulations;

3 “(11) Fail to comply with a provision of sections 1 to 13 of this 2009 Act, a rule adopted
4 by the Director of the Department of Consumer and Business Services or state or federal
5 laws, rules or regulations that apply to a business that is subject to regulation under
6 sections 1 to 13 of this 2009 Act;

7 “(12) Fail to conduct business as a mortgage loan originator in compliance with the pro-
8 visions of:

9 “(a) The Truth in Lending Act, 15 U.S.C. 1601 et seq. and Regulation Z, 12 C.F.R. part 226,
10 as in effect on October 1, 2009;

11 “(b) The Real Estate Settlement Procedures Act, 12 U.S.C. 2601 et seq. and Regulation
12 X, 24 C.F.R. part 3500, as in effect on January 1, 2010;

13 “(c) The Equal Credit Opportunity Act, 15 U.S.C. 1691 et seq. and Regulation B, 12 C.F.R.
14 202.9, 202.11, 202.12 and 202.14, as in effect on the effective date of this 2009 Act; or

15 “(d) 12 U.S.C. 5101 et seq. and regulations adopted under 12 U.S.C. 5101 et seq.;

16 “(13) Make, negligently or intentionally, a false or deceptive statement or representation
17 in any manner concerning the rates, points or other financing terms or conditions for a
18 residential mortgage loan;

19 “(14) Make a false statement negligently in, or omit knowingly or willfully a material fact
20 from, a report or information the person submits to a government agency or the Nationwide
21 Mortgage Licensing System and Registry or in connection with an investigation or exam-
22 ination conducted by the director or a government agency;

23 “(15) Make a payment, threat or promise, directly or indirectly, to another person for the
24 purpose of influencing the other person’s independent judgment concerning a residential
25 mortgage loan or to an appraiser for the purpose of influencing the appraiser’s independent
26 judgment concerning the value of property;

27 “(16) Charge or collect, attempt to charge or collect or propose or enter into an agree-
28 ment in which the person charges or collects a fee that is prohibited under sections 1 to 13
29 of this 2009 Act;

30 “(17) Cause or require a borrower to obtain property insurance in an amount that ex-
31 ceeds the replacement cost of the property subject to the residential mortgage loan; or

32 “(18) Fail to account truthfully for moneys that belong to a party to a residential mort-
33 gage loan transaction.

34 “SECTION 13. (1)(a) A licensed mortgage loan originator shall clearly display the licensed
35 mortgage loan originator’s unique identifier on a residential mortgage loan application form,
36 solicitation, advertisement, promotional material or website the licensed mortgage loan
37 originator uses in connection with the licensed mortgage loan originator’s business.

38 “(b) The Director of the Department of Consumer and Business Services by rule may
39 specify the location, size or other characteristics of the unique identifier that must appear
40 on the materials described in paragraph (a) of this subsection and the materials on which the
41 unique identifier must appear.

42 “(2) A person that employs a licensed mortgage loan originator shall submit a report of
43 condition to the Nationwide Mortgage Licensing System and Registry. The form and contents
44 of the report and the times at which the licensed mortgage loan originator submits the re-
45 port shall comply with the specifications of the Nationwide Mortgage Licensing System and

1 **Registry.**

2 **“(3) A loan processor or underwriter may not represent to the public by means of ad-**
3 **vertising, business cards, stationery, brochures, signs, rate lists or other communications,**
4 **promotional items or methods that the loan processor or underwriter can, will or is au-**
5 **thorized to perform the duties of a mortgage loan originator unless the loan processor or**
6 **underwriter obtains a mortgage loan originator’s license under section 4 of this 2009 Act.**

7 **“SECTION 13a. The Director of the Department of Consumer and Business Services may**
8 **adopt, amend and repeal rules that are necessary to carry out the provisions of sections 1**
9 **to 13 of this 2009 Act.**

10 **“SECTION 14.** ORS 59.840 is amended to read:

11 “59.840. As used in ORS 59.840 to 59.980:

12 “[*(1) ‘Director’ means the Director of the Department of Consumer and Business Services.*]

13 “[*(2) (1) ‘Fraud,’ ‘deceit’ and ‘defraud’ are not limited to common-law deceit.*]

14 “[*(3) (2) ‘License’ means a license issued to a mortgage banker or mortgage broker under ORS*
15 *59.840 to 59.980.*]

16 “[*(4)(a) ‘Loan originator’ means an individual employed by or purporting to act as an agent or*
17 *independent contractor for a mortgage banker or mortgage broker that is required to be licensed under*
18 *ORS 59.840 to 59.980, with the expectation by the individual of compensation or gain that is determined*
19 *by the amount borrowed or the terms and conditions agreed to by the mortgage loan borrower, and*
20 *having primary job responsibilities that include negotiating with a borrower or potential borrower for*
21 *the purpose of establishing the terms and conditions of a mortgage loan.*]

22 “[*(b) ‘Loan originator’ includes a person employed at a location outside this state whose primary*
23 *job responsibilities include contacting or attempting to contact a borrower or potential borrower within*
24 *this state through any medium or mode of communication for purposes of providing a mortgage loan*
25 *within this state.*]

26 “[*(c) ‘Loan originator’ does not include an individual whose responsibilities are clerical or admin-*
27 *istrative functions, including but not limited to gathering information, requesting information, word*
28 *processing, soliciting general interest in mortgage loans, sending correspondence and assembling*
29 *files.*]

30 “[*(d) ‘Loan originator’ does not include an employee of a mortgage banker that is rated as good*
31 *or better under the federal rating system in effect on May 1, 2001, for seller-servicers of Federal*
32 *Housing Administration, Federal Home Loan Mortgage Corporation or Federal National Mortgage*
33 *Association loans and that has an office within this state at which the mortgage banker maintains*
34 *complete and current copies of all employment records and other records as required by the Director*
35 *of the Department of Consumer and Business Services by order or rule, in a format acceptable to the*
36 *director.*]

37 “[*(e) ‘Loan originator’ does not include an insurance producer licensed under ORS 744.052 to*
38 *744.089 or insurance consultant licensed under ORS 744.002.*]

39 “[*(f) ‘Loan originator’ does not include a person or group of persons exempted by rule or order of*
40 *the director.*]

41 “[*(5) (3)(a) ‘Mortgage banker’[:]*]

42 “[*(a)* means [*any*] a person [*who*] **that** for compensation or in the expectation of compensation:

43 **“(A) Either directly or indirectly makes, negotiates or offers to make or negotiate a mortgage**
44 **banking loan or a mortgage loan; and**

45 **“(B) Services or sells a mortgage banking loan.**

1 “(b) **‘Mortgage banker’** does not include:

2 “(A) A financial institution, as defined in ORS 706.008.

3 “(B) A financial holding company or a bank holding company, as defined in ORS 706.008, holding

4 an institution described in subparagraph (A) of this paragraph; a savings and loan holding company

5 as defined in [*section 408 of the National Housing Act, 12 U.S.C. 1730a (1982)*] **12 U.S.C.**

6 **1467a(a)(1)(D)**, holding an association described in subparagraph (A) of this paragraph; the subsid-

7 iaries and affiliates of the financial holding company, bank holding company or savings and loan

8 holding company; or subsidiaries and affiliates of institutions described in subparagraph (A) of this

9 paragraph, provided that the appropriate statutory regulatory authority is exercising control over

10 or is regulating or supervising the persons listed in this subparagraph in their mortgage banking

11 activities in accordance with the purposes of ORS 59.840 to 59.980.

12 “(C) A person [*who*] **that** makes a loan secured by an interest in real estate with the person’s

13 own moneys[,] for the person’s own investment and [*who*] **that** is not engaged in the business of

14 making loans secured by an interest in real estate.

15 “(D) [*An attorney licensed in this state who negotiates mortgage banking loans or mortgage loans*

16 *in the ordinary course of business, unless the business of negotiating mortgage banking loans or*

17 *mortgage loans constitutes substantially all of the attorney’s professional activity.*] **An attorney li-**

18 **icensed or otherwise authorized to practice law in this state if the attorney:**

19 “(i) **Negotiates the terms of a residential mortgage loan as an ancillary matter in the**

20 **attorney’s representation of a client; and**

21 “(ii) **Does not receive compensation from a mortgage banker, mortgage broker, mortgage**

22 **loan originator or lender or an agent of the mortgage banker, mortgage broker, mortgage**

23 **loan originator or lender.**

24 “(E) A person [*who*] **that**, as seller of real property, receives one or more mortgages or deeds

25 of trust as security for a separate money obligation.

26 “(F) An agency of [*any*] **a** state or of the United States.

27 “(G) A person [*who*] **that** receives a mortgage or deed of trust on real property as security for

28 an obligation payable on an installment or deferred payment basis and arising out of materials fur-

29 nished or services rendered in the improvement of [*that*] **the** real property or [*any*] **a** lien created

30 without the consent of the owner of the real property.

31 “(H) A person [*who*] **that** funds a mortgage banking loan or mortgage loan [*which has been*

32 *originated and processed by a licensee or by an exempt person and who*] **that a licensee or exempt**

33 **person originated and processed and that** does not maintain a place of business in this state in

34 connection with funding mortgage banking loans or mortgage loans, does not directly or indirectly

35 solicit borrowers in this state for the purpose of making mortgage banking loans or mortgage loans

36 and does not participate in [*the negotiation of*] **negotiating** mortgage banking loans or mortgage

37 loans. For the purpose of this subparagraph, [*negotiation of*] **negotiating** mortgage banking loans

38 or mortgage loans’ does not include setting the terms under which a person may buy or fund a

39 mortgage banking loan or a mortgage loan [*originated by*] **that** a licensee or exempt person **origi-**

40 **nated.**

41 “(I) A nonprofit federally tax exempt corporation certified by the United States Small Business

42 Administration and organized to promote economic development within this state whose primary

43 activity consists of providing financing for business expansion.

44 “(J) A licensee licensed under ORS chapter 725 or a mortgage broker.

45 “(K) A retirement or pension fund.

1 “(L) An insurer as defined in ORS 731.106.

2 “(M) A court appointed fiduciary.

3 “(N) [Any other] **A** person designated by rule or order of the Director of the Department of
4 **Consumer and Business Services.**

5 “[6] (4) ‘Mortgage banking loan’ means a loan, extension of credit or a retail sales contract
6 that is funded exclusively from the mortgage banker’s own resources, [which] **that** is directly or
7 indirectly secured by a mortgage or deed of trust or any lien interest on real estate and [which] **that**
8 is created with the consent of the owner of the real property. For purposes of this subsection, ‘own
9 resources’ means any of the following:

10 “(a) Cash, corporate capital, warehouse credit lines at financial institutions defined in ORS
11 706.008 or other sources that are liability items of the mortgage banker’s financial statements for
12 which [its] **the mortgage banker’s** assets are pledged;

13 “(b) Correspondent contracts between the mortgage banker and a bank, savings bank, trust
14 company, savings and loan association, credit union, profit sharing or pension trust, a licensee under
15 ORS chapter 725 or an insurance company; or

16 “(c) The mortgage banker’s affiliates’ cash, corporate capital, warehouse credit lines at financial
17 institutions defined in ORS 706.008 or other sources that are liability items on the affiliates’ finan-
18 cial statements for which the affiliates’ assets are pledged. As used in this paragraph, ‘affiliates’
19 means entities that, directly or indirectly, through one or more intermediaries [controls] **control**, are
20 controlled by or are under common control with the entity specified.

21 “[7] (5)(a) ‘Mortgage broker’[:]

22 “[a] means a person [who] **that**:

23 “(A) Engages all or part of the time, for the account of others or for the person’s own account,
24 in the business of selling real estate paper whether as issuer, agent or principal to persons other
25 than persons enumerated in ORS 59.035 (4);

26 “(B) Engages all or part of the time, for the account of others or for the person’s own account,
27 in the business of accepting funds from one or more persons other than persons enumerated in ORS
28 59.035 (4) for investment in real estate paper; or

29 “(C) For compensation, or in the expectation of compensation, either directly or indirectly
30 makes, negotiates or offers to make or negotiate a mortgage loan.

31 “(b) ‘**Mortgage broker**’ does not include:

32 “(A) A financial institution, as defined in ORS 706.008.

33 “(B)(i) A financial holding company or a bank holding company, as defined in ORS 706.008,
34 holding an institution described in subparagraph (A) of this paragraph;

35 “(ii) A savings and loan holding company as defined in [section 408 of the National Housing Act,
36 12 U.S.C. 1730a (1982)] **12 U.S.C. 1467a(a)(1)(D)**, holding an association described in subparagraph
37 (A) of this paragraph;

38 “(iii) The subsidiaries and affiliates of the financial holding company, bank holding company or
39 savings and loan holding company; or

40 “(iv) Subsidiaries and affiliates of institutions described in subparagraph (A) of this paragraph,
41 provided that the appropriate statutory regulatory authority is exercising control over or is regu-
42 lating or supervising the persons listed in this subparagraph in [their] **the persons’** mortgage bro-
43 kering activities in accordance with the purposes of ORS 59.840 to 59.980.

44 “(C) A person [who] **that** purchases real property and issues an obligation to finance the
45 transaction to the seller incidentally to the sale.

1 “(D) A real estate licensee as defined in ORS 696.010 who performs services solely incidental
2 to the practice of professional real estate activity as defined in ORS 696.010, unless the real estate
3 licensee performs the functions of a mortgage banker or a mortgage broker as defined in this sec-
4 tion.

5 “(E) A person licensed under the provisions of ORS chapter 725 or a mortgage banker.

6 “(F) A person *[who]* **that** makes a loan secured by an interest in real estate with the person’s
7 own moneys, for the person’s own investment and *[who]* **that** is not engaged in the business of
8 making loans secured by an interest in real estate.

9 “(G) *[An attorney licensed in this state who negotiates mortgage loans in the ordinary course of*
10 *business, unless the business of negotiating mortgage loans constitutes substantially all of the attorney’s*
11 *professional activity.]* **An attorney licensed or otherwise authorized to practice law in this state**
12 **if the attorney:**

13 “(i) **Negotiates the terms of a residential mortgage loan as an ancillary matter in the**
14 **attorney’s representation of a client; and**

15 “(ii) **Does not receive compensation from a mortgage banker, mortgage broker, mortgage**
16 **loan originator or lender or an agent of the mortgage banker, mortgage broker, mortgage**
17 **loan originator or lender.**

18 “(H) A person *[who]* **that**, as a seller of real property, receives one or more mortgages or deeds
19 of trust as security for a separate money obligation.

20 “(I) An agency of *[any]* a state or of the United States.

21 “(J) A person *[who]* **that** receives a mortgage or deed of trust on real property as security for
22 an obligation payable on an installment or deferred payment basis and arising out of materials fur-
23 nished or services rendered in the improvement of *[that]* **the** real property or *[any]* a lien created
24 without the consent of the owner of the real property.

25 “(K) A person *[who]* **that** funds a mortgage loan *[which has been originated and processed by a*
26 *licensee or by an exempt person and who]* **that a licensee or exempt person originated and pro-**
27 **cessed and that** does not maintain a place of business in this state in connection with funding
28 mortgage loans, does not directly or indirectly solicit borrowers in this state for the purpose of
29 making mortgage loans and does not participate in *[the negotiation of]* **negotiating** mortgage loans.
30 For the purpose of this subparagraph, ‘*[negotiation of]* **negotiating** mortgage loans’ does not include
31 setting the terms under which a person may buy or fund a mortgage loan *[originated by]* **that** a
32 licensee or exempt person **originated**.

33 “(L) A nonprofit federally tax exempt corporation certified by the United States Small Business
34 Administration and organized to promote economic development within this state whose primary
35 activity consists of providing financing for business expansion.

36 “(M) A person licensed under ORS 446.691 or 446.696 or a temporary manufactured structure
37 dealer licensee under ORS 446.701 *[who]* **that** provides services customarily associated with the re-
38 tail sales of manufactured dwellings, including communication of generally available information
39 regarding mortgage loans, unless:

40 “(i) The person receives from a purchaser a fee or commission as a mortgage broker or mortgage
41 banker that is disclosed in the sales contract, purchase agreement or applicable federal documents;

42 “(ii) For the benefit of a potential purchaser, the person completes a loan application form or
43 other document that is part of a mortgage banking loan and completes a good faith estimate under
44 the federal Real Estate Settlement Procedures Act [(12 U.S.C. 2601 et seq.)];

45 “(iii) The person solicits or receives credit information from a prospective purchaser for the

1 purpose of making credit decisions; or

2 “(iv) The person negotiates with a potential purchaser the terms of a mortgage loan including
3 but not limited to points, interest rates, length of loan or other loan conditions.

4 “(N) [Any other] A person designated by rule or order of the director.

5 “[8] (6) ‘Mortgage loan’ means a loan, extension of credit or retail sales contract, other than
6 a mortgage banking loan, secured by a mortgage or deed of trust or [any] a lien interest on real
7 estate that is created with the consent of the owner of the real estate.

8 “(7) ‘Mortgage loan originator’ has the meaning given that term in section 1 of this 2009
9 Act.

10 “[9] (8) ‘Residential mortgage transaction’ means a transaction in which a mortgage, deed of
11 trust, purchase money security interest arising under an installment sales contract, or equivalent
12 consensual security interest is created or retained in property upon which four or fewer residential
13 dwelling units are planned or situated, including but not limited to individual units or condominiums
14 and cooperatives. As used in this subsection, ‘residential dwelling unit’ means an improvement de-
15 signed for residential occupancy.

19 nate licensing with [any national registration or licensing system] **the Nationwide Mortgage Li-**
20 **icensing System and Registry.**

21 “(2) An applicant for a license [as a mortgage banker or mortgage broker], or a managing partner,
22 director, executive officer or other individual [occupying] **that occupies** a similar position or [per-
23 forming] **performs** similar functions for the applicant, shall have, during the five years immediately
24 preceding the time of application, not less than three years’ experience in the mortgage business,
25 three years’ experience negotiating loans in a related business satisfactory to the director or three
26 years’ equivalent lending experience in a related business satisfactory to the director.

27 “(3) If a license [as a mortgage banker or mortgage broker] is issued to a person other than an
28 individual, at least one managing partner, director, executive officer or other individual [occupying]
29 **that occupies** a similar position or [performing] **performs** similar functions for the person shall, at
30 all times during the term of the license, satisfy the experience requirement described in subsection
31 (2) of this section.

32 “(4) [Every] An applicant for a license **that is not subject to the requirement set forth in**
33 **section 9 of this 2009 Act** [as a mortgage banker or mortgage broker] shall file with the director a
34 corporate surety bond or irrevocable letter of credit **that is approved by the director in an**
35 **amount the director specifies by rule, that runs to the State of Oregon and that is** issued by
36 an insured institution as defined in ORS 706.008 [as the director may approve by rule running to the
37 State of Oregon in a sum to be determined by the director by rule].

38 “(5) The total amount of the corporate surety bond or irrevocable letter of credit for a single
39 applicant under subsection (4) of this section shall be not less than **\$50,000.** [\$25,000 but not more

39 specified by the director by rule;

40 “(b) The [person] **individual** is suspended or has been prohibited from employment as a **mort-**
41 **gage** loan originator under [ORS 59.973 (5)(c)] **section 8 of this 2009 Act;**

42 “(c) The employment violates any conditions imposed under [ORS 59.973 (5)(c)] **section 8 of this**
43 **2009 Act;** or

44 “(d) The employment violates an order issued by the director, a state or federal agency or a
45 court of competent jurisdiction.

1 dealer license must include the names and residence addresses of the members of the firm or part-

8 “(A) **The Truth in Lending Act, 15 U.S.C. 1601 et seq. and Regulation Z, 12 C.F.R. part**
9 **226, as in effect on October 1, 2009;**

10 “(B) **The Real Estate Settlement Procedures Act, 12 U.S.C. 2601 et seq. and Regulation**
11 **X, 24 C.F.R. part 3500, as in effect on January 1, 2010;**

12 “(C) **The Equal Credit Opportunity Act, 15 U.S.C. 1691 et seq. and Regulation B, 12 C.F.R.**
13 **202.9, 202.11, 202.12 and 202.14, as in effect on the effective date of this 2009 Act; or**

19 “(i) **Employs a device, scheme or artifice to defraud or engage in an act, practice or**
20 **course of business that operates or would operate as a fraud or deceit.**

21 “(j) **Knowingly makes an untrue statement of a material fact or omits from a statement**
22 **a material fact that would make the statement not misleading in light of the circumstances**
23 **under which the dealer makes the statement.**

25 **or document that the dealer knows is false in a material respect or matter.**

26 “(2) The [department] **director** shall cancel a manufactured structure dealer license immediately
27 upon receipt of legal notice that [the] a bond described under ORS 446.726 **or under section 9 of**
28 **this 2009 Act** is canceled.

30 under this section, the [department] **director** shall demand the return of the license.

12 **as in effect on October 1, 2009;**
