SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Authorizes Director of Department of Consumer and Business Services to set different fees for different financial institutions and to share information with [*federal agencies that regulate financial institutions*] **Financial Crimes Enforcement Network established by order of United States Secretary of Treasury.**

Authorizes director to determine finance charge for consumer loans on date preceding calendar year in which finance charge will apply. Removes requirement to post consumer finance license application for 30 days.

[*Gives director authority to oversee financial holding companies and bank holding companies.*]

Broadens authority of director to issue cease and desist order to include instances involving violations of federal regulations.

Repeals regulations governing savings associations.

Declares emergency, effective on passage.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 56.080 is amended to read:

56.080. (1) Except as provided in subsections (2), (3) and (4) of this section, the Secretary of State, within one year after a filing and not less than 20 days after written notice to the company

1 or individual who submitted the document to the office, may withdraw any certificate issued or
2 document filed by the Secretary of State, except filings pursuant to ORS chapter 647, on any ground
3 existing at the time of the filing for which the Secretary of State could have originally refused to
4 issue the certificate or file the document. The written notice shall state the reason for the proposed
5 withdrawal.

6 (2) The Secretary of State, within one year after a filing, may withdraw from filing any document
7 filed by the Secretary of State when the person who submitted the document advises the office that
8 the document was submitted prematurely or by inadvertence or mistake. The person requesting the
9 withdrawal shall accompany the request with a written statement reflecting the basis of the person's
10 authority to initiate the withdrawal.

11 (3) The Secretary of State may withdraw without notice or hearing a certificate that the Sec-
12 retary of State has issued or a document the Secretary of State has filed when the fee was paid with
13 a check that was returned to the office for lack of sufficient funds. Such withdrawal shall be retro-
14 active to the date of filing.

15 (4) The Secretary of State shall withdraw a certificate the Secretary of State has issued or a
16 document the Secretary of State has filed if the Secretary of State receives a final written order
17 from the Director of the Department of Consumer and Business Services that establishes that the

20 (5) Any decision under this section may be reviewed in accordance with the provisions of ORS
21 chapter 183.

22 (6) A withdrawal from filing of a document under this section is retroactive to the date of the
23 filing but [*shall*] **does** not relieve a person of any liability the person may have incurred while the
24 document was filed with the office. The Secretary of State is not required to refund any fees paid
25 in conjunction with the document withdrawn.

26 (7) At any time prior to a delayed effective date specified in a document, upon written request
27 of the person or persons who originally filed the document with the Secretary of State, the document
28 shall be withdrawn. Upon such withdrawal of a document, the document [*shall have*] **has** no further
29 effect and shall be treated as if [*it*] **the document** had not been filed. The person requesting the
30 withdrawal shall accompany the request with a written statement reflecting the basis of the person's
31 authority to initiate the withdrawal.

33 112.810. (1) Any person having custody of a will:

34 (a) Shall deliver the will to the testator upon demand from the testator, unless the person having
35 custody of the will is an attorney and is entitled to retain the will pursuant to ORS 87.430;

36 (b) May at any time deliver the will to the testator;

37 (c) Upon demand from the conservator, shall deliver the will to a conservator for the testator;

38 (d) Upon demand from the attorney-in-fact, shall deliver the will to an attorney-in-fact acting
39 under a durable power of attorney signed by the testator expressly authorizing the attorney-in-fact
40 to demand custody of the will;

41 (e) May deliver the will to any attorney licensed to practice law in Oregon willing to accept
42 delivery of the will if the person does not know or cannot ascertain, upon diligent inquiry, the ad-
43 dress of the testator; or

44 (f) Shall deliver the will to a court having jurisdiction of the estate of the testator or to a per-

6 113.238. (1) [Any] A person who has knowledge that a decedent died wholly intestate, that the
7 decedent owned property subject to probate in Oregon and that the decedent died without a known
8 heir shall give notice of the death within 48 hours after acquiring that knowledge to an estate ad-
9 ministrator of the Department of State Lands appointed under ORS 113.235.

10 (2) Except as provided by ORS 708A.430[722.262] and 723.466, a person may not dispose of or
11 diminish any assets of the estate of a decedent who has died wholly intestate, who owned property
12 subject to probate in Oregon and who died without a known heir unless the person has prior written
13 approval of an estate administrator of the Department of State Lands appointed under ORS 113.235.
14 The prohibition of this subsection:

15 (a) Applies to a guardian or conservator for the decedent; and

16 (b) Does not apply to a personal representative appointed under ORS 113.085 (3) or to an affiant
17 authorized under ORS 114.520 to file an affidavit under ORS 114.515.

18 (3) For purposes of this section, a known heir is an heir who has been identified and found.

19 **SECTION 4.** ORS 114.535 is amended to read:

20 114.535. (1) [Any] A person indebted to the decedent or having possession of personal property
21 belonging to the estate, to whom a certified copy of the affidavit filed under ORS 114.515 is delivered
22 by the affiant on or after the 10th day following the filing of the affidavit, shall pay, transfer or
23 deliver the personal property to the affiant. [Any] A person who has received property of the
24 decedent under ORS 446.616[722.262] or 803.094, or [any] a similar statute providing for the transfer
25 of property of an estate [which] **that** is not being probated, shall pay, transfer or deliver the prop-
26 erty to the affiant if the person would be required to pay, transfer or deliver the property to a
27 personal representative of the estate. The transferor is discharged and released from any liability
28 or responsibility for the transfer in the same manner and with the same effect as if the property had
29 been transferred, delivered or paid to a personal representative of the estate of the decedent.

30 (2) A transfer agent of any corporate security registered in the name of the decedent shall
31 change the registered ownership on the books of the corporation to the person entitled thereto on
32 presentation of a certified copy of the affidavit filed under ORS 114.515.

33 (3) If a person to whom an affidavit is delivered refuses to pay, deliver or transfer any personal
34 property to the affiant or the person entitled to the property as disclosed in the affidavit filed under
35 ORS 114.515, the property may be recovered or [its] payment, delivery or transfer **of the property**
36 **may be** compelled upon proof of the transferee's entitlement in a proceeding brought for the purpose
37 by or on behalf of the transferee.

42 180.540. (1) Except as provided in subsection (2) of this section, a seller or extender of credit
43 may submit to the Department of Justice [any] a consumer contract issued by the seller or extender
44 of credit for the purpose of obtaining review of the consumer contract for [its] **the consumer con-**
45 **tract's** compliance with plain language standards in ORS 180.545.

1 (2) For the purpose of obtaining a review of a consumer contract for *[its]* **the consumer con-**
2 **tract's** compliance with plain language standards in ORS 180.545, if a consumer contract:

3 (a) Is an insurance policy, the seller or extender of credit issuing the policy may submit *[it]* **the**
4 **policy** to the Director of the Department of Consumer and Business Services.

5 (b) Is an agreement for a loan or other extension of credit in which the extender of credit is
6 an insured institution, as defined in ORS 706.008, the extender of credit under the agreement may
7 submit the agreement to the Director of the Department of Consumer and Business Services.

8 (c) Is an agreement for a loan or other extension of credit in which the extender of credit is a
9 *[savings association or federal association, as those terms are defined in ORS 722.004, a]* credit union,
10 as that term is defined in ORS 723.006, or a licensee under ORS chapter 725, the extender of credit
11 under the agreement may submit the agreement to the Director of the Department of Consumer and
12 Business Services.

13 (3) For purposes of this section, a consumer contract is a written contract made in the course
14 of a consumer transaction to the value of \$50,000, excluding interest or finance charges, in which
15 the contract involves any of the following, primarily for personal, family or household use:

16 (a) Real estate, goods or services as defined in ORS 646.605.

17 (b) Any extension of credit, including the lending of money.

18 **SECTION 6.** ORS 183.635 is amended to read:

19 183.635. (1) Except as provided in this section, all agencies must use administrative law judges
20 assigned from the Office of Administrative Hearings established under ORS 183.605 to conduct con-
21 tested case hearings, without regard to whether those hearings are subject to the procedural re-
22 quirements for contested case hearings.

23 (2) The following agencies need not use administrative law judges assigned from the office:

24 (a) Attorney General.

25 (b) Boards of stewards appointed by the Oregon Racing Commission.

26 (c) Bureau of Labor and Industries and the Commissioner of the Bureau of Labor and Industries.

27 (d) Department of Corrections.

28 (e) Department of Education, State Board of Education and Superintendent of Public Instruction.

29 (f) Department of Higher Education and institutions of higher education listed in ORS 352.002.

7 (3) The Workers' Compensation Board is exempt from using administrative law judges assigned
8 from the office for any hearing conducted by the board under ORS chapters 147, 654 and 656. Except
9 as specifically provided in this subsection, the Department of Consumer and Business Services must
10 use administrative law judges assigned from the office only for contested cases arising out of the
11 department's powers and duties under:

- 12 (a) ORS chapter 59;
- 13 (b) ORS 200.005 to 200.075;
- 14 (c) ORS chapter 455;
- 15 (d) ORS chapter 674;
- 16 (e) ORS chapters 706 to 716;
- 17 (f) ORS chapter 717;
- 18 (g) ORS chapters [722,] 723, 725 and 726; and
- 19 (h) ORS chapters 731, 732, 733, 734, 735, 737, 742, 743, 743A, 744, 746, 748 and 750.

20 (4) Notwithstanding any other provision of law, in any proceeding in which an agency is re-

22 agency may not conduct the hearing on behalf of the agency.

23 (5) Notwithstanding any other provision of ORS 183.600 to 183.690, an agency is not required to
24 use an administrative law judge assigned from the office if:

- 25 (a) Federal law requires that a different administrative law judge or hearing officer be used; or
- 26 (b) Use of an administrative law judge from the office could result in a loss of federal funds.

27 (6) Notwithstanding any other provision of this section, the Department of Environmental
28 Quality must use administrative law judges assigned from the office only for contested case hearings
29 conducted under the provisions of ORS 183.413 to 183.470.

30 **SECTION 7.** ORS 192.502 is amended to read:

31 192.502. The following public records are exempt from disclosure under ORS 192.410 to 192.505:

32 (1) Communications within a public body or between public bodies of an advisory nature to the
33 extent that they cover other than purely factual materials and are preliminary to any final agency
34 determination of policy or action. This exemption shall not apply unless the public body shows that
35 in the particular instance the public interest in encouraging frank communication between officials
36 and employees of public bodies clearly outweighs the public interest in disclosure.

37 (2) Information of a personal nature such as but not limited to that kept in a personal, medical
38 or similar file, if public disclosure would constitute an unreasonable invasion of privacy, unless the
39 public interest by clear and convincing evidence requires disclosure in the particular instance. The
40 party seeking disclosure shall have the burden of showing that public disclosure would not consti-
41 tute an unreasonable invasion of privacy.

42 (3) Public body employee or volunteer addresses, Social Security numbers, dates of birth and
43 telephone numbers contained in personnel records maintained by the public body that is the em-
44 ployer or the recipient of volunteer services. This exemption:

- 45 (a) Does not apply to the addresses, dates of birth and telephone numbers of employees or vol-

1 unteers who are elected officials, except that a judge or district attorney subject to election may
2 seek to exempt the judge's or district attorney's address or telephone number, or both, under the
3 terms of ORS 192.445;

4 (b) Does not apply to employees or volunteers to the extent that the party seeking disclosure
5 shows by clear and convincing evidence that the public interest requires disclosure in a particular
6 instance;

7 (c) Does not apply to a substitute teacher as defined in ORS 342.815 when requested by a pro-
8 fessional education association of which the substitute teacher may be a member; and

9 (d) Does not relieve a public employer of any duty under ORS 243.650 to 243.782.

10 (4) Information submitted to a public body in confidence and not otherwise required by law to
11 be submitted, where such information should reasonably be considered confidential, the public body
12 has obliged itself in good faith not to disclose the information, and when the public interest would
13 suffer by the disclosure.

14 (5) Information or records of the Department of Corrections, including the State Board of Parole
15 and Post-Prison Supervision, to the extent that disclosure would interfere with the rehabilitation of
16 a person in custody of the department or substantially prejudice or prevent the carrying out of the
17 functions of the department, if the public interest in confidentiality clearly outweighs the public in-
18 terest in disclosure.

19 (6) Records, reports and other information received or compiled by the Director of the Depart-
20 ment of Consumer and Business Services in the administration of ORS chapters 723 and 725 not
21 otherwise required by law to be made public, to the extent that the interests of lending institutions,
22 their officers, employees and customers in preserving the confidentiality of such information out-
23 weighs the public interest in disclosure.

24 (7) Reports made to or filed with the court under ORS 137.077 or 137.530.

25 (8) Any public records or information the disclosure of which is prohibited by federal law or
26 regulations.

27 (9)(a) Public records or information the disclosure of which is prohibited or restricted or other-
28 wise made confidential or privileged under Oregon law.

29 (b) Subject to ORS 192.423, paragraph (a) of this subsection does not apply to factual information
30 compiled in a public record when:

31 (A) The basis for the claim of exemption is ORS 40.225;

32 (B) The factual information is not prohibited from disclosure under any applicable state or fed-
33 eral law, regulation or court order and is not otherwise exempt from disclosure under ORS 192.410
34 to 192.505;

35 (C) The factual information was compiled by or at the direction of an attorney as part of an
36 investigation on behalf of the public body in response to information of possible wrongdoing by the
37 public body;

38 (D) The factual information was not compiled in preparation for litigation, arbitration or an
39 administrative proceeding that was reasonably likely to be initiated or that has been initiated by
40 or against the public body; and

41 (E) The holder of the privilege under ORS 40.225 has made or authorized a public statement
42 characterizing or partially disclosing the factual information compiled by or at the attorney's di-
43 rection.

44 (10) Public records or information described in this section, furnished by the public body ori-
45 ginally compiling, preparing or receiving them to any other public officer or public body in con-

1 nection with performance of the duties of the recipient, if the considerations originally giving rise
2 to the confidential or exempt nature of the public records or information remain applicable.

3 (11) Records of the Energy Facility Siting Council concerning the review or approval of security
4 programs pursuant to ORS 469.530.

5 (12) Employee and retiree address, telephone number and other nonfinancial membership records
6 and employee financial records maintained by the Public Employees Retirement System pursuant to
7 ORS chapters 238 and 238A.

8 (13) Records of or submitted to the State Treasurer, the Oregon Investment Council or the
9 agents of the treasurer or the council relating to active or proposed publicly traded investments
10 under ORS chapter 293, including but not limited to records regarding the acquisition, exchange or
11 liquidation of the investments. For the purposes of this subsection:

12 (a) The exemption does not apply to:

13 (A) Information in investment records solely related to the amount paid directly into an invest-
14 ment by, or returned from the investment directly to, the treasurer or council; or

15 (B) The identity of the entity to which the amount was paid directly or from which the amount
16 was received directly.

17 (b) An investment in a publicly traded investment is no longer active when acquisition, exchange
18 or liquidation of the investment has been concluded.

19 (14)(a) Records of or submitted to the State Treasurer, the Oregon Investment Council, the
20 Oregon Growth Account Board or the agents of the treasurer, council or board relating to actual
21 or proposed investments under ORS chapter 293 or 348 in a privately placed investment fund or a
22 private asset including but not limited to records regarding the solicitation, acquisition, deployment,
23 exchange or liquidation of the investments including but not limited to:

24 (A) Due diligence materials that are proprietary to an investment fund, to an asset ownership
25 or to their respective investment vehicles.

26 (B) Financial statements of an investment fund, an asset ownership or their respective invest-
27 ment vehicles.

28 (C) Meeting materials of an investment fund, an asset ownership or their respective investment
29 vehicles.

30 (D) Records containing information regarding the portfolio positions in which an investment
31 fund, an asset ownership or their respective investment vehicles invest.

32 (E) Capital call and distribution notices of an investment fund, an asset ownership or their re-
33 spective investment vehicles.

34 (F) Investment agreements and related documents.

35 (b) The exemption under this subsection does not apply to:

36 (A) The name, address and vintage year of each privately placed investment fund.

37 (B) The dollar amount of the commitment made to each privately placed investment fund since
38 inception of the fund.

39 (C) The dollar amount of cash contributions made to each privately placed investment fund since
40 inception of the fund.

41 (D) The dollar amount, on a fiscal year-end basis, of cash distributions received by the State
42 Treasurer, the Oregon Investment Council, the Oregon Growth Account Board or the agents of the
43 treasurer, council or board from each privately placed investment fund.

44 (E) The dollar amount, on a fiscal year-end basis, of the remaining value of assets in a privately
45 placed investment fund attributable to an investment by the State Treasurer, the Oregon Investment

1 Council, the Oregon Growth Account Board or the agents of the treasurer, council or board.

2 (F) The net internal rate of return of each privately placed investment fund since inception of
3 the fund.

4 (G) The investment multiple of each privately placed investment fund since inception of the fund.

5 (H) The dollar amount of the total management fees and costs paid on an annual fiscal year-end
6 basis to each privately placed investment fund.

7 (I) The dollar amount of cash profit received from each privately placed investment fund on a
8 fiscal year-end basis.

9 (15) The monthly reports prepared and submitted under ORS 293.761 and 293.766 concerning the
10 Public Employees Retirement Fund and the Industrial Accident Fund may be uniformly treated as
11 exempt from disclosure for a period of up to 90 days after the end of the calendar quarter.

12 (16) Reports of unclaimed property filed by the holders of such property to the extent permitted
13 by ORS 98.352.

14 (17) The following records, communications and information submitted to the Oregon Economic
15 and Community Development Commission, the Economic and Community Development Department,
16 the State Department of Agriculture, the Oregon Growth Account Board, the Port of Portland or
17 other ports, as defined in ORS 777.005, by applicants for investment funds, loans or services includ-
18 ing, but not limited to, those described in ORS 285A.224:

19 (a) Personal financial statements.

20 (b) Financial statements of applicants.

21 (c) Customer lists.

22 (d) Information of an applicant pertaining to litigation to which the applicant is a party if the
23 complaint has been filed, or if the complaint has not been filed, if the applicant shows that such
24 litigation is reasonably likely to occur; this exemption does not apply to litigation which has been
25 concluded, and nothing in this paragraph shall limit any right or opportunity granted by discovery
26 or deposition statutes to a party to litigation or potential litigation.

27 (e) Production, sales and cost data.

28 (f) Marketing strategy information that relates to applicant's plan to address specific markets
29 and applicant's strategy regarding specific competitors.

30 (18) Records, reports or returns submitted by private concerns or enterprises required by law
31 to be submitted to or inspected by a governmental body to allow it to determine the amount of any
32 transient lodging tax payable and the amounts of such tax payable or paid, to the extent that such
33 information is in a form which would permit identification of the individual concern or enterprise.
34 Nothing in this subsection shall limit the use which can be made of such information for regulatory
35 purposes or its admissibility in any enforcement proceedings. The public body shall notify the tax-
36 payer of the delinquency immediately by certified mail. However, in the event that the payment or
37 delivery of transient lodging taxes otherwise due to a public body is delinquent by over 60 days, the
38 public body shall disclose, upon the request of any person, the following information:

39 (a) The identity of the individual concern or enterprise that is delinquent over 60 days in the
40 payment or delivery of the taxes.

41 (b) The period for which the taxes are delinquent.

42 (c) The actual, or estimated, amount of the delinquency.

43 (19) All information supplied by a person under ORS 151.485 for the purpose of requesting ap-
44 pointed counsel, and all information supplied to the court from whatever source for the purpose of
45 verifying the financial eligibility of a person pursuant to ORS 151.485.

1 (20) Workers' compensation claim records of the Department of Consumer and Business Services,
2 except in accordance with rules adopted by the Director of the Department of Consumer and Busi-
3 ness Services, in any of the following circumstances:

4 (a) When necessary for insurers, self-insured employers and third party claim administrators to
5 process workers' compensation claims.

6 (b) When necessary for the director, other governmental agencies of this state or the United
7 States to carry out their duties, functions or powers.

8 (c) When the disclosure is made in such a manner that the disclosed information cannot be used
9 to identify any worker who is the subject of a claim.
