**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes certain fees to be charged in connection with elevator safety program and boiler and pressure vessel safety program. Exempts certain beverage service tanks and portable beverage tanks from boiler and pressure vessel safety program.

Harmonizes language between elevator safety program statutes and boiler and pressure vessel safety program statutes.

**Increases expenditure limit of Department of Consumer and Business Services for purpose of restoring three boiler inspector positions.**

Declares emergency, effective July 1, 2009.

**A BILL FOR AN ACT**

2 Relating to programs administering the state building code; amending ORS 455.148, 455.150, 460.005,  
3 460.024, 460.035, 460.045, 460.055, 460.065, 460.075, 460.085, 460.125, 460.165, 480.515, 480.520,  
4 480.525, 480.560, 480.570, 480.585, 480.595, 480.600, 480.605, 480.615, 480.630 and 480.647; repealing  
5 ORS 460.048 and 480.607; limiting expenditures; and declaring an emergency.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 460.005 is amended to read:

8 460.005. As used in ORS 460.005 to 460.175, unless the context requires otherwise:

9 (1) "Alteration" means [*any*] a change or addition to [*the*] equipment, other than **the** ordinary  
10 repair or replacement of an existing part of the equipment.

11 (2) "Certified elevator inspector" means an employee or representative of a casualty insurance  
12 company or companies who has passed the required examination and has been issued a certificate  
13 of competency as an elevator inspector by the Department of Consumer and Business Services.

14 (3) "Elevator" means a hoisting and lowering mechanism equipped with a car or platform that  
15 moves in guides, and that serves two or more landings, and includes but is not limited to  
16 dumbwaiters, escalators, manlifts, platform hoists, vertical parking units for motor vehicles and  
17 moving walks.

18 (4) "Elevator contractor license" means an authorization issued by the department [*of Consumer*  
19 *and Business Services*] under ORS 460.005 to 460.175 for the licensee to engage in the business of  
20 installing, altering, repairing and maintaining elevators.

21 (5) "**Installation permit**" means a permit issued by the department for the installation,  
22 alteration or repair of an elevator.

23 [*(5)*] (6) "Minimum safety standards" means safety standards provided by ORS 460.005 to 460.175  
24 **or by rules adopted under ORS 460.005 to 460.175.**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1        [(6)] (7) “Moving walk” means a power-driven, horizontal or inclined, or combination,  
2 passenger-carrying device, in which the passenger-carrying surface remains parallel to its direction  
3 of motion, and is uninterrupted.

4        [(7)] (8) “Operating permit” means a permit issued by the department for the operation of an  
5 elevator.

6        [(8)] (9) “Platform hoist” means a hoisting and lowering mechanism equipped with an open  
7 platform that moves in a substantially vertical direction and that travels a limited distance above  
8 or below a building floor or dock level.

9        [(9)] (10) “Provisional operating permit” means a permit issued by the department on the basis  
10 of a variance from the minimum safety standards under ORS 460.005 to 460.175.

11        (11) **“Temporary operation authorization” means an authorization issued by the depart-**  
12 **ment to operate an elevator for a specified period pending the issuance of an operating per-**  
13 **mit.**

14        **SECTION 2.** ORS 460.024 is amended to read:

15        460.024. The purpose of ORS 460.005 to 460.175 is to protect the health and safety of the people  
16 of Oregon from the danger of unsafe elevators. To accomplish this purpose the Legislative Assembly  
17 intends by ORS 460.005 to 460.175:

18        (1) To provide minimum safety standards for the installation, alteration, repair and maintenance  
19 of elevators to be operated in this state.

20        (2) To [assure] **ensure** compliance with minimum safety standards in installation, alteration, re-  
21 pair and maintenance of elevators to be operated within the state.

22        (3) To provide for the administration and enforcement of ORS 460.005 to 460.175 by the De-  
23 partment of Consumer and Business Services.

24        (4) To provide for defraying the cost of administering and enforcing ORS 460.005 to 460.175 by  
25 fees collected in connection with licensing, approval or rejection of plans, inspections, processing  
26 reports and issuing of elevator **installation permits and** operating permits.

27        **SECTION 3.** ORS 460.035 is amended to read:

28        460.035. (1) Fees are not required under ORS 460.005 to 460.175 to install, alter, repair, operate  
29 or maintain an elevator:

30        (a) Under the supervision of the United States Government.

31        (b) That is a nonpower-driven lifting device.

32        (c) Located in a private residence, except for initial installation.

33        (2) The owner or user of an elevator described in subsection (1) of this section may request that  
34 the Department of Consumer and Business Services inspect the elevator. If the department performs  
35 the inspection, the department, notwithstanding subsection (1) of this section, may collect the ap-  
36 propriate fee for performing the inspection.

37        (3) Pipes installed in an elevator hoistway prior to July 1, 1961, that do not convey gases or  
38 liquids that would endanger life if discharged into the hoistway need not be removed.

39        (4) ORS 460.005 to 460.175 do not apply to:

40        (a) Belt, bucket, scoop, roller or similar type material conveyors.

41        (b) Hoists for raising or lowering materials and that are provided with unguided hooks, slings  
42 and similar means for attachment to the materials.

43        (c) Material hoists used only to raise and lower building material in buildings under con-  
44 struction.

45        (d) Stackers that serve one floor only.

- 1 (e) Window-washing scaffolds.
- 2 (f) Nonpower-driven lifting devices.
- 3 (g) Amusement rides.
- 4 (h) Mine elevators.
- 5 (i) Elevators under the supervision of the United States Government.
- 6 (j) Elevators located in private residences, except for initial installation **permits and installa-**
- 7 **tion inspections.**
- 8 (k) Other elevators and equipment as provided by the department by rule.

9 **SECTION 4.** ORS 460.045 is amended to read:

10 460.045. A person may not:

11 (1) Engage in the business of installation, alteration, repair or maintenance of an elevator  
12 without an elevator contractor license issued under ORS 460.005 to 460.175 or 479.510 to 479.945.

13 (2) Install, alter, repair or maintain an elevator unless the person possesses a valid license is-  
14 sued under ORS 460.059 or 479.630 (6).

15 (3) Install, alter, or commence to install or alter, an elevator covered by ORS 460.005 to 460.175  
16 unless the Department of Consumer and Business Services has [*approved the plans and pertinent data*  
17 *for the installation or alteration*] **issued an installation permit.**

18 (4) Permit or suffer an elevator to be operated, without a **valid temporary operation author-**  
19 **ization or** current operating permit, on property that the person owns, controls, manages or super-  
20 vises.

21 (5) Act or offer to act as a certified elevator inspector unless the person has a current certif-  
22 icate of competency as an elevator inspector issued by the department.

23 (6) Place in service a new or altered elevator without a current operating permit issued after  
24 a satisfactory acceptance inspection made by the department and satisfactory acceptance tests per-  
25 formed in the presence of a member of the department's staff of elevator inspectors.

26 (7) Place in service an elevator that has caused an injury to a person or persons unless per-  
27 mission has been obtained from the department.

28 **SECTION 5.** ORS 460.055 is amended to read:

29 460.055. (1) The Department of Consumer and Business Services shall give its decision within a  
30 reasonable time, not exceeding 30 days:

31 (a) Approving or rejecting plans and pertinent data for proposed elevator installations or alter-  
32 ations submitted for the department's examination.

33 **(b) Issuing or denying an installation permit.**

34 [(b)] (c) Issuing or denying a certificate of competency to applicants after examinations **for the**  
35 **certificate** have been taken [*therefor*].

36 [(c)] (d) Issuing or denying **operating** permits for elevators inspected by a member of the de-  
37 partment's staff of elevator inspectors or by a certified elevator inspector.

38 (2) Except as provided in subsection (3) of this section **operating** permits [*shall*] **may** not be  
39 issued **or renewed** for [*the operation of*] elevators failing to meet minimum safety standards [*as*  
40 *provided by ORS 460.005 to 460.175*].

41 (3) A provisional operating permit may be issued for elevators whose safety standards vary from  
42 the minimum safety standards [*as provided in ORS 460.005 to 460.175, when*], **if** in the opinion of the  
43 department no immediate hazard to health or safety exists. [*Such*] **The department shall issue a**  
44 provisional operating permit [*shall be issued*] for a specific period of time determined by the de-  
45 partment at the time [*such*] **the** permit is granted. During the life of [*such*] **the** provisional operating

1 permit, [such] **the** elevator [shall] **must** be brought into compliance with the safety standards found  
2 at variance at the time of the issuance of [such] **the** provisional permit.

3 **(4) The department may adopt rules regarding installation permits and operating permits.**  
4 **The rules may include, but need not be limited to, rules for the use of standardized forms**  
5 **and terms and conditions for permit validity.**

6 [(4)] **(5) The department shall issue** a certificate of competency as an elevator inspector [shall  
7 be issued] only to an individual who has passed an examination administered by the department for  
8 [this] **that** purpose and who is employed by the department or is a representative of a casualty in-  
9 surance company or companies as an elevator inspector. The examination shall:

10 (a) Include questions, the answers to which are confined to matters [which] **that** will aid in de-  
11 termining the fitness and competency of the applicant for the intended service.

12 (b) Include a practical demonstration of manipulative skill directly related to the intended ser-  
13 vice, or the requirement of previous related experience in lieu [thereof] **of a practical demon-**  
14 **stration.**

15 (c) Be maintained on file with the records of practical demonstrations for no less than three  
16 years and shall be produced by the department upon the request of any court, or the Electrical and  
17 Elevator Board, or a person with a legitimate interest.

18 [(5)] **(6)** If for a period of more than two years after the person is issued a certificate of com-  
19 petency as an elevator inspector, a holder of the certificate is not employed as an elevator inspector,  
20 the person [shall not be] **is not** entitled to renewal of the certificate. The person may qualify for  
21 issuance of a new certificate in the manner provided for in subsection [(4)] **(5)** of this section.

22 [(6) *No plans or pertinent data for elevators to be installed or altered in this state shall be ap-*  
23 *proved by the department unless the proposed elevator installation or alteration meets minimum safety*  
24 *standards as provided in ORS 460.085 (1).]*

25 **SECTION 6.** ORS 460.065 is amended to read:

26 460.065. (1) A certified elevator inspector certificate of competency expires on December 31 of  
27 the year in which the certificate is issued or on a date established by rule of the Department of  
28 Consumer and Business Services.

29 (2) An elevator **installation permit or** operating permit expires on a date established by de-  
30 partment rule.

31 (3) Except as provided in ORS 460.055, a holder of a valid elevator inspector certificate of  
32 competency or elevator operating permit who has complied with ORS 460.005 to 460.175 and the  
33 rules adopted under ORS 460.085 (1) is entitled to renewal at the expiration of the certificate or  
34 permit.

35 **SECTION 7.** ORS 460.075 is amended to read:

36 460.075. (1) Subject to the provisions of ORS chapter 183, the Department of Consumer and  
37 Business Services [shall] **may** cancel, revoke or suspend the **installation permit, temporary op-**  
38 **eration authorization or** operating permit for any elevator that does not comply with [the] mini-  
39 mum safety standards [provided by ORS 460.005 to 460.175].

40 (2) Subject to the provisions of ORS chapter 183, the department may suspend or revoke the  
41 certificate of competency of any certified elevator inspector:

42 (a) Whom the department finds to be performing the work in a manner inconsistent with the  
43 intent and purposes of ORS 460.005 to 460.175.

44 (b) Who fails to file in advance with the department the name of any company for which the  
45 inspector performs an inspection.

1 (c) Who willfully violates ORS 460.005 to 460.175 or rules adopted under ORS 460.085 (1).

2 (d) Who deliberately falsified the application of the inspector for [*such*] **the** certificate or the  
3 inspection report made to the department.

4 (e) Who persistently fails to properly report to the department in writing regarding elevators  
5 inspected by the inspector.

6 **SECTION 8.** ORS 460.085 is amended to read:

7 460.085. (1) In accordance with the applicable provisions of ORS chapter 183, the Director of the  
8 Department of Consumer and Business Services, after consultation with the Electrical and Elevator  
9 Board, shall adopt reasonable rules:

10 (a) Establishing safety standards applicable to the installation of elevators.

11 (b) Establishing safety standards applicable to the alteration, repair or maintenance of elevators.  
12 The director may provide differing standards for elevators installed prior to July 1, 1961, and after  
13 July 1, 1961.

14 (c) Governing the issuance, renewal, suspension and revocation of permits and certificates of  
15 competency issued under ORS 460.005 to 460.175.

16 (d) Prescribing the time, place and circumstances under which permits, licenses and certificates  
17 of competency shall be exhibited for inspection.

18 (e) Governing the internal organization and procedure of the Department of Consumer and  
19 Business Services for administering and enforcing ORS 460.005 to 460.175.

20 (f) Prescribing, requiring and governing reports by the department's staff of elevator inspectors  
21 and certified elevator inspectors on elevators inspected by them.

22 (g) Establishing standards, criteria and intervals for the periodic inspection under ORS 460.125  
23 of the various types of elevators.

24 (h) Establishing standards for the inspection of, and safety testing on, a new or altered elevator  
25 prior to placement of the elevator into service.

26 (i) Establishing [*fees under ORS 460.165 and any other*] reasonable fees, **in addition to the fees**  
27 **established by ORS 460.165, that** the department considers appropriate for the purpose of admin-  
28 istering and enforcing ORS 460.005 to 460.175.

29 (2) In adopting rules under subsection (1) of this section, the director shall consider:

30 (a) Technological advances in the elevator industry.

31 (b) The practicability of following the standards under consideration, if adopted.

32 (c) The probability, extent and gravity of the injury to the public or property that would result  
33 from failure to follow the standards under consideration.

34 (d) Safety standards followed, proposed or approved by responsible members of the elevator in-  
35 dustry.

36 (3) The sole purpose of subsection (1)(b) of this section is to provide reasonable safety for life  
37 and limb. In case of practical difficulty or unnecessary hardship, the director shall grant exceptions  
38 from the literal requirements or permit the use of other devices or methods than specified pursuant  
39 to subsection (1)(b) of this section when it is evident that reasonable safety is thereby secured.

40 (4) Any owner, user or other person aggrieved by the application by the department of the  
41 minimum safety standards established by the director pursuant to subsection (1)(b) of this section  
42 may appeal in the same manner and for the same reasons as provided under ORS 460.155.

43 **SECTION 9.** ORS 460.125 is amended to read:

44 460.125. (1) The Department of Consumer and Business Services shall:

45 (a) Except as provided in this subsection, periodically inspect each elevator to ascertain if the

1 elevator is being operated and maintained in accordance with ORS 460.005 to 460.175. The depart-  
2 ment is not required to inspect an elevator if the department is notified in writing, by the employer  
3 of a certified elevator inspector, that inspection will be made by the certified inspector and a copy  
4 of the inspection report is filed with the department within 30 days of the date the elevator is due  
5 for inspection.

6 (b) Periodically check the authenticity, appropriateness and expiration date of elevator **operat-**  
7 **ing** permits.

8 (c) Review with the Electrical and Elevator Board any appeals from the decisions of the in-  
9 spectors.

10 (d) To the extent necessary to ensure safety, perform inspections and witness safety tests of new  
11 or altered elevators before the elevators are placed in service.

12 (2) Inspection reports provided to owners, users or other affected parties shall contain a notifi-  
13 cation of the right of appeal as provided in ORS 460.155.

14 (3) If the department finds that an elevator is **not** being operated [*otherwise than*] in compliance  
15 with ORS 460.005 to 460.175, **and the rules adopted under ORS 460.005 to 460.175**, the department  
16 may cause the elevator to be disconnected from the source of power for the elevator. The depart-  
17 ment shall give reasonable notice to the owner or operator prior to causing the elevator to be dis-  
18 connected unless continued operation of the elevator would constitute an immediate hazard to the  
19 health and safety of persons.

20 **SECTION 10.** ORS 460.165 is amended to read:

21 460.165. (1) Subject to ORS 460.035 (1) and 460.085 (1), the Department of Consumer and Business  
22 Services may [*adopt fees that do not exceed the maximum fees described in this subsection for exam-*  
23 *ining plans, for the inspection of elevators, for issuing or renewing an elevator contractor's license and*  
24 *for processing reports and issuing the permit for the operation of an elevator. Fees adopted by the*  
25 *department are subject to approval of the Oregon Department of Administrative Services. The maximum*  
26 *fees are:*] **collect the following fees:**

27 (a) For each year of an elevator contractor's license for each place of business operated by the  
28 applicant, \$195.

29 (b) For the submission of plans and other pertinent data **when required**, for each elevator, \$78.

30 (c) For each year of an inspection period for **an operating permit:**

31 (A) A dumbwaiter, sidewalk elevator, residential elevator, residential inclinor or subveyor,

37 (E) A power-driven elevator with [~~over~~] **a 10-floor rise or over**, but under **a 20-floor rise**, [~~\$124~~]

39 (F) A power-driven elevator with a 20-floor rise or over, [~~\$147~~] **\$157.**

40 [*d) For a callback made on a mechanism listed in subsection (c) of this section and made by re-*  
41 *quest or in the continued existence of a defect, \$52.]*

42 **(d) For a reinspection, \$75.**

43 (e) For special inspections of hoisting or lowering mechanisms other than elevators, **or for in-**  
44 **spection, testing, consultations, site visits or other services for which no fee is otherwise**  
45 **specified**, [*or under special agreement between the department and a person requesting a special in-*

1 *spection, \$55] \$75 per hour for travel and inspection time.*

2 *[(f) For the processing of each report of an inspection required under the provisions of ORS 460.005*  
3 *to 460.175, \$20.]*

4 *[(g)] (f) For [the inspection of an installation or alteration of] an elevator **installation permit**, if*  
5 *the total cost of the installation or alteration is:*

6 (A) \$1,000 or under, \$98.

7 (B) Over \$1,000 but under \$15,000, \$98 plus \$13 for each \$1,000 or fraction of \$1,000 by which  
8 the cost exceeds \$1,000.

9 (C) \$15,000 or over but under \$50,000, \$280 plus \$8 for each \$1,000 or fraction of \$1,000 by which  
10 the cost exceeds \$15,000.

11 (D) \$50,000 or over, \$553 plus \$3 for each \$1,000 or fraction of \$1,000 by which the cost exceeds  
12 \$50,000.

13 (2) *[Whenever] If an owner or user of any elevator equipment fails to pay a fee required under*  
14 *this section within 90 days after the [date of depositing written notification in the United States mail,*  
15 *postage prepaid, and addressed to the last-known address of said owner or user, the fee shall be con-*  
16 *sidered delinquent and the fee shall be doubled unless the owner or user of the elevator equipment es-*  
17 *tablishes to the satisfaction of the department justification for failure to pay. The court may award*  
18 *reasonable attorney fees to the department if the department prevails in an action for the collection of*  
19 *a fee required by this section. The court may award reasonable attorney fees to a defendant who pre-*  
20 *vails in an action for the collection of a fee required by this section if the court determines that the*

25 480.515. As used in ORS 480.510 to 480.670, unless the context requires otherwise:

26 (1) **“Alteration” means a change or addition to equipment, other than the ordinary repair**  
27 **or replacement of an existing part of the equipment.**

28 [(1)] (2) “Board” means the Board of Boiler Rules created under ORS 480.535.

29 [(2)] (3) “Boiler” or “boilers” means:

30 (a) A closed vessel or vessels intended for the heating or vaporizing of liquids to be used ex-  
31 ternally to such vessel or vessels by the application of heat from combustible fuels, electricity or  
32 nuclear energy;

33 (b) Related appurtenances including but not limited to pressure piping directly connected and  
34 related to the safe operation of a boiler; and

35 (c) Pressure piping consisting of boiler or nonboiler external piping connected to a boiler, but  
36 not potable water nonboiler external piping.

37 [(3)] (4) “Boiler external piping” has the meaning given the term in the 1986 Pressure Piping  
38 Code B 31.1, adopted by the American Society of Mechanical Engineers.

39 [(4)] (5) “Certificate of competency” means a certificate issued under the provisions of ORS  
40 480.565 (3).

41 [(5)] (6) “Department” means the Department of Consumer and Business Services.

42 [(6)] (7) “Director” means the Director of the Department of Consumer and Business Services.

43 [(7)] (8) *[“Install, alter or repair] “Installation permit” means [a written approval] a permit is-*  
44 *ssued by the department [under ORS 480.630 authorizing] **for** the installation, alteration or repair*  
45 *of a boiler or pressure vessel.*

1        [(8)] (9) “Minimum safety standards” means the rules, regulations, formulae, definitions and in-  
2        terpretations for the safe construction, installation, operation and repair of boilers and pressure  
3        vessels either adopted by ORS 480.510 to 480.670 or adopted by the board, under ORS 480.510 to  
4        480.670.

5        [(9)] (10) “Nonboiler external piping” has the meaning given the term in the 1986 Pressure Pip-  
6        ing Code B 31.1, adopted by the American Society of Mechanical Engineers.

7        [(10)] (11) “Operating permit” means a [*written approval*] **permit** issued by the department au-  
8        thorizing the operation of a boiler or pressure vessel.

9        [(11)] (12) “Pressure vessel” means containers for the containment of pressure, either internal  
10       or external. This pressure may be obtained from an external source or by the application of heat  
11       from a direct or indirect source, or any combination thereof.

12       [(12)] (13) “Related appurtenances” means any equipment instrumental to the safe operation of  
13       a boiler or pressure vessel.

14       [(13)] (14) “Shop inspection” means [*the inspection and testing, to determine the meeting of mini-*  
15       *imum safety standards, of boilers and pressure vessels being manufactured, altered, repaired or installed*  
16       *or in the process of manufacture, alteration, repair or installation in the shop or on the job site.*] **an**  
17       **inspection at a boiler or pressure vessel manufacturing, construction or repair facility.**

18       (15) “Temporary operation authorization” means **an authorization issued by the depart-**  
19       **ment to operate a boiler or pressure vessel for a specified period pending the issuance of an**  
20       **operating permit.**

21       **SECTION 12.** ORS 480.520 is amended to read:

22       480.520. The purpose of ORS 480.510 to 480.670 is to protect the safety of the people of Oregon  
23       and to protect property situated in Oregon from the hazard of fires and explosions caused by boilers  
24       and pressure vessels. To accomplish this purpose the Legislative Assembly intends by ORS 480.510  
25       to 480.670 to provide a system:

26       (1) For determining where and by whom boilers and pressure vessels are being constructed, in-  
27       stalled, repaired, used and operated.

28       (2) To ensure that only qualified persons do welding on boilers and on pressure vessels.

29       (3) To ensure that boilers and pressure vessels are manufactured, installed, repaired, operated,  
30       inspected and maintained so as to meet the minimum safety standards formulated and promulgated  
31       by the Board of Boiler Rules.

32       (4) For the administration and enforcement of ORS 480.510 to 480.670 by the Department of  
33       Consumer and Business Services and the board.

34       (5) To defray the cost of administration and the cost of enforcing ORS 480.510 to 480.670 by

41       480.525. (1) ORS 480.510 to 480.670 do not apply to:

42       (a) Boilers and pressure vessels under federal safety regulations or control.

43       (b) Domestic water heaters designed for heating potable water, equipped with an approved

- 10 (e) Air tanks used in the operation of brakes on self-propelled vehicles and trailers that are used
- 11 for transporting freight or passengers.
- 12 (f) Medical sterilizers that do not exceed one and one-half cubic feet in volume.
- 13 (g) Pressure vessels that do not exceed one and one-half cubic feet in volume and:
- 14 (A) Are not operated at gauge pressure of more than 150 pounds per square inch;
- 15 (B) Are equipped with a relief valve;
- 16 (C) Are approved under the American Society of Mechanical Engineers code adopted by the
