

## SENATE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2221

1 On page 1 of the printed A-engrossed bill, delete lines 4 through 25 and delete page 2 and insert:

2 **“SECTION 1. Sections 2 and 3 of this 2009 Act are added to and made a part of ORS**  
3 **chapter 498.**

4 **“SECTION 2. (1) A person may not offer for sale or sell a hunt for feral swine on public**  
5 **or private lands.**

6 **“(2) Violation of subsection (1) of this section is a Class A misdemeanor. A person may**  
7 **not be convicted under this subsection if a civil penalty has been imposed against the person**  
8 **under subsection (3) of this section.**

9 **“(3)(a) The State Fish and Wildlife Commission may impose a civil penalty of \$1,000 for**  
10 **a violation of subsection (1) of this section.**

11 **“(b) Civil penalties described in this subsection shall be imposed in the manner provided**  
12 **in ORS 183.745. A civil penalty may not be imposed against a person under this subsection**  
13 **if the person has been convicted under subsection (2) of this section.**

14 **“(4) Notwithstanding ORS 497.415 (1), (2), (3) and (5) and in addition to any criminal**  
15 **penalty or civil penalty imposed under this section, when a person is convicted under sub-**  
16 **section (2) of this section or a civil penalty is imposed under subsection (3) of this section,**  
17 **the commission shall revoke all hunting licenses, tags and permits issued to the person un-**  
18 **der the wildlife laws, and the person may not apply for or obtain any hunting license, tag or**  
19 **permit for a period of 24 months after the conviction or imposition of the civil penalty.**

20 **“SECTION 3. (1) A person, or an employee of that person who acts as a land manager,**  
21 **may not knowingly, as defined in ORS 161.085, allow feral swine to roam on land owned or**  
22 **controlled by that person.**

23 **“(2) A person, or an employee of that person who acts as a land manager, shall take**  
24 **action in a manner consistent with rules adopted by the State Fish and Wildlife Commission**  
25 **to remove any feral swine that roams on land owned or controlled by that person if the**  
26 **person or employee knows that feral swine roam on land owned or controlled by that person.**  
27 **ORS 497.075 does not apply to this subsection.**

28 **“(3) A person, or an employee of that person who acts as a land manager, shall, within**  
29 **10 days after discovering feral swine on land owned or controlled by that person, inform the**  
30 **State Department of Fish and Wildlife about the feral swine.”.**
