

SENATE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2229

- 1 On page 1 of the printed A-engrossed bill, line 3, after “197.040,” insert “197.650,”.
- 2 On page 4, line 13, delete “rural”.
- 3 On page 10, after line 3, insert:
- 4 **“SECTION 13a.** ORS 197.650 is amended to read:
- 5 “197.650. (1) A Land Conservation and Development Commission order may be appealed to the
- 6 Court of Appeals in the manner provided in ORS 183.482 by the following persons:
- 7 “(a) Persons who submitted comments or objections pursuant to ORS 197.251 (2) or proceedings
- 8 under ORS 197.633, 197.636 or 197.644 and are appealing a commission order issued under ORS
- 9 197.251 or 197.633, 197.636 or 197.644;
- 10 “(b) Persons who submitted comments or objections pursuant to procedures adopted by the
- 11 commission for certification of state agency coordination programs and are appealing a certification
- 12 issued under ORS 197.180 (6);
- 13 “(c) Persons who petitioned the commission for an order under ORS 197.324 and whose petition
- 14 was dismissed;
- 15 **“(d) Persons who submitted comments or objections pursuant to sections 5 to 7 and 13**
- 16 **of this 2009 Act or proceedings under sections 5 to 7 and 13 of this 2009 Act and are appealing**
- 17 **a commission order issued under sections 5 to 7 and 13 of this 2009 Act;**
- 18 **“(e) Persons who submitted comments or objections pursuant to ORS 197.652 to 197.658**
- 19 **and section 13 of this 2009 Act or proceedings under ORS 197.652 to 197.658 and section 13**
- 20 **of this 2009 Act and are appealing a commission order issued under ORS 197.652 to 197.658**
- 21 **and section 13 of this 2009 Act; or**
- 22 “[*d*] (f) Persons who submitted oral or written testimony in a proceeding before the commission
- 23 pursuant to ORS 215.780.
- 24 “(2) Notwithstanding ORS 183.482 (2) relating to contents of the petition, the petition shall state
- 25 the nature of the order petitioner desires reviewed and whether the petitioner submitted comments
- 26 or objections as provided in ORS 197.251 (2) or pursuant to ORS 197.633, 197.636 or 197.644 **or**
- 27 **section 13 of this 2009 Act.**
- 28 “(3) Notwithstanding ORS 183.482 (2) relating to service of the petition, copies of the petition
- 29 shall be served by registered or certified mail upon the Department of Land Conservation and De-
- 30 velopment, the local government and all persons who filed comments or objections.”.
