SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Increases bond requirement for issuance or renewal of commercial driver training school certificate.]

Increases insurance coverage required for applicant or holder of commercial driver training school certificate.

Eliminates insurance coverage requirement for commercial driver training school that provides only classroom training.

A BILL FOR AN ACT

2 Relating to commercial driver training; amending ORS 822.510.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 822.510 is amended to read:

5 822.510. **Except as provided in subsection (3) of this section**, an applicant or holder of a
6 commercial driver training school certificate may maintain proof of insurance required under ORS
7 822.515 for issuance or renewal of the certificate by complying with any of the following:

8 (1) The school may file a certificate of insurance with the Department of Transportation that
9 complies with all of the following:

10 (a) The insurance must be issued to the school.

11 (b) The insurance must be issued by an insurance company authorized to do business in this
12 state.

13 (c) The insurance must show that the insured has procured and has in effect a motor vehicle
14 liability policy that provides at least the following coverage:

15 (A) [*\$50,000*] **\$100,000** because of bodily injury to or death of one person in any one accident;

16 (B) Subject to the limit for one person, [*\$100,000*] **\$300,000** because of bodily injury to or death
17 of two or more persons in any one accident; and

18 (C) [*\$25,000*] **\$50,000** because of injury to or destruction of the property of others in any one
19 accident.

20 (d) The policy shall designate by explicit description or by appropriate reference all motor ve-
21 hicles with respect to which coverage is granted.

22 (e) The policy shall insure any and all persons using any motor vehicle owned or operated by
23 the school with the consent of the school against loss from the liabilities imposed by law for dam-
24 ages arising out of the operation, use or maintenance of the motor vehicle.

25 (2) The school may obtain a valid certificate of self-insurance from the department.

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 **(3) An applicant or holder of a commercial driver training school certificate does not**
2 **need to submit proof of insurance required under ORS 822.515 for issuance or renewal of the**
3 **certificate if the applicant or holder of the certificate conducts only classroom instruction.**
