**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes name of Board of Examiners of Nursing Home Administrators to Nursing Home Administrators Board.

Establishes Oregon Health Licensing Agency as provider of administrative and regulatory oversight and centralized service for board.

**Declares emergency, effective July 1, 2009.**

**A BILL FOR AN ACT**

2 Relating to regulation of licensed nursing home administrators; creating new provisions; amending  
3 ORS 441.109, 676.160, 676.606, 676.610, 676.612, 676.613, 676.992, 678.710, 678.720, 678.725, 678.730,  
4 678.740, 678.750, 678.760, 678.770, 678.775, 678.780, 678.790, 678.800, 678.810 and 678.820; repealing  
5 ORS 678.825, 678.830 and 678.840; appropriating money; and declaring an emergency.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 678.800 is amended to read:

8 678.800. *[(1) There is hereby created a Board of Examiners of Nursing Home Administrators in the*  
9 *Department of Human Services.]*

10 *[(2) The board shall be composed of nine individuals concerned with the care and treatment of the*  
11 *chronically ill or infirm elderly patients and shall be appointed by the Governor after consultation with*  
12 *the associations and societies appropriate to the professions and institutions:]*

13 **(1) The Nursing Home Administrators Board is established within the Oregon Health Li-**  
14 **censing Agency.**

15 **(2)(a) The board consists of nine members who are appointed by the Governor, after**  
16 **consultation with any appropriate licensing boards, as follows:**

17 *[(a)]* **(A) Three members [shall be] are nursing home administrators who are licensed under**  
18 **[ORS 678.710 to 678.780, 678.800 to 678.840 and 678.990 (2)] ORS 678.710 to 678.840;**

19 *[(b)]* **(B) One member is a medical doctor who is licensed by the Oregon Medical Board and**  
20 **is actively engaged in private practice and conversant with the care and treatment of the long-term**  
21 **patient;**

22 *[(c)]* **(C) One member is a licensed professional nurse who is actively engaged in caring for**  
23 **chronically ill and infirm patients and licensed by the Oregon State Board of Nursing;**

24 *[(d)]* **(D) Three members are representative of the public at large, [at least one of whom shall]**  
25 **and at least one is [be at least] 62 years of age or older; and**

26 *[(e)]* **(E) One member is a pharmacist who is licensed by the State Board of Pharmacy[; and].**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1        *[(f) Except for those persons described in paragraph (a) of this subsection, no member of the board*  
2 *shall have a direct financial interest in a nursing home.]*

3        *[(3) All members of the board shall be citizens of the United States or shall have declared their*  
4 *intent to become citizens of the United States and shall be residents of this state. No more than two*  
5 *of the members of the board may be officials or full-time employees of state or local governments.]*

6        **(b) The members of the board appointed as described in paragraph (a) of this subsection**  
7 **must also meet the following qualifications:**

8        **(A) Be citizens of the United States and residents of this state;**

9        **(B) Have a demonstrated concern with the care and treatment of the chronically ill or**  
10 **infirm elderly patients;**

11        **(C) Except for members described in paragraph (a)(A) of this subsection, not have a di-**  
12 **rect financial interest in a nursing home; and**

13        **(D) For members described in paragraph (a)(D) of this subsection, not have a financial**  
14 **interest in, or have an employment contract with, a long term care facility.**

15        *[(4)] (3) The term of office of each member of the board is [three] four years, but a member*  
16 *serves at the pleasure of the Governor. Before the expiration of the term of a member, the Governor*  
17 *shall appoint a successor. [whose term begins on July 1 next following. A member is eligible for re-*  
18 *appointment but no member shall serve more than two consecutive terms.] If there is a vacancy for any*  
19 *cause, the Governor shall make an appointment to become immediately effective for the unexpired*  
20 *term. A member holds office until the appointment and confirmation of a successor. A*  
21 **member is eligible for reappointment, but may not serve more than two consecutive full**  
22 **terms unless at least four years have passed since the member last held office.**

23        *[(5)] (4) All appointments of members of the board by the Governor are subject to confirmation*  
24 *by the Senate in the manner provided in ORS 171.562 and 171.565.*

25        *[(6)] (5) The members of the board are entitled to compensation and expenses as provided in*  
26 *ORS 292.495.*

27        *[(7) No public members of the board shall hold any pecuniary interest in, or have any employment*  
28 *contract with, a long term care facility.]*

29        **SECTION 2. The amendments to ORS 678.800 by section 1 of this 2009 Act that change**  
30 **the number of years of a term of office of a member of the Nursing Home Administrators**  
31 **Board apply to members whose terms of office begin on or after the effective date of this**  
32 **2009 Act.**

33        **SECTION 3. (1) The amendments to ORS 678.800 by (section 1 of this 2009 Act are intended**  
34 **to change the name of the “Board of Examiners of Nursing Home Administrators” to the**  
35 **“Nursing Home Administrators Board.”**

36        **(2) For the purpose of harmonizing and clarifying statute sections published in Oregon**  
37 **Revised Statutes, the Legislative Counsel may substitute for words designating the “Board**  
38 **of Examiners of Nursing Home Administrators,” wherever they occur in Oregon Revised**  
39 **Statutes, other words designating the “Nursing Home Administrators Board.”**

40        **SECTION 4. The duties, functions and powers of the Nursing Home Administrators Board**  
41 **relating to the administrative and regulatory oversight of nursing home administrator li-**  
42 **censes issued under ORS 678.710 to 678.840 are imposed upon, transferred to and vested in**  
43 **the Oregon Health Licensing Agency.**

44        **SECTION 5. (1) The chairperson of the Nursing Home Administrators Board shall deliver**  
45 **to the Oregon Health Licensing Agency all records within the jurisdiction of the chairperson**

1 that relate to the duties, functions and powers transferred by section 4 of this 2009 Act.

2 (2) The Director of the Oregon Health Licensing Agency shall take possession of the re-  
3 cords delivered under subsection (1) of this section.

4 (3) The Governor shall resolve any dispute between the Nursing Home Administrators  
5 Board and the Oregon Health Licensing Agency relating to transfers of records under this  
6 section, and the Governor's decision is final.

7 **SECTION 6.** The unexpended balance of the Board of Examiners of Nursing Home Ad-  
8 ministrators Account established in ORS 678.830 is transferred to the Oregon Health Li-  
9 censing Agency Account established in ORS 676.625 for expenditure by the agency for the  
10 biennium beginning July 1, 2009, for the purpose of administering and enforcing the duties,  
11 functions and powers transferred by section 4 of this 2009 Act.

12 **SECTION 7.** The transfer of duties, functions and powers to the Oregon Health Licensing  
13 Agency by section 4 of this 2009 Act does not affect any action, proceeding or prosecution  
14 involving or with respect to such duties, functions and powers begun before and pending at  
15 the time of the transfer, except that the Oregon Health Licensing Agency is substituted for  
16 the Nursing Home Administrators Board in the action, proceeding or prosecution.

17 **SECTION 8.** (1) Nothing in sections 4 to 11 of this 2009 Act relieves a person of a liability,  
18 duty or obligation accruing under or with respect to the duties, functions and powers  
19 transferred by section 4 of this 2009 Act. The Oregon Health Licensing Agency may under-  
20 take the collection or enforcement of any such liability, duty or obligation.

21 (2) The rights and obligations of the Nursing Home Administrators Board legally incurred  
22 under contracts, leases and business transactions executed, entered into or begun before the  
23 effective date of section 4 of this 2009 Act and accruing under or with respect to the duties,  
24 functions and powers transferred by section 4 of this 2009 Act are transferred to the Oregon  
25 Health Licensing Agency. For the purpose of succession to these rights and obligations, the  
26 Oregon Health Licensing Agency is a continuation of the Nursing Home Administrators  
27 Board and not a new authority.

28 **SECTION 9.** Notwithstanding the transfer of duties, functions and powers by section 4  
29 of this 2009 Act, the rules of the Nursing Home Administrators Board with respect to such  
30 duties, functions or powers that are in effect on the effective date of section 4 of this 2009  
31 Act continue in effect until superseded or repealed by rules of the Oregon Health Licensing  
32 Agency. References in such rules of the Nursing Home Administrators Board to the Nursing  
33 Home Administrators Board or an officer or employee of the Nursing Home Administrators  
34 Board are considered to be references to the Oregon Health Licensing Agency or an officer  
35 or employee of the Oregon Health Licensing Agency.

36 **SECTION 10.** Whenever, in any uncodified law or resolution of the Legislative Assembly  
37 or in any rule, document, record or proceeding authorized by the Legislative Assembly, in  
38 the context of the duties, functions and powers transferred by section 4 of this 2009 Act,  
39 reference is made to the Nursing Home Administrators Board, or an officer or employee of  
40 the Nursing Home Administrators Board, whose duties, functions or powers are transferred  
41 by section 4 of this 2009 Act, the reference is considered to be a reference to the Oregon  
42 Health Licensing Agency or an officer or employee of the Oregon Health Licensing Agency  
43 who by section 4 of this 2009 Act is charged with carrying out such duties, functions and  
44 powers.

45 **SECTION 11.** For the purpose of harmonizing and clarifying statute sections published

1 in Oregon Revised Statutes, the Legislative Counsel may substitute for words designating the  
2 “Nursing Home Administrators Board” or its officers, wherever they occur in ORS 678.810  
3 to 678.840 and are used in relation to the administrative and regulatory oversight of nursing  
4 home administrator licenses issued under ORS 678.810 to 678.840, other words designating the  
5 “Oregon Health Licensing Agency” or its officers.

6 **SECTION 12.** ORS 678.810 is amended to read:

7 678.810. (1) The *[Board of Examiners of Nursing Home Administrators]* **Nursing Home Admin-**  
8 **istrators Board** shall hold at least *[two meetings]* **one meeting** each year. *[At any meeting]* A ma-  
9 jority of the members of the board *[shall constitute]* **constitutes** a quorum for the transaction of  
10 business.

11 (2) The board shall *[elect annually from its membership a]* **select one of its members as** chair-  
12 person and *[a]* **another as** vice chairperson, **for a one-year term and with such duties and**  
13 **powers necessary for the performance of the functions of the offices as the board**  
14 **determines.**

15 **SECTION 13.** ORS 678.820 is amended to read:

16 678.820. *[It shall be the function of the Board of Examiners of Nursing Home Administrators to:]*

17 *[(1) Develop, impose and enforce standards which shall be met by individuals in order to receive*  
18 *and retain a license as a nursing home administrator, which standards shall be designed to insure that*  
19 *nursing home administrators will be individuals who are qualified by training or experience in the field*  
20 *of long-term health care administration to serve as nursing home administrators.]*

21 *[(2) Develop and apply appropriate techniques, including examinations and investigations for de-*  
22 *termining whether an individual meets such standards, if examinations are reviewed periodically to*  
23 *insure validity.]*

24 *[(3) Issue licenses to individuals determined after application of such techniques, to meet such*  
25 *standards, and subject to ORS chapter 183 impose any of the sanctions set out in ORS 678.780 where*  
26 *the individual holding any such license is determined substantially to have failed to conform to the*  
27 *requirements of such standards.]*

28 *[(4) Establish and carry out procedures designed to insure that individuals licensed as nursing*  
29 *home administrators will, during any period that they serve as such, comply with the requirements of*  
30 *such standards.]*

31 *[(5) Receive, investigate and take appropriate action with respect to any charge or complaint filed*  
32 *with the board in writing, charging that any individual licensed as a nursing home administrator has*  
33 *failed to comply with the requirements of such standards.]*

34 *[(6) Conduct a continuing study and investigation of nursing homes and administrators of nursing*  
35 *homes within the state with a view to the improvement of standards imposed for the licensing of such*  
36 *administrators and the procedures and methods for the enforcement of such standards with respect to*  
37 *administrators of nursing homes who have been licensed as such.]*

38 *[(7) Encourage qualified educational institutions and other qualified organizations to establish,*  
39 *provide, conduct and continue such training and instruction courses and programs as will enable all*  
40 *otherwise qualified individuals to meet requirements established under ORS 678.710 to 678.780, 678.800*  
41 *to 678.840 and 678.990 (2).]*

42 *[(8) Approve courses and programs conducted within or without the state as sufficient to meet ed-*  
43 *ucation and training requirements established pursuant to ORS 678.710 to 678.780, 678.800 to 678.840*  
44 *and 678.990 (2) and advise the appropriate state agencies regarding receipt and administration of such*  
45 *federal funds as are made available for such purposes.]*

1       [(9) *In accordance with ORS 183.330, adopt, amend and repeal rules which are necessary to carry*  
2 *out the provisions of ORS 678.710 to 678.780, 678.800 to 678.840 and 678.990 (2).*]

3       [(10) *Maintain a register of all licensed nursing home administrators.*]

4       **(1) The Nursing Home Administrators Board is responsible for advising the Oregon**  
5 **Health Licensing Agency in all matters relating to the administration of ORS 678.710 to**  
6 **678.840, including:**

7       **(a) Developing standards for education and training;**

8       **(b) Developing standards of practice and professional conduct;**

9       **(c) Establishing standards related to the issuance, denial, revocation, suspension or re-**  
10 **newal of licenses to practice as a nursing home administrator;**

11       **(d) Preparing or approving the examinations required under ORS 678.710 to 678.840, in**  
12 **accordance with standards provided by the agency; and**

13       **(e) Assisting the agency in administering the provisions of ORS 678.710 to 678.840.**

14       **(2) The Oregon Health Licensing Agency shall administer ORS 678.710 to 678.840 by:**

15       **(a) Determining the qualifications and fitness of applicants for licenses, renewed licenses,**  
16 **reciprocal licenses and provisional licenses under ORS 678.710 to 678.840.**

17       **(b) Examining, approving, issuing, denying, revoking, suspending and renewing licenses**  
18 **to practice as a nursing home administrator.**

19       **(c) Providing for waivers of examinations or provisional licenses.**

20       **(d) Establishing and carrying out procedures to ensure compliance with professional**  
21 **standards adopted by the board.**

22       **(e) Pursuant to ORS 676.608, receiving and investigating complaints filed regarding**  
23 **nursing home administrators.**

24       **(f) Establishing and collecting fees and charges to carry out the agency's duties under**  
25 **ORS 678.710 to 678.840.**

26       **(g) In accordance with ORS 183.330 and 676.615, adopting, amending and repealing rules**  
27 **that are necessary to carry out the administration of ORS 678.710 to 678.840.**

28       **(h) Maintaining a register of all licensed nursing home administrators.**

29       **(3) The agency shall consider and be guided by the recommendations of the board in all**  
30 **matters relating to the administration of ORS 678.710 to 678.840.**

31       **SECTION 14.** ORS 678.710 is amended to read:

32       678.710. As used in ORS 678.710 to 678.840, unless the context requires otherwise:

33       [(1) *"Board" means the Board of Examiners of Nursing Home Administrators of the State of*  
34 *Oregon.*]

35       [(2) *"Department" means the Department of Human Services.*]

36       [(3)] **(1) "Dual facility" means a facility that operates both a hospital and a long term care fa-**  
37 **ility on the same campus.**

38       **(2) "Nursing home" means any institution or facility defined as a long term care facility**  
39 **for licensing purposes under state statute or the rules of the Department of Human Services,**  
40 **including a long term care facility operated as part of a dual facility.**

41       [(4)] **(3) "Nursing home administrator" means an individual responsible for planning, organizing**  
42 **and managing the operation of a nursing home, whether or not such individual has an ownership**  
43 **interest in such home and whether or not such functions are shared by one or more other individ-**  
44 **uals, if:**

45       **(a) Final responsibility and authority are retained in the nursing home administrator; and**

1 (b) In the case of a dual facility, the nursing home administrator may be subject to the authority  
2 of the administrator of the dual facility or the dual facility administrator may administer the nursing  
3 home if the administrator is licensed or otherwise qualified by statute to administer a nursing home.

4 [(5) "Nursing home" means any institution or facility defined as a long term care facility for li-  
5 censing purposes under state statute or the rules of the department, including a long term care facility  
6 operated as part of a dual facility.]

7 [(6)] (4) "Provisional license" means a temporary license issued to a provisional nursing home  
8 administrator under the rules of the [board] **Oregon Health Licensing Agency**.

9 **SECTION 15.** ORS 678.720 is amended to read:

10 678.720. (1) [On and after July 1, 1971,] Unless an individual holds a valid license issued under  
11 the provisions of [ORS 678.710 to 678.780, 678.800 to 678.840 and 678.990 (2)] **ORS 678.710 to**  
12 **678.840**, an individual [shall] **may** not:

13 (a) Practice or offer to practice as a nursing home administrator; or

14 (b) Use in connection with the name of the individual the words or letters "nursing home ad-  
15 ministrator," "NHA" or any other words, letters or abbreviations or insignia tending to indicate that  
16 [such] **the** individual is a licensed nursing home administrator.

17 (2) [On and after July 1, 1971, no] **A** nursing home shall be conducted or operated [unless it is]  
18 under the supervision of a nursing home administrator who holds a valid license issued under the  
19 provisions of [ORS 678.710 to 678.780, 678.800 to 678.840 and ORS 678.990 (2)] **ORS 678.710 to**  
20 **678.840**.

21 **SECTION 16.** ORS 678.725 is amended to read:

22 678.725. (1) Any health care facility licensed under ORS 441.015, any licensee licensed by the  
23 [Board of Examiners of Nursing Home Administrators of the State of Oregon] **Oregon Health Li-**  
24 **icensing Agency**, any physician licensed by the Oregon Medical Board, any licensed professional  
25 nurse and any licensed pharmacist shall, and any other person may, report to the [board] **agency**  
26 suspected violations of ORS 678.710 to 678.840 and [insanitary] **unsanitary** or other unsatisfactory  
27 conditions in a nursing home.

28 (2) Information acquired by the [board] **agency** pursuant to subsection (1) of this section is  
29 confidential and [shall not be] **is not** subject to public disclosure.

30 (3) Any person who reports or provides information to the [board] **agency** under subsection (1)  
31 of this section and who provides information in good faith [shall] **may** not be subject to an action  
32 for civil damages as a result [thereof] **of making the report or providing the information**.

34 678.730. (1) [Any] **An** individual [is qualified] **qualifies** for licensure as a nursing home admin-  
35 istrator [who] **if the individual**:

36 (a) Meets the **education**, training [or experience] and other standards established by rules of the  
37 [Board of Examiners of Nursing Home Administrators] **Nursing Home Administrators Board**. The  
38 board shall **establish standards that** accept one year of experience as an administrator serving a  
39 dual facility in lieu of any residency or intern requirement [established pursuant to this paragraph]  
40 **that may be established by the board**; and

41 (b) Has passed an examination as provided in ORS 678.740.

42 (2) [Each license as a nursing home administrator may be renewed by the board upon compliance  
43 by the licensee with the requirements of ORS 678.760 and by presenting evidence of the completion of  
44 the continuing education work required by the board.] **A license holder may renew a license as**  
45 **provided by ORS 678.760**. The board may require up to 50 hours of continuing education in any

1 one-year period **for a renewed license.**

2 (3) In establishing educational standards pursuant to subsection (1)(a) of this section, the board  
3 shall require a baccalaureate degree from an accredited school of higher education. However, the  
4 educational requirement does not apply to any person who:

5 (a) Was a licensed administrator in any jurisdiction of the United States prior to January 1,

15 678.740. (1) Examinations for licensure as a nursing home administrator shall be conducted at  
16 such times and places as the [*Board of Examiners of Nursing Home Administrators of the State of*  
17 *Oregon shall designate*] **Nursing Home Administrators Board designates**, but not less than once  
18 a year. The fee for examination or reexamination shall be determined by the [*board*] **Oregon Health**  
19 **Licensing Agency** under ORS 678.775.

20 (2) The board shall, consistent with the purposes for which the examination is given, determine  
21 the subjects, scope, content and the minimum passing grade for examinations.

22 **SECTION 19.** ORS 678.750 is amended to read:

23 678.750. (1) Nothing in [*ORS 678.710 to 678.780, 678.800 to 678.840 and 678.990 (2)*] **ORS 678.710**  
24 **to 678.840** or the rules adopted [*thereunder shall*] **under ORS 678.710 to 678.840 may** be construed  
25 to require an individual, who is employed to administer an institution exempted under ORS 441.065  
26 as an institution that is operated by and for persons who rely on spiritual means alone for the care  
27 and treatment of the sick, to demonstrate proficiency in any medical techniques or to meet any  
28 medical educational qualifications or medical standards not in accord with the remedial care and  
29 treatment provided in [*such institutions*] **the institution**. Any license issued under [*ORS 678.710 to*  
30 *678.780, 678.800 to 678.840 and 678.990 (2)*] **ORS 678.710 to 678.840** to [*such*] an individual **described**  
31 **in this subsection** shall indicate the limited extent of the authority of the individual to act as an  
32 administrator.

33 (2) Subsection (1) of this section does not limit or prohibit the operator of an institution from  
34 enforcing any religious affiliation [*requirement*] **requirements** imposed as a bona fide occupational  
35 qualification or business necessity or as otherwise permitted by section 703(e) of Title VII of the  
36 Civil Rights Act of 1964 or other provision of federal law.

37 **SECTION 20.** ORS 678.760 is amended to read:

38 678.760. [*(1) Upon compliance with the requirements of ORS 678.730 and the payment of a fee as*  
39 *determined by the Board of Examiners of Nursing Home Administrators of the State of Oregon under*  
40 *ORS 678.775, an individual shall upon application be granted a nursing home administrator's original*  
41 *license. All original licenses shall expire on June 30 of the next odd-numbered year or on such date*  
42 *as may be specified by board rule.]*

43 [*(2) Upon application within one year following expiration of an original or a renewal license, and*  
44 *the payment of a fee as determined by the board under ORS 678.775, the board shall issue a renewal*  
45 *license, provided the continuing education requirements and all other requirements set by the board*

1 *have been met. All renewal licenses shall expire on June 30 of the next odd-numbered year or on such*  
2 *date as may be specified by board rule.]*

3 *[(3) The fee for a provisional license shall be determined by the board under ORS 678.775.]*

4 **(1) Subject to ORS 676.612 and subsection (2) of this section, the Oregon Health Licensing**  
5 **Agency shall:**

6 **(a) Issue a license as a nursing home administrator to a qualified applicant upon satis-**  
7 **factory evidence of meeting the requirements of ORS 678.730 and other qualifications adopted**  
8 **by the Nursing Home Administrators Board by rule.**

9 **(b) Renew a license as a nursing home administrator if, by a date specified by the agency**  
10 **by rule, the license holder submits to the agency a completed renewal application, required**  
11 **renewal fees and satisfactory evidence of completion of any required continuing education**  
12 **credits.**

13 **(2) For up to one year from the date of a denial, suspension, revocation or expiration of**  
14 **a nursing home administrator license, the agency may refuse to grant or renew the license**  
15 **of a nursing home administrator whose license has expired or been denied, suspended or re-**  
16 **voked.**

17 **(3)(a) Except as provided by paragraph (b) of this subsection, a nursing home adminis-**  
18 **trator license expires on the last day of the month, one year from the date of issuance.**

19 **(b) The agency may adopt by rule an expiration date that is different than the date pro-**  
20 **vided by paragraph (a) of this subsection if the license holder is provided written notice of**  
21 **the different renewal date and the renewal fee is prorated.**

22 **(4) The agency may adopt rules for the reactivation of an expired license, including ad-**  
23 **ditional requirements for a license that has been expired for three years or more.**

24 **(5) The agency may establish requirements for the issuance of a temporary provisional**
