**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes name of Board of Examiners of Nursing Home Administrators to Nursing Home Administrators Board.

Establishes Oregon Health Licensing Agency as provider of administrative and regulatory oversight and centralized service for board.

Declares emergency, effective July 1, 2009.

**A BILL FOR AN ACT**

6 678.830 and 678.840 and section 15, chapter \_\_\_, Oregon Laws 2009 (Enrolled House Bill 2059);  
7 appropriating money; and declaring an emergency.

8 **Be It Enacted by the People of the State of Oregon:**

9 **SECTION 1.** ORS 678.800 is amended to read:

10 678.800. [(1) *There is hereby created a Board of Examiners of Nursing Home Administrators in the*  
11 *Department of Human Services.*]

12 [(2) *The board shall be composed of nine individuals concerned with the care and treatment of the*  
13 *chronically ill or infirm elderly patients and shall be appointed by the Governor after consultation with*  
14 *the associations and societies appropriate to the professions and institutions.*]

15 **(1) The Nursing Home Administrators Board is established within the Oregon Health Li-**  
16 **censing Agency.**

17 **(2)(a) The board consists of nine members who are appointed by the Governor, after**  
18 **consultation with any appropriate licensing boards, as follows:**

19 [(a)] **(A)** Three members [*shall be*] **are** nursing home administrators **who are** licensed under  
20 [*ORS 678.710 to 678.780, 678.800 to 678.840 and 678.990 (2)*] **ORS 678.710 to 678.840;**

21 [(b)] **(B)** One **member is** a medical doctor **who is** licensed by the Oregon Medical Board **and**  
22 **is** actively engaged in private practice and conversant with the care and treatment of the long-term  
23 patient;

24 [(c)] **(C)** One **member is** a licensed professional nurse **who is** actively engaged in caring for

1 chronically ill and infirm patients and licensed by the Oregon State Board of Nursing;

2 [(d)] **(D)** Three members **are** representative of the public at large, [*at least one of whom shall*]  
3 **and at least one is** [*be at least*] 62 years of age **or older; and**

4 [(e)] **(E)** **One member is** a pharmacist **who is** licensed by the State Board of Pharmacy[; *and*].

5 [(f) *Except for those persons described in paragraph (a) of this subsection, no member of the board*  
6 *shall have a direct financial interest in a nursing home.*]

7 [(3) *All members of the board shall be citizens of the United States or shall have declared their*  
8 *intent to become citizens of the United States and shall be residents of this state. No more than two*  
9 *of the members of the board may be officials or full-time employees of state or local governments.*]

10 **(b) The members of the board appointed as described in paragraph (a) of this subsection**  
11 **must also meet the following qualifications:**

12 **(A) Be citizens of the United States and residents of this state;**

13 **(B) Have a demonstrated concern with the care and treatment of the chronically ill or**  
14 **infirm elderly patients;**

15 **(C) Except for members described in paragraph (a)(A) of this subsection, not have a di-**  
16 **rect financial interest in a nursing home; and**

17 **(D) For members described in paragraph (a)(D) of this subsection, not have a financial**  
18 **interest in, or have an employment contract with, a long term care facility.**

19 [(4)] **(3)** The term of office of each member **of the board** is [*three*] **four** years, but a member  
20 serves at the pleasure of the Governor. Before the expiration of the term of a member, the Governor  
21 shall appoint a successor. [*whose term begins on July 1 next following. A member is eligible for re-*  
22 *appointment but no member shall serve more than two consecutive terms.*] If there is a vacancy for any  
23 cause, the Governor shall make an appointment to become immediately effective for the unexpired  
24 term. **A member holds office until the appointment and confirmation of a successor. A**  
25 **member is eligible for reappointment, but may not serve more than two consecutive full**  
26 **terms unless at least four years have passed since the member last held office.**

27 [(5)] **(4)** All appointments of members of the board by the Governor are subject to confirmation  
28 by the Senate in the manner provided in ORS 171.562 and 171.565.

29 [(6)] **(5)** The members of the board are entitled to compensation and expenses as provided in  
30 ORS 292.495.

31 [(7) *No public members of the board shall hold any pecuniary interest in, or have any employment*  
32 *contract with, a long term care facility.*]

33 **SECTION 2. The amendments to ORS 678.800 by section 1 of this 2009 Act that change**  
34 **the number of years of a term of office of a member of the Nursing Home Administrators**  
35 **Board apply to members whose terms of office begin on or after the effective date of this**  
36 **2009 Act.**

37 **SECTION 3. (1) The amendments to ORS 678.800 by section 1 of this 2009 Act are intended**  
38 **to change the name of the “Board of Examiners of Nursing Home Administrators” to the**  
39 **“Nursing Home Administrators Board.”**

40 **(2) For the purpose of harmonizing and clarifying statute sections published in Oregon**  
41 **Revised Statutes, the Legislative Counsel may substitute for words designating the “Board**  
42 **of Examiners of Nursing Home Administrators,” wherever they occur in Oregon Revised**  
43 **Statutes, other words designating the “Nursing Home Administrators Board.”**

44 **SECTION 3a. If House Bill 2058 becomes law, section 1 of this 2009 Act (amending ORS**  
45 **678.800) is repealed and ORS 678.800, as amended by section 13, chapter \_\_, Oregon Laws 2009**

1 **(Enrolled House Bill 2058), is amended to read:**

2 678.800. (1) *[There is hereby created a Board of Examiners of Nursing Home Administrators.]* **The**  
3 **Nursing Home Administrators Board is established within the Oregon Health Licensing**  
4 **Agency.**

5 (2) The board consists of nine members appointed by the Governor and subject to confirmation  
6 by the Senate in the manner provided in ORS 171.562 and 171.565. All members of the board must  
7 be concerned with the care and treatment of the chronically ill or infirm elderly patients and must  
8 be residents of this state. Of the members of the board:

9 (a) Three must be nursing home administrators licensed under *[ORS 678.710 to 678.780, 678.800*  
10 *to 678.840 and 678.990 (2)]* **ORS 678.710 to 678.840;**

11 (b) One must be a medical doctor licensed by the Oregon Medical Board actively engaged in  
12 private practice and conversant with the care and treatment of the long-term patient;

13 (c) One must be a licensed professional nurse actively engaged in caring for chronically ill and  
14 infirm patients and licensed by the Oregon State Board of Nursing;

15 (d) One must be a pharmacist licensed by the State Board of Pharmacy; and

16 (e) Three must be members of the public who are not:

17 (A) Otherwise eligible for appointment to the board; or

18 (B) A spouse, domestic partner, child, parent or sibling of a nursing home administrator.

19 (2)(a) Board members required to be nursing home administrators may be selected by the Gov-  
20 ernor from a list of three to five nominees submitted by any professional organization representing  
21 nursing home administrators.

22 (b) Except for those persons described in paragraph (a) of this subsection, no member of the  
23 board may have a direct financial interest in a nursing home.

24 (c) No more than two of the members of the board may be officials or full-time employees of  
25 state or local governments.

26 (d) At least one public member must be at least 62 years of age.

27 (e) No public members of the board may hold any pecuniary interest in, or have any employment  
28 contract with, a long term care facility.

29 (f) In selecting the members of the board, the Governor shall strive to balance the represen-  
30 tation on the board according to:

31 (A) Geographic areas of this state; and

32 (B) Ethnic group.

33 (3)(a) The term of office of each member is three years but a member serves at the pleasure of  
34 the Governor. The terms must be staggered so that no more than three terms end each year. Before  
35 the expiration of the term of a member, the Governor shall appoint a successor whose term begins  
36 on July 1 next following. A member is eligible for reappointment. If there is a vacancy for any cause  
37 the Governor shall make an appointment to become immediately effective for the unexpired term.

38 (b) A board member shall be removed immediately from the board if, during the member's term,  
39 the member:

40 (A) Is not a resident of this state;

41 (B) Has been absent from three consecutive board meetings, unless at least one absence is ex-  
42 cused; or

43 (C) Is not a licensed nursing home administrator or a retired nursing home administrator whose  
44 license as a nursing home administrator was in good standing at the time of retirement, if the  
45 member was appointed to serve on the board as a nursing home administrator.

1 (4) The members of the board are entitled to compensation and expenses as provided in ORS  
2 292.495. The board may provide by rule for compensation to board members for the performance of  
3 official duties at a rate that is greater than the rate provided in ORS 292.495.

4 **SECTION 3b. If House Bill 2058 becomes law, section 2 of this 2009 Act is repealed.**

5 **SECTION 3c.** If House Bill 2058 becomes law, section 3 of this 2009 Act is amended to read:

6 **Sec. 3.** (1) The amendments to ORS 678.800 by section [I] 3a of this 2009 Act are intended to  
7 change the name of the “Board of Examiners of Nursing Home Administrators” to the “Nursing  
8 Home Administrators Board.”

9 (2) For the purpose of harmonizing and clarifying statute sections published in Oregon Revised  
10 Statutes, the Legislative Counsel may substitute for words designating the “Board of Examiners of  
11 Nursing Home Administrators,” wherever they occur in Oregon Revised Statutes, other words des-  
12 ignating the “Nursing Home Administrators Board.”

13 **SECTION 4. The duties, functions and powers of the Nursing Home Administrators Board**  
14 **relating to the administrative and regulatory oversight of nursing home administrator li-**  
15 **licenses issued under ORS 678.710 to 678.840 are imposed upon, transferred to and vested in**  
16 **the Oregon Health Licensing Agency.**

17 **SECTION 5.** (1) **The chairperson of the Nursing Home Administrators Board shall deliver**  
18 **to the Oregon Health Licensing Agency all records within the jurisdiction of the chairperson**  
19 **that relate to the duties, functions and powers transferred by section 4 of this 2009 Act.**

20 (2) **The Director of the Oregon Health Licensing Agency shall take possession of the re-**  
21 **records delivered under subsection (1) of this section.**

22 (3) **The Governor shall resolve any dispute between the Nursing Home Administrators**  
23 **Board and the Oregon Health Licensing Agency relating to transfers of records under this**  
24 **section, and the Governor’s decision is final.**

25 **SECTION 6.** **The unexpended balance of the Board of Examiners of Nursing Home Ad-**  
26 **ministrators Account established in ORS 678.830 is transferred to the Oregon Health Li-**  
27 **icensing Agency Account established in ORS 676.625 for expenditure by the agency for the**  
28 **biennium beginning July 1, 2009, for the purpose of administering and enforcing the duties,**  
29 **functions and powers transferred by section 4 of this 2009 Act.**

30 **SECTION 7.** **The transfer of duties, functions and powers to the Oregon Health Licensing**  
31 **Agency by section 4 of this 2009 Act does not affect any action, proceeding or prosecution**  
32 **involving or with respect to such duties, functions and powers begun before and pending at**  
33 **the time of the transfer, except that the Oregon Health Licensing Agency is substituted for**  
34 **the Nursing Home Administrators Board in the action, proceeding or prosecution.**

35 **SECTION 8.** (1) **Nothing in sections 4 to 11 of this 2009 Act relieves a person of a liability,**  
36 **duty or obligation accruing under or with respect to the duties, functions and powers**  
37 **transferred by section 4 of this 2009 Act. The Oregon Health Licensing Agency may under-**  
38 **take the collection or enforcement of any such liability, duty or obligation.**

39 (2) **The rights and obligations of the Nursing Home Administrators Board legally incurred**  
40 **under contracts, leases and business transactions executed, entered into or begun before the**  
41 **effective date of section 4 of this 2009 Act and accruing under or with respect to the duties,**  
42 **functions and powers transferred by section 4 of this 2009 Act are transferred to the Oregon**  
43 **Health Licensing Agency. For the purpose of succession to these rights and obligations, the**  
44 **Oregon Health Licensing Agency is a continuation of the Nursing Home Administrators**  
45 **Board and not a new authority.**

1       **SECTION 9.** Notwithstanding the transfer of duties, functions and powers by section 4  
2 of this 2009 Act, the rules of the Nursing Home Administrators Board with respect to such  
3 duties, functions or powers that are in effect on the effective date of section 4 of this 2009  
4 Act continue in effect until superseded or repealed by rules of the Oregon Health Licensing  
5 Agency. References in such rules of the Nursing Home Administrators Board to the Nursing  
6 Home Administrators Board or an officer or employee of the Nursing Home Administrators  
7 Board are considered to be references to the Oregon Health Licensing Agency or an officer  
8 or employee of the Oregon Health Licensing Agency.

9       **SECTION 10.** Whenever, in any uncodified law or resolution of the Legislative Assembly  
10 or in any rule, document, record or proceeding authorized by the Legislative Assembly, in  
11 the context of the duties, functions and powers transferred by section 4 of this 2009 Act,  
12 reference is made to the Nursing Home Administrators Board, or an officer or employee of  
13 the Nursing Home Administrators Board, whose duties, functions or powers are transferred  
14 by section 4 of this 2009 Act, the reference is considered to be a reference to the Oregon  
15 Health Licensing Agency or an officer or employee of the Oregon Health Licensing Agency  
16 who by section 4 of this 2009 Act is charged with carrying out such duties, functions and  
17 powers.

18       **SECTION 11.** For the purpose of harmonizing and clarifying statute sections published  
19 in Oregon Revised Statutes, the Legislative Counsel may substitute for words designating the  
20 “Nursing Home Administrators Board” or its officers, wherever they occur in ORS 678.810  
21 to 678.840 and are used in relation to the administrative and regulatory oversight of nursing  
22 home administrator licenses issued under ORS 678.810 to 678.840, other words designating the  
23 “Oregon Health Licensing Agency” or its officers.

24       **SECTION 12.** ORS 678.810 is amended to read:

25       678.810. (1) The *[Board of Examiners of Nursing Home Administrators]* **Nursing Home Admin-**  
26 **istrators Board** shall hold at least *[two meetings]* **one meeting** each year. *[At any meeting]* A ma-  
27 jority of the members of the board *[shall constitute]* **constitutes** a quorum for the transaction of  
28 business.

29       (2) The board shall *[elect annually from its membership a]* **select one of its members as** chair-  
30 person and *[a]* **another as** vice chairperson, **for a one-year term and with such duties and**  
31 **powers necessary for the performance of the functions of the offices as the board**  
32 **determines.**

33       **SECTION 13.** ORS 678.820 is amended to read:

34       678.820. *[It shall be the function of the Board of Examiners of Nursing Home Administrators to:]*

35       *[(1) Develop, impose and enforce standards which shall be met by individuals in order to receive*  
36 *and retain a license as a nursing home administrator, which standards shall be designed to insure that*  
37 *nursing home administrators will be individuals who are qualified by training or experience in the field*  
38 *of long-term health care administration to serve as nursing home administrators.]*

39       *[(2) Develop and apply appropriate techniques, including examinations and investigations for de-*  
40 *termining whether an individual meets such standards, if examinations are reviewed periodically to*  
41 *insure validity.]*

42       *[(3) Issue licenses to individuals determined after application of such techniques, to meet such*  
43 *standards, and subject to ORS chapter 183 impose any of the sanctions set out in ORS 678.780 where*  
44 *the individual holding any such license is determined substantially to have failed to conform to the*  
45 *requirements of such standards.]*

1        *[(4) Establish and carry out procedures designed to insure that individuals licensed as nursing*  
2 *home administrators will, during any period that they serve as such, comply with the requirements of*  
3 *such standards.]*

4        *[(5) Receive, investigate and take appropriate action with respect to any charge or complaint filed*  
5 *with the board in writing, charging that any individual licensed as a nursing home administrator has*  
6 *failed to comply with the requirements of such standards.]*

7        *[(6) Conduct a continuing study and investigation of nursing homes and administrators of nursing*  
8 *homes within the state with a view to the improvement of standards imposed for the licensing of such*  
9 *administrators and the procedures and methods for the enforcement of such standards with respect to*  
10 *administrators of nursing homes who have been licensed as such.]*

11        *[(7) Encourage qualified educational institutions and other qualified organizations to establish,*  
12 *provide, conduct and continue such training and instruction courses and programs as will enable all*  
13 *otherwise qualified individuals to meet requirements established under ORS 678.710 to 678.780, 678.800*  
14 *to 678.840 and 678.990 (2).]*

15        *[(8) Approve courses and programs conducted within or without the state as sufficient to meet ed-*  
16 *ucation and training requirements established pursuant to ORS 678.710 to 678.780, 678.800 to 678.840*  
17 *and 678.990 (2) and advise the appropriate state agencies regarding receipt and administration of such*  
18 *federal funds as are made available for such purposes.]*

19        *[(9) In accordance with ORS 183.330, adopt, amend and repeal rules which are necessary to carry*  
20 *out the provisions of ORS 678.710 to 678.780, 678.800 to 678.840 and 678.990 (2).]*

21        *[(10) Maintain a register of all licensed nursing home administrators.]*

22        **(1) The Nursing Home Administrators Board is responsible for advising the Oregon**  
23 **Health Licensing Agency in all matters relating to the administration of ORS 678.710 to**  
24 **678.840, including:**

25        **(a) Developing standards for education and training;**

26        **(b) Developing standards of practice and professional conduct;**

27        **(c) Establishing standards related to the issuance, denial, revocation, suspension or re-**  
28 **newal of licenses to practice as a nursing home administrator;**

29        **(d) Preparing or approving the examinations required under ORS 678.710 to 678.840, in**  
30 **accordance with standards provided by the agency; and**

31        **(e) Assisting the agency in administering the provisions of ORS 678.710 to 678.840.**

32        **(2) The Oregon Health Licensing Agency shall administer ORS 678.710 to 678.840 by:**

33        **(a) Determining the qualifications and fitness of applicants for licenses, renewed licenses,**  
34 **reciprocal licenses and provisional licenses under ORS 678.710 to 678.840.**

35        **(b) Examining, approving, issuing, denying, revoking, suspending and renewing licenses**  
36 **to practice as a nursing home administrator.**

37        **(c) Providing for waivers of examinations or provisional licenses.**

38        **(d) Establishing and carrying out procedures to ensure compliance with professional**  
39 **standards adopted by the board.**

40        **(e) Pursuant to ORS 676.608, receiving and investigating complaints filed regarding**  
41 **nursing home administrators.**

42        **(f) Establishing and collecting fees and charges to carry out the agency's duties under**  
43 **ORS 678.710 to 678.840.**

44        **(g) In accordance with ORS 183.330 and 676.615, adopting, amending and repealing rules**  
45 **that are necessary to carry out the administration of ORS 678.710 to 678.840.**

1       **(h) Maintaining a register of all licensed nursing home administrators.**

2       **(3) The agency shall consider and be guided by the recommendations of the board in all**  
3 **matters relating to the administration of ORS 678.710 to 678.840.**

4       **SECTION 14.** ORS 678.710 is amended to read:

5       678.710. As used in ORS 678.710 to 678.840, unless the context requires otherwise:

6       [(1) “Board” means the Board of Examiners of Nursing Home Administrators of the State of  
7 Oregon.]

8       [(2) “Department” means the Department of Human Services.]

9       [(3)] (1) “Dual facility” means a facility that operates both a hospital and a long term care fa-  
10 cility on the same campus.

11       **(2) “Nursing home” means any institution or facility defined as a long term care facility**  
12 **for licensing purposes under state statute or the rules of the Department of Human Services,**  
13 **including a long term care facility operated as part of a dual facility.**

14       [(4)] (3) “Nursing home administrator” means an individual responsible for planning, organizing  
15 and managing the operation of a nursing home, whether or not such individual has an ownership  
16 interest in such home and whether or not such functions are shared by one or more other individ-  
17 uals, if:

18       (a) Final responsibility and authority are retained in the nursing home administrator; and

19       (b) In the case of a dual facility, the nursing home administrator may be subject to the authority  
20 of the administrator of the dual facility or the dual facility administrator may administer the nursing  
21 home if the administrator is licensed or otherwise qualified by statute to administer a nursing home.

22       [(5) “Nursing home” means any institution or facility defined as a long term care facility for li-  
23 censing purposes under state statute or the rules of the department, including a long term care facility  
24 operated as part of a dual facility.]

25       [(6)] (4) “Provisional license” means a temporary license issued to a provisional nursing home  
26 administrator under the rules of the [board] **Oregon Health Licensing Agency.**

27       **SECTION 15.** ORS 678.720 is amended to read:

28       678.720. (1) [On and after July 1, 1971,] Unless an individual holds a valid license issued under  
29 the provisions of [ORS 678.710 to 678.780, 678.800 to 678.840 and 678.990 (2)] **ORS 678.710 to**  
30 **678.840**, an individual [shall] **may** not:

31       (a) Practice or offer to practice as a nursing home administrator; or

32       (b) Use in connection with the name of the individual the words or letters “nursing home ad-  
33 ministrator,” “NHA” or any other words, letters or abbreviations or insignia tending to indicate that  
34 [such] **the** individual is a licensed nursing home administrator.

35       (2) [On and after July 1, 1971, no] **A** nursing home shall be conducted or operated [unless it is]  
36 under the supervision of a nursing home administrator who holds a valid license issued under the  
37 provisions of [ORS 678.710 to 678.780, 678.800 to 678.840 and ORS 678.990 (2)] **ORS 678.710 to**  
38 **678.840.**

39       **SECTION 16.** ORS 678.725 is amended to read:

40       678.725. (1) Any health care facility licensed under ORS 441.015, any licensee licensed by the  
41 [Board of Examiners of Nursing Home Administrators of the State of Oregon] **Oregon Health Li-**  
42 **censing Agency**, any physician licensed by the Oregon Medical Board, any licensed professional  
43 nurse and any licensed pharmacist shall, and any other person may, report to the [board] **agency**  
44 suspected violations of ORS 678.710 to 678.840 and [insanitary] **unsanitary** or other unsatisfactory  
45 conditions in a nursing home.

1 (2) Information acquired by the [board] **agency** pursuant to subsection (1) of this section is  
2 confidential and [shall not be] **is not** subject to public disclosure.

3 (3) Any person who reports or provides information to the [board] **agency** under subsection (1)  
4 of this section and who provides information in good faith [shall] **may** not be subject to an action  
5 for civil damages as a result [thereof] **of making the report or providing the information.**

40 not to exceed \$5,000 for each violation of the following statutes and any rule adopted thereunder:

41 (a) ORS 688.701 to 688.734 (athletic training);

42 (b) ORS 690.500 to 690.570 (body piercing);

43 (c) ORS 690.005 to 690.235 (cosmetology);

44 (d) ORS 680.500 to 680.570 (denture technology);

45 (e) ORS 687.405 to 687.495 (direct entry midwifery);

- 1 (f) ORS 690.350 to 690.430 (electrology and permanent coloring or tattooing);
- 2 (g) ORS 694.015 to 694.185 (dealing in hearing aids);
- 3 (h) ORS 688.800 to 688.840 (respiratory therapy);
- 4 (i) ORS chapter 700 (environmental sanitation);
- 5 (j) ORS 676.617 (single facility licensure); [and]
- 6 (k) ORS 675.360 to 675.410 (sex offender treatment); **and**
- 7 **(L) ORS 678.710 to 678.840 (nursing home administrators).**

8 (2) The agency may take any other disciplinary action that it finds proper, including but not  
9 limited to assessment of costs of disciplinary proceedings, not to exceed \$5,000, for violation of any  
10 statute or rule adopted under any statute listed in subsection (1) of this section.

11 (3) Subsection (1) of this section does not limit the amount of the civil penalty resulting from a  
12 violation of ORS 694.042.

13 (4) In imposing a civil penalty pursuant to this section, the agency shall consider the following  
14 factors:

- 15 (a) The immediacy and extent to which the violation threatens the public health or safety;
- 16 (b) Any prior violations of statutes, rules or orders;
- 17 (c) The history of the person incurring a penalty in taking all feasible steps to correct any vio-  
18 lation; and
- 19 (d) Any other aggravating or mitigating factors.

20 (5) Civil penalties under this section shall be imposed as provided in ORS 183.745.

21 (6) The moneys received by the agency from civil penalties under this section shall be paid into  
22 the General Fund of the State Treasury and credited to the Oregon Health Licensing Agency Ac-  
23 count established under ORS 676.625. Such moneys are continuously appropriated to the agency for  
24 the administration and enforcement of the laws the agency is charged with administering and en-  
25 forcing that govern the person against whom the penalty was imposed.

26 **SECTION 32.** ORS 441.109 is amended to read:

27 441.109. The office of the Long Term Care Ombudsman shall carry out the following duties:

28 (1) Investigate and resolve complaints made by or for residents of long term care facilities about  
29 administrative actions that may adversely affect their health, safety, welfare or rights, including  
30 subpoenaing any person to appear, give sworn testimony or to produce documentary or other evi-  
31 dence that is reasonably material to any matter under investigation.

32 (2) Undertake, participate in or cooperate with persons and agencies in such conferences, in-  
33 quiries, meetings or studies as may lead to improvements in the functioning of long term care fa-  
34 cilities.

35 (3) Monitor the development and implementation of federal, state and local laws, regulations and  
36 policies that relate to long term care facilities in this state.

37 (4) Provide information to public agencies about the problems of residents of long term care fa-  
38 cilities.

39 (5) Work closely with cooperative associations and citizen groups in this state.

40 (6) Widely publicize the Long Term Care Ombudsman's service, purpose and mode of operation.

41 (7) Collaborate with the Department of Human Services and the [*Board of Examiners of Nursing*  
42 *Home Administrators*] **Nursing Home Administrators Board** to establish a statewide system to  
43 collect and analyze information on complaints and conditions in long term care facilities for the  
44 purpose of publicizing improvements and resolving significant problems.

45 (8) Appoint designees to serve as local representatives of the office in various districts of the



1 state and regularly monitor their functions.

2 (9) Specify qualifications and duties of designees.

3 (10) Adopt rules necessary for carrying out ORS 441.100 to 441.133, after consultation with the  
4 committee.

5 (11) Provide periodically, or at least twice annually, a report to the Governor, department and  
6 the Legislative Assembly.

7 (12) Prepare necessary reports with the assistance of the department.

29 (19) Oregon State Veterinary Medical Examining Board; and

32 **SECTION 34.** ORS 678.825, 678.830 and 678.840 are repealed.

33 **SECTION 35.** This 2009 Act being necessary for the immediate preservation of the public  
34 peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect  
35 July 1, 2009.
