

## HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2287

By JOINT COMMITTEE ON WAYS AND MEANS

1 On page 1 of the printed A-engrossed bill, line 2, after “ORS” delete the rest of the line and lines  
2 3 through 5 and insert “1.202, 18.999, 21.010, 21.110, 36.170, 135.265, 137.540 and 153.125 and section  
3 15, chapter 860, Oregon Laws 2007; appropriating money; declaring an emergency; and providing for  
4 revenue raising that requires approval by a three-fifths majority.”.

5 Delete lines 7 through 23 and delete pages 2 through 30 and insert:

### “JUDICIAL SYSTEM SURCHARGE ACCOUNT

7  
8

9 **“SECTION 1. (1) The Judicial System Surcharge Account is established in the General**  
10 **Fund of the State Treasury. All moneys in the account are continuously appropriated to the**  
11 **Department of Revenue to be distributed by the Department of Revenue according to allo-**  
12 **cations made by the Legislative Assembly. The Department of Revenue shall keep a record**  
13 **of moneys transferred into and out of the account.**

14 **“(2) The Department of Revenue shall deposit in the General Fund all moneys remaining**  
15 **in the account after the distributions required by subsection (1) of this section have been**  
16 **made. Moneys deposited in the General Fund under this subsection are available for general**  
17 **governmental purposes.**

18 **“SECTION 1a. (1) During the biennium commencing July 1, 2009, the Department of Re-**  
19 **venue shall make monthly distributions from the Judicial System Surcharge Account. The**  
20 **department may not make a monthly distribution if the balance in the account is less than**  
21 **\$500,000 at the time the distribution would otherwise be made.**

22 **“(2) Before a monthly distribution is made by the department under this section, the**  
23 **department shall distribute to itself the lesser of 0.05 percent of the balance in the Judicial**  
24 **System Surcharge Account or the amount necessary to pay the department’s costs incurred**  
25 **in administering the account.**

26 **“(3) As soon as possible after making the distribution required by subsection (2) of this**  
27 **section, the Department of Revenue shall make the following distributions from the Judicial**  
28 **System Surcharge Account:**

29 **“(a) To the Judicial Department, 65 percent of the remaining balance in the account, to**  
30 **be used for court operations. Amounts distributed to the Judicial Department under this**  
31 **paragraph in the biennium commencing July 1, 2009, may not exceed \$6.5 million.**

32 **“(b) To the Public Defense Services Commission, 35 percent of the remaining balance in**  
33 **the account, to be used for trial-level indigent defense. Amounts distributed to the Public**  
34 **Defense Services Commission under this paragraph in the biennium commencing July 1, 2009,**  
35 **may not exceed \$3.5 million.**

2  
3 **“OFFENSE SURCHARGE**

4 **“SECTION 2. (1) In all cases of conviction for the commission of a crime or violation,**  
5 **excluding parking violations, the trial court, whether a circuit, justice or municipal court,**  
6 **shall impose upon the defendant, in addition to any fine, cost or other monetary obligation**  
7 **imposed, an offense surcharge under this section. Except when the person successfully as-**  
8 **serts the defense set forth in ORS 419C.522, the offense surcharge shall also be imposed by**  
9 **the circuit court and county court in juvenile cases under ORS 419C.005 (1). The offense**  
10 **surcharge is a penal obligation in the nature of a fine and shall be in an amount as follows:**

11 **“(a) \$35 in the case of a felony.**

12 **“(b) \$35 in the case of a misdemeanor.**

13 **“(c) \$45 in the case of a violation as described in ORS 153.008.**

14 **“(2) A court may waive all or part of the offense surcharge required by this section only**  
15 **if the court imposes no fine on the defendant.**

16 **“(3) The offense surcharge required by this section shall be imposed only for offenses**  
17 **that are committed on or after October 1, 2009, and before July 1, 2011.**

18 **“(4) Offense surcharges imposed under this section are part of the base fine for the**  
19 **purposes of ORS chapter 153.**

20 **“(5) Offense surcharges imposed in a circuit court under this section are category 3**  
21 **monetary obligations for the purposes of ORS 137.295 and shall be collected as provided in**  
22 **ORS 137.295. Offense surcharges imposed in a justice court, county court or municipal court**  
23 **under this section are category 4 monetary obligations for the purposes of ORS 137.295 and**  
24 **shall be collected as provided in ORS 137.295. Amounts collected as offense surcharges under**  
25 **this section may not be deposited in the Criminal Fine and Assessment Account, or trans-**  
26 **ferred to the Department of Revenue, under ORS 137.295 (5), but must be deposited or paid**  
27 **as follows:**

28 **“(a) Offense surcharges imposed in circuit courts shall be deposited by the Department**  
29 **of Revenue in the Judicial System Surcharge Account.**

30 **“(b) Offense surcharges imposed in a justice court or county court shall be paid to the**  
31 **county treasurer.**

32 **“(c) Offense surcharges imposed in a municipal court shall be paid to the city treasurer.**

33 **“(6) The collections and revenue management program established under ORS 1.204 may**  
34 **not be reimbursed under ORS 1.204 from amounts imposed as offense surcharges under this**  
35 **section.**

36 **“SECTION 2a. ORS 153.125 is amended to read:**

37 **“153.125. (1) The base fine required in violation proceedings under this chapter is the sum of a**  
38 **foundation amount calculated under ORS 153.125 to 153.145 plus the unitary and county assessments**  
39 **established under ORS 137.290 and 137.309, and the offense surcharge under section 2 of this**  
40 **2009 Act, for the violation. The amount of the county assessment under ORS 137.309 shall be cal-**  
41 **culated using the foundation amount determined under ORS 153.125 to 153.145, and may not be cal-**  
42 **culated using the maximum fine for the violation.**

43 **“(2) Except as otherwise provided in ORS 153.125 to 153.145, the foundation amount to be used**  
44 **in calculating the base fine required in violation proceedings under this chapter is 50 percent of the**  
45 **maximum fine established for the violation.**

**“(3) Except as otherwise provided in ORS 153.125 to 153.145, the foundation amount to be used**

1 for a specific fine violation in calculating the base fine required in a violation proceeding under this  
2 chapter is the maximum fine provided for the violation.

3 “(4) If the law creating a violation establishes a minimum fine, and the foundation amount cal-  
4 culated for the violation under ORS 153.125 to 153.145 is less than the minimum fine for the vio-  
5 lation, the foundation amount to be used in calculating the base fine required in a violation  
6 proceeding under this chapter is the minimum fine established for the violation.

7 “**SECTION 2b. The amendments to ORS 153.125 by section 2a of this 2009 Act apply only**  
8 **to offenses that are committed on or after October 1, 2009, and before July 1, 2011.**

9 “**SECTION 2c.** ORS 153.125, as amended by section 2a of this 2009 Act, is amended to read:

10 “153.125. (1) The base fine required in violation proceedings under this chapter is the sum of a  
11 foundation amount calculated under ORS 153.125 to 153.145 plus the unitary and county assessments  
12 established under ORS 137.290 and 137.309[ *and the offense surcharge under section 2 of this 2009*  
13 *Act,*] for the violation. The amount of the county assessment under ORS 137.309 shall be calculated  
14 using the foundation amount determined under ORS 153.125 to 153.145, and may not be calculated  
15 using the maximum fine for the violation.

16 “(2) Except as otherwise provided in ORS 153.125 to 153.145, the foundation amount to be used  
17 in calculating the base fine required in violation proceedings under this chapter is 50 percent of the  
18 maximum fine established for the violation.

19 “(3) Except as otherwise provided in ORS 153.125 to 153.145, the foundation amount to be used  
20 for a specific fine violation in calculating the base fine required in a violation proceeding under this  
21 chapter is the maximum fine provided for the violation.

22 “(4) If the law creating a violation establishes a minimum fine, and the foundation amount cal-  
23 culated for the violation under ORS 153.125 to 153.145 is less than the minimum fine for the vio-  
24 lation, the foundation amount to be used in calculating the base fine required in a violation  
25 proceeding under this chapter is the minimum fine established for the violation.

26 “**SECTION 2d. (1) The amendments to ORS 153.125 by section 2c of this 2009 Act become**  
27 **operative July 1, 2011.**

28 “**(2) The amendments to ORS 153.125 by section 2c of this 2009 Act do not affect the im-**  
29 **position of a surcharge under section 2 of this 2009 Act for an offense committed on or after**  
30 **October 1, 2009, and before July 1, 2011.**

32 “**EXTENSION OF 2007 FILING FEE SURCHARGES**  
33 **TO SEPTEMBER 30, 2009**  
34

35 “**SECTION 3.** Section 15, chapter 860, Oregon Laws 2007, is amended to read:

36 “**Sec. 15.** (1) In addition to the fees provided for in ORS 21.010 (1), for the period commencing  
37 September 1, 2007, and ending [June] **September** 30, 2009, at the time of filing a response in the  
38 Court of Appeals or the Supreme Court, the State Court Administrator shall collect a surcharge of  
39 \$8.

40 “(2)(a) In addition to the fees provided for in ORS 21.110 (1), for the period commencing Sep-  
41 tember 1, 2007, and ending [June] **September** 30, 2009, at the time of filing in the circuit court of  
42 any civil action, suit or proceeding, including appeals, the clerk of the circuit court shall collect  
43 from the plaintiff, appellant or moving party a surcharge of \$5. In addition, at the time of filing any  
44 appearance in any such action, suit or proceeding upon the part of any defendant or respondent  
45 appearing separately, or upon the part of defendants or respondents appearing jointly, the clerk

1 shall collect from the party or parties a surcharge of \$4.

2 “(b) In addition to the fees provided for in ORS 21.110 (2), for the period commencing September  
3 1, 2007, and ending [June] **September** 30, 2009, the clerk of the circuit court shall collect a sur-  
4 charge of \$3 from the plaintiff, appellant or moving party, and shall collect a surcharge of \$3 from  
5 any defendant or respondent appearing separately, or upon the part of defendants or respondents  
6 appearing jointly, in the actions described in ORS 21.110 (2).

7 “(3)(a) In addition to the fees provided for in ORS 21.111 (1), for the period commencing Sep-  
8 tember 1, 2007, and ending [June] **September** 30, 2009, in the proceedings specified in ORS 21.111  
9 (2) the clerk of the circuit court shall collect a surcharge of \$5 from the petitioner at the time the  
10 petition is filed, and shall collect a surcharge of \$3 from the respondent upon the respondent making  
11 an appearance.

12 “(b) In addition to the fees provided for in ORS 21.111 (3), for the period commencing September  
13 1, 2007, and ending [June] **September** 30, 2009, the clerk of the circuit court shall collect from the  
14 moving party a surcharge of \$3 at the time of the filing of a motion for the modification of a decree  
15 of marital annulment, dissolution or separation, if the motion is filed more than one year after the  
16 entry of the decree in the register of the court.

17 “(4) In addition to the fees provided for ORS 21.114 (1), for the period commencing September  
18 1, 2007, and ending [June] **September** 30, 2009, the clerk of the court shall collect:

19 “(a) In an adoption proceeding, a surcharge of \$2 from the party filing the petition for adoption  
20 and a surcharge of \$1 from an objecting party appearing separately or objecting parties appearing  
21 jointly.

22 “(b) In a change of name proceeding, a surcharge of \$2 from the party filing the application for  
23 change of name and a surcharge of \$1 from an objecting party appearing separately or objecting  
24 parties appearing jointly.

25 “(5) In addition to the fee provided for in ORS 21.114 (3), for the period commencing September  
26 1, 2007, and ending [June] **September** 30, 2009, in any adoption or change of name proceeding in a  
27 court having jurisdiction, the clerk of the court shall collect from the party having the affirmative  
28 of the issue, at the time the proceeding comes on for trial or hearing upon the issues of fact or law  
29 involved therein, a surcharge of \$2.

30 “(6)(a) In addition to the trial fee provided for in ORS 21.270 (2), for the period commencing  
31 September 1, 2007, and ending [June] **September** 30, 2009, the clerk of the circuit court shall collect  
32 from the plaintiff, appellant or moving party, for a trial on the merits without a jury, a surcharge  
33 on the trial fee of \$4 for each full or partial day of the trial.

34 “(b) In addition to the jury trial fee provided for in ORS 21.270 (3), for the period commencing  
35 September 1, 2007, and ending [June] **September** 30, 2009, the clerk shall collect from the plaintiff  
36 or appellant, for a trial by a jury of more than six persons, a surcharge on the jury trial fee of \$10  
37 for each full or partial day of the trial. The clerk shall collect from the plaintiff or appellant, for a  
38 trial by a jury of six persons, a surcharge on the jury trial fee of \$6 for each full or partial day of  
39 the trial.

40 “(7) In addition to the hearing fee provided for in ORS 21.275 (3), for the period commencing  
41 September 1, 2007, and ending [June] **September** 30, 2009, the clerk of the circuit court shall collect  
42 a surcharge on the hearing fee of \$2 if the hearing period is not more than three hours or \$4 if the  
43 hearing period is more than three hours.

44 “(8)(a) In addition to the fees provided for in ORS 21.310 (1), for the period commencing Sep-  
45 tember 1, 2007, and ending [June] **September** 30, 2009, the clerk of the court shall collect the fol-

1 lowing surcharges for the filing of the initial papers in any probate proceeding, including petitions  
2 for the appointment of personal representatives, probate of wills and contest of wills, or in any  
3 conservatorship proceeding:

4 “

5  
6 Where the amount of the estate is:

- 7 1. Not more than \$10,000--a surcharge of \$1.
- 8 2. More than \$10,000 and not more than \$25,000--a surcharge of \$4.
- 9 3. More than \$25,000 and not more than \$50,000--a surcharge of \$8.
- 10 4. More than \$50,000 and not more than \$100,000--a surcharge of \$12.
- 11 5. More than \$100,000 and not more than \$500,000--a surcharge of \$15.
- 12 6. More than \$500,000 and not more than \$1,000,000--a surcharge of \$19.
- 13 7. More than \$1,000,000--a surcharge of \$23.

16 “(b) In addition to the fee provided for in ORS 21.310 (3), for the period commencing September  
17 1, 2007, and ending [June] **September** 30, 2009, the clerk shall collect a surcharge of \$1 for the filing  
18 of the initial papers in any guardianship proceeding.

19 “(c) In addition to the fee provided for in ORS 21.310 (5), for the period commencing September  
20 1, 2007, and ending [June] **September** 30, 2009, at the time of filing any answer, motion or objection  
21 in a probate proceeding or protective proceeding under ORS chapter 125, the party filing the an-  
22 swer, motion or objection shall pay a surcharge of \$1 to the clerk.

23 “(d) In addition to the fee provided for in ORS 21.310 (7), for the period commencing September  
24 1, 2007, and ending [June] **September** 30, 2009, the clerk shall collect from the party having the  
25 affirmative of the issue, at the time the proceeding comes on for trial or hearing upon the issues  
26 of fact or law involved therein, a surcharge on the trial or hearing fee of \$2.

27 “(9) In addition to the fees provided for in ORS 21.325 (3), for the period commencing September  
28 1, 2007, and ending [June] **September** 30, 2009, the clerk of the court shall collect a surcharge of  
29 \$2 for the filing of a copy of foreign judgment and affidavit filed as provided in ORS 24.115 and  
30 24.125 or the filing of a copy of child custody determination of another state filed as provided in  
31 ORS 109.787.

32 “(10) In addition to the fee provided for in ORS 34.340, for the period commencing September  
33 1, 2007, and ending [June] **September** 30, 2009, the clerk of the court shall collect a surcharge of  
34 \$1 upon the filing of a petition for a writ of habeas corpus.

35 “(11) In addition to the fees provided for in ORS 36.520 (5), for the period commencing September  
36 1, 2007, and ending [June] **September** 30, 2009, the clerk of the circuit court shall collect from the  
37 party making application for setting aside under ORS 36.520 (1) a surcharge of \$2 and from a party  
38 filing an appearance in opposition to the application a surcharge of \$1.

39 “(12) In addition to the fee provided for in ORS 36.522 (3), for the period commencing September  
40 1, 2007, and ending [June] **September** 30, 2009, the clerk of the circuit court shall collect a sur-  
41 charge of \$1 for the filing of an arbitral award or application for enforcement of an arbitral award  
42 under ORS 36.522.

43 “(13) In addition to the fee provided for in ORS 36.524 (1), for the period commencing September  
44 1, 2007, and ending [June] **September** 30, 2009, the clerk of the circuit court shall collect a sur-  
45 charge of \$1 for the filing under ORS 36.524 (1).

1           “(14) In addition to the fee provided for in ORS 36.615 (1)(b), for the period commencing Sep-  
2           tember 1, 2007, and ending [*June*] **September** 30, 2009, the clerk of the circuit court shall collect  
3           a surcharge of \$2 upon the filing of a petition to seek confirmation, vacation, modification or cor-  
4           rection of an award under ORS 36.700, 36.705 or 36.710, and a surcharge of \$1 from a person filing  
5           an appearance in opposition to the petition.

6           “(15) In addition to the fees provided for in ORS 46.570 (1), for the period commencing September  
7           1, 2007, and ending [*June*] **September** 30, 2009, in the small claims department of a circuit court the  
8           clerk of the court shall collect:

9           “(a) A \$1 surcharge when a plaintiff files a claim and the amount or value claimed does not  
10           exceed \$1,500;

11           “(b) A \$2 surcharge when a plaintiff files a claim and the amount or value claimed exceeds  
12           \$1,500;

13           “(c) A \$1 surcharge when a defendant demands a hearing and the amount or value claimed by  
14           the plaintiff does not exceed \$1,500; and

15           “(d) A \$2 surcharge when a defendant demands a hearing and the amount or value claimed by  
16           the plaintiff exceeds \$1,500.

17           “(16)(a) In addition to the fees provided for in ORS 105.130 (2), for the period commencing Sep-  
18           tember 1, 2007, and ending [*June*] **September** 30, 2009, upon filing a complaint in the case of a  
19           dwelling unit to which ORS chapter 90 applies, the clerk of the court shall collect a surcharge of  
20           \$3.

21           “(b) In addition to the fees provided for in ORS 105.130 (3), for the period commencing Septem-  
22           ber 1, 2007, and ending [*June*] **September** 30, 2009, if the defendant demands a trial after a com-  
23           plaint is filed under ORS 105.130 (2), the plaintiff shall pay a surcharge of \$2.

24           “(17) In addition to the fee provided for in ORS 107.434 (1), for the period commencing Septem-  
25           ber 1, 2007, and ending [*June*] **September** 30, 2009, the clerk of the court shall collect a surcharge  
26           of \$3 upon the filing of a motion seeking enforcement of a parenting time order or a substantial vi-  
27           olation of a parenting plan.

28           “(18) In addition to the fee provided for in ORS 112.820 (1)(d), for the period commencing Sep-  
29           tember 1, 2007, and ending [*June*] **September** 30, 2009, the clerk of the probate court shall collect  
30           a surcharge of \$1 for filing of an affidavit under ORS 112.820 (1).

31           “(19) In addition to the fee provided for in ORS 114.515 (6), for the period commencing Septem-  
32           ber 1, 2007, and ending [*June*] **September** 30, 2009, the clerk of the probate court shall collect a  
33           surcharge of \$1 upon the filing of an affidavit under ORS 114.515.

34           “(20) In addition to the fee provided for in ORS 130.200 (8)(a), for the period commencing Sep-  
35           tember 1, 2007, and ending [*June*] **September** 30, 2009, the clerk of the circuit court shall collect  
36           a surcharge of \$3 for the filing of an agreement or memorandum of agreement under ORS 130.200  
37           (6) and a surcharge of \$2 for the filing of objections under ORS 130.200 (7).

38           “(21) In addition to the fee provided for in ORS 138.560, for the period commencing September  
39           1, 2007, and ending [*June*] **September** 30, 2009, a petitioner shall pay a surcharge of \$1 at the time  
40           of filing a petition under ORS 138.560.

41           “(22) In addition to the fee provided for in ORS 166.274, for the period commencing September  
42           1, 2007, and ending [*June*] **September** 30, 2009, the clerk of the court shall collect a surcharge of  
43           \$5 for the filing of a petition for relief under ORS 166.274.

44           “(23) In addition to the fee provided for in ORS 419B.555 (6), for the period commencing Sep-  
45           tember 1, 2007, and ending [*June*] **September** 30, 2009, the clerk of the court shall collect a sur-

1 charge of \$4 for each application for emancipation under ORS 419B.555.

2 “(24) Except as provided in subsection (25) of this section, surcharges imposed under this  
3 section on or after July 1, 2009, and before October 1, 2009, shall be deposited in the Judicial  
4 System Surcharge Account. The collections and revenue management program established  
5 under ORS 1.204 may not be reimbursed under ORS 1.204 from surcharges imposed under  
6 this section on or after July 1, 2009, and before October 1, 2009.

7 “(25) A surcharge imposed by a county court under subsection (8) of this section or by  
8 a justice court under subsection (16) of this section shall be paid to the county treasurer.

9  
10 “SURCHARGES OPERATIVE OCTOBER 1, 2009

11  
12 “**SECTION 4.** (1) In addition to the fees provided for in ORS 21.010 (1), for the period  
13 commencing October 1, 2009, and ending June 30, 2011, at the time of filing a response in the  
14 Court of Appeals or the Supreme Court, the State Court Administrator shall collect a sur-  
15 charge of \$8.

16 “(2)(a) In addition to the fees provided for in ORS 21.111 (1), for the period commencing  
17 October 1, 2009, and ending June 30, 2011, in the proceedings specified in ORS 21.111 (2) the  
18 clerk of the circuit court shall collect a surcharge of \$5 from the petitioner at the time the  
19 petition is filed, and shall collect a surcharge of \$3 from the respondent upon the respondent  
20 making an appearance.

21 “(b) In addition to the fees provided for in ORS 21.111 (3), for the period commencing  
22 October 1, 2009, and ending June 30, 2011, the clerk of the circuit court shall collect from the  
23 moving party a surcharge of \$3 at the time of the filing of a motion for the modification of  
24 a decree of marital annulment, dissolution or separation, if the motion is filed more than one  
25 year after the entry of the decree in the register of the court.

26 “(3) In addition to the fees provided for ORS 21.114 (1), for the period commencing Oc-  
27 tober 1, 2009, and ending June 30, 2011, the clerk of the court shall collect:

28 “(a) In an adoption proceeding, a surcharge of \$2 from the party filing the petition for  
29 adoption and a surcharge of \$1 from an objecting party appearing separately or objecting  
30 parties appearing jointly.

31 “(b) In a change of name proceeding, a surcharge of \$61 from the party filing the appli-  
32 cation for change of name and a surcharge of \$61 from an objecting party appearing sepa-  
33 rately or objecting parties appearing jointly.

34 “(4) In addition to the fee provided for in ORS 21.114 (3), for the period commencing Oc-  
35 tober 1, 2009, and ending June 30, 2011, in any adoption or change of name proceeding in a  
36 court having jurisdiction, the clerk of the court shall collect from the party having the af-  
37 firmative of the issue, at the time the proceeding comes on for trial or hearing upon the is-  
38 sues of fact or law involved therein, a surcharge of \$2.

39 “(5)(a) In addition to the trial fee provided for in ORS 21.270 (2), for the period com-  
40 mencing October 1, 2009, and ending June 30, 2011, the clerk of the circuit court shall collect  
41 from the plaintiff, appellant or moving party, for a trial on the merits without a jury, a  
42 surcharge on the trial fee of \$33 for each full or partial day of the trial.

43 “(b) In addition to the jury trial fee provided for in ORS 21.270 (3), for the period com-  
44 mencing October 1, 2009, and ending June 30, 2011, the clerk shall collect from the plaintiff  
45 or appellant, for a trial by a jury of more than six persons, a surcharge on the jury trial fee

1 of \$32 for each full or partial day of the trial. The clerk shall collect from the plaintiff or  
2 appellant, for a trial by a jury of six persons, a surcharge on the jury trial fee of \$40 for each  
3 full or partial day of the trial.

4 “(6) In addition to the hearing fee provided for in ORS 21.275 (3), for the period com-  
5 mencing October 1, 2009, and ending June 30, 2011, the clerk of the circuit court shall collect  
6 a surcharge on the hearing fee of \$12 if the hearing period is not more than three hours or  
7 \$33 if the hearing period is more than three hours.

8 “(7)(a) In addition to the fees provided for in ORS 21.310 (1), for the period commencing  
9 October 1, 2009, and ending June 30, 2011, the clerk of the court shall collect the following  
10 surcharges for the filing of the initial papers in any probate proceeding, including petitions  
11 for the appointment of personal representatives, probate of wills and contest of wills, or in  
12 any conservatorship proceeding:

- 16 1. Not more than \$10,000--a surcharge of \$1.

**“SECTION 9.** ORS 135.265 is amended to read:

“135.265. (1) If the defendant is not released on personal recognizance under ORS 135.255, or granted conditional release under ORS 135.260, or fails to agree to the provisions of the conditional release, the magistrate shall set a security amount that will reasonably assure the defendant’s appearance. The defendant shall execute the security release in the amount set by the magistrate.

“(2) The defendant shall execute a release agreement and deposit with the clerk of the court before which the proceeding is pending a sum of money equal to 10 percent of the security amount, but in no event shall such deposit be less than \$25. The clerk shall issue a receipt for the sum deposited. Upon depositing this sum the defendant shall be released from custody subject to the condition that the defendant appear to answer the charge in the court having jurisdiction on a day certain and thereafter as ordered by the court until discharged or final order of the court. Once security has been given and a charge is pending or is thereafter filed in or transferred to a court of competent jurisdiction the latter court shall continue the original security in that court subject to ORS 135.280 and 135.285. When conditions of the release agreement have been performed and the defendant has been discharged from all obligations in the cause, the clerk of the court shall return to the person shown by the receipt to have made the deposit, unless the court orders otherwise, 85 percent of the sum which has been deposited and shall retain as security release costs 15 percent, but not less than \$5 [*nor more than \$200*], of the amount deposited. The interest that has accrued on the full amount deposited shall also be retained by the clerk. The amount retained by the clerk of a circuit court shall be paid over as directed by the State Court Administrator for deposit in the Criminal Fine and Assessment Account created under ORS 137.300. The amount retained by a justice of the peace shall be deposited in the county treasury. The amount retained by the clerk of a municipal court shall be deposited in the municipal corporation treasury. At the request of the defendant the court may order whatever amount is repayable to defendant from such security amount to be paid to defendant’s attorney of record.

“(3) Instead of the security deposit provided for in subsection (2) of this section the defendant may deposit with the clerk of the court an amount equal to the security amount in cash, stocks, bonds, or real or personal property situated in this state with equity not exempt owned by the defendant or sureties worth double the amount of security set by the magistrate. The stocks, bonds, real or personal property shall in all cases be justified by affidavit. The magistrate may further examine the sufficiency of the security as the magistrate considers necessary.

**“SECTION 10.** (1) **The amendments to ORS 135.265 by section 9 of this 2009 Act apply only to security deposits made on or after October 1, 2009, and before July 1, 2011.**

**“(2) All amounts retained in a circuit court under ORS 135.265 as security deposit costs from security deposits made on or after October 1, 2009, and before July 1, 2011, that are in excess of \$200 shall be deposited in the Judicial System Surcharge Account. 20 on the full amount deposited shall also be retained by the clerk. The amount retained by the clerk  
21 of a circuit court shall be paid over as directed by the State Court Administrator for deposit in the

23 tice of the peace shall be deposited in the county treasury. The amount retained by the clerk of a

7 offender who is on probation, parole or post-prison supervision resides, without the approval of the  
8 person’s supervising parole and probation officer, or in which more than one other sex offender who  
9 is on probation, parole or post-prison supervision resides, without the approval of the director of the  
10 probation agency that is supervising the person or of the county manager of the Department of  
11 Corrections, or a designee of the director or manager. As soon as practicable, the supervising parole  
12 and probation officer of a person subject to the requirements of this subsection shall review the  
13 person’s living arrangement with the person’s sex offender treatment provider to ensure that the

17 “(b) ‘Dwelling’ does not include a residential treatment facility or a halfway house.

19 ity that provides rehabilitative care and treatment for sex offenders.

20 “(d) ‘Sex offender’ has the meaning given that term in ORS 181.594.

21 “(4)(a) If the person is released on probation following conviction of a sex crime, as defined in  
22 ORS 181.594, or an assault, as defined in ORS 163.175 or 163.185, and the victim was under 18 years  
23 of age, the court, if requested by the victim, shall include as a special condition of the person’s  
24 probation that the person not reside within three miles of the victim unless:

25 “(A) The victim resides in a county having a population of less than 130,000 and the person is  
26 required to reside in that county;

27 “(B) The person demonstrates to the court by a preponderance of the evidence that no mental

21           “(A) Is under supervision for a sex offense under ORS 163.305 to 163.467;

22           “(B) Was previously convicted of a sex offense under ORS 163.305 to 163.467; or

23           “(C) Was previously convicted in another jurisdiction of an offense that would constitute a sex  
24 offense under ORS 163.305 to 163.467 if committed in this state.

25           “(n) Participate in a mental health evaluation as directed by the supervising officer and follow  
26 the recommendation of the evaluator.

27           “(o) Report as required and abide by the direction of the supervising officer.

28           “(p) If required to report as a sex offender under ORS 181.596, report with the Department of  
29 State Police, a chief of police, a county sheriff or the supervising agency:

30           “(A) When supervision begins;

31           “(B) Within 10 days of a change in residence;

32           “(C) Once each year within 10 days of the probationer’s date of birth;

33           “(D) Within 10 days of the first day the person works at, carries on a vocation at or attends an  
34 institution of higher education; and

35           “(E) Within 10 days of a change in work, vocation or attendance status at an institution of  
36 higher education.

37           “(2) In addition to the general conditions, the court may impose any special conditions of pro-  
38 bation that are reasonably related to the crime of conviction or the needs of the probationer for the  
39 protection of the public or reformation of the probationer, or both, including, but not limited to, that  
40 the probationer shall:

41           “(a) For crimes committed prior to November 1, 1989, and misdemeanors committed on or after  
42 November 1, 1989, be confined to the county jail or be restricted to the probationer’s own residence  
43 or to the premises thereof, or be subject to any combination of such confinement and restriction,  
44 such confinement or restriction or combination thereof to be for a period not to exceed one year  
45 or one-half of the maximum period of confinement that could be imposed for the offense for which

1 the defendant is convicted, whichever is the lesser.

2 “(b) For felonies committed on or after November 1, 1989, be confined in the county jail, or be  
3 subject to other custodial sanctions under community supervision, or both, as provided by rules of  
4 the Oregon Criminal Justice Commission.

5 “(c) For crimes committed on or after December 5, 1996, sell any assets of the probationer as  
6 specifically ordered by the court in order to pay restitution.

7 “(3) When a person who is a sex offender is released on probation, the court shall impose as a  
8 special condition of probation that the person not reside in any dwelling in which another sex  
9 offender who is on probation, parole or post-prison supervision resides, without the approval of the  
10 person’s supervising parole and probation officer, or in which more than one other sex offender who  
11 is on probation, parole or post-prison supervision resides, without the approval of the director of the  
12 probation agency that is supervising the person or of the county manager of the Department of  
13 Corrections, or a designee of the director or manager. As soon as practicable, the supervising parole  
14 and probation officer of a person subject to the requirements of this subsection shall review the  
15 person’s living arrangement with the person’s sex offender treatment provider to ensure that the  
16 arrangement supports the goals of offender rehabilitation and community safety. As used in this  
17 subsection:

18 “(a) ‘Dwelling’ has the meaning given that term in ORS 469.160.

19 “(b) ‘Dwelling’ does not include a residential treatment facility or a halfway house.

20 “(c) ‘Halfway house’ means a publicly or privately operated profit or nonprofit residential facil-  
21 ity that provides rehabilitative care and treatment for sex offenders.

22 “(d) ‘Sex offender’ has the meaning given that term in ORS 181.594.

23 “(4)(a) If the person is released on probation following conviction of a sex crime, as defined in  
24 ORS 181.594, or an assault, as defined in ORS 163.175 or 163.185, and the victim was under 18 years  
25 of age, the court, if requested by the victim, shall include as a special condition of the person’s  
26 probation that the person not reside within three miles of the victim unless:

27 “(A) The victim resides in a county having a population of less than 130,000 and the person is  
28 required to reside in that county;

29 “(B) The person demonstrates to the court by a preponderance of the evidence that no mental  
30 intimidation or pressure was brought to bear during the commission of the crime;

31 “(C) The person demonstrates to the court by a preponderance of the evidence that imposition  
32 of the condition will deprive the person of a residence that would be materially significant in aiding  
33 in the rehabilitation of the person or in the success of the probation; or

34 “(D) The person resides in a halfway house. As used in this subparagraph, ‘halfway house’ means  
35 a publicly or privately operated profit or nonprofit residential facility that provides rehabilitative  
36 care and treatment for sex offenders.

37 “(b) A victim may request imposition of the special condition of probation described in this  
38 subsection at the time of sentencing in person or through the prosecuting attorney.

39 “(c) If the court imposes the special condition of probation described in this subsection and if  
40 at any time during the period of probation the victim moves to within three miles of the  
41 probationer’s residence, the court may not require the probationer to change the probationer’s resi-  
42 dence in order to comply with the special condition of probation.

43 “(5) When a person who is a sex offender, as defined in ORS 181.594, is released on probation,  
44 the Department of Corrections or the county community corrections agency, whichever is appropri-  
45 ate, shall notify the chief of police, if the person is going to reside within a city, and the county



1 sheriff of the county in which the person is going to reside of the person's release and the conditions  
2 of the person's release.

3 “(6) Failure to abide by all general and special conditions imposed by the court and supervised  
4 by the Department of Corrections or a county community corrections agency may result in arrest,  
5 modification of conditions, revocation of probation or imposition of structured, intermediate sanc-  
6 tions in accordance with rules adopted under ORS 137.595.

7 “[7] *The court may order that probation be supervised by the court. If the court orders that pro-  
8 bation be supervised by the court, the defendant shall pay a fee of \$100 to the court. Fees imposed  
9 under this subsection in the circuit court shall be deposited by the clerk of the court in the Judicial  
10 System Surcharge Account. Fees imposed in a justice court under this subsection shall be paid to the  
11 county treasurer. Fees imposed in a municipal court under this subsection shall be paid to the city  
12 treasurer.*]

13 “[8] (7) The court may at any time modify the conditions of probation.

14 “[9] (8) A court may not order revocation of probation as a result of the probationer's failure  
15 to pay restitution unless the court determines from the totality of the circumstances that the pur-  
16 poses of the probation are not being served.

17 “[10] (9) It is not a cause for revocation of probation that the probationer failed to apply for  
18 or accept employment at any workplace where there is a labor dispute in progress. As used in this  
19 subsection, ‘labor dispute’ has the meaning for that term provided in ORS 662.010.

20 “[11] *If the court determines that a defendant has violated the terms of probation, the court shall  
21 impose a \$25 assessment against the defendant. The assessment becomes part of the judgment and may  
22 be collected in the same manner as a fine. Assessments imposed under this subsection in the circuit  
23 court shall be deposited by the clerk of the court in the Judicial System Surcharge Account. Assess-  
24 ments imposed in a justice court under this subsection shall be paid to the county treasurer. Assess-  
25 ments imposed in a municipal court under this subsection shall be paid to the city treasurer.*]

26 “[12] (10) As used in this section, ‘attends,’ ‘institution of higher education,’ ‘works’ and ‘car-  
27 ries on a vocation’ have the meanings given those terms in ORS 181.594.

28 “**SECTION 24. (1) The amendments to ORS 137.540 by section 23 of this 2009 Act become  
29 operative July 1, 2011.**

30 “**(2) The amendments to ORS 137.540 by section 23 of this 2009 Act do not affect any fee  
31 or assessment that was added to a judgment under ORS 137.540 before July 1, 2011.**

32  
33 **“PROBATE ACCOUNTING FEES**

34  
35 “**SECTION 25. (1) In a court with probate jurisdiction, the clerk shall charge and collect  
36 the following fees for an annual or final accounting filed in a probate proceeding or a con-  
37 servatorship proceeding on or after October 1, 2009, and before July 1, 2011:**

38 “**(a) If the amount of the estate is not more than \$500,000, a fee of \$100.**

39 “**(b) If the amount of the estate is more than \$500,000 and not more than \$1 million, a  
40 fee of \$200.**

41 “**(c) If the amount of the estate is more than \$1 million, a fee of \$300.**

42 “**(2) In determining fees under subsection (1) of this section in a probate proceeding, the  
43 amount of a settlement in a wrongful death action brought for the benefit of the decedent's  
44 surviving spouse or dependents is not part of the estate.**

45 “**(3) All fees imposed under this section in a circuit court shall be deposited in the Judi-**

1 cial System Surcharge Account. All fees imposed by a county court under this section shall  
2 be paid to the county treasurer.

3 “(4) The collections and revenue management program established under ORS 1.204 may  
4 not be reimbursed under ORS 1.204 from fees imposed under this section.

5  
6 “DIVERSION PROGRAM ADMINISTRATION FEE

7  
8 “SECTION 26. (1) In addition to the fees provided in ORS 135.921 and 813.240, upon the  
9 filing of a petition for diversion under ORS 135.909 or 813.210, the court shall order the de-  
10 fendant to pay \$100 to the court as a program administration fee.

11 “(2) This section applies only to petitions for diversion filed on or after October 1, 2009,  
12 and before July 1, 2011.

13 “(3) Fees imposed under this section in the circuit court shall be deposited by the clerk  
14 of the court in the Judicial System Surcharge Account. Fees imposed in a justice court under  
15 this section shall be paid to the county treasurer. Fees imposed in a municipal court under  
16 this section shall be paid to the city treasurer.

17 “(4) The collections and revenue management program established under ORS 1.204 may  
18 not be reimbursed under ORS 1.204 from fees imposed under this section.

20 “EXPUNCTION FEE

21  
22 “SECTION 27. (1) In addition to the fee provided in ORS 137.225, upon the filing of an  
23 application under ORS 137.225 (1), the court shall order the defendant to pay a fee of \$250 to  
24 the court.

25 “(2) This section applies only to applications filed under ORS 137.225 (1) on or after Oc-  
26 tober 1, 2009, and before July 1, 2011.

27 “(3) Fees imposed under this section in the circuit court shall be deposited by the clerk  
28 of the court in the Judicial System Surcharge Account. Fees imposed in a justice court under  
29 this section shall be paid to the county treasurer. Fees imposed in a municipal court under  
30 this section shall be paid to the city treasurer.

31 “(4) The collections and revenue management program established under ORS 1.204 may  
32 not be reimbursed under ORS 1.204 from amounts imposed under this section.

33  
34 “ADDITIONAL PARTY FEES IN APPELLATE CASES

35  
36 “SECTION 28. ORS 21.010 is amended to read:

37 “21.010. (1) Except as provided in [subsection (2) of] this section, the appellant in an appeal or  
38 the petitioner in a judicial review in the Supreme Court or the Court of Appeals shall pay a filing  
39 fee of \$154 in the manner prescribed by ORS 19.265. The respondent in such case and any other  
40 person appearing in the appeal, upon entering first appearance or filing first brief in the court, shall  
41 pay to the State Court Administrator the sum of \$154. The party entitled to costs and disbursements  
42 on such appeal shall recover from the opponent the amount so paid.

37 **fines and assessments, or use of community service, in connection with programs such as**  
38 **Project Clean Slate.**

39 **“(3) The interim committee shall develop recommendations, including draft legislation,**  
40 **on improvements to the existing revenue structure. The recommendations should be based**  
41 **on the following principles:**

42 **“(a) Simplification of the revenue collection and distribution process, minimization of**  
43 **administrative and public costs, and transparency in the revenue collection process;**

44 **“(b) Preservation of, or improvement to, state judicial system access;**

45 **“(c) Ensuring legislative oversight of all state judicial system revenue collections, dis-**
