House Bill 2506

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires health plans to cover services of professional counselors and marriage and family therapists if certain other services are covered by plan. Prohibits practice of professional counseling or marriage and family therapy without license.

6 <u>SECTION 1.</u> Section 2 of this 2009 Act is added to and made a part of ORS chapter 743.

7 SECTION 2. (1) If a health benefit plan, as defined in ORS 743.730, provides for coverage

8 for services performed by a clinical social worker or nurse practitioner, the plan also must

9 cover services provided by a professional counselor or marriage and family therapist licensed

10 under ORS 675.715 to 675.835 when the counselor or therapist is acting within the counselor's

11 or therapist's lawful scope of practice.

12 (2) The provisions of ORS 743A.001 do not apply to this section.

(9) The Legislative Assembly has found that health care cost containment is necessary and intends to encourage insurance policies designed to achieve cost containment by ensuring that re imbursement is limited to appropriate utilization under criteria incorporated into such policies,
 either directly or by reference.

5 (11) Health maintenance organizations may limit the receipt of covered services by enrollees to 6 services provided by or upon referral by providers contracting with the health maintenance organ-7 ization. Health maintenance organizations and health care service contractors may create substan-8 tive plan benefit and reimbursement differentials at the same level as, and subject to limitations no 9 more restrictive than, those imposed on coverage or reimbursement of expenses arising out of other 10 medical conditions and apply them to contracting and noncontracting providers.
