SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Increases rate of tax on distribution of moist snuff. Requires Department of Revenue to recompute rate of tax each biennium beginning in 2019. [Directs tobacco tax revenues to payment of expenses related to provision of medical examinations to children who are victims of suspected physical abuse and to pilot program for shaken baby prevention.] Requires manufacturers of smokeless tobacco products to report certain information to Attorney General. Requires Attorney General to develop and maintain directory of information reported. Prohibits selling, offering for sale or possessing for sale smokeless tobacco products of manufacturers not listed in directory. Prohibits distribution of free samples of smokeless tobacco products to persons under 21 years of age or in areas accessible by persons under 21 years of age. Establishes civil and criminal penalties for various acts or omissions.

Continuously appropriates moneys deposited in Tobacco Enforcement Fund pursuant to Act to Department of Justice for enforcement.

Applies to smokeless tobacco products distributed on or after January 1, 2010. Takes effect on 91st day following adjournment sine die.

SECTION 1. ORS 323.500 is amended to read:

8 323.500. As used in ORS 323.500 to 323.645, unless the context otherwise requires:

(2) "Cigar" means a roll for smoking that is of any size or shape and that is made wholly or in part of tobacco, irrespective of whether the tobacco is pure or flavored, adulterated or mixed with any other ingredient, if the roll has a wrapper made wholly or in greater part of tobacco and if 1,000 of these rolls collectively weigh more than three pounds. "Cigar" does not include a cigarette, as defined in ORS 323.010.

(3) "Consumer" means any person who purchases tobacco products in this state for the person's
use or consumption or for any purpose other than for reselling the tobacco products to another
person.

(4) "Contraband tobacco products" means tobacco products or packages containing tobaccoproducts:

(a) That do not comply with the requirements of ORS 323.500 to 323.645;

12 **SECTION 2.** ORS 323.505 is amended to read:

(1) A tax is hereby imposed upon the distribution of all tobacco products in this state. 14 The tax imposed by this section is intended to be a direct tax on the consumer, for which payment 15 upon distribution is required to achieve convenience and facility in the collection and administration 16 of the tax. The tax shall be imposed on a distributor at the time the distributor distributes tobacco 17 products.

18 (2) The tax imposed under this section shall be imposed at the rate of:

(a) Sixty-five percent of the wholesale sales price of cigars, but not to exceed 50 cents per cigar;

(3) For reporting periods beginning on or after July 1, 2019, the rates of tax applicable 2627to moist snuff under subsection (2)(b) of this section shall be adjusted for each biennium according to the cost-of-living adjustment for the calendar year. The Department of Revenue 28shall recompute the rates for each biennium by adding to the rates in subsection (2)(b) of 2930 this section the product obtained by multiplying the rates in subsection (2)(b) of this section 31 by a factor that is equal to 0.25 multiplied by the percentage (if any) by which the monthly averaged U.S. City Average Consumer Price Index for the 12 consecutive months ending 32August 31 of the prior calendar year exceeds the monthly averaged U.S. City Average Con-33 34 sumer Price Index for the 12 consecutive months ending August 31, 2017.

[(3)] (4) If the tax imposed under this section does not equal an amount calculable to a whole cent, the tax shall be equal to the next higher whole cent. However, the amount remitted to the Department of Revenue by the taxpayer for each quarter shall be equal only to 98.5 percent of the total taxes due and payable by the taxpayer for the quarter.

[(4)] (5) No tobacco product shall be subject to the tax if the base product or other intermediate
 form thereof has previously been taxed under this section.

(1)(a) Any nonresident or foreign nonparticipating manufacturer that has 8 9 not registered to do business in the State of Oregon as a foreign corporation or business 10 entity shall, as a condition precedent to being listed or retained in the directory developed under section 10 of this 2009 Act, appoint and continuously engage the services of a resident 11 12 agent in this state. The agent shall act as agent for service of process on whom all process 13 in any action or proceeding against the nonparticipating manufacturer concerning or arising out of the enforcement of this section or section 8, 9, 10, 12, 13 or 20 of this 2009 Act, or rules 14 15 adopted under sections 14 and 15 of this 2009 Act, may be served in any manner authorized 16by law. Service on the agent constitutes legal and valid service of process on the nonpartic-17 ipating manufacturer.

(b) The nonparticipating manufacturer shall provide the name, address, telephone num ber and proof of the appointment and availability of the agent to the Attorney General.

(2) The nonparticipating manufacturer shall provide notice to the Attorney General at least 30 calendar days prior to termination of the authority of an agent and shall provide proof to the satisfaction of the Attorney General of the appointment of a new agent at least five calendar days prior to the termination of an existing agent appointment. If an agent terminates the agent's appointment, the nonparticipating manufacturer shall notify the Attorney General of the termination within five calendar days and shall include proof to the Attorney General of the appointment of a new agent.

(3) A nonparticipating manufacturer whose smokeless tobacco products are sold in this state who has not appointed or designated an agent as required by this section shall be deemed to have appointed the Secretary of State as the agent and may be proceeded against in courts of this state by service of process upon the Secretary of State. However, the appointment of the Secretary of State as the agent does not satisfy the condition precedent to the nonparticipating manufacturer being listed or retained in the directory.

SECTION 12. (1) Not later than 20 days after the end of each calendar quarter, and more 33 34 frequently if so directed by the Attorney General, a distributor of smokeless tobacco products subject to the requirements of ORS 323.500 to 323.645 shall report such information as 35 the Attorney General requires to facilitate compliance by tobacco product manufacturers 36 37 with this section and sections 8, 9, 10, 11, 13 and 20 of this 2009 Act and with rules adopted 38 under sections 14 and 15 of this 2009 Act. The information shall include, but need not be limited to, a list of the total number of units sold of smokeless tobacco products for which 39 40 the distributor paid the tax due during the previous calendar quarter.

(2) A distributor shall maintain for a period of five years all invoices and documentation
of sales of smokeless tobacco products manufactured by nonparticipating manufacturers and
any other information relied upon in reporting to the Attorney General under subsection (1)
of this section. The distributor shall make the invoices and other documentation available
to the Attorney General upon request.

1 (3) A distributor shall provide the Attorney General with an electronic mail address so 2 that the Attorney General may notify the distributor of the information required under 3 subsections (1) and (7) of this section.

4 (4) The Attorney General and the Department of Revenue may share with each other 5 information received under this section and sections 8 and 9 of this 2009 Act and ORS 323.520 6 and may share such information with federal, state or local agencies for purposes of 7 enforcement of this section and sections 8, 9, 10, 11, 13 and 20 of this 2009 Act, rules adopted 8 under sections 14 and 15 of this 2009 Act and corresponding laws of other states.

9 (5) The Attorney General may at any time require a nonparticipating manufacturer to 10 produce proof from the financial institution in which the nonparticipating manufacturer has 11 established a qualified escrow fund for the purpose of compliance with section 20 of this 2009 12 Act of the amount of moneys in the fund, exclusive of interest, the amount and date of each 13 deposit and the amount and date of each withdrawal from the fund.

(6) The Attorney General shall, upon request of a nonparticipating manufacturer whose 14 15 compliance with escrow requirements is at issue, provide the manufacturer with copies of 16all documents upon which any proposed addition to the escrow is based. Documents required to be provided under this subsection include, but are not necessarily limited to, reports under 17 18 this section from distributors. The information provided to the manufacturer under this subsection may not include information about products of any tobacco product manufacturer 19 other than the one to whom the information is provided. The information may be used only 20for the purpose of determining the appropriate amount of escrow deposits. 21

(7) The Attorney General may require a distributor or a tobacco product manufacturer to submit any additional information, including, but not limited to, samples of the packaging and labeling of each smokeless tobacco product manufactured or distributed, to enable the Attorney General to determine whether a tobacco product manufacturer is in compliance with this section and sections 8, 9, 10, 11, 13 and 20 of this 2009 Act and with rules adopted under sections 14 and 15 of this 2009 Act.

SECTION 13. (1) A person may not:

(a) Sell, offer for sale or possess for sale in this state smokeless tobacco products of a
 tobacco product manufacturer that is not included in the directory developed under section
 10 of this 2009 Act;

SECTION 14. (1) To promote compliance with the provisions of sections 8, 9, 10, 11, 12 3 and 13 of this 2009 Act, the Attorney General may adopt rules requiring a nonparticipating 4 manufacturer to make the escrow deposits required by section 20 of this 2009 Act in quar-5 terly installments during the year in which the sales covered by the deposits are made. The 6 Attorney General may require a nonparticipating manufacturer to produce information suf-7 ficient to enable the Attorney General to determine the adequacy of the amount of the in-8 9 stallment deposit.

(2) If the Attorney General adopts rules requiring a nonparticipating manufacturer to 10 make escrow deposits in quarterly installments, the rules may also provide that a nonpar-11 12 ticipating manufacturer that has been in continuous compliance for one year with sections 8, 9, 10, 11, 12, 13 and 20 of this 2009 Act may make escrow deposits required by section 20 13 of this 2009 Act in annual payments during the second and subsequent years in which de-14 15 posits are required.

(1) A determination by the Attorney General to omit or remove a tobacco product manufacturer from the directory developed under section 10 of this 2009 Act is sub-17 ject to review in the manner prescribed by ORS 183.484 for judicial review of orders in other 18 than contested cases. 19

(2) The Attorney General may adopt rules necessary to effect the purposes of sections 6 to 16 of this 2009 Act and ORS 323.520 (3).

22(3) In any action brought by the state to enforce section 8, 9, 10, 11, 12, 13 or 20 of this 2009 Act, or any rule adopted under this section or section 14 of this 2009 Act, the state may 23recover the costs of investigation, expert witness fees, costs of the action and reasonable 24attorney fees. Moneys recovered under this subsection shall be deposited into the Tobacco 25Enforcement Fund established under ORS 180.205. 26

For purposes 18 of defining "affiliate": 19 (a) "Owns," "is owned" and "ownership" mean ownership of an equity interest, or the 20equivalent thereof, of 10 percent or more; and 2122(b) "Person" means an individual, partnership, committee, association, corporation or any other organization or group of persons. 23(3) "Qualified escrow fund" means an escrow arrangement with a federally or state 24chartered financial institution having no affiliation with any tobacco product manufacturer 25and having assets of at least \$1 billion, where such arrangement requires that such financial 2627institution hold the escrowed funds' principal for the benefit of releasing parties and prohibits the tobacco product manufacturer who is placing the funds into escrow from using, 28accessing or directing the use of the escrowed funds' principal except as consistent with 2930 section 20 (2)(b) of this 2009 Act. 31 (4) "Released claims" has the meaning given that term in section II(gg) of the Smokeless 32**Tobacco Master Settlement Agreement.** (5) "Releasing parties" has the meaning given that term in section II(ii) of the Smokeless 33 34 **Tobacco Master Settlement Agreement.** 35 (6) "Smokeless Tobacco Master Settlement Agreement" means the settlement agreement (and related documents) entered into on November 23, 1998, by the State of Oregon and 36 37 leading United States tobacco product manufacturers. 38

(7) "Smokeless tobacco products" means moist snuff, as defined in ORS 323.500, or
 chewing tobacco, as defined in section 5702 of the Internal Revenue Code.

40 (8)(a) "Tobacco product manufacturer" means an entity that, after the effective date of
41 this 2009 Act, directly (and not exclusively through any affiliate):

(A) Manufactures smokeless tobacco products anywhere that such manufacturer intends
to be sold in the United States, including smokeless tobacco products intended to be sold in
the United States through an importer (except where such importer is an Original Participating Manufacturer, as defined in section II(cc) of the Smokeless Tobacco Master Settle-

1 ment Agreement), that will be responsible for the payments under the Smokeless Tobacco 2 Master Settlement Agreement with respect to such smokeless tobacco products as a result 3 of the provisions of section VI(b) of the Smokeless Tobacco Master Settlement Agreement 4 and that pays the taxes specified in section II(w) of the Smokeless Tobacco Master Settle-5 ment Agreement, and provided that the manufacturer of such smokeless tobacco products 6 does not market or advertise such smokeless tobacco products in the United States);

7 (B) Is the first purchaser anywhere for resale in the United States of smokeless tobacco 8 products manufactured anywhere that the manufacturer does not intend to be sold in the 9 United States; or

10 (C) Becomes a successor of an entity described in subparagraph (A) or (B) of this para-11 graph.

(b) "Tobacco product manufacturer" does not include an affiliate of a tobacco product
manufacturer unless such affiliate is itself a tobacco product manufacturer under paragraph
(a) of this subsection.

15 (9) "Units sold" means the number of individual containers of smokeless tobacco products sold in the State of Oregon by the applicable tobacco product manufacturer (whether 16 directly or through a distributor, retailer or similar intermediary or intermediaries) during 17 18 the year in question, as measured by excise taxes collected by the State of Oregon. The Department of Revenue shall adopt such rules as are necessary to ascertain the amount of 19 20state excise tax paid on the smokeless tobacco products of such tobacco product manufacturer for each year. A unit container shall contain 3.2 ounces of moist snuff, as defined in 2122ORS 323.500, or 3.0 ounces of chewing tobacco.

<u>SECTION 19.</u> (1) The use of smokeless tobacco products presents serious public health concerns to the State of Oregon and to the residents of the State of Oregon. The United States Surgeon General has determined that use of smokeless tobacco causes cancer, noncancerous oral conditions and other serious diseases, and that there are hundreds of thousands of tobacco-related deaths in the United States each year. These diseases most often do not appear until many years after the person in question begins using tobacco products.

(2) Use of smokeless tobacco products also presents serious financial concerns for this state. Under certain health care programs, the State of Oregon may have a legal obligation to provide medical assistance to eligible persons for health conditions associated with the use of smokeless tobacco, and those persons may have a legal entitlement to receive such medical assistance.

(3) Under those health care programs, the State of Oregon pays millions of dollars each
 year to provide medical assistance for persons for health conditions associated with the use
 of smokeless tobacco products.

(4) It is the policy of the State of Oregon that financial burdens imposed on this state
by the use of smokeless tobacco be borne by tobacco product manufacturers rather than by
this state to the extent that such manufacturers either determine to enter into a settlement
with the State of Oregon or are found culpable by the courts.

(5) On November 23, 1998, leading United States tobacco product manufacturers entered
into a settlement agreement, titled the "Smokeless Tobacco Master Settlement
Agreement," with the State of Oregon. The Smokeless Tobacco Master Settlement Agreement obligates those manufacturers, in return for a release of past, present and certain fu-

1 ture claims against them as described in the Smokeless Tobacco Master Settlement 2 Agreement:

(a) To pay substantial sums to the State of Oregon (tied in part to their volume of sales);

(b) To fund a national foundation devoted to the interests of public health; and

5 (c) To make substantial changes in their advertising and marketing practices and cor-6 porate culture, with the intention of reducing underage smoking.

(6) It would be contrary to the policy of the State of Oregon if those tobacco product 7 manufacturers who determine not to enter into such a settlement could use a resulting cost 8 9 advantage to derive large, short-term profits in the years before liability may arise without ensuring that this state will have an eventual source of recovery from them if they are 10 proven to have acted culpably. It is thus in the interest of the State of Oregon to require 11 12that such manufacturers establish a reserve fund to guarantee a source of compensation and 13 to prevent such manufacturers from deriving large, short-term profits and then becoming judgment-proof before liability may arise. 14

15 <u>SECTION 20.</u> (1) Any tobacco product manufacturer selling smokeless tobacco products 16 to consumers within the State of Oregon (whether directly or through a distributor, retailer 17 or similar intermediary or intermediaries) after the effective date of this 2009 Act shall do 18 one of the following:

(a) Comply with the requirements imposed on Participating Manufacturers that are set
forth in sections III, V and VII of the Smokeless Tobacco Master Settlement Agreement; or
(b) Place into a qualified escrow fund, by April 15 of the year following the year in question, the amount of \$0.40 per unit sold for 2010 or such amount adjusted for inflation for each
year thereafter.

(2) A tobacco product manufacturer that places funds into escrow pursuant to this sec tion shall receive the interest or other appreciation on such funds as earned. The funds
 themselves shall be released from escrow only under the following circumstances:

(a) To pay a judgment or settlement on any released claim brought against such tobacco
product manufacturer by the State of Oregon or any releasing party located or residing in
this state. Funds shall be released from escrow under this paragraph in the order in which
they were placed into escrow and only to the extent and at the time necessary to make
payments required under such judgment or settlement;

(b) To refund any excess amount owed to a tobacco product manufacturer when the to-32bacco product manufacturer establishes that the amount it was required to place into escrow 33 34 on account of units sold in Oregon in a particular year was greater than the Smokeless To-35 bacco Master Settlement Agreement payments, as determined pursuant to section IX(c) of that agreement after final determination of all adjustments, that the manufacturer would 36 37 have been required to make on account of such units sold had it been a Participating Man-38 ufacturer, as defined in section II(ee) of the Smokeless Tobacco Master Settlement Agreement; or 39

40 (c) To refund funds to a tobacco product manufacturer 25 years after the date on which
41 they were placed in escrow, only if the funds were not released from escrow under paragraph
42 (a) or (b) of this subsection.

(3) Each tobacco product manufacturer that elects to place funds into escrow pursuant
to this section shall annually certify to the Attorney General that it is in compliance with
this section. The Attorney General may bring a civil action on behalf of the State of Oregon

1 against any tobacco product manufacturer that fails to place into escrow the funds required

2 under this section. Any tobacco product manufacturer that fails in any year to place into 3 escrow the funds required under this section shall:

(4) "Pattern of racketeering activity" means engaging in at least two incidents of racketeering 3 activity that have the same or similar intents, results, accomplices, victims or methods of commis-4 sion or otherwise are interrelated by distinguishing characteristics, including a nexus to the same 5 enterprise, and are not isolated incidents, provided at least one of such incidents occurred after 6 November 1, 1981, and that the last of such incidents occurred within five years after a prior inci-7 dent of racketeering activity. Notwithstanding ORS 131.505 to 131.525 or 419A.190 or any other 8 9 provision of law providing that a previous prosecution is a bar to a subsequent prosecution, conduct that constitutes an incident of racketeering activity may be used to establish a pattern of 10 racketeering activity without regard to whether the conduct previously has been the subject of a 11 12 criminal prosecution or conviction or a juvenile court adjudication, unless the prosecution resulted 13 in an acquittal or the adjudication resulted in entry of an order finding the youth not to be within the jurisdiction of the juvenile court. 14
