

House Bill 2685

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Authorizes Department of Transportation to issue duplicate disabled parking permit placards for each vehicle registered by applicant in this state.

A BILL FOR AN ACT

2 Relating to disabled person parking placards; amending ORS 811.602.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 811.602 is amended to read:

5 811.602. (1) A disabled person parking permit is a means of identifying vehicles being used to
6 exercise the parking privileges described in ORS 811.635. The following are disabled person parking
7 permits:

8 (a) A special decal described in ORS 811.605 issued by the Department of Transportation to be
9 affixed to a golf cart or substantially similar vehicle;

10 (b) An individual placard described in ORS 811.605;

11 (c) A program placard issued by the department under ORS 811.607;

12 (d) A family placard issued by the department under ORS 811.609;

13 (e) A foreign visitor placard issued by the department under ORS 811.611; and

14 (f) A "Wheelchair User" placard or decal issued by the department under ORS 811.613.

15 (2) The department shall issue a disabled person parking permit in the form of a decal or indi-
16 vidual placard to any person who submits an application that complies with ORS 811.604. Nothing
17 in this section prohibits the department from issuing a decal or individual placard to a person who
18 has disabled veteran registration plates issued under ORS 805.100 and who qualifies for the decal
19 or placard.

20 (3) Except as otherwise provided in this subsection, the department may not issue more than one
21 individual placard to an applicant. The department may issue a replacement placard upon receipt
22 of proof satisfactory to the department that the original placard has been lost, mutilated or de-
23 stroyed. **The department may issue a duplicate placard for each vehicle registered by an ap-**
24 **plicant in this state.** The department may issue a temporary duplicate permit to a person who
25 needs a duplicate permit for travel purposes. A temporary duplicate permit shall be valid for 30
26 days. The department shall adopt rules governing application for and issuance of temporary dupli-
27 cate permits. Nothing in this subsection prohibits issuance of an individual placard to a person who
28 has been issued a decal.

29 (4) Permits issued under this section, other than temporary duplicate permits, may be renewed
30 by mail.

31 (5) Permits for use on vehicles that are regularly used as part of a program for the transporta-

1 tion of persons with disabilities are issued as provided in ORS 811.607.

2 (6) Except as provided in subsection (7) of this section, the department shall determine the form,
3 size and content of any decal or placard issued under this section and shall adopt rules governing
4 their issuance, display and use as necessary to carry out this section.

5 (7)(a) Except as provided in paragraph (b) of this subsection, the department may not require a
6 decal or placard issued under this section to an individual or a family to contain any identifying
7 information about the person to whom the decal or placard is issued, including any of the following:

8 (A) Name;

9 (B) Address;

10 (C) Telephone number;

11 (D) Social Security number;

12 (E) Driver license number;

13 (F) Golf cart driver permit number;

14 (G) Identification card number;

15 (H) Passport or visa number; or

16 (I) Photograph.

17 (b) The department may require a decal or placard issued under this section to an individual
18 or a family to contain not more than four digits of the driver license or identification card number
19 of the person to whom the decal or placard is issued.
