

House Bill 2689

Sponsored by COMMITTEE ON HEALTH CARE

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires health benefit plan to provide payment, coverage or reimbursement for covered service when performed by chiropractic physician.

Adds orthotic and prosthetic devices to cross-references for coverage by health care service contractors and multiple employer welfare arrangements.

A BILL FOR AN ACT

Relating to health insurance; creating new provisions; and amending ORS 750.055 and 750.333.

Be It Enacted by the People of the State of Oregon:

SECTION 1. Section 2 of this 2009 Act is added to and made a part of ORS chapter 743A.

SECTION 2. Whenever a health benefit plan, as defined in ORS 743.730, provides for payment, coverage or reimbursement for a service that is within the lawful scope of practice of both a chiropractic physician and a medical doctor, the plan may not deny payment, coverage or reimbursement on the basis that the service is performed by a chiropractic physician if the chiropractic physician is licensed under ORS chapter 684.
