

House Bill 2732

Sponsored by COMMITTEE ON BUSINESS AND LABOR

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates Career and Technical Education Collaboration Task Force for purpose of increasing collaboration and partnerships among kindergarten through grade 12 schools, labor, business and industry in relation to career and technical education.

Declares emergency, effective on passage.

A BILL FOR AN ACT

1
2 Relating to education collaboration; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Career and Technical Education Collaboration Task Force is created.**
5 **The purpose of the task force is to increase collaboration and partnerships among**
6 **kindergarten through grade 12 schools, labor, business and industry in relation to career and**
7 **technical education.**

8 **(2) The task force consists of nine members appointed as follows:**

9 **(a) The President of the Senate shall appoint one member from among members of the**
10 **Senate.**

11 **(b) The Speaker of the House of Representatives shall appoint one member from among**
12 **members of the House of Representatives.**

13 **(c) The Governor shall appoint:**

14 **(A) One member who is a teacher or administrator at a school that teaches any grade**
15 **from kindergarten through grade 12.**

16 **(B) One member who is a teacher or administrator at a community college.**

17 **(C) One member who represents labor.**

18 **(D) One member who represents business or industry.**

19 **(E) One member who represents the Bureau of Labor and Industries.**

20 **(F) One member who represents the Department of Education.**

21 **(G) One member who represents the State Workforce Investment Board.**

22 **(3) The task force shall:**

23 **(a) Identify the collaborations and partnerships among kindergarten through grade 12**
24 **schools, labor, business and industry in relation to career and technical education that are**
25 **currently established or are in the process of being established.**

26 **(b) Make recommendations regarding increasing collaborative efforts and using partner-**
27 **ships for the purpose of better sharing facilities and resources and developing a high-skill,**
28 **high-wage sustainable workforce.**

29 **(4) Members of the Legislative Assembly appointed to the task force are nonvoting**
30 **members of the task force and may act in an advisory capacity only.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (5) A majority of the voting members of the task force constitutes a quorum for the
2 transaction of business.

3 (6) Official action by the task force requires the approval of a majority of the voting
4 members of the task force.

5 (7) The task force shall elect one of its voting members to serve as chairperson.

6 (8) If there is a vacancy for any cause, the appointing authority shall make an appoint-
7 ment to become immediately effective.

8 (9) The task force shall meet at times and places specified by the call of the chairperson
9 or of a majority of the voting members of the task force.

10 (10) The task force may adopt rules necessary for the operation of the task force.

11 (11) The task force shall submit a report, and may include recommendations for legis-
12 lation, to the interim committees of the Legislative Assembly related to education and
13 workforce development no later than October 1, 2010.

14 (12) The Department of Education shall provide staff support to the task force.

15 (13) Members of the task force who are not members of the Legislative Assembly are not
16 entitled to compensation, but may be reimbursed for actual and necessary travel and other
17 expenses incurred by them in the performance of their official duties in the manner and
18 amounts provided for in ORS 292.495. Claims for expenses incurred in performing functions
19 of the task force shall be paid out of funds appropriated to Department of Education.

20 (14) All agencies of state government, as defined in ORS 174.111, are directed to assist
21 the task force in the performance of its duties and, to the extent permitted by laws relating
22 to confidentiality, to furnish such information and advice as the members of the task force
23 consider necessary to perform their duties.

24 **SECTION 2.** Section 1 of this 2009 Act is repealed on the date of the convening of the next
25 regular biennial legislative session.

26 **SECTION 3.** This 2009 Act being necessary for the immediate preservation of the public
27 peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect
28 on its passage.
