

HOUSE AMENDMENTS TO HOUSE BILL 2738

April 29

1 On page 1 of the printed bill, line 4, delete “, 819.270”.

2 In line 5, delete “819.250 and 819.260” and insert “819.250, 819.260 and 819.270”.

3 On page 11, delete lines 25 through 34 and insert:

4 “(2) The authority that requests towing of an abandoned vehicle shall provide to the person that
5 tows the vehicle, at the time of the tow or as soon as possible thereafter, a written statement that
6 contains the name and address of the registered owner of the vehicle, as shown by records of the
7 department, and the names and addresses of any persons claiming interests in the vehicle, as shown
8 by records of the department.

9 “(3) Within 48 hours after the written statement is provided under subsection (2) of this section
10 to a person that tows a vehicle, the person must give written notice to the persons whose names
11 are furnished in the statement. The 48-hour period does not include Saturdays, Sundays or holidays.
12 The notice shall state that a person that is entitled to possession of the vehicle has 15 days from
13 the date the notice was mailed to claim the vehicle and that if the vehicle is not claimed, it will be
14 disposed of as provided in this section.

15 “(4) If the authority that requests towing of an abandoned vehicle does not provide to the person
16 that tows the vehicle the written statement within 48 hours after the vehicle is towed, the person
17 may dispose of the vehicle as provided in ORS 819.210.”.

18 In line 35, delete “(4)” and insert “(5)”.

19 In line 37, delete “(5)” and insert “(6)”.

20 Delete lines 42 through 45.

21 On page 12, delete lines 1 and 2.

22 In line 3, delete “18” and insert “17”.

23 Delete lines 28 through 35 and insert:

24 “**SECTION 18. ORS 819.220, 819.240, 819.250, 819.260 and 819.270 are repealed.**

25 “**SECTION 19. The amendments to ORS 801.040, 809.700, 819.016, 819.040, 819.100, 819.110,
26 819.120, 819.140, 819.150, 819.160, 819.170, 819.180, 819.185, 819.190, 819.210, 819.215 and 819.480
27 by sections 1 to 17 of this 2009 Act and the repeal of ORS 819.220, 819.240, 819.250, 819.260 and
28 819.270 by section 18 of this 2009 Act apply only to vehicles taken into custody under ORS
29 819.110 to 819.215 on or after the effective date of this 2009 Act. Any vehicle taken into cus-
30 tody under ORS 819.110 to 819.215 before the effective date of this 2009 Act shall continue to
31 be governed by the law in effect immediately before the effective date of this 2009 Act.”.**
