

House Bill 2780

Sponsored by Representative JENSON (at the request of Toni Harrington)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires health benefit plan coverage for treatment of infertility.

A BILL FOR AN ACT

Relating to health insurance; creating new provisions; and amending ORS 750.055 and 750.333.

Be It Enacted by the People of the State of Oregon:

SECTION 1. Section 2 of this 2009 Act is added to and made a part of the Insurance Code.

SECTION 2. A health benefit plan, as defined in ORS 743.730, shall provide coverage for the treatment of infertility.

SECTION 3. Section 2 of this 2009 Act applies to health benefit plan policies or certificates issued or renewed on or after the effective date of this 2009 Act.
