SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires health benefit plans to provide coverage of human papillomavirus vaccine for female beneficiaries who are [*11 years of age or older*] **at least 11 years of age but no older than 26 years of age.**

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2009 Act is added to and made a part of the Insurance Code.**

6 **SECTION 2. (1) All health benefit plans, as defined in ORS 743.730, shall include coverage**
7 **of the human papillomavirus vaccine for female beneficiaries under the health benefit plan**
8 **who are at least 11 years of age but no older than 26 years of age.**
