# House Bill 2794

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** 

Requires health benefit plans to provide coverage of human papillomavirus vaccine for female beneficiaries who are 11 years of age or older.

A BILL FOR AN ACT
