

# B-Engrossed House Bill 2834

Ordered by the House May 27  
Including House Amendments dated April 17 and May 27

Sponsored by Representative GELSER; Representatives BARNHART, BERGER, KOTEK

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs Superintendent of Public Instruction to close Oregon School for the Blind by September 1, 2009. Abolishes Board of Directors of the Oregon School for the Blind on September 1, 2009.

Directs Department of Education to develop individual comprehensive transition plans for certain students who attend Oregon School for the Blind.

*[Establishes Oregon Trust Fund for Blind and Visually Impaired Students. Requires moneys in trust fund to be used to further independence of and educational opportunities for certain blind and visually impaired students. Establishes Board of Directors of the Oregon Trust Fund for Blind and Visually Impaired Students to act as trustee of fund.]*

Directs *[board]* **Oregon Department of Administrative Services** to develop plan to sell Oregon School for the Blind **and to hold property in trust until title transfers to purchaser**. Requires proceeds from sale to be *[deposited in fund]* **transferred to Education Stability Fund**.

Establishes Blind and Visually Impaired Student *[Legacy]* Fund. Continuously appropriates moneys in fund to Department of Education for purpose of assisting blind and visually impaired students. Appropriates moneys from General Fund to department for deposit in Blind and Visually Impaired Student *[Legacy]* Fund.

**Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department for purposes related to sale of Oregon School for the Blind.**

Declares emergency, effective on passage.

## A BILL FOR AN ACT

2 Relating to the Oregon School for the Blind; creating new provisions; amending ORS 179.210,  
3 179.460, 238.350, 240.205, 240.240, 326.543, 326.603, 327.023, 339.370, 339.877, 343.236, 343.239,  
4 346.010, 346.015, 346.017, 346.019, 346.020, 346.030, 346.041, 346.047, 346.055, 346.080 and 656.135;  
5 repealing ORS 346.097, 346.099, 346.101 and 346.104 and section 53, chapter 858, Oregon Laws  
6 2007; appropriating money; limiting expenditures; and declaring an emergency.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1. Prior to September 1, 2009, the Superintendent of Public Instruction shall**  
9 **close the Oregon School for the Blind.**

10 **SECTION 2. On September 1, 2009, the Board of Directors of the Oregon School for the**  
11 **Blind is abolished and the tenure of office of the members of the Board of Directors of the**  
12 **Oregon School for the Blind ceases.**

13 **SECTION 3. (1) Prior to August 1, 2009, the Department of Education shall ensure that**  
14 **a comprehensive transition plan is developed for each student of the Oregon School for the**  
15 **Blind who:**

16 **(a) Was enrolled in the Oregon School for the Blind on March 1, 2009;**

17 **(b) Expected to be enrolled in the Oregon School for the Blind during the 2009-2010 school**  
18 **year; and**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (c) Is under 21 years of age on September 1, 2009.

2 (2)(a) For the purpose of assisting in the development of a comprehensive transition plan  
3 under this section, the Department of Human Services shall ensure that each student de-  
4 scribed in subsection (1) of this section is screened and evaluated to determine the student's  
5 eligibility for services offered by the community mental health and developmental disabilities  
6 program serving the community where a student will be located after the closure of the  
7 Oregon School for the Blind.

8 (b) A student who is determined to be eligible for services provided by a community  
9 mental health and developmental disabilities program shall have priority access to the ser-  
10 vices, including any community-based support services and family support services.

11 (3)(a) A comprehensive transition plan developed under this section shall provide stu-  
12 dents described in subsection (1) of this section with a plan to receive appropriate resources  
13 and services, including educational services, to ensure a successful transition to the com-  
14 munity where the student will be located after the closure of the Oregon School for the  
15 Blind.

16 (b) The educational services offered to a student under a comprehensive transition plan  
17 shall be substantially equivalent to the level, frequency and type of educational services of-  
18 fered to the student when the student was enrolled in the Oregon School for the Blind, ex-  
19 cept that the comprehensive transition plan need not include residential services.

20 (c) A comprehensive transition plan may provide for any of the following:

21 (A) The purchase of assistive technology;

22 (B) The purchase of needed equipment, adaptive curriculum and materials;

23 (C) Staff training and development for the school district where the student will be lo-  
24 cated after the closure of the Oregon School for the Blind;

25 (D) The development of behavior support plans, including training for families to support  
26 continued growth and safety at home and school; and

27 (E) Any other resources and services that may help a student successfully transition to  
28 the community where the student will be located after the closure of the Oregon School for  
29 the Blind.

30 (4)(a) A comprehensive transition plan developed under this section shall be developed  
31 by:

32 (A) The members of the student's individualized education program team;

33 (B) A representative from the regional program authorized under ORS 343.236 (1)(a)(A)  
34 and (C) that provides services to the region where the student will be located;

35 (C) The principal of the school that the student will attend;

36 (D) If appropriate, a representative of a provider of vocational rehabilitation services or  
37 the youth transition program that serves the community where the student will be located;

38 (E) If appropriate, a representative of the community mental health and developmental  
39 disabilities program that serves the community where the student will be located; and

40 (F) One person who provided educational services to the student when the student was  
41 enrolled at the Oregon School for the Blind.

42 (b) In addition to the persons identified under paragraph (a) of this subsection, the stu-  
43 dent or a parent of the student may invite any person with knowledge of the student's needs  
44 to participate in the development of a comprehensive transition plan.

45 **SECTION 4.** (1) Except as otherwise provided by a collective bargaining agreement, a

1 public employer shall give preference for a vacant position to an otherwise qualified person  
2 who worked for the Oregon School for the Blind.

3 (2) The Department of Education shall facilitate communication between:

4 (a) Persons who were employed at the Oregon School for the Blind at the time the school  
5 closed; and

6 (b) School districts recruiting to hire persons with the skills or credentials that a person  
7 who worked at the Oregon School for the Blind may have.

8 (3) The Personnel Division of the Oregon Department of Administrative Services shall  
9 facilitate communication between:

10 (a) Persons who were employed at the Oregon School for the Blind at the time the school  
11 closed; and

12 (b) Political subdivisions recruiting to hire persons with the skills or experience that a  
13 person who worked at the Oregon School for the Blind may have.

14 **SECTION 5.** Section 4 of this 2009 Act is repealed July 1, 2012.

15 **SECTION 6.** (1) The Oregon Department of Administrative Services, in consultation with  
16 the Department of Education and other interested parties, shall develop a plan for the sale  
17 of the real property owned by the Department of Education known as the Oregon School for  
18 the Blind.

19 (2) For the period beginning July 1, 2009, and ending on the date that title is transferred  
20 to a purchaser, the Oregon Department of Administrative Services shall hold the real prop-  
21 erty described in subsection (1) of this section in trust. While held in trust, any proceeds  
22 related to the real property must first be used to reimburse expenditures incurred by the  
23 Oregon Department of Administrative Services in holding the property in trust. Proceeds  
24 in excess of the reimbursements shall be transferred to the Education Stability Fund estab-  
25 lished under ORS 348.696.

26 (3) Notwithstanding ORS 270.100 to 270.190, the Oregon Department of Administrative  
27 Services shall sell the real property described in subsection (1) of this section in a manner  
28 consistent with this section. The Oregon Department of Administrative Services may engage  
29 the services of a licensed real estate broker or real estate organization or any other profes-  
30 sional necessary to facilitate the sale of the real property.

31 (4) The sale price of the real property described in subsection (1) of this section:

32 (a) Must equal or exceed the fair market value of the real property; and

33 (b) Shall be determined by the Oregon Department of Administrative Services.

34 (5)(a) The Oregon Department of Administrative Services shall retain from the sale of  
35 the real property described in subsection (1) of this section the costs incurred by the state  
36 in selling the real property, including:

37 (A) Costs incurred by the Department of Education in transferring the real property to  
38 the Oregon Department of Administrative Services;

39 (B) Any costs incurred by the Oregon Department of Administrative Services in holding  
40 the real property in trust that are not reimbursed as provided by subsection (2) of this sec-  
41 tion or by appropriation or other source of moneys; and

42 (C) Costs incurred by the Oregon Department of Administrative Services in selling the  
43 real property.

44 (b) The Oregon Department of Administrative Services and the Department of Education  
45 shall be reimbursed for any costs described in paragraph (a) of this subsection from the

1 amount retained as provided by paragraph (a) of this subsection.

2 (c) Proceeds from the sale of the real property that remain after the amounts described  
3 in paragraph (a) of this subsection have been retained shall be transferred to the Education  
4 Stability Fund established under ORS 348.696.

5 (6)(a) Except for property described in subsection (1) of this section, all other property  
6 of the Oregon School for the Blind:

7 (A) When practicable, shall be distributed to the regional program described in ORS  
8 343.236 (1)(b) or to the school districts providing educational services to students described  
9 in section 3 (1) of this 2009 Act; and

10 (B) May be preserved in a manner determined by the Superintendent of Public Instruc-  
11 tion if the property has historic significance.

12 (b) Proceeds from the sale, lease or other action related to the property described in this  
13 subsection shall be transferred to the Education Stability Fund.

14 **SECTION 7.** (1) The Blind and Visually Impaired Student Fund is established in the State  
15 Treasury, separate and distinct from the General Fund. Interest earned by the Blind and  
16 Visually Impaired Student Fund shall be credited to the Blind and Visually Impaired Student  
17 Fund.

18 (2) Moneys in the Blind and Visually Impaired Student Fund are continuously appropri-  
19 ated to the Department of Education for the purposes of:

20 (a) Assisting students who are blind or visually impaired in receiving appropriate re-  
21 sources and services, including educational services, in the communities where the students  
22 reside;

23 (b) Supplementing funds available to regional programs authorized under ORS 343.236  
24 (1)(a)(A) and (C) to ensure access to the expanded core curriculum for students who are blind  
25 or visually impaired;

26 (c) Coordinating professional development of persons who provide educational services  
27 to students who are blind or visually impaired;

28 (d) Providing technical assistance for the purpose of providing educational services to  
29 students who are blind or visually impaired; and

30 (e) Coordinating activities for the benefit of students who are blind or visually impaired.

31 (3) When determining the manner in which to spend the moneys in the Blind and Visually  
32 Impaired Student Fund, the Department of Education shall:

33 (a) Give priority to services or resources used by students described in section 3 (1) of  
34 this 2009 Act; and

35 (b) Ensure that the moneys are used in addition to any other available moneys and do  
36 not supplant moneys available from any other source.

37 **SECTION 8.** Section 7 of this 2009 Act is amended to read:

38 **Sec. 7.** (1) The Blind and Visually Impaired Student Fund is established in the State Treasury,  
39 separate and distinct from the General Fund. Interest earned by the Blind and Visually Impaired  
40 Student Fund shall be credited to the Blind and Visually Impaired Student Fund.

41 (2) Moneys in the Blind and Visually Impaired Student Fund are continuously appropriated to  
42 the Department of Education for the purposes of:

43 (a) Assisting students who are blind or visually impaired in receiving appropriate resources and  
44 services, including educational services, in the communities where the students reside;

45 (b) Supplementing funds available to regional programs authorized under ORS 343.236 (1)(a)(A)

1 and (C) to ensure access to the expanded core curriculum for students who are blind or visually  
2 impaired:

3 (c) Coordinating professional development of persons who provide educational services to stu-  
4 dents who are blind or visually impaired;

5 (d) Providing technical assistance for the purpose of providing educational services to students  
6 who are blind or visually impaired; and

7 (e) Coordinating activities for the benefit of students who are blind or visually impaired.

8 (3) When determining the manner in which to spend the moneys in the Blind and Visually Im-  
9 paired Student Fund, the Department of Education shall[:]

10 [(a) Give priority to services or resources used by students described in section 3 (1) of this 2009  
11 Act; and]

12 [(b)] ensure that the moneys are used in addition to any other available moneys and do not  
13 supplant moneys available from any other source.

14 **SECTION 9. The amendments to section 7 of this 2009 Act by section 8 of this 2009 Act**  
15 **become operative June 30, 2020.**

16 **SECTION 10. There is appropriated to the Department of Education, for the biennium**  
17 **beginning July 1, 2009, out of the General Fund, to be deposited in the Blind and Visually**  
18 **Impaired Student Fund established under section 7 of this 2009 Act, the amount of \$2,985,218**  
19 **for the purposes described in section 7 (2) of this 2009 Act.**

20 **SECTION 11. ORS 343.236 is amended to read:**

21 343.236. (1)(a) The Superintendent of Public Instruction may provide special education on a lo-  
22 cal, county or regional basis without regard to county boundaries in all areas of the state for chil-  
23 dren who have:

24 [(a)] (A) A visual impairment;

25 [(b)] (B) A hearing impairment;

26 [(c)] (C) Blindness or deafness, or both;

27 [(d)] (D) An orthopedic impairment;

28 [(e)] (E) Autism; or

29 [(f)] (F) Traumatic brain injury.

30 (b) **The superintendent shall designate one of the regional programs that provides special**  
31 **education to children who are blind or visually impaired to provide statewide coordination**  
32 **and technical assistance related to:**

33 (A) **The provision of services described in section 7 (2) of this 2009 Act; and**

34 (B) **The transition of students from the Oregon School for the Blind to the communities**  
35 **and school districts where the students will be located after the closure of the Oregon School**  
36 **for the Blind.**

37 (c) **The program designated under paragraph (b) of this subsection may receive moneys**  
38 **from the Blind and Visually Impaired Student Fund established under section 7 of this 2009**  
39 **Act and distribute those moneys to other regional programs.**

40 (2) The Superintendent of Public Instruction may operate and administer a local, county or re-  
41 gional program of special education or the superintendent may contract for the operation and ad-  
42 ministration of the program with a school district or an education service district.

43 (3) The State Board of Education by rule shall establish eligibility criteria and educational  
44 standards for the programs described in subsection (1) of this section and those programs in  
45 [schools] **the school** operated under ORS 346.010.

1 (4) A school district which contracts to provide a program under this section shall be paid for  
2 the state-approved program as determined and funded by the Legislative Assembly. Contracting  
3 school districts are authorized to negotiate supplemental programs with participating school dis-  
4 tricts.

5 **SECTION 12.** ORS 343.236, as amended by section 11 of this 2009 Act, is amended to read:

6 343.236. (1)(a) The Superintendent of Public Instruction may provide special education on a local,  
7 county or regional basis without regard to county boundaries in all areas of the state for children  
8 who have:

- 9 (A) A visual impairment;
- 10 (B) A hearing impairment;
- 11 (C) Blindness or deafness, or both;
- 12 (D) An orthopedic impairment;
- 13 (E) Autism; or
- 14 (F) Traumatic brain injury.

15 (b) The superintendent shall designate one of the regional programs that provides special edu-  
16 cation to children who are blind or visually impaired to provide statewide coordination and techni-  
17 cal assistance related to[:]

18 [(A)] the provision of services described in section 7 (2) of this 2009 Act[; and]

19 [(B)] *The transition of students from the Oregon School for the Blind to the communities and school*  
20 *districts where the students will be located after the closure of the Oregon School for the Blind*].

21 (c) The program designated under paragraph (b) of this subsection may receive moneys from the  
22 Blind and Visually Impaired Student Fund established under section 7 of this 2009 Act and distribute  
23 those moneys to other regional programs.

24 (2) The Superintendent of Public Instruction may operate and administer a local, county or re-  
25 gional program of special education or the superintendent may contract for the operation and ad-  
26 ministration of the program with a school district or an education service district.

27 (3) The State Board of Education by rule shall establish eligibility criteria and educational  
28 standards for the programs described in subsection (1) of this section and those programs in the  
29 school operated under ORS 346.010.

30 (4) A school district which contracts to provide a program under this section shall be paid for  
31 the state-approved program as determined and funded by the Legislative Assembly. Contracting

34 **SECTION 13. The amendments to ORS 343.236 by section 12 of this 2009 Act become op-**  
35 **erative September 1, 2010.**

36 **SECTION 14.** ORS 179.210 is amended to read:

37 179.210. (1) The Department of Human Services, the Department of Corrections and the Super-  
38 intendent of Public Instruction may audit, allow and pay a claim for damage to property made by  
39 an employee of one of those agencies if:

40 (a) The damage to property arises out of the claimant's employment at one of the institutions  
41 or facilities operated by the Department of Human Services or the Department of Corrections, or  
42 [one of the schools] **the school** operated by the Superintendent of Public Instruction under ORS  
43 346.010; and

44 (b) The employee files a written claim with the employee's employer within 180 days after the  
45 employee discovers or should have discovered the damage.

1 (2) No claim under subsection (1) of this section shall be paid:

2 (a) That exceeds, in the aggregate with payments of other claims, the moneys appropriated for  
3 such purpose.

4 (b) To the extent that the person incurring damage has been or may be compensated by liability  
5 insurance or otherwise.

6 (c) If the Department of Human Services, the Department of Corrections or the Superintendent  
7 of Public Instruction determines the cause or occasion of the accident resulting in damage is  
8 chargeable to the conduct or negligence of the party damaged.

9 **SECTION 15.** ORS 179.460 is amended to read:

10 179.460. (1) In order to encourage industry and thereby increase productiveness in the insti-  
11 tutions, the Department of Corrections and the Department of Human Services shall prescribe rules  
12 and regulations for the sale and exchange of surplus products of each.

13 (2) The funds derived from the sale of the surplus products shall be paid into the State Treasury  
14 and become a part of a fund to be known as the State Institutional Betterment Fund, which fund  
15 shall be expended by the Department of Corrections and the Department of Human Services, re-  
16 spectively, for the benefit of the institutions in proportion to the amount earned by each.

17 (3) The provisions of this section apply to [schools] **the school** operated under ORS 346.010.

18 **SECTION 16.** ORS 238.350 is amended to read:

19 238.350. (1)(a) Upon the request by a public employer that its employees be compensated for  
20 accumulated unused sick leave with pay in the form of increased retirement benefits upon service  
21 or disability retirement, the board shall establish a procedure for adding to the gross amount of  
22 salary used in determining final average salary the monetary value of one-half of the accumulated  
23 unused sick leave with pay of each retiring employee of the requesting public employer and shall  
24 establish benefits of the retiring employee on the basis of a final average salary reflecting that ad-  
25 dition.

26 (b) For employees of a common school district, a union high school district, an education service  
27 district or a community college, or employees of the State Board of Higher Education engaged in  
28 teaching or other school activity at an institution of higher education, or employees of [schools] **the**  
29 **school** operated under ORS 346.010 engaged in teaching or other school activity, who are employed  
30 under contract for a period of less than 12 consecutive months and who are entitled to sick leave  
31 with pay of less than 96 hours for a year, each hour of accumulated unused sick leave with pay shall  
32 be valued on the basis of the actual number of contract hours of employment during the last year  
33 of contributing membership of an employee before retiring and the salary of the employee during the  
34 same period. This paragraph does not apply to any employee who is employed under contract for  
35 12 consecutive months in any of the three or less years used in determining the final average salary  
36 of the employee.

37 (c) For the purpose of this subsection, accumulated unused sick leave with pay includes unused  
38 sick leave with pay accumulated by an active member of the system while in the service of any  
39 public employer participating in the system that has the request described in paragraph (a) of this  
40 subsection in effect at the time of the member's separation from the service of the employer, whether  
41 that employer is or is not the employer of the member at the time of the member's retirement.

42 (d) The board shall establish rules requiring all public employers participating in the system to  
43 transmit to the board reports of unused sick leave with pay accumulated by their employees who  
44 are members of the system and to provide timely notification to each of those employees of unused  
45 sick leave with pay accumulated by the employee and reported to the board.

1 (2) Accumulated unused sick leave with pay may be considered for the purpose of subsection (1)  
2 of this section only in accordance with the following requirements:

3 (a) Sick leave not credited at the rate actually provided by the public employer may not be  
4 considered. The amount of sick leave exceeding an amount credited at the lowest rate in effect for  
5 any employee of the public employer who is normally entitled to sick leave, and in any event ex-  
6 ceeding an amount credited at a rate of eight hours for each full month worked, may not be con-  
7 sidered.

8 (b) Sick leave credited for periods when an employee was absent from employment on sabbatical  
9 leave, educational leave or any leave without pay may not be considered.

10 (c) Any period during which an employee was absent from employment for illness or injury that  
11 was charged against sick leave not qualified for consideration shall be deducted from sick leave  
12 qualified for consideration.

13 (d) Sick leave for any period for which the public employer provides no sick leave with pay for  
14 its employees may not be considered.

15 (e) Sick leave accumulated on and after July 1, 1973, may be considered only to the extent it is  
16 supported by records of accumulation and use pursuant to a plan adopted formally by the public  
17 employer.

18 (f) Accumulated unused sick leave for periods before July 1, 1973, may be considered as follows:

19 (A) If any department, bureau or other organizational unit of a public employer maintained  
20 formal records of accumulation and use even though the public employer did not require that those  
21 records be maintained, the accumulated unused sick leave shall be considered according to those  
22 records.

23 (B) Where the public employer provided sick leave before July 1, 1973, but formal records of  
24 accumulation and use were not required or if required, are unavailable or incomplete, or the sick  
25 leave was subject to administrative limitations on total accumulation or transfer between public  
26 employers, accumulated unused sick leave for periods before July 1, 1973, may be considered as  
27 equal to 2.675 hours for each full month worked or an amount per month equal to the average  
28 monthly accumulation by an employee during the period beginning July 1, 1973, and ending at the  
29 time of retirement, whichever amount is greater, but reduced by the amount of any accumulated  
30 unused sick leave credited to the employee on July 1, 1973.

31 (g) The written certification of a member or former member of the Legislative Assembly shall  
32 constitute a formal record of accumulation and use in determining the amount of accumulated un-  
33 used sick leave of an employee of the Legislative Assembly, either of its houses or any of its com-  
34 mittees or officers for periods of employment before July 1, 1981. Sick leave accumulated on and  
35 after July 1, 1981, by employees of the Legislative Assembly, either of its houses or any of its com-  
36 mittees or officers may be considered only to the extent it is supported by records of accumulation  
37 and use maintained by the Legislative Administration Committee, or any statutory, standing, special  
38 or interim committee of the Legislative Assembly or either house thereof, or any constitutional or  
39 statutory office of the Legislative Assembly or either house thereof, pursuant to a plan adopted  
40 formally by the committee or officer.

41 (3)(a) As used in this subsection, "legislative employee" means any person employed by the  
42 Legislative Assembly, either of its houses or any of its committees or officers, but does not include  
43 a regular employee of a statutory committee or statutory office of the Legislative Assembly de-  
44 scribed in ORS 173.005 (1).

45 (b) Upon the request of a retiring legislative employee who is a member of the system, and the



1 request of the public employer of the legislative employee, that the legislative employee be com-  
2 pensated for accumulated unused vacation with pay for periods of legislative employment in the form  
3 of increased retirement benefits upon service or disability retirement, the board shall add to the  
4 gross amount of salary used in determining final average salary of the legislative employee the  
5 monetary value of one-half of the accumulated unused vacation with pay of the legislative employee  
6 and shall establish the benefits of the legislative employee on the basis of a final average salary  
7 reflecting that addition.

8 (c) Accumulated unused vacation with pay may be considered for the purposes of paragraph (b)  
9 of this subsection only in accordance with the following requirements:

10 (A) Vacation not credited at the rate actually provided by the public employer may not be  
11 considered.

12 (B) Amounts of vacation exceeding amounts creditable to employees in the classified service of  
13 the state service pursuant to ORS 240.515 (1), and rules adopted pursuant thereto, in effect on June  
14 30, 1981, shall not be considered.

15 (C) Vacation accumulated before, on and after July 1, 1981, may be considered only to the extent  
16 it is supported by records of accumulation and use pursuant to a plan adopted formally by the public  
17 employer. However, the written certification of a member or former member of the Legislative As-  
18 sembly shall constitute a formal record of accumulation and use in determining the amount of ac-  
19 cumulated unused vacation of a legislative employee for periods of legislative employment before  
20 July 1, 1981.

21 (4) Employers with plans providing payments on account of sickness in lieu of sick leave with  
22 pay may request the board to consider the monetary value of accumulated unused payments on ac-  
23 count of sickness as if such payments were an equivalent amount of accumulated unused sick leave  
24 with pay under the same terms and conditions specified in subsections (1) and (2) of this section.

40 **SECTION 36.** ORS 346.097, 346.099, 346.101 and 346.104 and section 53, chapter 858, Oregon  
41 Laws 2007, are repealed.

42 **SECTION 37.** The amendments to ORS 179.210, 179.460, 238.350, 240.205, 240.240, 326.543,  
43 326.603, 327.023, 339.370, 339.877, 343.239, 346.010, 346.015, 346.017, 346.019, 346.020, 346.030,  
44 346.041, 346.047, 346.055, 346.080 and 656.135 by sections 14 to 35 of this 2009 Act and the repeal  
45 of ORS 346.097, 346.099, 346.101 and 346.104 and section 53, chapter 858, Oregon Laws 2007,

1 by section 36 of this 2009 Act become operative September 1, 2009.

2 **SECTION 38.** (1) In addition to and not in lieu of any other appropriation, there is ap-  
3 propriated to the Emergency Board, for the biennium beginning July 1, 2009, out of the  
4 General Fund, the amount of \$2,850,000, to be allocated to the Department of Education, the  
5 Department of Human Services and the Oregon Department of Administrative Services for  
6 transition costs and other services provided to blind and visually impaired students and for  
7 the closure and disposition of the Oregon School for the Blind.

8 (2) If any of the moneys appropriated by subsection (1) of this section are not allocated  
9 by the Emergency Board prior to December 1, 2010, the moneys remaining on that date be-  
10 come available for any purpose for which the Emergency Board lawfully may allocate funds.

11 **SECTION 39.** Notwithstanding any other law limiting expenditures, the amount of  
12 \$450,000 is established for the biennium beginning July 1, 2009, as the maximum limit for the  
13 payment of expenses by the Oregon Department of Administrative Services, from fees,  
14 moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and  
15 federal funds, collected or received by the department for the purposes of sections 1 to 6 of  
16 this 2009 Act.

17 **SECTION 40.** This 2009 Act being necessary for the immediate preservation of the public  
18 peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect  
19 on its passage.
