SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Creates Task Force on Effective and Cost-Efficient Service Provision.
Directs task force to establish technical committee to aid and advise task force.
Sunsets on date of convening of next regular biennial legislative session.
Declares emergency, effective upon passage.

A BILL FOR AN ACT

Relating to efficiencies in the provision of governmental services; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. (1) There is created the Task Force on Effective and Cost-Efficient Service Provision, consisting of 21 members appointed as follows:

(a) The Governor shall appoint:

(A) Two members from among staff of the office of the Governor.

(B) One member who was a member of the Governor's Task Force on Federal Forest Payments and County Services.

(C) One member who was a member of the Task Force on Comprehensive Revenue Restructuring.

(D) Seven members from state agencies and departments other than the Governor's office.

(E) Three members who are county commissioners. The Governor shall consider recommendations for these positions from the Association of Oregon Counties.

(b) The President of the Senate shall appoint two members from among members of the Senate, including at least one member of the Joint Committee on Ways and Means.

(c) The Speaker of the House of Representatives shall appoint two members from among members of the House of Representatives, including at least one member from the Joint Committee on Ways and Means.

(d) The Secretary of State, the State Treasurer and the Chief Justice of the Supreme Court shall serve as ex officio members.

(2) The task force shall:

(a) Review opportunities to provide services in the most effective and cost-efficient manner;

(b) Consider the ability of intergovernmental agreements, existing or new service dis-

1 **tricts and technology to achieve cost savings; and**

2 **(c) Encourage effective fiscal planning for counties managing the phaseout of federal**
3 **forest safety net payments.**

4 **(3) The task force shall analyze, at a minimum, the following categories of services under**
5 **subsection (2) of this section:**

6 **(a) Assessment and taxation;**

7 **(b) Elections;**

8 **(c) Human services;**

9 **(d) Public health;**

10 **(e) Criminal justice; and**

11 **(f) Transportation and public works.**

12 **(4) The task force may analyze additional services under subsection (2) of this section.**

13 **(5) A majority of the members of the task force constitutes a quorum for the transaction**
14 **of business.**

15 **(6) Official action by the task force requires the approval of a majority of the members**
16 **of the task force.**

17 **(7) The Governor shall appoint one of the members as chairperson.**

18 **(8) If there is a vacancy for any cause, the appointing authority shall make an appoint-**
19 **ment to become immediately effective.**

20 **(9) The task force shall meet at times and places specified by the call of the chairperson**
21 **or of a majority of the members of the task force.**

22 **(10) The task force may adopt rules necessary for the operation of the task force.**

23 **(11) The task force shall submit an interim report to the Legislative Assembly no later**
24 **than November 30, 2009, reporting progress of work and initial recommendations, and shall**
25 **submit a final report to the Legislative Assembly no later than October 1, 2010.**

26 **(12) The task force shall use the services of permanent staff of the offices of the Gover-**
27 **nor, Secretary of State, State Treasurer, Judicial Department and Legislative Fiscal Officer.**
28 **The task force shall also accept staff assistance from the Association of Oregon Counties if**
29 **the association offers assistance.**

30 **(13) Members of the task force who are not members of the Legislative Assembly are not**
31 **entitled to compensation, but may be reimbursed for actual and necessary travel and other**
32 **expenses incurred by them in the performance of their official duties in the manner and**
33 **amounts provided for in ORS 292.495. Claims for expenses incurred in performing functions**
34 **of the task force shall be paid out of funds appropriated to the Governor's office for purposes**
35 **of the task force.**

36 **(14) All agencies of state government, as defined in ORS 174.111, are directed to assist**
37 **the task force in the performance of its duties and, to the extent permitted by laws relating**
38 **to confidentiality, to furnish such information and advice as the members of the task force**
39 **consider necessary to perform their duties.**

40 **(15)(a) The task force shall establish a technical committee to aid and advise the task**
41 **force in the performance of its functions. The task force shall determine the representation,**
42 **membership, terms and organization of the committee and shall appoint its members. If the**
43 **Executive Director of the Association of Oregon Counties consents to serve on the technical**
44 **committee, the task force shall appoint the director to the committee.**

45 **(b) Members of the committee are not entitled to compensation, but at the discretion of**

1 the task force may be reimbursed from funds available to the task force for actual and
2 necessary travel and other expenses incurred by them in the performance of their official
3 duties, in the manner and amount provided in ORS 292.495.

4 SECTION 2. Section 1 of this 2009 Act is repealed on the date of the convening of the next
5 regular biennial legislative session.

6 SECTION 3. This 2009 Act being necessary for the immediate preservation of the public
7 peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect
8 on its passage.
