

HOUSE AMENDMENTS TO HOUSE BILL 2987

- 1 On page 1 of the printed bill, line 2, delete “657A.030,”.
2 Delete lines 5 through 30.
3 On page 2, delete lines 1 through 15.
4 In line 16, delete “2” and insert “1”.
5 In line 44, delete “unless provided”.
6 Delete line 45 and insert “for four hours or less a day.”.
7 On page 3, line 1, after “care” insert “for school-age children” and delete “a single”.
8 Delete line 2 and insert “a single enrichment activity, for eight hours or less a week.”.
9 Delete line 5.
10 In lines 6 through 13, delete the boldfaced material and restore the bracketed material.
11 Delete line 15 and insert:
12 “(i) Facility operated as a school-age recorded program.”.
13 In lines 17 through 25, delete the boldfaced material and restore the bracketed material.
14 After line 30, insert:
15 “(10) ‘Record’ means the record that is issued under section 4 of this 2009 Act to a school-age
16 recorded program.”.
17 In line 31, delete the colon.
18 In lines 32 through 34, delete the boldfaced material.
19 After line 37, insert:
20 “(13) ‘School-age recorded program’ means a program for school-age children:
21 “(a) That is not operated by a school district as defined in ORS 332.002;
22 “(b) That is not required to be certified under ORS 657A.280 or registered under ORS 657A.330;
23 and
24 “(c) In which youth development activities are provided to children during hours that school is
25 not in session and does not take the place of a parent’s care.”.
26 Delete lines 38 through 43 and insert:
27 “(14) ‘Youth development activities’ means care, supervision or guidance that is intended for
28 enrichment, including but not limited to teaching skills or proficiency in physical, social or educa-
29 tional activities such as tutoring, music lessons, social activities, sports and recreational
30 activities.”.
31 In line 44, delete “3” and insert “2”.
32 On page 4, line 1, delete “and” and insert a comma and after “registration” insert “and re-
33 cording”.
34 Delete line 16 and insert:
35 “(f) For School-Age Recorded Program Recording, \$20;”.

1 In line 23, delete “4” and insert “3” and delete “5” and insert “4”.

2 In line 25, delete “5” and insert “4” and delete “an exempt tracked” and insert “a school-age

11 In line 34, delete the first “and” and delete “181.534, 181.537 and”.

12 In line 35, after “section” delete the rest of the line and line 36 and insert a period.

13 In line 37, delete “registration” and insert “the record” and delete “regis-” and insert
14 “record”.

15 In line 38, delete “tration”.

16 In line 39, delete “registration” and insert “record” and delete “exempt tracked” and insert
17 “school-age recorded”.

18 In line 40, delete “registration” and insert “record” in both places.

19 In line 41, delete “exempt tracked” and insert “school-age recorded” and delete “regis-” and
20 insert “recorded”.

23 “(a) Name and address of the program;
24 “(b) Name of operator; and”.

27 In line 3, delete “An exempt tracked program registered” and insert “A school-age recorded
28 program recorded”.

29 In line 4, delete “exempt tracked” and insert “school-age recorded”.

30 In line 6, delete “registration of an exempt tracked” and insert “recording of a school-age re-
31 corded”.

32 In line 7, delete “or a temporary or regular registration may be”.

33 In line 9, delete “181.537 and”.
