Sponsored by Representative CLEM (at the request of Oregon Farm Bureau)

**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies conditional and outright permitted uses of land zoned for exclusive farm use. Modifies criteria for uses.

**A BILL FOR AN ACT**

2 Relating to use of land zoned for exclusive farm use; creating new provisions; amending ORS 197.065,  
3 215.203, 215.213, 215.246, 215.249, 215.251, 215.263, 215.275, 215.283, 215.417, 215.452, 215.780 and  
4 308A.056; and repealing ORS 215.297.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 215.213 is amended to read:

7 215.213. (1) In counties that have adopted marginal lands provisions under ORS 197.247 (1991  
8 Edition), the following uses may be established in any area zoned for exclusive farm use:

9 [(a) *Public or private schools, including all buildings essential to the operation of a school.*]

10 [(b)] **(a)** Churches and cemeteries in conjunction with churches.

11 [(c)] **(b)** The propagation or harvesting of a forest product.

12 [(d)] **(c)** Utility facilities necessary for public service, including wetland waste treatment systems  
13 but not including commercial facilities for the purpose of generating electrical power for public use  
14 by sale or transmission towers over 200 feet in height. A utility facility necessary for public service  
15 may be established as provided in ORS 215.275.

16 [(e)] **(d)** A dwelling on real property used for farm use if the dwelling is occupied by a relative  
17 of the farm operator or the farm operator's spouse, which means a child, parent, stepparent, grand-  
18 child, grandparent, stepgrandparent, sibling, stepsibling, niece, nephew or first cousin of either, if  
19 the farm operator does or will require the assistance of the relative in the management of the farm  
20 use and the dwelling is located on the same lot or parcel as the dwelling of the farm operator.  
21 Notwithstanding ORS 92.010 to 92.190 or the minimum lot or parcel size requirements under ORS  
22 215.780, if the owner of a dwelling described in this paragraph obtains construction financing or  
23 other financing secured by the dwelling and the secured party forecloses on the dwelling, the se-  
24 cured party may also foreclose on the homesite, as defined in ORS 308A.250, and the foreclosure  
25 shall operate as a partition of the homesite to create a new parcel.

26 [(f)] **(e)** Nonresidential buildings customarily provided in conjunction with farm use.

27 [(g)] **(f)** Primary or accessory dwellings customarily provided in conjunction with farm use. For  
28 a primary dwelling, the dwelling must be on a lot or parcel that is managed as part of a farm op-

1 eration and is not smaller than the minimum lot size in a farm zone with a minimum lot size ac-  
2 knowledged under ORS 197.251.

3 [(h)] (g) Operations for the exploration for and production of geothermal resources as defined  
4 by ORS 522.005 and oil and gas as defined by ORS 520.005, including the placement and operation  
5 of compressors, separators and other customary production equipment for an individual well adja-  
6 cent to the wellhead. Any activities or construction relating to such operations shall not be a basis  
7 for an exception under ORS 197.732 (2)(a) or (b).

8 [(i)] (h) Operations for the exploration for minerals as defined by ORS 517.750. Any activities  
9 or construction relating to such operations shall not be a basis for an exception under ORS 197.732  
10 (2)(a) or (b).

11 [(j)] (i) A site for the disposal of solid waste that has been ordered to be established by the  
12 Environmental Quality Commission under ORS 459.049, together with equipment, facilities or  
13 buildings necessary for its operation.

14 [(k)] (j) One manufactured dwelling or recreational vehicle, or the temporary residential use of  
15 an existing building, in conjunction with an existing dwelling as a temporary use for the term of a  
16 hardship suffered by the existing resident or a relative of the resident. Within three months of the  
17 end of the hardship, the manufactured dwelling or recreational vehicle shall be removed or demol-  
18 ished or, in the case of an existing building, the building shall be removed, demolished or returned  
19 to an allowed nonresidential use. The governing body or its designee shall provide for periodic re-  
20 view of the hardship claimed under this paragraph. A temporary residence approved under this  
21 paragraph is not eligible for replacement under paragraph [(t)] (r) of this subsection.

22 [(L) *The breeding, kenneling and training of greyhounds for racing in any county with a population*  
23 *of more than 200,000 in which there is located a greyhound racing track or in a county with a popu-*  
24 *lation of more than 200,000 that is contiguous to such a county.*]

25 [(m)] (k) Climbing and passing lanes within the right of way existing as of July 1, 1987.

26 [(n)] (L) Reconstruction or modification of public roads and highways, including the placement  
27 of utility facilities overhead and in the subsurface of public roads and highways along the public  
28 right of way, but not including the addition of travel lanes, where no removal or displacement of  
29 buildings would occur, or no new land parcels result.

30 [(o)] (m) Temporary public road and highway detours that will be abandoned and restored to  
31 original condition or use at such time as no longer needed.

32 [(p)] (n) Minor betterment of existing public road and highway related facilities, such as main-  
33 tenance yards, weigh stations and rest areas, within right of way existing as of July 1, 1987, and  
34 contiguous public-owned property utilized to support the operation and maintenance of public roads  
35 and highways.

36 [(q)] (o) A replacement dwelling to be used in conjunction with farm use if the existing dwelling  
37 has been listed in a county inventory as historic property as defined in ORS 358.480.

38 [(r)] (p) Creation [of], restoration [of] or enhancement of wetlands.

39 [(s)] (q) A winery, as described in ORS 215.452.

40 [(t)] (r) Alteration, restoration or replacement of a lawfully established dwelling that:

41 (A) Has intact exterior walls and roof structure;

42 (B) Has indoor plumbing consisting of a kitchen sink, toilet and bathing facilities connected to  
43 a sanitary waste disposal system;

44 (C) Has interior wiring for interior lights;

45 (D) Has a heating system; and

1 (E) In the case of replacement:

2 (i) Is removed, demolished or converted to an allowable nonresidential use within three months  
3 of the completion of the replacement dwelling. A replacement dwelling may be sited on any part of  
4 the same lot or parcel. A dwelling established under this paragraph shall comply with all applicable  
5 siting standards. However, the standards shall not be applied in a manner that prohibits the siting  
6 of the dwelling. If the dwelling to be replaced is located on a portion of the lot or parcel not zoned  
7 for exclusive farm use, the applicant, as a condition of approval, shall execute and record in the  
8 deed records for the county where the property is located a deed restriction prohibiting the siting  
9 of a dwelling on that portion of the lot or parcel. The restriction imposed shall be irrevocable unless  
10 a statement of release is placed in the deed records for the county. The release shall be signed by  
11 the county or its designee and state that the provisions of this paragraph regarding replacement  
12 dwellings have changed to allow the siting of another dwelling. The county planning director or the  
13 director's designee shall maintain a record of the lots and parcels that do not qualify for the siting  
14 of a new dwelling under the provisions of this paragraph, including a copy of the deed restrictions  
15 and release statements filed under this paragraph; and

16 (ii) For which the applicant has requested a deferred replacement permit, is removed or demol-  
17 ished within three months after the deferred replacement permit is issued. A deferred replacement  
18 permit allows construction of the replacement dwelling at any time. If, however, the established  
19 dwelling is not removed or demolished within three months after the deferred replacement permit  
20 is issued, the permit becomes void. The replacement dwelling must comply with applicable building  
21 codes, plumbing codes, sanitation codes and other requirements relating to health and safety or to  
22 siting at the time of construction. A deferred replacement permit may not be transferred, by sale  
23 or otherwise, except by the applicant to the spouse or a child of the applicant.

24 [(u)] (s) Farm stands if:

25 (A) The structures are designed and used for the sale of farm crops or livestock grown on the  
26 farm operation, or grown on the farm operation and other farm operations in the local agricultural  
27 area, including the sale of retail incidental items and fee-based activity to promote the sale of farm  
28 crops or livestock sold at the farm stand if the annual sale of incidental items and fees from pro-  
29 motional activity do not make up more than 25 percent of the total annual sales of the farm stand;  
30 and

31 (B) The farm stand does not include structures designed for occupancy as a residence or for  
32 activity other than the sale of farm crops or livestock and does not include structures for banquets,  
33 public gatherings or public entertainment.

34 [(v)] (t) An armed forces reserve center, if the center is within one-half mile of a community  
35 college. For purposes of this paragraph, "armed forces reserve center" includes an armory or Na-  
36 tional Guard support facility.

37 [(w)] (u) A site for the takeoff and landing of model aircraft, including such buildings or facili-  
38 ties as may reasonably be necessary. Buildings or facilities shall not be more than 500 square feet  
39 in floor area or placed on a permanent foundation unless the building or facility preexisted the use  
40 approved under this paragraph. The site shall not include an aggregate surface or hard surface area  
41 unless the surface preexisted the use approved under this paragraph. **An owner of property used**  
42 **for the purpose authorized in this paragraph may charge a person operating the use on the**  
43 **property rent for the property. An operator may charge users of the property a fee that does**  
44 **not exceed the operator's cost to maintain the property, buildings and facilities.** As used in  
45 this paragraph, "model aircraft" means a small-scale version of an airplane, glider, helicopter,

1 dirigible or balloon that is used or intended to be used for flight and is controlled by radio, lines  
2 or design by a person on the ground.

3 [(x)] (v) A facility for the processing of farm crops, or the production of biofuel as defined in  
4 ORS 315.141, that is located on a farm operation that provides at least one-quarter of the farm crops  
5 processed at the facility. The building established for the processing facility shall not exceed 10,000  
6 square feet of floor area exclusive of the floor area designated for preparation, storage or other farm  
7 use or devote more than 10,000 square feet to the processing activities within another building  
8 supporting farm uses. A processing facility shall comply with all applicable siting standards but the  
9 standards shall not be applied in a manner that prohibits the siting of the processing facility.

10 [(y)] (w) Fire service facilities providing rural fire protection services.

11 [(z)] (x) Irrigation canals, delivery lines and those structures and accessory operational facilities  
12 associated with a district as defined in ORS 540.505.

13 [(aa)] (y) Utility facility service lines. Utility facility service lines are utility lines and accessory  
14 facilities or structures that end at the point where the utility service is received by the customer  
15 and that are located on one or more of the following:

16 (A) A public right of way;

17 (B) Land immediately adjacent to a public right of way, provided the written consent of all ad-  
18 jacent property owners has been obtained; or

19 (C) The property to be served by the utility.

20 [(bb)] (z) Subject to the issuance of a license, permit or other approval by the Department of  
21 Environmental Quality under ORS 454.695, 459.205, 468B.050, 468B.053 or 468B.055, or in compliance  
22 with rules adopted under ORS 468B.095, and as provided in ORS 215.246 to 215.251, the land appli-  
23 cation of reclaimed water, agricultural or industrial process water or biosolids for agricultural,  
24 horticultural or silvicultural production, or for irrigation in connection with a use allowed in an  
25 exclusive farm use zone under this chapter.

26 (2) In counties that have adopted marginal lands provisions under ORS 197.247 (1991 Edition),  
27 the following uses may be established in any area zoned for exclusive farm use subject to ORS  
28 215.296:

29 (a) A primary dwelling in conjunction with farm use or the propagation or harvesting of a forest  
30 product on a lot or parcel that is managed as part of a farm operation or woodlot if the farm op-  
31 eration or woodlot:

32 (A) Consists of 20 or more acres; and

33 (B) Is not smaller than the average farm or woodlot in the county producing at least \$2,500 in  
34 annual gross income from the crops, livestock or forest products to be raised on the farm operation  
35 or woodlot.

36 (b) A primary dwelling in conjunction with farm use or the propagation or harvesting of a forest  
37 product on a lot or parcel that is managed as part of a farm operation or woodlot smaller than re-  
38 quired under paragraph (a) of this subsection, if the lot or parcel:

39 (A) Has produced at least \$20,000 in annual gross farm income in two consecutive calendar  
40 years out of the three calendar years before the year in which the application for the dwelling was  
41 made or is planted in perennials capable of producing upon harvest an average of at least \$20,000  
42 in annual gross farm income; or

43 (B) Is a woodlot capable of producing an average over the growth cycle of \$20,000 in gross an-  
44 nual income.

45 (c) Commercial activities that are in conjunction with farm use, including the processing of farm

1 crops into biofuel not permitted under ORS 215.203 (2)(b)(L) or subsection [(1)(x)] (1)(v) of this sec-  
2 tion.

3 (d) Operations conducted for:

4 (A) Mining and processing of geothermal resources as defined by ORS 522.005 and oil and gas  
5 as defined by ORS 520.005, not otherwise permitted under subsection [(1)(h)] (1)(g) of this section;

6 (B) Mining, crushing or stockpiling of aggregate and other mineral and other subsurface re-  
7 sources subject to ORS 215.298;

8 (C) Processing, as defined by ORS 517.750, of aggregate into asphalt or portland cement; and

9 (D) Processing of other mineral resources and other subsurface resources.

10 (e) Community centers owned by a governmental agency or a nonprofit community organization  
11 and operated primarily by and for residents of the local rural community, hunting and fishing pre-  
12 serves, public and private parks, playgrounds and campgrounds. Subject to the approval of the  
13 county governing body or its designee, a private campground may provide yurts for overnight  
14 camping. No more than one-third or a maximum of 10 campsites, whichever is smaller, may include  
15 a yurt. The yurt shall be located on the ground or on a wood floor with no permanent foundation.  
16 Upon request of a county governing body, the Land Conservation and Development Commission may  
17 provide by rule for an increase in the number of yurts allowed on all or a portion of the  
18 campgrounds in a county if the commission determines that the increase will comply with the stan-  
19 dards described in ORS 215.296 (1). A public park or campground may be established as provided  
20 under ORS 195.120. As used in this paragraph, "yurt" means a round, domed shelter of cloth or  
21 canvas on a collapsible frame with no plumbing, sewage disposal hookup or internal cooking appli-  
22 ance.

23 (f) Golf courses **on land determined to not be high-value farmland as defined in ORS**  
24 **195.300.**

25 (g) Commercial utility facilities for the purpose of generating power for public use by sale.

26 (h) Personal-use airports for airplanes and helicopter pads, including associated hangar, main-  
27 tenance and service facilities. A personal-use airport as used in this section means an airstrip re-  
28 stricted, except for aircraft emergencies, to use by the owner, and, on an infrequent and occasional  
29 basis, by invited guests, and by commercial aviation activities in connection with agricultural op-  
30 erations. No aircraft may be based on a personal-use airport other than those owned or controlled  
31 by the owner of the airstrip. Exceptions to the activities permitted under this definition may be  
32 granted through waiver action by the Oregon Department of Aviation in specific instances. A  
33 personal-use airport lawfully existing as of September 13, 1975, shall continue to be permitted sub-  
34 ject to any applicable rules of the Oregon Department of Aviation.

35 (i) A facility for the primary processing of forest products, provided that such facility is found  
36 to not seriously interfere with accepted farming practices and is compatible with farm uses de-  
37 scribed in ORS 215.203 (2). Such a facility may be approved for a one-year period which is  
38 renewable. These facilities are intended to be only portable or temporary in nature. The primary  
39 processing of a forest product, as used in this section, means the use of a portable chipper or stud  
40 mill or other similar methods of initial treatment of a forest product in order to enable its shipment  
41 to market. Forest products, as used in this section, means timber grown upon a parcel of land or  
42 contiguous land where the primary processing facility is located.

43 (j) A site for the disposal of solid waste approved by the governing body of a city or county or  
44 both and for which a permit has been granted under ORS 459.245 by the Department of Environ-  
45 mental Quality together with equipment, facilities or buildings necessary for its operation.

1 (k) Dog kennels *[not described in subsection (1)(L) of this section]*.

2 (L) Residential homes as defined in ORS 197.660, in existing dwellings.

3 (m) The propagation, cultivation, maintenance and harvesting of aquatic species that are not  
4 under the jurisdiction of the State Fish and Wildlife Commission or insect species. Insect species  
5 shall not include any species under quarantine by the State Department of Agriculture or the United  
6 States Department of Agriculture. The county shall provide notice of all applications under this  
7 paragraph to the State Department of Agriculture. Notice shall be provided in accordance with the  
8 county's land use regulations but shall be mailed at least 20 calendar days prior to any administra-  
9 tive decision or initial public hearing on the application.

10 (n) Home occupations as provided in ORS 215.448.

11 (o) Transmission towers over 200 feet in height.

12 (p) Construction of additional passing and travel lanes requiring the acquisition of right of way  
13 but not resulting in the creation of new land parcels.

14 (q) Reconstruction or modification of public roads and highways involving the removal or dis-  
15 placement of buildings but not resulting in the creation of new land parcels.

16 (r) Improvement of public road and highway related facilities such as maintenance yards, weigh  
17 stations and rest areas, where additional property or right of way is required but not resulting in  
18 the creation of new land parcels.

19 (s) A destination resort that is approved consistent with the requirements of any statewide  
20 planning goal relating to the siting of a destination resort.

21 (t) Room and board arrangements for a maximum of five unrelated persons in existing resi-  
22 dences.

23 (u) A living history museum related to resource based activities owned and operated by a gov-  
24 ernmental agency or a local historical society, together with limited commercial activities and fa-  
25 cilities that are directly related to the use and enjoyment of the museum and located within  
26 authentic buildings of the depicted historic period or the museum administration building, if areas  
27 other than an exclusive farm use zone cannot accommodate the museum and related activities or if  
28 the museum administration buildings and parking lot are located within one quarter mile of the  
29 metropolitan urban growth boundary. As used in this paragraph:

30 (A) "Living history museum" means a facility designed to depict and interpret everyday life and  
31 culture of some specific historic period using authentic buildings, tools, equipment and people to  
32 simulate past activities and events; and

33 (B) "Local historical society" means the local historical society, recognized as such by the  
34 county governing body and organized under ORS chapter 65.

35 (v) Operations for the extraction and bottling of water.

36 *[(w) An aerial fireworks display business that has been in continuous operation at its current lo-  
37 cation within an exclusive farm use zone since December 31, 1986, and possesses a wholesaler's permit  
38 to sell or provide fireworks.]*

39 *[(x)]* (w) A landscape contracting business, as defined in ORS 671.520, or a business providing  
40 landscape architecture services, as described in ORS 671.318, if the business is pursued in conjunc-  
41 tion with the growing and marketing of nursery stock on the land that constitutes farm use.

42 **(x) Public or private schools for kindergarten through grade 12, including all buildings  
43 essential to the operation of a school, primarily for residents of the rural area in which the  
44 school is located.**

45 (3) In counties that have adopted marginal lands provisions under ORS 197.247 (1991 Edition),

1 a single-family residential dwelling not provided in conjunction with farm use may be established  
2 on a lot or parcel with soils predominantly in capability classes IV through VIII as determined by  
3 the Agricultural Capability Classification System in use by the United States Department of Agri-  
4 culture Soil Conservation Service on October 15, 1983. A proposed dwelling is subject to approval  
5 of the governing body or its designee in any area zoned for exclusive farm use upon written findings  
6 showing all of the following:

7 (a) The dwelling or activities associated with the dwelling will not force a significant change in  
8 or significantly increase the cost of accepted farming practices on nearby lands devoted to farm use.

9 (b) The dwelling is situated upon generally unsuitable land for the production of farm crops and  
10 livestock, considering the terrain, adverse soil or land conditions, drainage and flooding, location  
11 and size of the tract. A lot or parcel shall not be considered unsuitable solely because of its size  
12 or location if it can reasonably be put to farm use in conjunction with other land.

13 (c) Complies with such other conditions as the governing body or its designee considers neces-  
14 sary.

15 (4) In counties that have adopted marginal lands provisions under ORS 197.247 (1991 Edition),  
16 one single-family dwelling, not provided in conjunction with farm use, may be established in any  
17 area zoned for exclusive farm use on a lot or parcel described in subsection (7) of this section that  
18 is not larger than three acres upon written findings showing:

19 (a) The dwelling or activities associated with the dwelling will not force a significant change in  
20 or significantly increase the cost of accepted farming practices on nearby lands devoted to farm use;

21 (b) If the lot or parcel is located within the Willamette River Greenway, a floodplain or a  
22 geological hazard area, the dwelling complies with conditions imposed by local ordinances relating  
23 specifically to the Willamette River Greenway, floodplains or geological hazard areas, whichever is  
24 applicable; and

25 (c) The dwelling complies with other conditions considered necessary by the governing body or  
26 its designee.

27 (5) Upon receipt of an application for a permit under subsection (4) of this section, the governing  
28 body shall notify:

29 (a) Owners of land that is within 250 feet of the lot or parcel on which the dwelling will be es-  
30 tablished; and

31 (b) Persons who have requested notice of such applications and who have paid a reasonable fee  
32 imposed by the county to cover the cost of such notice.

33 (6) The notice required in subsection (5) of this section shall specify that persons have 15 days  
34 following the date of postmark of the notice to file a written objection on the grounds only that the  
35 dwelling or activities associated with it would force a significant change in or significantly increase  
36 the cost of accepted farming practices on nearby lands devoted to farm use. If no objection is re-  
37 ceived, the governing body or its designee shall approve or disapprove the application. If an ob-  
38 jection is received, the governing body shall set the matter for hearing in the manner prescribed in  
39 ORS 215.402 to 215.438. The governing body may charge the reasonable costs of the notice required  
40 by subsection (5)(a) of this section to the applicant for the permit requested under subsection (4) of  
41 this section.

42 (7) Subsection (4) of this section applies to a lot or parcel lawfully created between January 1,  
43 1948, and July 1, 1983. For the purposes of this section:

44 (a) Only one lot or parcel exists if:

45 (A) A lot or parcel described in this section is contiguous to one or more lots or parcels de-

1 scribed in this section; and

2 (B) On July 1, 1983, greater than possessory interests are held in those contiguous lots, parcels  
3 or lots and parcels by the same person, spouses or a single partnership or business entity, separately  
4 or in tenancy in common.

5 (b) "Contiguous" means lots, parcels or lots and parcels that have a common boundary, including  
6 but not limited to, lots, parcels or lots and parcels separated only by a public road.

7 (8) A person who sells or otherwise transfers real property in an exclusive farm use zone may  
8 retain a life estate in a dwelling on that property and in a tract of land under and around the  
9 dwelling.

10 (9) No final approval of a nonfarm use under this section shall be given unless any additional  
11 taxes imposed upon the change in use have been paid.

12 (10) Roads, highways and other transportation facilities and improvements not allowed under  
13 subsections (1) and (2) of this section may be established, subject to the approval of the governing  
14 body or its designee, in areas zoned for exclusive farm use subject to:

15 (a) Adoption of an exception to the goal related to agricultural lands and to any other applicable  
16 goal with which the facility or improvement does not comply; or

17 (b) ORS 215.296 for those uses identified by rule of the Land Conservation and Development  
18 Commission as provided in section 3, chapter 529, Oregon Laws 1993.

19 **SECTION 2.** ORS 215.283 is amended to read:

20 215.283. (1) The following uses may be established in any area zoned for exclusive farm use:

21 [(a) *Public or private schools, including all buildings essential to the operation of a school.*]

22 [(b)] (a) Churches and cemeteries in conjunction with churches.

23 [(c)] (b) The propagation or harvesting of a forest product.

24 [(d)] (c) Utility facilities necessary for public service, including wetland waste treatment systems  
25 but not including commercial facilities for the purpose of generating electrical power for public use  
26 by sale or transmission towers over 200 feet in height. A utility facility necessary for public service  
27 may be established as provided in ORS 215.275.

28 [(e)] (d) A dwelling on real property used for farm use if the dwelling is occupied by a relative  
29 of the farm operator or the farm operator's spouse, which means a child, parent, stepparent, grand-  
30 child, grandparent, stepgrandparent, sibling, stepsibling, niece, nephew or first cousin of either, if  
31 the farm operator does or will require the assistance of the relative in the management of the farm  
32 use and the dwelling is located on the same lot or parcel as the dwelling of the farm operator.  
33 Notwithstanding ORS 92.010 to 92.190 or the minimum lot or parcel size requirements under ORS  
34 215.780, if the owner of a dwelling described in this paragraph obtains construction financing or  
35 other financing secured by the dwelling and the secured party forecloses on the dwelling, the se-  
36 cured party may also foreclose on the homesite, as defined in ORS 308A.250, and the foreclosure  
37 shall operate as a partition of the homesite to create a new parcel.

38 [(f)] (e) Primary or accessory dwellings and other buildings customarily provided in conjunction  
39 with farm use.

40 [(g)] (f) Operations for the exploration for and production of geothermal resources as defined  
41 by ORS 522.005 and oil and gas as defined by ORS 520.005, including the placement and operation  
42 of compressors, separators and other customary production equipment for an individual well adja-  
43 cent to the wellhead. Any activities or construction relating to such operations shall not be a basis  
44 for an exception under ORS 197.732 (2)(a) or (b).

45 [(h)] (g) Operations for the exploration for minerals as defined by ORS 517.750. Any activities

1 or construction relating to such operations shall not be a basis for an exception under ORS 197.732  
2 (2)(a) or (b).

3 [(i)] **(h)** A site for the disposal of solid waste that has been ordered to be established by the  
4 Environmental Quality Commission under ORS 459.049, together with equipment, facilities or  
5 buildings necessary for its operation.

6 [(j)] *The breeding, kenneling and training of greyhounds for racing.*]

7 [(k)] **(i)** Climbing and passing lanes within the right of way existing as of July 1, 1987.

8 [(L)] **(j)** Reconstruction or modification of public roads and highways, including the placement  
9 of utility facilities overhead and in the subsurface of public roads and highways along the public  
10 right of way, but not including the addition of travel lanes, where no removal or displacement of  
11 buildings would occur, or no new land parcels result.

12 [(m)] **(k)** Temporary public road and highway detours that will be abandoned and restored to  
13 original condition or use at such time as no longer needed.

14 [(n)] **(L)** Minor betterment of existing public road and highway related facilities such as main-  
15 tenance yards, weigh stations and rest areas, within right of way existing as of July 1, 1987, and  
16 contiguous public-owned property utilized to support the operation and maintenance of public roads  
17 and highways.

18 [(o)] **(m)** A replacement dwelling to be used in conjunction with farm use if the existing dwelling  
19 has been listed in a county inventory as historic property as defined in ORS 358.480.

20 [(p)] **(n)** Creation [of], restoration [of] or enhancement of wetlands.

21 [(q)] **(o)** A winery, as described in ORS 215.452.

22 [(r)] **(p)** Farm stands if:

23 (A) The structures are designed and used for the sale of farm crops or livestock grown on the  
24 farm operation, or grown on the farm operation and other farm operations in the local agricultural  
25 area, including the sale of retail incidental items and fee-based activity to promote the sale of farm  
26 crops or livestock sold at the farm stand if the annual sale of incidental items and fees from pro-  
27 motional activity do not make up more than 25 percent of the total annual sales of the farm stand;  
28 and

29 (B) The farm stand does not include structures designed for occupancy as a residence or for  
30 activity other than the sale of farm crops or livestock and does not include structures for banquets,  
31 public gatherings or public entertainment.

32 [(s)] **(q)** Alteration, restoration or replacement of a lawfully established dwelling that:

33 (A) Has intact exterior walls and roof structure;

34 (B) Has indoor plumbing consisting of a kitchen sink, toilet and bathing facilities connected to  
35 a sanitary waste disposal system;

36 (C) Has interior wiring for interior lights;

37 (D) Has a heating system; and

38 (E) In the case of replacement:

39 (i) Is removed, demolished or converted to an allowable nonresidential use within three months  
40 of the completion of the replacement dwelling. A replacement dwelling may be sited on any part of  
41 the same lot or parcel. A dwelling established under this paragraph shall comply with all applicable  
42 siting standards. However, the standards shall not be applied in a manner that prohibits the siting  
43 of the dwelling. If the dwelling to be replaced is located on a portion of the lot or parcel not zoned  
44 for exclusive farm use, the applicant, as a condition of approval, shall execute and record in the  
45 deed records for the county where the property is located a deed restriction prohibiting the siting

1 of a dwelling on that portion of the lot or parcel. The restriction imposed shall be irrevocable unless  
 2 a statement of release is placed in the deed records for the county. The release shall be signed by  
 3 the county or its designee and state that the provisions of this paragraph regarding replacement  
 4 dwellings have changed to allow the siting of another dwelling. The county planning director or the  
 5 director's designee shall maintain a record of the lots and parcels that do not qualify for the siting

 32 supporting farm uses. A processing facility shall comply with all applicable siting standards but the

34 [(v)] (t) Fire service facilities providing rural fire protection services.

35 [(w)] (u) Irrigation canals, delivery lines and those structures and accessory operational facili-  
 36 ties associated with a district as defined in ORS 540.505.

37 [(x)] (v) Utility facility service lines. Utility facility service lines are utility lines and accessory  
 38 facilities or structures that end at the point where the utility service is received by the customer  
 39 and that are located on one or more of the following:

40 (A) A public right of way;

41 (B) Land immediately adjacent to a public right of way, provided the written consent of all ad-  
 42 jacent property owners has been obtained; or

43 (C) The property to be served by the utility.

44 [(y)] (w) Subject to the issuance of a license, permit or other approval by the Department of  
 45 Environmental Quality under ORS 454.695, 459.205, 468B.050, 468B.053 or 468B.055, or in compliance

1 with rules adopted under ORS 468B.095, and as provided in ORS 215.246 to 215.251, the land appli-  
 2 cation of reclaimed water, agricultural or industrial process water or biosolids for agricultural,  
 3 horticultural or silvicultural production, or for irrigation in connection with a use allowed in an  
 4 exclusive farm use zone under this chapter.

5 [(z)] (x) A county law enforcement facility that lawfully existed on August 20, 2002, and is used  
 6 to provide rural law enforcement services primarily in rural areas, including parole and post-prison  
 7 supervision, but not including a correctional facility as defined under ORS 162.135.

8 (2) The following nonfarm uses may be established, subject to the approval of the governing body  
 9 or its designee in any area zoned for exclusive farm use subject to ORS 215.296:

10 (a) Commercial activities that are in conjunction with farm use, including the processing of farm  
 11 crops into biofuel not permitted under ORS 215.203 (2)(b)(L) or subsection [(1)(u)] (1)(s) of this sec-  
 12 tion.

13 (b) Operations conducted for:

14 (A) Mining and processing of geothermal resources as defined by ORS 522.005 and oil and gas  
 15 as defined by ORS 520.005 not otherwise permitted under subsection [(1)(g)] (1)(f) of this section;

16 (B) Mining, crushing or stockpiling of aggregate and other mineral and other subsurface re-  
 17 sources subject to ORS 215.298;

18 (C) Processing, as defined by ORS 517.750, of aggregate into asphalt or portland cement; and

19 (D) Processing of other mineral resources and other subsurface resources.

20 (c) Private parks, playgrounds, hunting and fishing preserves and campgrounds. Subject to the  
 21 approval of the county governing body or its designee, a private campground may provide yurts for  
 22 overnight camping. No more than one-third or a maximum of 10 campsites, whichever is smaller,  
 23 may include a yurt. The yurt shall be located on the ground or on a wood floor with no permanent  
 24 foundation. Upon request of a county governing body, the Land Conservation and Development  
 25 Commission may provide by rule for an increase in the number of yurts allowed on all or a portion  
 26 of the campgrounds in a county if the commission determines that the increase will comply with the

 37 income replacement and substance abuse services, only in a facility that is in existence on January  
 38 1, 2006. The services may not include direct delivery of medical, mental health, disability income  
 39 replacement or substance abuse services.

40 (f) Golf courses **on land determined to not be high-value farmland, as defined in ORS**  
 41 **195.300.**

42 (g) Commercial utility facilities for the purpose of generating power for public use by sale.

43 (h) Personal-use airports for airplanes and helicopter pads, including associated hangar, main-  
 44 tenance and service facilities. A personal-use airport, as used in this section, means an airstrip re-  
 45 stricted, except for aircraft emergencies, to use by the owner, and, on an infrequent and occasional

1 basis, by invited guests, and by commercial aviation activities in connection with agricultural op-  
 2 erations. No aircraft may be based on a personal-use airport other than those owned or controlled  
 3 by the owner of the airstrip. Exceptions to the activities permitted under this definition may be  
 4 granted through waiver action by the Oregon Department of Aviation in specific instances. A

30 (p) The propagation, cultivation, maintenance and harvesting of aquatic species that are not  
 31 under the jurisdiction of the State Fish and Wildlife Commission or insect species. Insect species  
 32 shall not include any species under quarantine by the State Department of Agriculture or the United  
 33 States Department of Agriculture. The county shall provide notice of all applications under this  
 34 paragraph to the State Department of Agriculture. Notice shall be provided in accordance with the  
 35 county's land use regulations but shall be mailed at least 20 calendar days prior to any administra-  
 36 tive decision or initial public hearing on the application.

37 (q) Construction of additional passing and travel lanes requiring the acquisition of right of way  
 38 but not resulting in the creation of new land parcels.

39 (r) Reconstruction or modification of public roads and highways involving the removal or dis-  
 40 placement of buildings but not resulting in the creation of new land parcels.

41 (s) Improvement of public road and highway related facilities, such as maintenance yards, weigh  
 42 stations and rest areas, where additional property or right of way is required but not resulting in  
 43 the creation of new land parcels.

44 (t) A destination resort that is approved consistent with the requirements of any statewide  
 45 planning goal relating to the siting of a destination resort.

1 (u) Room and board arrangements for a maximum of five unrelated persons in existing resi-  
2 dences.

3 (v) Operations for the extraction and bottling of water.

4 (w) Expansion of existing county fairgrounds and activities directly relating to county  
5 fairgrounds governed by county fair boards established pursuant to ORS 565.210.

6 (x) A living history museum related to resource based activities owned and operated by a gov-  
7 ernmental agency or a local historical society, together with limited commercial activities and fa-  
8 cilities that are directly related to the use and enjoyment of the museum and located within  
9 authentic buildings of the depicted historic period or the museum administration building, if areas  
10 other than an exclusive farm use zone cannot accommodate the museum and related activities or if  
11 the museum administration buildings and parking lot are located within one quarter mile of an ur-  
12 ban growth boundary. As used in this paragraph:

13 (A) "Living history museum" means a facility designed to depict and interpret everyday life and  
14 culture of some specific historic period using authentic buildings, tools, equipment and people to  
15 simulate past activities and events; and

16 (B) "Local historical society" means the local historical society recognized by the county gov-

18 *[(y) An aerial fireworks display business that has been in continuous operation at its current lo-

21 *[(z)]* (y) A landscape contracting business, as defined in ORS 671.520, or a business providing  
22 landscape architecture services, as described in ORS 671.318, if the business is pursued in conjunc-  
23 tion with the growing and marketing of nursery stock on the land that constitutes farm use.

24 (z) **Public or private schools for kindergarten through grade 12, including all buildings  
25 essential to the operation of a school, primarily for residents of the rural area in which the  
26 school is located.**

27 (3) Roads, highways and other transportation facilities and improvements not allowed under  
28 subsections (1) and (2) of this section may be established, subject to the approval of the governing  
29 body or its designee, in areas zoned for exclusive farm use subject to:

30 (a) Adoption of an exception to the goal related to agricultural lands and to any other applicable  
31 goal with which the facility or improvement does not comply; or

32 (b) ORS 215.296 for those uses identified by rule of the Land Conservation and Development

19 (D) ORS 215.283 (2)(a), (j), (L) or (p) to (s).

20 (3) When a state agency or a local government makes a land use decision relating to the land  
21 application of reclaimed water, agricultural or industrial process water or biosolids under a license,  
22 permit or approval by the Department of Environmental Quality, the applicant shall explain in  
23 writing how alternatives identified in public comments on the land use decision were considered and,  
24 if the alternatives are not used, explain in writing the reasons for not using the alternatives. The  
25 applicant must consider only those alternatives that are identified with sufficient specificity to af-  
26 ford the applicant an adequate opportunity to consider the alternatives. A land use decision relating  
27 to the land application of reclaimed water, agricultural or industrial process water or biosolids may  
28 not be reversed or remanded under this subsection unless the applicant failed to consider identified

45 (5) Uses not allowed under this section include:

1 (a) The establishment and use of facilities, including buildings or equipment, for the treatment  
2 of reclaimed water, agricultural or industrial process water or biosolids other than those treatment  
3 facilities related to the treatment that occurs as a result of the land application; or

4 (b) The establishment and use of utility facility service lines allowed under ORS 215.213  
5 [(1)(aa)] (1)(y) or 215.283 [(1)(x)] (1)(v).

12 215.251. Nothing in ORS 215.213 [(1)(bb)] (1)(z), 215.246 to 215.249 or 215.283 [(1)(y)] (1)(w) af-  
13 fects whether the land application of a substance not described in ORS 215.213 [(1)(bb)] (1)(z),  
14 215.246 to 215.249 or 215.283 [(1)(y)] (1)(w) is a farm use as defined in ORS 215.203.

16 215.263. (1) Any proposed division of land included within an exclusive farm use zone resulting

6 (B) The parcels for the nonfarm dwellings are divided from a lot or parcel that was lawfully  
7 created prior to July 1, 2001;

8 (C) The parcels for the nonfarm dwellings are divided from a lot or parcel that is equal to or  
9 smaller than the minimum size established under ORS 215.780 but equal to or larger than 40 acres;

10 (D) The parcels for the nonfarm dwellings are:

11 (i) Not capable of producing more than at least 50 cubic feet per acre per year of wood fiber;

13 (ii) Composed of at least 90 percent Class VI through VIII soils;

14 (E) The parcels for the nonfarm dwellings do not have established water rights for irrigation;

16 (F) The parcels for the nonfarm dwellings are generally unsuitable for the production of farm

25 (A) The nonfarm dwellings have been approved under ORS 215.284 (7);

26 (B) The parcels for the nonfarm dwellings are divided from a lot or parcel that was lawfully

28 (C) The parcels for the nonfarm dwellings are divided from a lot or parcel that complies with  
29 the minimum size established under ORS 215.780;

32 (E) The parcels for the nonfarm dwellings are generally unsuitable for the production of farm

44 (D) The parcels for the nonfarm dwellings are:

45 (i) Not capable of producing more than at least 20 cubic feet per acre per year of wood fiber;

2 (ii) Either composed of at least 90 percent Class VII and VIII soils, or composed of at least 90  
3 percent Class VI through VIII soils and are not capable of producing adequate herbaceous forage  
4 for grazing livestock. The Land Conservation and Development Commission, in cooperation with the  
5 State Department of Agriculture and other interested persons, may establish by rule objective cri-  
6 teria for identifying units of land that are not capable of producing adequate herbaceous forage for  
7 grazing livestock. In developing the criteria, the commission shall use the latest information from

29 (b) For historic property that meets the requirements of ORS 215.213 [(1)(q)] **(1)(o)** and 215.283

31 (10)(a) Notwithstanding ORS 215.780, the governing body of a county or its designee may ap-  
32 prove a proposed division of land provided:

33 (A) The land division is for the purpose of allowing a provider of public parks or open space,  
34 or a not-for-profit land conservation organization, to purchase at least one of the resulting parcels;

36 (B) A parcel created by the land division that contains a dwelling is large enough to support

23 to provide the service.

24 (2) To demonstrate that a utility facility is necessary, an applicant for approval under ORS  
25 215.213 [(1)(d)] **(1)(c)** or 215.283 [(1)(d)] **(1)(c)** must show that reasonable alternatives have been  
26 considered and that the facility must be sited in an exclusive farm use zone due to one or more of  
27 the following factors:

28 (a) Technical and engineering feasibility;

29 (b) The proposed facility is locationally dependent. A utility facility is locationally dependent if  
30 it must cross land in one or more areas zoned for exclusive farm use in order to achieve a reason-  
31 ably direct route or to meet unique geographical needs that cannot be satisfied on other lands;

32 (c) Lack of available urban and nonresource lands;

33 (d) Availability of existing rights of way;

35 (f) Other requirements of state or federal agencies.

36 (3) Costs associated with any of the factors listed in subsection (2) of this section may be con-

22 215.452. (1) A winery, authorized under ORS 215.213 [(1)(s)] (1)(q) and 215.283 [(1)(q)] (1)(o), is  
23 a facility that produces wine with a maximum annual production of:

24 (a) Less than 50,000 gallons and that:

25 (A) Owns an on-site vineyard of at least 15 acres;

26 (B) Owns a contiguous vineyard of at least 15 acres;

27 (C) Has a long-term contract for the purchase of all of the grapes from at least 15 acres of a  
28 vineyard contiguous to the winery; or

29 (D) Obtains grapes from any combination of subparagraph (A), (B) or (C) of this paragraph; or

30 (b) At least 50,000 gallons and no more than 100,000 gallons and that:

31 (A) Owns an on-site vineyard of at least 40 acres;

32 (B) Owns a contiguous vineyard of at least 40 acres;

33 (C) Has a long-term contract for the purchase of all of the grapes from at least 40 acres of a  
34 vineyard contiguous to the winery; or

35 (D) Obtains grapes from any combination of subparagraph (A), (B) or (C) of this paragraph.

36 (2) The winery described in subsection (1)(a) or (b) of this section shall allow only the sale of:

37 (a) Wines produced in conjunction with the winery; and

38 (b) Items directly related to wine, the sales of which are incidental to retail sale of wine on-site.

39 Such items include those served by a limited service restaurant, as defined in ORS 624.010.

40 (3) Prior to the issuance of a permit to establish a winery under this section, the applicant shall  
41 show that vineyards, described in subsection (1)(a) and (b) of this section, have been planted or that  
42 the contract has been executed, as applicable.

43 (4) A local government shall adopt findings for each of the standards described in paragraphs  
44 (a) and (b) of this subsection. Standards imposed on the siting of a winery shall be limited solely

10 215.780. (1) Except as provided in subsection (2) of this section, the following minimum lot or  
11 parcel sizes apply to all counties:

12 (a) For land zoned for exclusive farm use and not designated rangeland, at least 80 acres;

13 (b) For land zoned for exclusive farm use and designated rangeland, at least 160 acres; and

14 (c) For land designated forestland, at least 80 acres.

15 (2) A county may adopt a lower minimum lot or parcel size than that described in subsection (1)  
16 of this section in any of the following circumstances:

17 (a) By demonstrating to the Land Conservation and Development Commission that it can do so  
18 while continuing to meet the requirements of ORS 215.243 and 527.630 and the land use planning  
19 goals adopted under ORS 197.230.

20 (b) To allow the establishment of a parcel for a dwelling on land zoned for forest use or mixed  
21 farm and forest use, subject to the following requirements:

22 (A) The parcel established shall not be larger than five acres, except as necessary to recognize  
23 physical factors such as roads or streams, in which case the parcel shall be no larger than 10 acres;

24 (B) The dwelling existed prior to June 1, 1995;

25 (C)(i) The remaining parcel, not containing the dwelling, meets the minimum land division stan-  
26 dards of the zone; or

27 (ii) The remaining parcel, not containing the dwelling, is consolidated with another parcel, and  
28 together the parcels meet the minimum land division standards of the zone; and

45 (D) Shall not result in a parcel of less than 35 acres, except:

1 (i) Where the purpose of the land division is to facilitate an exchange of lands involving a gov-  
2 ernmental agency; or

3 (ii) Where the purpose of the land division is to allow transactions in which at least one par-  
4 ticipant is a person with a cumulative ownership of at least 2,000 acres of forestland; and

5 (E) If associated with the creation of a parcel where a dwelling is involved, shall not result in  
6 a parcel less than the minimum lot or parcel size of the zone.

7 (e) To allow a division of a lot or parcel zoned for forest use or mixed farm and forest use under  
8 a statewide planning goal protecting forestland if:

9 (A) At least two dwellings lawfully existed on the lot or parcel prior to November 4, 1993;

10 (B) Each dwelling complies with the criteria for a replacement dwelling under ORS 215.213  
11 [(1)(t)] (1)(r) or 215.283 [(1)(s)] (1)(q);

12 (C) Except for one lot or parcel, each lot or parcel created under this paragraph is between two  
13 and five acres in size;

14 (D) At least one dwelling is located on each lot or parcel created under this paragraph; and

1 (b) A restriction imposed under this subsection shall be irrevocable unless a statement of release  
2 is signed by the county planning director of the county where the property is located indicating that  
3 the comprehensive plan or land use regulations applicable to the property have been changed in  
4 such a manner that the parcel is no longer subject to statewide planning goals pertaining to agri-  
5 cultural land or forestland.

6 (c) The county planning director shall maintain a record of parcels that do not qualify for the  
7 siting of a new dwelling under restrictions imposed by this subsection. The record shall be readily  
8 available to the public.

9 (7) A landowner allowed a land division under subsection (2) of this section shall sign a state-  
10 ment that shall be recorded with the county clerk of the county in which the property is located,  
11 declaring that the landowner and the landowner's successors in interest will not in the future com-  
12 plain about accepted farming or forest practices on nearby lands devoted to farm or forest use.

13 **SECTION 13.** ORS 308A.056 is amended to read:

14 308A.056. (1) As used in ORS 308A.050 to 308A.128, "farm use" means the current employment  
15 of land for the primary purpose of obtaining a profit in money by:

16 (a) Raising, harvesting and selling crops;

17 (b) Feeding, breeding, managing or selling livestock, poultry, fur-bearing animals or honeybees  
18 or the produce thereof;

19 (c) Dairying and selling dairy products;

20 (d) Stabling or training equines, including but not limited to providing riding lessons, training  
21 clinics and schooling shows;

22 (e) Propagating, cultivating, maintaining or harvesting aquatic species and bird and animal  
23 species to the extent allowed by the rules adopted by the State Fish and Wildlife Commission;

24 (f) On-site constructing and maintaining equipment and facilities used for the activities described  
25 in this subsection;

26 (g) Preparing, storing or disposing of, by marketing or otherwise, the products or by-products  
27 raised for human or animal use on land described in this section; or

28 (h) Using land described in this section for any other agricultural or horticultural use or animal  
29 husbandry or any combination thereof.

30 (2) "Farm use" does not include the use of land subject to timber and forestland taxation under  
31 ORS chapter 321, except land used exclusively for growing cultured Christmas trees or land de-  
32 scribed in ORS 321.267 (3) or 321.824 (3) (relating to land used to grow certain hardwood timber,  
33 including hybrid cottonwood).

34 (3) For purposes of this section, land is currently employed for farm use if the land is:

35 (a) Farmland, the operation or use of which is subject to any farm-related government program;

36 (b) Land lying fallow for one year as a normal and regular requirement of good agricultural  
37 husbandry;

38 (c) Land planted in orchards or other perennials, other than land specified in paragraph (d) of  
39 this subsection, prior to maturity;

40 (d) Land not in an exclusive farm use zone that has not been eligible for assessment at special  
41 farm use value in the year prior to planting the current crop and has been planted in orchards,  
42 cultured Christmas trees or vineyards for at least three years;

43 (e) Wasteland, in an exclusive farm use zone, dry or covered with water, neither economically  
44 tillable nor grazeable, lying in or adjacent to and in common ownership with farm use land and that  
45 is not currently being used for any economic farm use;

1 (f) Except for land under a single family dwelling, land under buildings supporting accepted  
2 farming practices, including the processing facilities allowed by ORS 215.213 [(1)(x)] (1)(v) and  
3 215.283 [(1)(u)] (1)(s) and the processing of farm crops into biofuel as commercial activities in con-  
4 junction with farm use under ORS 215.213 (2)(c) and 215.283 (2)(a);

5 (g) Water impoundments lying in or adjacent to and in common ownership with farm use land;

6 (h) Any land constituting a woodlot, not to exceed 20 acres, contiguous to and owned by the  
7 owner of land specially valued for farm use even if the land constituting the woodlot is not utilized  
8 in conjunction with farm use;

9 (i) Land lying idle for no more than one year when the absence of farming activity is the result  
10 of the illness of the farmer or a member of the farmer's immediate family, including injury or  
11 infirmity, regardless of whether the illness results in death;

12 (j) Land described under ORS 321.267 (3) or 321.824 (3) (relating to land used to grow certain  
13 hardwood timber, including hybrid cottonwood);

14 (k) Land used for the primary purpose of obtaining a profit in money by breeding, raising,  
15 kenneling or training greyhounds for racing; or

16 (L) Land used for the processing of farm crops into biofuel, as defined in ORS 315.141, if:

17 (i) Only the crops of the landowner are being processed;

18 (ii) The biofuel from all of the crops purchased for processing into biofuel is used on the farm  
19 of the landowner; or

20 (iii) The landowner is custom processing crops into biofuel from other landowners in the area  
21 for their use or sale.

22 (4) As used in this section:

23 (a) "Accepted farming practice" means a mode of operation that is common to farms of a similar  
24 nature, necessary for the operation of these similar farms to obtain a profit in money and custom-  
25 arily utilized in conjunction with farm use.

26 (b) "Cultured Christmas trees" means trees:

27 (A) Grown on lands used exclusively for that purpose, capable of preparation by intensive cul-  
28 tivation methods such as plowing or turning over the soil;

29 (B) Of a marketable species;

30 (C) Managed to produce trees meeting U.S. No. 2 or better standards for Christmas trees as  
31 specified by the Agricultural Marketing Service of the United States Department of Agriculture; and

32 (D) Evidencing periodic maintenance practices of shearing for Douglas fir and pine species, weed  
33 and brush control and one or more of the following practices:

34 (i) Basal pruning;

35 (ii) Fertilizing;

36 (iii) Insect and disease control;

37 (iv) Stump culture;

38 (v) Soil cultivation; or

39 (vi) Irrigation.

40 **SECTION 14. ORS 215.297 is repealed.**

41 **SECTION 15. The amendments to ORS 215.213 and 215.283 by sections 1 and 2 of this 2009**  
42 **Act apply to uses established on or after the effective date of this 2009 Act.**
