

SENATE AMENDMENTS TO HOUSE BILL 3116

1 On page 1 of the printed bill, line 2, after “ORS” insert “341.601, 341.604,”.
2 After line 4, insert:
3 “**SECTION 1.** ORS 341.601 is amended to read:
4 “341.601. As used in ORS 341.604 to 341.618[,];
5 “(1) ‘District’ means the:
6 “[1] (a) Blue Mountain Community College District, a political subdivision and municipal cor-
7 poration of the state organized pursuant to this chapter; [and]
8 “(b) **Columbia Gorge Community College District, a political subdivision and municipal**
9 **corporation of the state organized pursuant to this chapter;**
10 “[2] (c) Rogue Community College District, a political subdivision and municipal corporation
11 of the state organized pursuant to this chapter[.]; and
12 “(d) **Southwestern Oregon Community College District, a political subdivision and mu-**
13 **nicipal corporation of the state organized pursuant to this chapter.**
14 “(2) ‘Service area’ means:
15 “(a) **For the Blue Mountain Community College District and the Rogue Community Col-**
16 **lege District, a service area established as provided by ORS 341.604.**
17 “(b) **For the Columbia Gorge Community College District and the Southwestern Oregon**
18 **Community College District:**
19 “(A) **The area served by the district when the district first was formed; and**
20 “(B) **The territory within a county annexed by the district.**
21 “**SECTION 2.** ORS 341.604 is amended to read:
22 “341.604. (1) **The Blue Mountain Community College District and the Rogue Community**
23 **College District may expand as provided by this section.**
24 “[1] (2) If expansion of [a district] **the Blue Mountain Community College District or the**
25 **Rogue Community College District** is approved by the voters, the Legislative Assembly shall:
26 “(a) **For the Blue Mountain Community College District, classify and designate service**
27 **areas within the district. The boundaries of the service areas shall be coterminous with the**
28 **boundaries of the counties within the district.**
29 “[a] (b) For the Rogue Community College District, initially classify and designate two service
30 areas within the district. The first service area shall be coterminous with the boundaries of Jackson
31 County or such portion thereof as is included in the expanded district approved by the voters. The
32 second service area shall be coterminous with the boundaries of Josephine County.
33 “[b] *For the Blue Mountain Community College District, classify and designate service areas*
34 *within the district. The boundaries of the service areas shall be coterminous with the boundaries of the*
35 *counties within the district.]*

1 “[(2)] (3) [Thereafter,] The district board **of the Blue Mountain Community College District**
2 **or the Rogue Community College District** by resolution may designate as additional service areas
3 any territory or territories within the district that are benefited by the acquisition, construction and
4 installation of community college facilities. Each additional service area designated by the district
5 board shall be located entirely within the territory of a service area designated in subsection [(1)]
6 (2) of this section. In no event shall the district board designate as a service area any portion of
7 the district incorporating territory located within two or more service areas designated in sub-
8 section [(1)] (2) of this section.

9 “[(3)] (4) The district board may not amend the boundaries of the service areas designated in
10 subsection [(1)] (2) of this section. The district board may by resolution amend the boundaries of any
11 additional service area designated pursuant to subsection [(2)] (3) of this section to conform to
12 changes in the community college services provided by the district. However, the boundaries of a
13 service area may not be amended if bonded indebtedness issued pursuant to ORS 341.611 or any
14 other indebtedness for the benefit of such service area is then outstanding.”.
