

## HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 3225

- 1 On page 1 of the printed A-engrossed bill, line 3, delete “5.”
- 2 In line 6, after “5,” insert “5a.”
- 3 On page 2, delete lines 28 through 37 and insert:
- 4 **“SECTION 4. (1) Notwithstanding the requirement in sections 5 (1) and 6 (6), chapter 424,**
- 5 **Oregon Laws 2007, that the property be located entirely outside any urban growth boundary**
- 6 **and entirely outside the boundaries of any city, a claimant is eligible to pursue relief under**
- 7 **this section if:**
- 8 **“(a) A majority, but not all, of the property described in the claim is outside an urban**
- 9 **growth boundary; and**
- 10 **“(b) The claimant filed a valid claim with the state for just compensation under ORS**
- 11 **195.305.**
- 12 **“(2) A claimant described in subsection (1) of this section is eligible to pursue relief under**
- 13 **this section and section 6, chapter 424, Oregon Laws 2007.**
- 14 **“(3) The Department of Land Conservation and Development shall review claims under**
- 15 **this section using the procedures established pursuant to section 6 of this 2009 Act.”.**
- 16 In line 42, delete the second “section” and insert “sections”.
- 17 In line 43, delete “6,” and insert “5 to 11.”
- 18 On page 3, after line 2, insert:
- 19 **“SECTION 5a. Notwithstanding the requirement in section 5, chapter 424, Oregon Laws**
- 20 **2007, that the property described in the claim be located entirely outside any urban growth**
- 21 **boundary and entirely outside the boundaries of any city for the claimant to be entitled to**
- 22 **just compensation under section 6 or 7, chapter 424, Oregon Laws 2007, a claimant is eligible**
- 23 **to pursue relief under section 6, chapter 424, Oregon Laws 2007, if the property described in**
- 24 **the claim is within the boundaries of a city, but entirely outside any urban growth**
- 25 **boundary.”.**
- 26 In line 4, delete “procedure” and insert “procedures” and delete “5” and insert “5a”.
- 27 In line 7, delete “5” and insert “5a”.
- 28 Delete lines 20 through 33 and insert:
- 29 **“NOTE: Section 10 was deleted by amendment. Subsequent sections were not renumbered.”.**
- 30 Delete line 43.
- 31 In line 44, delete the period and insert “; or”.
- 32 After line 44, insert:
- 33 **“(F) Section 5a of this 2009 Act and section 11, chapter 424, Oregon Laws 2007, are met.”.**
- 34 On page 4, line 1, delete “5” and insert “5a”.
- 35 In line 19, delete “5” and insert “5a”.

- 1 On page 11, line 38, delete "5" and insert "5a".
- 2 On page 12, line 13, delete "5" and insert "5a".
