

# B-Engrossed House Bill 3300

Ordered by the House June 12  
Including House Amendments dated April 30 and June 12

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Instructs State Workforce Investment Board to develop plan for initiative to promote growth of green jobs. Requires plan to identify high demand green industries and promote certain workforce development activities to promote growth of green jobs. Requires board to define terms related to green jobs and green economy. Mandates submission of final plan to Legislative Assembly by January 14, 2010.

Requires Economic and Community Development Department to develop criteria for and make recommendations about promoting green industries, technology and innovation.

**Specifies means by which costs associated with Act must be paid.**

Declares emergency, effective on passage.

## A BILL FOR AN ACT

2 Relating to the green economy; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. Sections 2 to 6 of this 2009 Act are added to and made a part of ORS 660.300**  
5 **to 660.339.**

6 **SECTION 2. As used in sections 2 to 6 of this 2009 Act:**

7 (1) "Green job" means a job that provides a service or produces a product that:

8 (a) Increases energy efficiency;

9 (b) Produces renewable energy;

10 (c) Prevents, reduces or mitigates environmental degradation;

11 (d) Cleans up and restores the natural environment; or

12 (e) Provides education, consultation, policy promotion, accreditation, trading and offsets  
13 or similar supporting services for any of the activities identified in this subsection.

14 (2) "Targeted population" means:

15 (a) Entry level or similar workers in high demand green job careers who are in or pre-  
16 paring for high wage green jobs;

17 (b) Dislocated workers in declining industries who are in or are seeking training for high  
18 wage green jobs;

19 (c) Dislocated workers in the timber, agricultural or energy sectors who are in or are  
20 seeking training for high wage green jobs;

21 (d) Veterans who are residents of Oregon or members of the Oregon National Guard; or

22 (e) Members of disadvantaged groups.

23 **SECTION 3. (1) The State Workforce Investment Board, in consultation with the Gover-**

1 nor, the Education and Workforce Policy Advisor and other parties deemed appropriate by  
2 the board and after consideration of the clean energy and energy efficiency policies of this  
3 state, shall develop a plan for a green jobs growth initiative to promote the development of  
4 emerging technologies and innovations that lead to, create or sustain family wage green jobs.

5 (2) The plan for the initiative developed by the board shall:

6 (a) Identify industries that are high demand green industries based on current and  
7 projected creation of family wage green jobs and the potential for career pathways created  
8 for such jobs.

9 (b) Use the needs of identified high demand green industries as the basis for the planning  
10 of workforce development activities that promote the development of emerging green tech-  
11 nologies and innovations. These activities include, but are not limited to, such efforts  
12 undertaken by community colleges, the institutions of the Oregon University System, desig-  
13 nated signature research centers, registered apprenticeship programs and other private  
14 sector training programs.

15 (c) Leverage and align existing public workforce development programs and other public  
16 and private resources to the goal of recruiting, supporting, educating and training of tar-  
17 geted populations of workers.

18 (d) Require the board to work collaboratively with stakeholders from business, labor and  
19 low income advocacy groups in the regional economy to develop and implement the initiative.

20 (e) Link adult basic and remedial education programs with job training for skills neces-  
21 sary for green jobs.

22 (f) Require the board to collaborate with employers and labor organizations to identify  
23 skills and competencies necessary for green job career pathways.

24 (g) Ensure that support services are integrated with education and training for green  
25 jobs and that such services are provided by organizations with direct access to and experi-  
26 ence with targeted populations.

27 **SECTION 4.** The State Workforce Investment Board, in consultation with state agencies,  
28 boards, commissions and private entities deemed appropriate by the State Workforce In-  
29 vestment Board shall develop a list of defined terms related to green jobs and the green  
30 economy that are consistent with current workforce development and economic development  
31 terminology.

32 **SECTION 5.** (1) The State Workforce Investment Board shall submit the final plan for  
33 the green jobs growth initiative required under section 3 of this 2009 Act in the manner  
34 provided in ORS 192.245 by January 14, 2010.

35 (2)(a) The plan submitted in accordance with this section shall also be submitted to the  
36 appropriate interim committees of the Legislative Assembly.

37 (b) In addition to providing the final plan, the board shall also submit progress reports  
38 on the development of the plan as requested by the interim committees.

39 **SECTION 6.** The Economic and Community Development Department, in consultation  
40 with the State Workforce Investment Board, shall:

41 (1) Develop criteria for existing investments and new or expanded financial incentives and  
42 comprehensive strategies to recruit, retain and expand green economy industries and small  
43 businesses.

44 (2) Make recommendations for new or expanded financial incentives and comprehensive  
45 strategies to stimulate research and development of green technology and innovation.

1        **SECTION 7.** The payment of costs associated with sections 2 to 6 of this 2009 Act is the  
2 responsibility of the Office of the Governor and those costs shall be paid from moneys  
3 available for disbursement at the direction of the Governor.

4        **SECTION 8.** The Legislative Assembly finds that the development of green jobs is essen-  
5 tial to the economic well-being of Oregonians and encourages the Governor to support clean  
6 technology and efforts to prepare workers for employment in green jobs.

7        **SECTION 9.** This 2009 Act being necessary for the immediate preservation of the public  
8 peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect  
9 on its passage.
