SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

Creates process by which Water Resources Department may loan or grant moneys to enable construction of water development projects located in Columbia River Basin. Specifies applicants that [qualify to receive certain loans or grants] must apply for loan under new process. Specifies procedures for applying for loan or grant. Specifies guidelines for evaluating applications.

Authorizes department to issue grant for critical ground water storage project located in Umatilla Basin that meets specified conditions.

Modifies provisions related to financing water development projects. [Authorizes State Treasurer, for specified biennia, to issue Article XI-I(1) bonds. Directs State Treasurer to credit net proceeds of bonds to Water Development Fund. Authorizes department to use moneys in fund to make loans to water developers that propose projects that qualify to receive Article XI-I(1) funds.]

Establishes Water Resources Investment Fund and Water Resources Grant Fund. Authorizes State Treasurer, for biennium beginning July 1, 2009, to issue lottery bonds. Directs State Treasurer to de-posit specified amount of bond proceeds in each fund. Continuously appropriates moneys in Water Re-sources Investment Fund to department for purpose of making loans to persons other than water developers or to water developers that propose projects that do not qualify to receive Article XI-I(1) funds and for purpose of funding integrated strategy for implementing state water resources policy. Continuously appropriates moneys in Water Resources Grant Fund to department for purpose of making grants.]

Requires certain moneys to be deposited in Water Conservation, Reuse and Storage Investment Fund.]

Establishes Water Investment Grant Fund. Continuously appropriates moneys in fund to department for purpose of operating Columbia River Basin grant program. Declares emergency, effective July 1, 2009.

INTEGRATED WATER RESOURCES STRATEGY

39 SECTION 44. ORS 536.220 is amended to read:

40 536.220. (1) The Legislative Assembly recognizes and declares that:

(a) The maintenance of the present level of the economic and general welfare of the people of
this state and the future growth and development of this state for the increased economic and general welfare of the people thereof are in large part dependent upon a proper utilization and control
of the water resources of this state, and such use and control is therefore a matter of greatest
concern and highest priority.

(b) A proper utilization and control of the water resources of this state can be achieved only 1 2 through a coordinated, integrated state water resources policy, through plans and programs for the development of such water resources and through other activities designed to encourage, promote 3 and secure the maximum beneficial use and control of such water resources, all carried out by a 4 single state agency. 5

(c) The economic and general welfare of the people of this state have been seriously impaired 6 7 and are in danger of further impairment by the exercise of some single-purpose power or influence over the water resources of this state or portions thereof by each of a large number of public au-8 9 thorities, and by an equally large number of legislative declarations by statute of single-purpose policies with regard to such water resources, resulting in friction and duplication of activity among 10 such public authorities, in confusion as to what is primary and what is secondary beneficial use or 11 12 control of such water resources and in a consequent failure to utilize and control such water re-13 sources for multiple purposes for the maximum beneficial use and control possible and necessary.

(2) The Legislative Assembly, therefore, finds that: 14

15 (a) It is in the interest of the public welfare that a coordinated, integrated state water resources policy be formulated and means provided for its enforcement, that plans and programs for the de-16 17 velopment and enlargement of the water resources of this state be devised and promoted and that 18 other activities designed to encourage, promote and secure the maximum beneficial use and control 19 of such water resources and the development of additional water supplies be carried out by a single 20state agency which, in carrying out its functions, shall give proper and adequate consideration to the multiple aspects of the beneficial use and control of such water resources with an impartiality 2122of interest except that designed to best protect and promote the public welfare generally.

(b) The state water resources policy shall be consistent with the goal set forth in ORS 468B.155. (3)(a) The Water Resources Department shall develop an integrated state water re-24 sources strategy to implement the state water resources policy specified in subsection (2) 25of this section. The department shall design the strategy to meet Oregon's in-stream and 2627out-of-stream water needs.

(b) The Water Resources Department shall work in close cooperation with the Depart-28ment of Environmental Quality and the State Department of Fish and Wildlife to develop the 2930 integrated state water resources strategy in consultation with other state, local and federal 31 agencies, with other states, with Indian tribes, with stakeholders and with the public.

(c) The Water Resources Department, in close cooperation with the Department of En-32vironmental Quality and the State Department of Fish and Wildlife, shall develop data on an 33 34 ongoing basis to forecast Oregon's in-stream and out-of-stream water needs, including but not limited to in-stream, underground water, human consumption and water supply needs, 35 for the purpose of developing and updating the integrated state water resources strategy. 36

(d) The integrated water resources strategy shall describe the following:

38 (A) Oregon's in-stream and out-of-stream water needs, including but not limited to ecosystem services, water quality and water supply needs. 39

40 (B) Objectives of the strategy.

(C) Actions that are designed to achieve the objectives of the strategy. 41

(D) Plans related to the challenges presented by climate change. 42

(E) Provisions to ensure communication and partnership with key stakeholders. 43

(F) Specific functions and roles to be played by state agencies, including but not limited 44 to the State Department of Agriculture, the State Forestry Department, the Department of 45

Human Services, the Economic and Community Development Department, the Department 1 of Land Conservation and Development, the Oregon Watershed Enhancement Board, the 2 State Parks and Recreation Department, the Department of State Lands and other relevant 3 state agencies.

(G) Public policy options and recommendations.

(H) Relevant strategy factors, including but not limited to population growth and land 6 7 use change.

(I) Recommendations of the Water Resources Department regarding the continuous 8 9 monitoring of climate change effects on Oregon's water supply and regarding water user 10 actions that are necessary to address climate change.

(e)(A) The Water Resources Commission shall give the Environmental Quality Commis-11 12sion, the State Department of Agriculture and the State Department of Fish and Wildlife 13 notice of the integrated state water resources strategy prior to adoption of the strategy. The strategy shall take effect upon adoption by the Water Resources Commission. 14

15 (B) The Water Resources Commission shall review and update the integrated state water resources strategy every five years. The Water Resources Commission shall give notice to 16 the Environmental Quality Commission, the State Department of Agriculture and the State 17 Department of Fish and Wildlife prior to adopting any revisions of the strategy. Revisions 18 of the strategy shall take effect upon the Water Resources Commission's adoption of the 19 20revised strategy by reference in rule.

(4) This section does not limit the authority granted the Environmental Quality Com-2122mission or the Department of Environmental Quality under ORS chapter 468B.

23SECTION 45. (1) The Water Resources Department shall, working in close cooperation with the Department of Environmental Quality, the State Department of Agriculture and the 24State Department of Fish and Wildlife, submit a report by February 1, 2011, to the Seventy-25sixth Legislative Assembly, in the manner provided in ORS 192.245, detailing benchmarks and 2627progress toward the development of the integrated state water resources strategy. The report must include a discussion of whether the Water Resources Department expects to 28complete development of the strategy by December 31, 2012. 29

30 (2) As part of the report specified in subsection (1) of this section, the Water Resources 31 Department, working in close cooperation with the Department of Environmental Quality, the State Department of Fish and Wildlife and other state agencies, may identify legislative 32amendments and submit budget recommendations, including but not limited to requests for 33 34 a long-term, dedicated funding source to implement the integrated state water resources 35 strategy.
