SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies definition of "child care facility" [to include preschool facility and delete provision re-garding number of hours of care provided per day.] and creates definitions for "preschool re-corded program" and "record" for purposes related to regulation of child care facilities. Creates provisions relating to operation and regulation of preschool recorded programs, including procedure by which preschool recorded program may obtain recording. Imposes maximum civil penalty of \$100 on person who violates specified provision.

5	SECTION 1. ORS 657A.250 is amended to read:
6	657A.250. As used in ORS 657A.030 and 657A.250 to 657A.450, unless the context requires oth-
7	erwise:
8	(1) "Babysitter" means a person who goes into the home of a child to give care during the
9	temporary absence of the parent or legal guardian or custodian.
10	(2) "Certification" means the certification that is issued under ORS 657A.280 by the Child Care
11	Division to a family child care home, child care center or other child care facility.
12	(3) "Child" means a child under 13 years of age or a child under 18 years of age who has special
13	needs or disabilities and requires a level of care that is above normal for the child's age.
14	(4) Subject to ORS 657A.440, "child care" means the care, supervision and guidance on a regular
15	basis of a child, unaccompanied by a parent, guardian or custodian, provided to a child during a part
16	of the 24 hours of the day, in a place other than the child's home, with or without compensation.
17	"Child care" does not include care provided:
18	(a) In the home of the child;
19	(b) By the child's parent, guardian, or person acting in loco parentis;
20	(c) By a person related to the child by blood or marriage within the fourth degree as determined
21	by civil law;
22	(d) On an occasional basis by a person not ordinarily engaged in providing child care;
23	(e) By providers of medical services;

(f) By a babysitter; 1 2 (g) By a person who cares for children from only one family other than the person's own family; (h) By a person who cares for no more than three children other than the person's own children; 3 4 or $\mathbf{5}$ (i) By a person who is a member of the child's extended family, as determined by the division on a case-by-case basis. 6 (5) "Child care facility" means any facility that provides child care to children, including a day 7 nursery, nursery school, child care center, certified or registered family child care home or similar 8 9 unit operating under any name, but not including any: (a) [Facility providing care that is primarily educational, unless provided to a preschool child for 10 more than four hours a day] Preschool recorded program. 11 12 (b) Facility providing care for school-age children that is primarily [supervised training in a 13 specific subject, including but not limited to dancing, drama, music or religion.] a single enrichment activity, for eight hours or less a week. 14 15 (c) Facility providing care that is primarily [an incident of] group athletic or social activities sponsored by or under the supervision of an organized club or hobby group. 16 17 (d) Facility operated by: 18 (A) A school district as defined in ORS 332.002; (B) A political subdivision of this state; or 19 (C) A governmental agency. 20(e) Residential facility licensed under ORS 443.400 to 443.455. 21(f) Babysitters. 22(g) Facility operated as a parent cooperative for no more than four hours a day. 23(h) Facility providing care while the child's parent remains on the premises and is engaged in 24 an activity offered by the facility or in other nonwork activity. 25(6) "Division" means the Child Care Division of the Employment Department. 2627(7) "Family" has the meaning given that term in ORS 329.145. (8) "Occasional" means that care is provided for no more than 70 days in any calendar year. 28(9) "Parent cooperative" means a child care program in which: 2930 (a) Care is provided by parents on a rotating basis; 31 (b) Membership in the cooperative includes parents; (c) There are written policies and procedures; and 32(d) A board of directors that includes parents of the children cared for by the cooperative con-33 34 trols the policies and procedures of the program. (10) "Preschool recorded program" means a facility providing care for preschool children 35 that is primarily educational for four hours or less per day and where no child is present at 36 37 the facility for more than four hours per day. 38 (11) "Record" means the record that is issued under section 4 of this 2009 Act to a preschool recorded program. 39 40 [(10)] (12) "Registration" means the registration that is issued under ORS 657A.330 by the Child Care Division to a family child care home where care is provided in the family living quarters of 41 the provider's home. 42 [(11)] (13) "School age" means of an age eligible to be enrolled in the first grade or above and, 43 during the months of summer vacation from school, means of an age eligible to be enrolled in first 44 grade or above in the next school year. 45

SECTION 2. ORS 657A.275 is amended to read: 1 2 657A.275. (1) A person operating a preschool recorded program may not operate the 27program without performing criminal background checks for all staff and volunteers and 28becoming recorded with the Child Care Division of the Employment Department as provided 2930 in this section. 31 (2) To obtain recording, the person must apply to the division by submitting a completed record application form and a nonrefundable fee as established by the division. The division 32shall determine and apply the fee through rules adopted by the division under ORS 657A.275. 33 34 The division shall deposit fees received under this subsection as provided in ORS 657A.310 (2). 35 (3) The division shall issue a record to a person operating a preschool recorded program if the division determines that the applicant meets the requirements of ORS 657A.250 to 36 37 657A.450 and the rules adopted pursuant to ORS 657A.250 to 657A.450 and subsection (9) of 38 this section. (4) Unless the record is revoked as provided in subsection (8) of this section, the record 39 is valid for a period of two years from the date of issuance. 40 (5) A record authorizes operation of the preschool recorded program only on the prem-41 ises described in the record and only by the person named in the record. 42 (6) The division shall create and maintain a database of preschool recorded programs 43 recorded under this section and shall update the database annually. 3 (c) Significant program information, as determined by the division by rule.

4 (7) A preschool recorded program recorded under this section must post, and provide 5 parents with, a notice that the preschool recorded program is not certified under ORS 6 657A.280 or registered under ORS 657A.330.

(8) An initial application or renewal application for recording of a preschool recorded
 program may be denied, revoked or suspended, if the division finds:

9 (a) That the program or its operation does not comply with ORS 657A.250 to 657A.450, 10 with applicable rules and with any term or condition imposed under the record; or

(b) That visitation, on-site investigation or inspection of a program or its records au thorized by ORS 657A.390 has not been permitted.

(9) The division shall adopt any rules necessary to carry out the provisions of this sec tion.

(10) A person who violates any provision of this section or any term or condition of a
 record is subject to a civil penalty not to exceed \$100.

(1) Whenever an authorized representative of the Child Care Division is advised or 19 has reason to believe that child care that is subject to regulation by the division is being provided 20 without a certification, [or] registration **or record**, the authorized representative may visit and 21 conduct an on-site investigation of the premises of the facility at any reasonable time to determine 22 whether the facility is subject to the requirements of ORS 181.537, 657A.030 and 657A.250 to 23 657A.450.

(2) At any reasonable time, an authorized representative of the Child Care Division may conduct
an on-site investigation of the premises of any certified or registered child care facility to determine
whether the child care facility is in conformity with ORS 181.537, 657A.030 and 657A.250 to 657A.450
and the rules promulgated pursuant to ORS 181.534, 181.537, 657A.030 and 657A.250 to 657A.450.

(3) An authorized representative of the Child Care Division shall conduct an on-site investigation of the premises of any certified or registered child care facility or of any other child care facility that is subject to regulation by the division if the division receives a serious complaint about the child care facility. The division, by rule, shall adopt a definition for "serious complaint."

(4) Any state agency that receives a complaint about a certified or registered child care facility
 or a preschool recorded program shall notify the Child Care Division about the complaint and any
 subsequent action taken by the state agency based on that complaint.

(5) The director and operator of a child care facility or a preschool recorded program shall
 permit an authorized representative of the division to inspect records of the facility or program and
 shall furnish promptly reports and information required by the division.

at variance with the explanation given of the injury.

(B) Any mental injury to a child, which shall include only observable and substantial impairment
 of the child's mental or psychological ability to function caused by cruelty to the child, with due
