House Bill 3496

Sponsored by Representative D EDWARDS

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Exempts requirement that health insurance cover nonprescription elemental enteral formula for treatment of severe intestinal malabsorption from automatic six-year sunset provision.

A BILL FOR AN ACT

11 (2) The coverage required by subsection (1) of this section may be made subject to provisions 12 of the policy that apply to other benefits under the policy including, but not limited to, provisions 13 related to deductibles and coinsurance. Deductibles and coinsurance for elemental enteral formulas 14 shall be no greater than those for any other treatment for the condition under the policy.
