

House Bill 5008

Ordered printed by the Speaker pursuant to House Rule 12.00A (5). Pre-session filed (at the request of Budget and Management Division, Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Economic and Community Development Department for Oregon Arts Commission.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department for certain purposes.

Limits biennial expenditures by department from lottery moneys for certain purposes.

Limits biennial expenditures by department from federal funds for certain purposes.

Authorizes certain nonlimited expenditures.

Declares emergency, effective July 1, 2009.

A BILL FOR AN ACT

Relating to financial administration of the Economic and Community Development Department; appropriating money; limiting expenditures; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. There is appropriated to the Economic and Community Development Department, for the biennium beginning July 1, 2009, out of the General Fund, the amount of \$5,431,047 for the Oregon Arts Commission.

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2009, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Economic and Community Development Department, for the following purposes:

- (1) Business, Innovation, and Trade \$ 5,327,784
- (2) Infrastructure Financing \$ 42,668,152
- (3) Shared Services..... \$ 1,456,233
- (4) Arts and Cultural Trust \$ 6,379,049
- (5) Debt Service..... \$ 3,263,782

SECTION 3. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2009, as the maximum limits for payment of expenses from lottery moneys allocated from the Administrative Services Economic Development Fund to the Economic and Community Development Department, for the following purposes:

- (1) Business, Innovation, and Trade \$ 49,839,783
- (2) Infrastructure Financing \$ 125,981
- (3) Shared Services..... \$ 7,901,233
- (4) Oregon Film and Video Office .. \$ 1,267,582
- (5) Debt Service (pass through) \$ 69,314,146

Note: For budget, see 2009-2011 Biennial Budget

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

SECTION 4. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2009, as the maximum limits for payment of expenses from federal funds collected or received by the Economic and Community Development Department, for the following purposes:

- (1) Business, Innovation, and Trade \$ 820,000
- (2) Infrastructure Financing..... \$ 24,527,249
- (3) Arts..... \$ 1,793,447

SECTION 5. For the biennium beginning July 1, 2009, expenditures by the Economic and Community Development Department are not limited for:

- (1) Loans from the following funds:
 - (a) Marine Navigation Improvement Fund ORS 777.267
 - (b) Oregon Business Development Fund..... ORS 285B.092
 - (c) Oregon Entrepreneurial Development Loan Fund..... ORS 285B.758
 - (d) Oregon Port Revolving Fund ORS 285A.708
 - (e) Safe Drinking Water Revolving Loan Fund ORS 285A.213
 - (f) Special Public Works Fund..... ORS 285B.455
 - (g) Water Fund..... ORS 285B.563
 - (h) Credit Enhancement Fund..... ORS 285B.215
 - (i) Brownfields Redevelopment Fund..... ORS 285A.188
- (2) Debt service.

SECTION 6. This 2009 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect July 1, 2009.
