SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Emergency Board for allocations during biennium.
Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to state financial administration of the Emergency Board; appropriating money; and de-
3 claring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. In addition to and not in lieu of any other appropriation, there is appropri-**
6 **ated to the Emergency Board, for the biennium beginning July 1, 2009, out of the General**
7 **Fund, the amount of \$30,000,000 for the purposes for which the Emergency Board lawfully**
8 **may allocate funds.**

9 **SECTION 2. (1) In addition to and not in lieu of any other appropriation, there is appro-**
10 **priated to the Emergency Board, for the biennium beginning July 1, 2009, out of the General**
11 **Fund, the amount of \$5,100,000, to be allocated to state agencies for state employee com-**
12 **ensation changes for the biennium beginning July 1, 2009.**

13 **(2) If any of the moneys appropriated by subsection (1) of this section are not allocated**
14 **by the Emergency Board prior to December 1, 2010, the moneys remaining on that date be-**
15 **come available for any purpose for which the Emergency Board lawfully may allocate funds.**

16 **SECTION 3. (1) In addition to and not in lieu of any other appropriation, there is appro-**
17 **priated to the Emergency Board, for the biennium beginning July 1, 2009, out of the General**
18 **Fund, the amount of \$5,119,084, to be allocated to the State Forestry Department to pay for**
19 **fire insurance premium costs and severity resources.**

20 **(2) If any of the moneys appropriated by subsection (1) of this section are not allocated**
21 **by the Emergency Board prior to December 1, 2010, the moneys remaining on that date be-**
22 **come available for any purpose for which the Emergency Board lawfully may allocate funds.**

23 **SECTION 4. This 2009 Act being necessary for the immediate preservation of the public**
24 **peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect**
25 **on its passage.**
