

HOUSE AMENDMENTS TO HOUSE BILL 5015

By JOINT COMMITTEE ON WAYS AND MEANS

1 In line 2 of the printed bill, delete “limiting expenditures;”.

2 Delete lines 5 through 18 and insert:

3 **“SECTION 1. (1) Notwithstanding any other provision of law, the General Fund appro-**
4 **priation made to the Legislative Administration Committee by section 1 (1), chapter 762,**
5 **Oregon Laws 2007, for the biennium ending June 30, 2009, is decreased by \$165,615.**

6 **“(2) Notwithstanding any other provision of law, the General Fund appropriation made**
7 **to the Legislative Administration Committee by section 23, chapter 860, Oregon Laws 2007,**
8 **for the biennium ending June 30, 2009, is decreased by \$150,000.**

9 **“(3) Notwithstanding any other provision of law, the General Fund appropriation made**
10 **to the Legislative Administration Committee by section 3, chapter 832, Oregon Laws 2007, for**
11 **the biennium ending June 30, 2009, is decreased by \$23,000.**

12 **“(4) Notwithstanding any other provision of law, the General Fund appropriation made**
13 **to the Legislative Administration Committee by section 37 (1), chapter 910, Oregon Laws**
14 **2007, for the biennium ending June 30, 2009, is decreased by \$210,812.**

15 **“(5) Notwithstanding any other provision of law, the General Fund appropriation made**
16 **to the Legislative Administration Committee by section 1 (2), chapter 762, Oregon Laws 2007,**
17 **for the biennium ending June 30, 2009, is decreased by \$277,564.**

18 **“(6) Notwithstanding any other provision of law, the General Fund appropriation made**
19 **to the Legislative Assembly by section 5 (1), chapter 762, Oregon Laws 2007, for the biennium**
20 **ending June 30, 2009, is decreased by \$2,237,159.**

21 **“(7) Notwithstanding any other provision of law, the General Fund appropriation made**
22 **to the Legislative Assembly by section 4, chapter 762, Oregon Laws 2007, for the biennium**
23 **ending June 30, 2009, is decreased by \$466,955.**

24 **“(8) Notwithstanding any other provision of law, the General Fund appropriation made**
25 **to the Legislative Counsel Committee by section 9, chapter 762, Oregon Laws 2007, for the**
26 **biennium ending June 30, 2009, is decreased by \$428,108.**

27 **“(9) Notwithstanding any other provision of law, the General Fund appropriation made**
28 **to the Legislative Fiscal Officer by section 13, chapter 762, Oregon Laws 2007, for the**
29 **biennium ending June 30, 2009, is decreased by \$297,000.**

30 **“(10) Notwithstanding any other provision of law, the General Fund appropriation made**
31 **to the Legislative Revenue Officer by section 14, chapter 762, Oregon Laws 2007, for the**
32 **biennium ending June 30, 2009, is decreased by \$49,902.**

33 **“SECTION 2. This 2009 Act being necessary for the immediate preservation of the public**
34 **peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect**
35 **on its passage.”.**
