SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to State Department of Geology and Mineral Industries for biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and specified federal funds, but excluding lottery funds and other federal funds, collected or received by department.

Limits biennial expenditures by department from other federal funds **and from lottery moneys allocated from Parks and Natural Resources Fund to department for purposes related to section 4 (10), Article XV of Oregon Constitution.**

Declares emergency, effective July 1, 2009.

A BILL FOR AN ACT

2 Relating to financial administration of the State Department of Geology and Mineral Industries;
3 appropriating money; limiting expenditures; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There is appropriated to the State Department of Geology and Mineral In-**
6 **dustry, for the biennium beginning July 1, 2009, out of the General Fund, the amount of**
7 **\$3,058,414 for operations of the department.**

8 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**
9 **\$6,962,582 is established for the biennium beginning July 1, 2009, as the maximum limit for**
10 **payment of expenses from fees, moneys or other revenues, including federal funds for con-**
11 **tract services and Miscellaneous Receipts, but excluding lottery funds and federal funds not**
12 **described in this section, collected or received by the State Department of Geology and**
13 **Mineral Industries.**

14 **SECTION 3. Notwithstanding any other law limiting expenditures, the amount of**
15 **\$2,423,652 is established for the biennium beginning July 1, 2009, as the maximum limit for**
16 **payment of expenses from federal funds other than those described in section 2 of this 2009**
17 **Act, collected or received by the State Department of Geology and Mineral Industries.**

18 **SECTION 4. Notwithstanding any other law limiting expenditures, the amount of \$500,000**
19 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
20 **expenses from lottery moneys allocated from the Parks and Natural Resources Fund to the**
21 **State Department of Geology and Mineral Industries for activities and projects to implement**
22 **section 4 (10), Article XV of the Oregon Constitution.**

23 **SECTION 5. This 2009 Act being necessary for the immediate preservation of the public**
