SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Legislative Administration Committee, Legislative Assembly, Legislative Counsel Committee, Legislative Fiscal Officer, Legislative Revenue Officer and Commission on Indian Services for biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by certain legislative branch agencies.

Transfers to Emergency Board, on July 1, 2009, moneys remaining from certain previous appropriations made to Legislative Assembly.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2009.

A BILL FOR AN ACT

2 Relating to financial administration of legislative branch agencies; appropriating money; limiting
3 expenditures; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There are appropriated to the Legislative Administration Committee, for the**
6 **biennium beginning July 1, 2009, out of the General Fund, the following amounts for payment**
7 **of the expenses of the Legislative Administration Committee for the following purposes:**

8 (1) General program..... \$ 19,708,894

9 (2) Debt service \$ 5,766,596

10 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**
11 **\$4,575,874 is established for the biennium beginning July 1, 2009, as the maximum limit for**
12 **payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,**
13 **but excluding lottery funds and federal funds, collected or received by the Legislative Ad-**
14 **ministration Committee.**

15 **SECTION 3. For the biennium beginning July 1, 2009, expenditures by the Legislative**
16 **Administration Committee from the Stores Revolving Account and the Property and Supplies**
17 **Stores Account established by ORS 173.790 are not limited.**

18 **SECTION 4. There is appropriated to the Legislative Assembly, for the biennium begin-**
19 **ning July 1, 2009, out of the General Fund, the amount of \$10,258,085 for payment of the ex-**
20 **penses of the following offices:**

21 (1) The offices of the President of the Senate and the Speaker of the House of Repre-
22 sentatives;

23 (2) The majority and minority offices of the Senate and of the House of Representatives;

2 (3) The offices of the Secretary of the Senate and the Chief Clerk of the House of Rep-
3 resentatives.

4 SECTION 5. (1) There is appropriated to the Legislative Assembly, for the biennium be-
5 ginning July 1, 2009, out of the General Fund, the amount of \$15,449,172 for payment of the
6 expenses of members of the Seventy-fifth Legislative Assembly of the State of Oregon.

7 (2) There is appropriated to the Legislative Assembly, for the biennium beginning July
8 1, 2009, out of the General Fund, the amount of \$7,226,709 for payment of the expenses of
9 members of the Seventy-sixth Legislative Assembly of the State of Oregon.

10 SECTION 6. Notwithstanding ORS 293.190, any moneys remaining from the appropri-
11 ations made by sections 4 and 5 (2), chapter 762, Oregon Laws 2007, on June 30, 2009, are
12 transferred to the Emergency Board on July 1, 2009, to be available for any purpose for
13 which the Emergency Board lawfully may allocate funds.

14 SECTION 7. Notwithstanding any other law limiting expenditures, the amount of \$208,653
15 is established for the biennium beginning July 1, 2009, as the maximum limit for payment of
16 expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-
17 cluding lottery funds and federal funds, collected or received by the Legislative Assembly of
18 the State of Oregon.

19 SECTION 8. For the biennium beginning July 1, 2009, expenditures by the Legislative
20 Assembly from the Lounge Revolving Account established by ORS 171.117 for the costs of
21 food served in members' lounges and reimbursed through receipts on the basis of sales or
22 by payroll deductions from members are not limited.

23 SECTION 9. There is appropriated to the Legislative Counsel Committee, for the
24 biennium beginning July 1, 2009, out of the General Fund, the amount of \$8,413,056.

25 SECTION 10. Notwithstanding any other law limiting expenditures, the amount of
26 \$121,966 is established for the biennium beginning July 1, 2009, as the maximum limit for
27 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,
28 but excluding lottery funds and federal funds, collected or received by the Legislative Counsel
29 Committee from state agencies or other offices for bill drafting and any other legal services
30 authorized or required by law to be rendered by the Legislative Counsel Committee, including
31 duties under ORS 183.710 to 183.725 provided pursuant to policies established by the Legisla-
32 tive Counsel Committee.

33 SECTION 11. Notwithstanding any other law limiting expenditures, the amount of
34 \$1,391,651 is established for the biennium beginning July 1, 2009, as the maximum limit for
35 payment of expenses by the Legislative Counsel Committee from the ORS Revolving Account
36 established by ORS 171.305 for personnel costs connected with the editing of the Oregon Re-
37 vised Statutes.

38 SECTION 12. For the biennium beginning July 1, 2009, expenditures by the Legislative
39 Counsel Committee from the ORS Revolving Account established by ORS 171.305 and from
40 the Legislative Publications Account established by ORS 171.245, for services and supplies
41 connected with printing and distributing legislative publications and the Oregon Revised
42 Statutes, are not limited.

43 SECTION 13. There is appropriated to the Legislative Fiscal Officer, for the biennium
44 beginning July 1, 2009, out of the General Fund, the amount of \$6,000,198.

45 SECTION 14. There is appropriated to the Legislative Revenue Officer, for the biennium

1 **beginning July 1, 2009, out of the General Fund, the amount of \$2,147,121.**

2 **SECTION 15. There is appropriated to the Commission on Indian Services, for the**
3 **biennium beginning July 1, 2009, out of the General Fund, the amount of \$414,701.**

4 **SECTION 16. Notwithstanding any other law limiting expenditures, the amount of \$6,280**
5 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
6 **expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
7 **cluding lottery funds and federal funds, collected or received by the Commission on Indian**
8 **Services.**

9 **SECTION 17. This 2009 Act being necessary for the immediate preservation of the public**
10 **peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect**
11 **July 1, 2009.**
