

# House Bill 5033

Ordered printed by the Speaker pursuant to House Rule 12.00A (5). Pre-session filed (at the request of Budget and Management Division, Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by State Parks and Recreation Department.

Limits biennial expenditures by department from lottery moneys for certain purposes.

Limits biennial expenditures by department from federal funds for certain purposes.

Declares emergency, effective July 1, 2009.

## A BILL FOR AN ACT

Relating to financial administration of the State Parks and Recreation Department; limiting expenditures; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1.** Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2009, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the State Parks and Recreation Department, for the following purposes:

- (1) Administration..... \$ 4,343,163
- (2) Heritage Programs..... \$ 533,574
- (3) Grant programs ..... \$ 15,964,138
- (4) Operations/Recreation Programs ..... \$ 61,102,077
- (5) Facility repair and ..... \$ 3,116,336 maintenance
- (6) Oregon State Fair operations... \$ 11,020,053

**SECTION 2.** Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2009, as the maximum limits for payment of expenses from lottery moneys allocated from the Parks and Natural Resources Fund to the State Parks and Recreation Department for the following purposes:

- (1) Administration..... \$ 21,669,043
- (2) Heritage Programs..... \$ 4,071,701
- (3) Grant programs ..... \$ 9,994,763
- (4) Land acquisition..... \$ 10,551,178
- (5) Operations/Recreation Programs ..... \$ 28,455,284
- (6) Facility repair and ..... \$ 18,796,525

5 **SECTION 3.** Notwithstanding any other law limiting expenditures, the following amounts  
 6 are established for the biennium beginning July 1, 2009, as the maximum limits for payment  
 7 of expenses from federal funds collected or received by the State Parks and Recreation De-  
 8 partment for the following purposes:

- 9 (1) Heritage Programs..... \$ 1,554,778
- 10 (2) Grant programs ..... \$ 4,065,732
- 11 (3) Operations..... \$ 1,426,196
- 12 (4) Facility repair and ..... \$ 1,589,972

14 **SECTION 4.** This 2009 Act being necessary for the immediate preservation of the public  
 15 peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect  
 16 July 1, 2009.
