SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Public Defense Services Commission for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by commission.

Decreases appropriations made to commission for biennium ending June 30, 2009, for purposes related to legal services and contract and business services.

Declares emergency, effective *[July 1, 2009]* on passage.

A BILL FOR AN ACT

2 Relating to financial administration of the Public Defense Services Commission; appropriating
3 money; limiting expenditures; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There are appropriated to the Public Defense Services Commission, for the**
6 **biennium beginning July 1, 2009, out of the General Fund, the following amounts for the fol-**
7 **lowing purposes:**

8 (1) **Appellate Division..... \$ 10,690,165**

9 (2) **Public Defense Services**

10 **Account..... \$198,319,908**

11 (3) **Contract and Business**

12 **Services Division..... \$ 3,187,312**

13 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of \$512,049**
14 **is established for the biennium beginning July 1, 2009, as the maximum limit for payment of**
15 **expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
16 **cluding lottery funds and federal funds, collected or received by the Public Defense Services**
17 **Commission, for the Contract and Business Services Division.**

18 **SECTION 3. (1) Notwithstanding any other provision of law, the General Fund appropri-**
19 **ation made to the Public Defense Services Commission by section 1 (1), chapter 596, Oregon**
20 **Laws 2007, for the biennium ending June 30, 2009, for the purpose of legal services, as mod-**
21 **ified by Emergency Board action, is decreased by \$26,500.**

22 (2) **Notwithstanding any other provision of law, the General Fund appropriation made to**
23 **the Public Defense Services Commission by section 1 (3), chapter 596, Oregon Laws 2007, for**
24 **the biennium ending June 30, 2009, for the purpose of contract and business services, as**
25 **modified by Emergency Board action, is decreased by \$24,900.**

1 **SECTION 4. This 2009 Act being necessary for the immediate preservation of the public**
2 **peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect**
3 **on its passage.**
