Appropriates moneys from General Fund to Department of Veterans' Affairs for certain biennial

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and Oregon War Veterans' Bond Sinking Account, but excluding lottery funds and federal funds, collected or received by department.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2009.

14	SECTION 2. (1) Notwithstanding any other law limiting expenditures, the amount of

payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and the Oregon War Veterans' Bond Sinking Account, but excluding lottery funds and federal funds, collected or received by the Department of Veterans' Affairs for administration, grants and services supplied to veterans.

- (2) This section does not limit expenditures from the Oregon War Veterans' Bond Sinking Account for purposes described in section 3 of this 2009 Act.
- 22 SECTION 3. For the biennium beginning July 1, 2009, expenditures by the Department of Veterans' Affairs for the following purposes are not limited: 23

 (4) Payments on behalf of borrowers for property taxes, city liens, fire insurance, mortgage cancellation insurance and repairs to and miscellaneous charges for borrower-owned property that are charged to the loan account and repaid along with the payment of loan interest and principal.

<u>SECTION 4.</u> This 2009 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect July 1, 2009.
