6	\$6,715,016 for patrol services, criminal investigations and gaming enforcement.
7	"(2) Notwithstanding any other provision of law, the General Fund appropriation made
8	to the Department of State Police by section 1 (2), chapter, Oregon Laws 2009 (Enrolled
9	House Bill 5037), for the biennium beginning July 1, 2009, is increased by \$913,280 for fish and
10	wildlife enforcement.
11	"(3) Notwithstanding any other provision of law, the General Fund appropriation made
12	to the Department of State Police by section 1 (3), chapter, Oregon Laws 2009 (Enrolled
13	House Bill 5037), for the biennium beginning July 1, 2009, is increased by \$4,523,282 for
14	forensic services and the State Medical Examiner.
15	"SECTION 2. Notwithstanding any other provision of law, the General Fund appropriation
16	made to the Oregon Youth Authority by section 1 (1), chapter, Oregon Laws 2009 (En
17	rolled House Bill 5051), for the biennium beginning July 1, 2009, is increased by \$23,612,265 for
18	operations.
19	"SECTION 3. (1) Notwithstanding any other provision of law, the General Fund appro
20	priation made to the Department of Corrections by section 1 (1), chapter, Oregon Laws
21	2009 (Enrolled House Bill 5005), for the biennium beginning July 1, 2009, is increased by
22	\$8,200,792 for operations.
23	"(2) Notwithstanding any other provision of law, the General Fund appropriation made
24	to the Department of Corrections by section 1 (2), chapter, Oregon Laws 2009 (Enrolled
25	House Bill 5005), for the biennium beginning July 1, 2009, is increased by \$1,000,000 for ad
26	ministration, public services, general services and human resources.
27	"(3) Notwithstanding any other provision of law, the General Fund appropriation made
28	to the Department of Corrections by section 1 (3), chapter, Oregon Laws 2009 (Enrolled
29	House Bill 5005), for the biennium beginning July 1, 2009, is increased by \$1,886,767 for trans
30	sitional services.
31	"(4) Notwithstanding any other provision of law, the General Fund appropriation made
32	to the Department of Corrections by section 1 (4), chapter, Oregon Laws 2009 (Enrolled
33	House Bill 5005), for the biennium beginning July 1, 2009, is increased by \$6,070,757 for com-
34	munity corrections.
35	"SECTION 4. Notwithstanding any other provision of law, the General Fund appropriation

made to the Oregon Criminal Justice Commission by section 1, chapter ____, Oregon Laws 2009 (Enrolled House Bill 5007), for the biennium beginning July 1, 2009, is increased by \$1,553,207.

"SECTION 5. Notwithstanding any other provision of law, the General Fund appropriation made to the Department of Justice by section 1, chapter ____, Oregon Laws 2009 (Enrolled House Bill 5022), for the biennium beginning July 1, 2009, is increased by \$2,971,639.

"SECTION 6. In addition to and not in lieu of any other appropriation, there is appropriated to the Department of Public Safety Standards and Training, for the biennium beginning July 1, 2009, out of the General Fund, the amount of \$1,056,000 for operations.

"SECTION 7. Notwithstanding any other provision of law, the General Fund appropriation made to the Department of Justice by section 1, chapter ____, Oregon Laws 2009 (Enrolled Senate Bill 5518), for the biennium beginning July 1, 2009, is increased by \$456,835 for paying expenses of district attorneys.

"SECTION 8. Notwithstanding any other provision of law, the General Fund appropriation made to the Public Defense Services Commission by section 1 (2), chapter ____, Oregon Laws 2009 (Enrolled House Bill 5040), for the biennium beginning July 1, 2009, is increased by \$1,105,814 for the Public Defense Services Account.

"SECTION 9. In addition to and not in lieu of any other appropriation, there is appropriated to the Judicial Department, for the biennium beginning July 1, 2009, out of the General Fund, the amount of \$131,064 for operations.

"SECTION 10. Sections 1 to 9 of this 2009 Act become operative only if House Bill 3508 becomes law. Sections 1 to 9 of this 2009 Act become operative on the date House Bill 3508 becomes law.

"SECTION 11. This 2009 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect July 1, 2009."
